Letter dated 25 August 1988 from the Deputy Permanent Observer of the Palestine Liberation Organization to the United Nations addressed to the Secretary-General

I am instructed by the Executive Committee of the Palestine Liberation Organization to bring the following to your attention. On 17 August 1988, Israel deported tour of the six Palestinians it had served with deportation notices on 1 August 1988; their names are:

- 1. Fathi Sheqaqeh, pharmacist from Rafah, Gasa, 38 years old, Sheqaqeh had been in prison since 1986. Married.
- 2, Yusri Al Hams, restaurant owner from Rafah, Gasa, 38 years old, Al Hams was arrested in March 1088 and had been under administrative detention in Ansar 3 detention centre in the Negev. Married.
- 3. Ahmrd Mustafa Mai'lek, student at the Gaza Islamic University, from Gaza City, 29 yerro old. Mai'lek was arrested in June 1968, and had boon detained for 18 dayo in Ansar 2 detention contra in Gaza, then moved to Gaza Central Prison.
- 4, Mohammrd Abdallah Ismail Gharableh, fror arrested in June 1988, and had been und. administrative detention,

Deportation orders were issued on 17 August 1988 to 25 Palestinians from the occupied territories; their names are as follows:

- 1, Hussein Hassan Barakeh, 32 years old, from Bani Suhallah,
- 2, Nabl1 Mohammed Tamus, 21 years old, from Gaza.
- 3. Fathi Mustapha Hajaj, 36 years old, from Bureij camp,
- 4. Riad Wajih Kernel 'Ajur, 26 years old, from Gaza.
- 5. Abdullah Ayad Abu Ssmhadani, 38 yaars old, from Gaza.
- 6. Ayash Abdul Aziz Abu Sa'adi, 30 yearn old, from Jabalia camp,
- 7. Risk Mahmoud al-Bayari, 29 years old, from Gasa.
- 8. Mohammad Saadi Dukh, 30 years old, from Gaza.
- 9. Abdul Min'am Abu'Ataya, 33 years old, from Gasa.
- 10. Ata Mohammed Abu Karsh, 54 years old, from Shate camp.

- 11. Yusef Harb Oden, from Balatta camp.
- 12. 'Asam Amin Fattah Dibay, 29 years old, from Nablus.
- 13. Sirhan Othrm Duwerst, 29 years old, from Balatta camp,
- 14. Jamal Ibrrhim Faraj, 25 yearn old, ftom Dheisheh camp.
- 15. Taysir Rajab Aruri, 43 years old, from al-Bireh.
- 16. Abdul Hamid Ismail al-Baba, 28 years old, from al-'Amari camp.
- 17. Odrn Yusef Ma'ale, 30 years old, from Kufr Na'ameh.
- 18. Majed Andullah Labadi, 28 years old, from Abu Dis.
- 19. 'Akif Wanid Hamdallah, 27 years old, from Anabta.
- 20. Qthman Mohammed Daoud, 29 years old, from Al-Bireh.
- 21. Mohammed AbdulJailil M'tur, 38 years old, from al-Bireh.
- 22, Masoud Othman Zaiter, 42 years old, from Nablus.
- 23. Bilal Issedine Shakahir, 36 years old. from Nablus.

Again, the Palestine Liberation Organization would stress that these deportations are flagrant violations of the Fourth Geneva Convention of 1949, the Universal Declaration of Human Rights, and numerous United Nations resolutions on the inalienable rights of the Palestinian people, in particular Security Council resolutions 607 (1988) and 608 (1988).

In addition to the deportation and pending deportstione of Palestinians from the occupied territories, the situation continues to deteriorate, Israel continues to impose currews by sealing off areas. 600,000 Palestinians were affected by the sealing off of Gaza for several days. Nablus and the eurrounding area, including refugee camps in the West Bank, were also sealed off for reverel days, affecting 120.000 Palestinians.

The numbers of Palestinians killed and wounded by the Israeli occupation forces are increasing at an alarming rate.

On 24 August 1988 at 2 a.m. in the morning, Israell occupation troops blew up three Palestinian homer in Jalason refugee camp. The homer belonged to Yussef Sharaqa, 35 years old, Audrn Tabakhna, 26 years old, and Assad Mbhanned, 24 years

old, Five families in the Jabalia refugee camp were served notice today by the Israeli occupation authorities that their homer will be blown up within 48 hours.

On 22 August 1988, Hani Al-Shami, a Palestinian from the Jabalia refugee camp, was arrerted by the Israeli occupation authorities. Al-Shami was beaten to death by his jailers.

The intensification of deportationo, the sealing-off of large areas, the increase in the killing and wounding of Palestinians, the blowing-up of homor - all is part of war minister Rabin's now pre-emptive policies, Rabin has also declared that Palestinians who are members of popular committree will face 10 years' imprisonment or expulsion. This poses the danger of imprisonment or expulsion of the total Palestinian population under Israeli occupation, which translates into the transferring out of the Palestinian people from their homeland,

The situation in the occupied Palestinian territories is extremely grave and calls for immediate action by the international community. In bringing the aforementioned to your attention, the Palestine Liberation Organisation requests that immediate and appropriate measures bo taken to bring adequate pressure on Israel, the occupying power, to ensure respect for the Fourth Geneva Convention of 1949, and Security Council resolutions 605 (1987), 607 (1988) and 608 (1988).
