## Report of the First Committee

#### I. INTROLUCTION

1. The item entitled "Prohibition of the development and manufacture of new types of weapons of mass destruction and rew systems of such weapons: report of the Conference on Disarmament" was included in tha provisional agenda of the forty-fourth session in accordance with General Assembly resolution 43'72 of 7 December 1988.

2. At its 3rd plenary meeting, on 22 September 1989, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee,

3. At its 2nd meeting, on 13 October, the First Committee decided to hold a general debate on the disarmament items allocated to it, namely, items 49 to 69 and 151. The deliberations on those items took place between the 3rd and the 25th meetings, from 16 October to 1 November (see  $\lambda/C.1/44/PV.3-25$ ). Consideration of and action on draft resolution8 on those items took place from the 26th to 41st meetinga, between 2 and 17 November (see  $\lambda/C.1/44/PV.26-41$ ).
