ANNEX

Statement issued on 31 August 1990 by the Spokesman of the Ministry of Foreign Affairs of Viet Nam

Viet Nam welcomes and highly appreciates the efforts of the five permanent members of the United Nations Security Council in working out the five documents regarding the Cambodian issue. The efforts by the five countries are in the right direction in the search for a comprehensive, fair, and reasonable solution to the Cambodian issue. The agreements reached by the five countries on the international aspects of the Cambodian is sue are basically inconformity with the contents agreed upon by the countries participating in the Paris International Conference on 'ambodia held in August 1989.

As to the internal aspects of a settlement, the Cambodian parties have a lready agreed that a solution should include a coase-fire, the establishment of the Supreme National Council, an important role played by the United Nations, froo, democratic and fair elections organized so that the Cambodian people can decide their own future dostiny. The internal questions relating to the sovereignty of Cambodian should be discussed and decided by the Cambodian parties. Viet Nnm will respect those decisions.

The Paris International Conference, with the participation of . the Cambodian parties and all countries concerned, including the five permanent mombors of the United Nations Security Council, should be based on the agreement of the Cambodian parties and of the five permanent mombors of the United Nations Security Council to decide and sign the final documents for an overall agreement on Cambodia.
