24 June 1991, the members of the Permanent **Commission** for the South Pacific **once** again reject the continuation of nuclear testing by France **in view** of the grave risk such testing poses to the marine environment **and** to life in the Pacific basin, and again call **for an** immediate and permanent end to such tests.

ANNEX

Statement by the Permanent Commission for the South Pacific issued at Santiago on 8 July 1991

There have been reports in the media relaying information provided by the Ministry of **Defence** of France to the effect that on 5 July 1991 France conducted a further nuclear test at Mururoa atoll. This was the fifth such test so far this year and the second since France submitted an arms control and disarmament plan.

This deplorable announcement compels the secretariat to state, once again, the categorical and utter rejection by the Permanent Commission for the South Pacific of such tests in view of the grave risk which they pose to the marine environment and marine resources and the fact that they are in direct contravention of the common policy of the member States of this regional maritime organization for the protection and defence of the marine environment and resources.

Accordingly the secretariat of the Commission, pursuant to the mandate conferred upon it by the Ministers for **Foreign Affairs** of the member States and the Permanent Commission, reiterates its urgent **demand** for the immediate and permanent cessation of such tests in the Pacific basin.
