I. ORGANIZATION OF THE SESSION

A. Opening and duration of the session

1. The Preparatory Committee held its resumed first session at United Nations Headquarters from 7 to 11 March 1994. The Committee held 3 meetings (16th to 18th meetings) and several informal meetings.
2. The session was opened by the Chairman of the Preparatory Committee.
3. At the 16th meeting, on 7 March, the Coordinator for the Conference read out a message from the Secretary-General addressed to the Committee.
4. At the same meeting, the observer for the Caribbean Conservation Association, a non-governmental organization accredited to participate in the Conference and its preparatory process, made a statement.
5. At the 17th meeting, on 8 March, statements were made by the Federal Minister for Environment, Nature Conservation and Nuclear Safety of Germany and by the representative of Italy.
6. At the same meeting, the representative of the Food and Agriculture Organization of the United Nations made a statement.
7. Also at the same meeting, statements were made by the observers for the following non-governmental organizations accredited to participate in the Conference and its preparatory process: Pacific Concerns Resource Centre, Caribbean Conservation Association, Greenpeace International and Caribbean Policy Development Centre.
8. At the 18th meeting, on 11 March, the Under-Secretary-General for Policy Coordination and Sustainable Development made a statement.

B. Attendance

9. 10. The following associate members of the regional commissions were represented by observers: British Virgin Islands, Guam, Montserrat, Niue, Republic of Palau and United States Virgin Islands.

11. The following United Nations bodies and programmes were represented: United Nations Centre for Human Settlements (Habitat), United Nations Development Programme, United Nations Environment Programme and United Nations International Drug Control Programme.

12. The Economic Commission for Africa and the Economic and Social Commission for Asia and the Pacific were represented.

13. The following specialized agencies were represented: International Labour Organization, Food and Agriculture Organization of the United Nations, United Nations Educational, Scientific and Cultural Organization, World Bank, International Monetary Fund, World Meteorological Organization and United Nations Industrial Development Organization.

14. The following intergovernmental organizations were represented: Agency for Cultural and Technical Cooperation, Asian and Pacific Development Centre, Asian-African Legal Consultative Committee, Caribbean Community, Commission of the European Communities, Commonwealth Secretariat, International Organization for Migration, Organization of African Unity and South Pacific Regional Environment Programme.

15. The African National Congress was represented by an observer.

16. C. Adoption of the agenda and other organizational matters

17. At its 16th meeting, on 7 March, the Preparatory Committee adopted the provisional agenda and organization of work contained in document A/CONF.167/PC/12 and Add.1. The agenda was as follows:

1. Adoption of the agenda and other organizational matters.
2. Preparations for the first Global Conference on the Sustainable Development of Small Island Developing States on the basis of General Assembly resolution 47/189 and taking into account other relevant General Assembly resolutions:
 - (a) Organization and programme of work of the Conference;
 - (b) Participation of non-governmental organizations in the Conference and its preparatory process;
 - (c) Preparations by the host Government;
 - (d) Operations of the voluntary fund.
3. Consideration of plans and programmes to support the sustainable development of small island developing States and the utilization of their marine and coastal resources, which includes meeting essential human needs, maintaining biodiversity and improving the quality of life for island people, as well as measures that will enable small island developing States to cope effectively, creatively and in a sustainable manner with environmental changes and to mitigate the impacts on and reduce the threats posed to marine and coastal resources:
 - (a) Draft programme of action for the sustainable development of small island developing States;
 - (b) Information on donor activities in support of sustainable development in small island developing States;
 - (c) Consideration of proposals for a Barbados declaration on the sustainable development of small island developing States.
4. Adoption of the report of the Preparatory Committee on its resumed first session.

II. PREPARATIONS FOR THE FIRST GLOBAL CONFERENCE ON THE SUSTAINABLE DEVELOPMENT OF SMALL ISLAND DEVELOPING STATES ON THE BASIS OF GENERAL ASSEMBLY RESOLUTION 47/189 OF 22 DECEMBER 1992 AND TAKING INTO ACCOUNT OTHER RELEVANT GENERAL ASSEMBLY RESOLUTIONS

A. Organization and programme of work of the Conference

18. The Preparatory Committee considered agenda item 2 (a) at its 16th and 18th meetings, on 7 and 11 March. It had before it a note by the Secretariat on the organization and programme of work of the Conference (A/CONF.167/PC/L.8).

1. Rules of procedure of the Conference

19. At its 18th meeting, on 11 March, the Committee had before it a draft decision entitled "Rules of procedure of the Conference" (A/CONF.167/PC/L.12) submitted by the Chairman and the Bureau of the Preparatory Committee.

20. At the same meeting, the Committee adopted the draft decision (see para. 52, decision 15).

2. High-level segment

21. At its 18th meeting, on 11 March, the Committee had before it a draft decision entitled "High-level segment" (A/CONF.167/PC/L.13), submitted by the Chairman and the Bureau of the Preparatory Committee.

22. At the same meeting, the Committee adopted the draft decision (see para. 52, decision 16).

3. Decision on the organization and programme of work of the Conference

23. At its 18th meeting, on 11 March, the Committee had before it a draft decision entitled "Organization and programme of work of the Conference" (A/CONF.167/PC/L.14), submitted by the Chairman and the Bureau of the Preparatory Committee.

24. At the same meeting, the Committee adopted the draft decision (see para. 52, decision 17).

B. Participation of non-governmental organizations in the Conference and its preparatory process

25. The Preparatory Committee considered agenda item 2 (b) at its 16th meeting, on 7 March. The Committee had before it a note by the Secretariat on the participation of non-governmental organizations in the preparatory process (A/CONF.167/PC/L.4/Add.1).

26. At the same meeting, the Committee approved the accreditation of the non-governmental organizations listed in document A/CONF.167/PC/L.4/Add.1 to

participate in the Conference and its preparatory process. (See para. 52, decision 21).

C. Preparations by the host Government

27. The Preparatory Committee considered agenda item 2 (c) at its 16th meeting, on 7 March. The Minister for Environment, Housing and Lands of Barbados made an oral presentation.

III. A. Draft programme of action for the sustainable development of small island developing States

28. The Preparatory Committee considered agenda item 3 (a) at its 16th and 18th meetings, on 7 and 11 March. It had before it the report of the Preparatory Committee on its organizational and first sessions (A/48/36).

29. At the 16th meeting, statements were made by the representatives of the United States of America, Australia and Papua New Guinea.

30. At the same meeting, statements were made by the representatives of Algeria (on behalf of the States Members of the United Nations that are members of the Group of 77 and China), Trinidad and Tobago (on behalf of the Alliance of Small Island States) and Greece (on behalf of the European Union).

31. At its 18th meeting, on 11 March, the Committee had before it a draft decision entitled "Draft programme of action for the sustainable development of small island developing States" (A/CONF.167/PC/L.16), submitted by the Chairman and the Bureau of the Preparatory Committee.

32. At the same meeting, the Committee adopted the draft decision (see para. 52, decision 19).

B. Information on donor activities in support of sustainable development in small island developing States

33. The Preparatory Committee considered agenda item 3 (b) at its 16th and 18th meetings, on 7 and 11 March.

34. For its consideration of the item, the Committee had before it the report of the Secretary-General on current donor activities in support of sustainable development in small island developing States (A/CONF.167/PC/13 and Add.1), and a document containing an inventory of current donor activities in support of sustainable development of small island developing States (A/CONF.167/PC/CRP.1).

35. At the 16th meeting, on 7 March, the Coordinator for the Conference made a preliminary statement.

36. At the same meeting, the Deputy Coordinator for the Conference made a statement.

Report on current donor activities

37. At its 18th meeting, on 11 March, the Committee had before it a draft decision entitled "Report on current donor activities" (A/CONF.167/PC/L.17), submitted by the Chairman and the Bureau of the Preparatory Committee.

38. At the same meeting, the representatives of Greece (on behalf of the European Union) and the Commission of the European Communities made statements.

39. At the same meeting, the Coordinator for the Conference made a statement.

40. Also at the same meeting, the Committee adopted the draft decision (see para. 52, decision 20).

C. Consideration of proposals for a Barbados declaration on the sustainable development of small island developing States

41. The Preparatory Committee considered agenda item 3 (c) at its 18th meeting, on 11 March. The Committee had before it a draft text (A/CONF.167/PC/L.10) entitled "The Barbados declaration (elements for discussion)", submitted by Barbados.

42. At the 18th meeting, on 11 March, the Committee had before it a draft decision entitled "Proposals for a Barbados declaration" (A/CONF.167/PC/L.15), submitted by the Chairman and the Bureau of the Preparatory Committee.

43. At the same meeting, the Committee adopted the draft decision (see para. 52, decision 18).

IV. ADOPTION OF THE REPORT OF THE PREPARATORY COMMITTEE
ON ITS RESUMED FIRST SESSION

44. At its 18th meeting, on 11 March, the Committee considered the draft report of the Preparatory Committee at its resumed first session (A/CONF.167/PC/L.9).

45. At the same meeting, the Rapporteur introduced and orally revised the draft report.

46. At the same meeting, the Committee adopted the draft report, as orally revised, and decided to entrust the Rapporteur with finalizing the report in the light of the comments made and the decisions taken at its final meeting, with a view to its submission to the Conference.

V. CLOSURE OF THE SESSION

47. At the 18th meeting, on 11 March, the Coordinator of the Conference made a statement.

48. At the same meeting, the observer for Women and Fisheries Network, a non-governmental organization accredited to participate in the Conference and its preparatory process, made a statement on behalf of the non-governmental organizations represented in the Preparatory Committee.

49. Also at the same meeting, statements were made by the representatives of Canada, Australia, Germany and Japan.

50. At the same meeting, the Chairman made a concluding statement.

51. Also at the same meeting, concluding statements were also made by the representatives of Greece (on behalf of the European Union), Algeria (on behalf of the Group of 77 and China) and Trinidad and Tobago (on behalf of the Alliance of Small Island States).

VII. DECISIONS OF THE PREPARATORY COMMITTEE ON ITS RESUMED
FIRST SESSION CALLING FOR ACTION BY THE CONFERENCE

52. At its resumed first session, the Preparatory Committee for the Global Conference on the Sustainable Development of Small Island Developing States adopted 8 decisions* which are before the Conference for its consideration and appropriate action, as follows:

DECISION 15

Rules of procedure of the Conference

The Preparatory Committee recommends to the Conference the following amendment to the draft rules of procedure of the Conference (A/CONF.167/PC/3):

Elections

Rule 6

The Conference shall elect from among the representatives of participating States the following officers: a President, nine Vice-Presidents plus an ex officio Vice-President from the host country, a Rapporteur-General and a Chairman for the Main Committee established in accordance with rule 46. These officials shall be elected on the basis of ensuring the representative character of the General Committee. The Conference may also elect such other officers as it deems necessary for the performance of its functions.

DECISION 16

High-level segment

The Preparatory Committee recommends to the Conference that the high-level segment should be open to participation at the Head of State or Government or Ministerial level. The high-level segment should last for one and one half days, from the morning of Thursday, 5 May, through the morning of Friday, 6 May 1994. Thursday will be devoted to a debate on the theme "Forging partnerships for sustainable development". Statements in the debate during the high-level segment should be limited to seven minutes. The Preparatory Committee also notes the intention of the host country to organize a round table for participants in the high-level segment on the morning of 6 May, and it invites the President of the Conference to report to the Conference on the results of the high-level segment and the round table in the form of a presidential summary prepared under his own authority.

DECISION 17

Decision on the organization and programme of work
of the Conference

The Preparatory Committee takes note of the organization and programme of work of the Conference (A/CONF.167/PC/L.8).

DECISION 18

Decision on the proposals for a Barbados declaration

The Preparatory Committee requests the Secretary-General to transmit the text containing proposals for a Barbados declaration (A/CONF.167/PC/L.10) to the Conference for its consideration and appropriate action.

DECISION 19

Draft programme of action for the sustainable development
of small island developing States

The Preparatory Committee requests the Secretary-General to transmit the draft programme of action for the sustainable development of small island developing States, as amended during the resumed first session of the Preparatory Committee, to the Conference for its consideration and appropriate action.

DECISION 20

Report on current donor activities

The Preparatory Committee requests the Secretary-General to transmit a revised version of the report on current donor activities in support of sustainable development in small island developing States to the Conference for its consideration and appropriate action.
