NOTE.

The resolutions and decisions of the General Assembly are identified as follows:

Regular sessions

Until the thirtieth regular session, the resolutions of the General Assembly were identified by an arabic numeral followed by a roman numeral in parentheses indicating the session (for example: resolution 3363 (XXX)). When several resolutions were adopted under the same number, each of them was identified by a capital letter placed between the two numerals (for example: resolution 3367 A (XXX), resolutions 3411 A and B (XXX), resolutions 3419 A to D (XXX)). The decisions were not numbered.

Since the thirty-first session, as part of the new system adopted for symbols of General Assembly documents, resolutions and decisions have been identified by an arabic numeral, indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution 31/1, decision 31/301). When several resolutions or decisions were adopted under the same number, each of them has been identified by a capital letter placed after the two numerals (for example: resolution 31/16 A, resolutions 31/6 A and B, decisions 31/406 A to E).

Special sessions

Until the seventh special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letter "S" and a roman numeral indicating the session (for example: resolution 3362 (S-VII)). The decisions were not numbered.

Since the eighth special session, resolutions and decisions have been identified by the letter "S" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution S-8/1, decision S-8/11).

Emergency special sessions

Until the fifth emergency special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letters "ES" and a roman numeral indicating the session (for example: resolution 2252 (ES-V)). The decisions were not numbered.

Since the sixth emergency special session, resolutions and decisions have been identified by the letters "ES" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution ES-6/1, decision ES-6/11).


In each of the series described above, the numbering follows the order of adoption.

ORGANIZATION OF THE LIST OF SPEAKERS FOR THE SPECIAL COMMEMORATIVE MEETING OF THE GENERAL ASSEMBLY ON THE OCCASION OF THE FIFTIETH ANNIVERSARY OF THE UNITED NATIONS

The General Assembly,

Recalling its resolution 48/215 B of 26 May 1994, in which it decided to convene a special commemorative meeting on the occasion of the fiftieth anniversary of the entry into force of the Charter of the United Nations, to be held at United Nations Headquarters from 22 to 24 October 1995.

Recalling also paragraph 8 of the report of the Preparatory Committee for the Fiftieth Anniversary of the United Nations,2 in which the modalities for inviting Palestine and, if they so request, other observers to attend the Special Commemorative Meeting were agreed upon,

- 1. Decides that the Special Commemorative Meeting shall consist of a total of six meetings, on the basis of two meetings a day:
- 2. Also decides that the list of speakers for the Special Commemorative Meeting shall be organized in accordance with the procedure set forth in the annex to the present resolution.

ANNEX

Organization of the list of speakers for the Special Commemorative Meeting of the General Assembly on the occasion of the fiftieth anniversary of the United Nations

- 1. The list of speakers for the Special Commemorative Meeting will be established on the basis of six meetings, each meeting having 25 speaking slots, with the exception of the meeting on Tuesday, 24 October 1995, in the afternoon, which will have 60 speaking slots.
- 2. The first speaker in the Special Commemorative Meeting will be the head of State of the host country of the Organization.
- The list of speakers for the Special Commemorative Meeting will be initially established as follows:
- (a) The Secretary-General or his representative will draw one name from a box containing the names of all Member States, observer

States and Palestine, in its capacity as observer, participating in the Special Commemorative Meeting. This procedure will be repeated until all names have been drawn from the box, thus establishing the order in which participants will be invited to choose their meetings and select their speaking slots;

- (b) Six boxes will be prepared, each one representing a meeting and each one containing numbers corresponding to speaking slots at that meeting;
- (c) Once the name of a Member State, observer State or Palestine, in its capacity as observer, has been drawn by the Secretary-General or his representative, that Member State, observer State or Palestine, in its capacity as observer, will be invited first to choose a meeting and then to draw from the appropriate box the number indicating the speaking slot in the meeting;
- (d) A number of speaking slots at each meeting will be reserved for observers participating in the Special Commemorative Meeting. They will be invited to participate in the initial establishment of the list of speakers in the same manner as Member States, observer States and Palestine, in its capacity as observer, but from a different set of six boxes.
- 4. The establishment of the initial list of speakers for the Special Commemorative Meeting as outlined in paragraph 3 of the present annex will take place at a meeting of the Preparatory Committee for the Fiftieth Anniversary of the United Nations to be held on 7 June 1995.
- 5. Subsequently, the list of speakers for each meeting will be rearranged in accordance with the established practice of the General Assembly when organizing each category of speakers, following the order resulting from the selection process outlined in paragraph 3 of the present annex:
- (a) Heads of State will thus be accorded first priority, followed by vice-presidents, crown princes/princesses, heads of Government, the highest-ranking official of the Holy See and Switzerland, as observer States, and Palestine, in its capacity as observer, ministers, permanent representatives and other observers;
- (b) In the event that the level at which a statement is to be made is subsequently changed, the speaker will be moved to the next available speaking slot in the appropriate category at the same meeting;
- (c) Participants may arrange to exchange their speaking slots in accordance with the established practice of the General Assembly;
- (d) Speakers who are not present when their speaking turn comes will be automatically moved to the next available speaking slot within their category.
- 6. In order to accommodate all speakers at the Special Commemorative Meeting, statements should be limited to five minutes, on the understanding that this will not preclude the circulation of more extensive texts.
- 7. The full text of all speeches provided to the Special Commemorative Meeting will be subsequently published in a bound book.

FINANCING OF THE PALESTINIAN POLICE FORCE

The General Assembly,

Recalling its resolution 49/21 B of 2 December 1994 on the financing of the Palestinian Police Force,

Taking note of the report of the Secretary-General of 6 April 1995³ and his designation of the United Nations Relief and Works Agency for Palestine Refugees in the Near East in pursuance of paragraph 1 of resolution 49/21 B,

1. Requests the Secretary-General to designate once again the United Nations Relief and Works Agency for Palestine Refugees in the Near East to disburse, with due

attention to the need for thorough accounting, the voluntary contributions given by donors in light of the activities of the Ad Hoc Liaison Committee for salaries and other start-up costs of the Palestinian Police Force, for a period ending not later than 31 December 1995;

- 2. Encourages all Member States to contribute funds for this purpose through the Agency;
- 3. Requests the Secretary-General to report on the implementation of the present resolution.

EMERGENCY ASSISTANCE TO ANTIGUA AND BARBUDA, DOMINICA, MONTSERRAT, SAINT KITTS AND NEVIS AND SINT MAARTEN (NETHERLANDS ANTILLES)

The General Assembly,

Recalling its resolutions 42/169 of 11 December 1987, 43/202 of 20 December 1988, 44/236 of 22 December 1989, 45/185 of 21 December 1990, 46/149 of 18 December 1991, 46/182 of 19 December 1991, 48/188 of 21 December 1993 and 49/22 A of 2 December 1994,

Deeply distressed by the large number of afflicted persons and the destruction wrought by Hurricane Luis, which on 4 and 5 September 1995 devastated Antigua and Barbuda, Dominica, Montserrat, Saint Kitts and Nevis, and Sint Maarten (Netherlands Antilles),

Conscious of the efforts of the Governments and peoples of Antigua and Barbuda, Dominica, Montserrat and Saint Kitts and Nevis and the people of Sint Maarten (Netherlands Antilles) to save lives and alleviate the sufferings of the victims of Hurricane Luis,

Noting the enormous effort that will be required to alleviate the grave situation caused by this natural disaster.

Conscious of the prompt response being made by Governments, the bodies and agencies of the United Nations system, international and regional agencies, non-governmental organizations and private individuals to provide relief,

Recognizing that the magnitude of the disaster and its medium-term and long-term effects will require, as a complement to the efforts being made by the Governments and peoples of Antigua and Barbuda, Dominica, Montserrat and Saint Kitts and Nevis and the people of Sint Maarten (Netherlands Antilles), a demonstration of international solidarity and humanitarian concern to ensure broad multilateral cooperation in order to meet the immediate emergency situation in the affected areas and to initiate the process of reconstruction,

- 1. Expresses its solidarity and support to the Governments and peoples of Antigua and Barbuda, Dominica, Montserrat and Saint Kitts and Nevis and the people of Sint Maarten (Netherlands Antilles);
- 2. Expresses its appreciation to all States of the international community, international agencies and non-governmental organizations that are providing emergency relief to the affected countries;
- 3. Urges all States of the international community, as a matter of urgency, to contribute generously to the relief, rehabilitation and reconstruction efforts in the affected countries:
- 4. Requests the Secretary-General, in collaboration with the international financial institutions and bodies and

agencies of the United Nations system, to assist the Governments of Antigua and Barbuda, Dominica, Montserrat and Saint Kitts and Nevis and the people of Sint Maarten (Netherlands Antilles) in identifying their medium-term and long-term needs and in mobilizing resources, as well as to help with the task of reconstruction of the affected countries undertaken by their respective Governments;

5. Also requests the Secretary-General to submit to the General Assembly at its fiftieth session a report on the collaborative effort referred to in paragraph 4 above and on progress made with the relief, rehabilitation and reconstruction efforts in the affected countries.

The General Assembly,

Having considered further the item entitled "The situation of democracy and human rights in Haiti",

Recalling its resolutions 46/7 of 11 October 1991, 46/138 of 17 December 1991, 47/20 A and B of 24 November 1992 and 20 April 1993, respectively, 47/143 of 18 December 1992, 48/27 A and B of 6 December 1993 and 8 July 1994, respectively, 48/151 of 20 December 1993, 49/27 of 5 December 1994 and 49/201 of 23 December 1994, as well as the resolutions and decisions adopted on the question by the Economic and Social Council and the Commission on Human Rights,

Recalling also Security Council resolutions 841 (1993) of 16 June 1993, 861 (1993) of 27 August 1993, 862 (1993) of 31 August 1993, 867 (1993) of 23 September 1993, 873 (1993) of 13 October 1993, 875 (1993) of 16 October 1993, 905 (1994) of 23 March 1994, 917 (1994) of 6 May 1994, 933 (1994) of 30 June 1994, 940 (1994) of 31 July 1994, 944 (1994) of 29 September 1994, 948 (1994) of 15 October 1994, 964 (1994) of 29 November 1994 and 975 (1995) of 30 January 1995,

Welcoming resolutions MRE/RES.1/91, MRE/RES.2/91, MRE/RES.3/92, MRE/RES.4/92, MRE/RES.5/93 Corr.1, MRE/RES.6/94 and MRE/RES.7/95, adopted on 3 and 8 October 1991, 17 May and 13 December 1992, 5 June 1993, 8 June 1994 and 5 June 1995, respectively, by the Ministers for Foreign Affairs of the member countries of the Organization of American States, as well as resolutions CP/RES.567 (870/91), CP/RES.575 (885/92), CP/RES.594 (923/92), CP/RES.610 (968/93), CP/RES.6/30 (987/94) and CP/RES.633 (995/94), and declarations CP/DEC.2 (896/92), CP/DEC.8 (927/93), CP/DEC.9 (931/93), CP/DEC.10 (934/93), CP/DEC.14 (960/93), CP/DEC.15 (967/93), CP/DEC.18 (986/94) and CP/DEC.21 (1006/94), adopted by the Permanent Council of the Organization of American States,

Reaffirming that the goal of the international community remains the full observance of human rights and fundamental freedoms and the promotion of social and economic development in Haiti,

Noting in this context the importance of free and fair legislative elections now in progress in Haiti, and the willingness of the Government of Haiti to hold such elections as called for in the Constitution, within the framework of the full restoration of democracy in Haiti,

Stressing the importance of free and fair presidential elections in Haiti, and the willingness of the Government of Haiti to hold such elections in accordance with the Constitution, as a crucial step in the complete consolidation of long-lasting democracy in Haiti,

Strongly supportive of the continuing leadership of the Secretary-General of the United Nations and the Secretary-General of the Organization of American States in the efforts of the international community in furthering political progress in Haiti,

Welcoming the success of the United Nations Mission in Haiti and the contributions of the Special Representative of the Secretary-General of the United Nations and his staff to that success,

Welcoming also the continued efforts by States to provide humanitarian assistance and technical cooperation to the people of Haiti,

Supporting fully the renewed role of the International Civilian Mission to Haiti in the establishment of a climate of freedom and tolerance propitious to the full observance of human rights and the full restoration of the constitutional democracy of Haiti,

Paying tribute to the members and staff of the International Civilian Mission to Haiti for their contribution, undertaken in difficult and sometimes dangerous circumstances, in accompanying the Haitian people in their efforts to return to constitutional order and democracy,

Taking note of the report of the Secretary-General of 29 June 1995⁵ on the situation of democracy and human rights in Haiti, and in particular its annex containing the letter dated 23 June 1995 from President Jean-Bertrand Aristide to the Secretary-General requesting the extension of the mandate of the Mission created by the General Assembly in its resolution 47/20 B,

- 1. Approves the recommendation of the Secretary-General contained in his report to renew the mandate of the joint participation of the United Nations with the Organization of American States in the International Civilian Mission to Haiti, with the task of verifying full observance by Haiti of human rights and fundamental freedoms, with a view to making recommendations thereon, in order to further the establishment of a climate of freedom and tolerance propitious to the consolidation of long-term constitutional democracy in Haiti and to contribute to the strengthening of democratic institutions;
- 2. Decides to authorize the extension of the mandate of the United Nations component of the Mission until 7 February 1996, according to the terms of reference and modalities under which the Mission is operating;
- 3. Expresses its full support for the Mission and trusts that the Government of Haiti will continue to afford it timely, complete and effective cooperation;
- 4. Pays tribute to the Haitian people in their ongoing quest for strong and lasting democracy, economic prosperity and national reconciliation;
 - 5. Expresses its appreciation to those States which

have assisted in the restoration of democracy to Haiti and the return of President Jean-Bertrand Aristide to office, including those participating in the United Nations Mission in Haiti and those which have accompanied the Haitian people in their efforts to return to constitutional order and democracy;

- 6. Welcomes the prospect of free and fair presidential elections and the smooth transition to a new, democratically elected government in February 1996, in accordance with the Constitution of Haiti;
- 7. Reaffirms once again the commitment of the international community to an increase in technical, economic and financial cooperation with Haiti, in support of its economic and social development efforts and in order to strengthen those institutions responsible for dispensing justice and guaranteeing democracy, political stability and economic development;
- 8. Commends the cooperation between the Secretary-General of the United Nations and the Secretary-General of the Organization of American States in their efforts to promote respect for the rights of all Haitians and to contribute to the strengthening of democratic institutions, including the support of those organizations for election monitoring;
- 9. Reaffirms its request that the Secretary-General support the Government of Haiti as it works towards the national reconstruction and development of Haiti, in order to consolidate a climate propitious to the establishment of a lasting democracy and full respect for human rights;
- 10. Requests the Secretary-General to continue coordination of the efforts of the United Nations system towards an appropriate response capable of providing humanitarian aid and of meeting the development requirements of Haiti;
- 11. Also requests the Secretary-General to submit to the General Assembly regular reports on the work of the International Civilian Mission to Haiti;
 - 12. Decides to keep open its consideration of this item.

49/236. United Nations Mission for the Verification of Human Rights and of Compliance with the Commitments of the Comprehensive Agreement on Human Rights in Guatemala

The General Assembly,

Recalling its resolutions 45/15 of 20 November 1990, 46/109 A of 17 December 1991, 47/118 of 18 December 1992, 48/161 of 20 December 1993 and, in particular, 48/267 of 19 September 1994, in which it decided to establish the United Nations Mission for the Verification of Human Rights and of Compliance with the Commitments of the Comprehensive Agreement on Human Rights in Guatemala in accordance with the recommendations contained in the report of the Secretary-General for an initial period of six months, and its resolution 49/137 of 19 December 1994, in which it requested the Secretary-General to continue his support for the Guatemalan peace process,

through his representative, and his assistance in implementing the agreements.

Welcoming the inauguration and full deployment of the Mission and the support and cooperation provided to it by the Government of Guatemala and the Unidad Revolucionaria Nacional Guatemalteca.

Also welcoming the conclusion of the status-of-mission agreement between the Government of Guatemala and the Secretary-General and its subsequent approval by the Guatemalan Congress,

Taking into account the note by the Secretary-General⁷ containing the report of the Director of the Mission on the first three months of the Mission's activities.

Taking note of the recommendations addressed to the Government of Guatemala and the Unidad Revolucionaria Nacional Guatemalteca contained in that report, regarding the implementation of their commitments under the Comprehensive Agreement on Human Rights,⁸

Stressing the importance of mobilizing national and international resources for institution-building and cooperation projects intended to strengthen the Guatemalan system for the protection of human rights,

Recognizing the efforts of the Secretary-General and the Group of Friends of the Guatemalan peace process⁹ in support of the peace negotiations,

Concerned that the peace negotiations slowed down during the second half of 1994 and that the target dates agreed by the parties for the conclusion of an agreement on a firm and lasting peace were not met,

Emphasizing the importance of giving new momentum to the peace negotiations with a view to reaching promptly a package of agreements that will put an end to the armed confrontation and lay the foundations for a lasting peace in Guatemala,

Taking note with appreciation of the report of the Secretary-General concerning steps taken since 22 December 1994 to give new dynamism to the peace negotiations.¹⁰

Having considered the recommendation of the Secretary-General regarding the extension of the mandate of the Mission, contained in his report on the Mission, ¹¹

- 1. Welcomes the report of the Secretary-General on the United Nations Mission for the Verification of Human Rights and of Compliance with the Commitments of the Comprehensive Agreement on Human Rights in Guatemala;
- 2. Takes note with satisfaction of the report of the Director of the Mission on the first three months of the Mission's activities;
- 3. Decides to authorize the renewal of the mandate of the Mission for a further period of six months, in accordance with the recommendation of the Secretary-General;
- 4. Calls upon the Government of Guatemala and the Unidad Revolucionaria Nacional Guatemalteca to follow

the recommendations of the Mission and to comply fully with their commitments under the Comprehensive Agreement on Human Rights;

- 5. Reiterates the importance of the undertaking by the parties, contained in the Comprehensive Agreement on Human Rights, to provide their broadest support to the Mission and whatever cooperation it may need to carry out its functions, particularly with respect to the security of the members of the Mission;
- 6. Invites the international community to increase its support for institution-building and cooperation projects with governmental and non-governmental organizations, intended to strengthen the Guatemalan system for the protection of human rights, in particular through voluntary contributions to the trust fund for the Guatemalan peace process being established by the Secretary-General;
- 7. Reiterates the great importance it attaches to the early conclusion of the agreement on a firm and lasting peace and urges the parties to make good on their commitment to give new momentum to the negotiating process;
- 8. Requests the Secretary-General to keep the General Assembly fully informed of the implementation of the present resolution.

The General Assembly,

Recalling its resolutions 45/15 of 20 November 1990, 46/109 A of 17 December 1991, 47/118 of 18 December 1992, 48/161 of 20 December 1993 and 48/267 of 19 September 1994, in which it decided to establish the United Nations Mission for the Verification of Human Rights and of Compliance with the Commitments of the Comprehensive Agreement on Human Rights in Guatemala, and its resolutions 49/137 of 19 December 1994 and, in particular, 49/236 A of 31 March 1995, in which it decided to authorize the renewal of the mandate of the Mission for a further period of six months,

Welcoming the signing by the parties on 31 March 1995 of the Agreement on Identity and Rights of Indigenous Peoples,12

Taking into account the note by the Secretary-General containing the second report of the Director of the Mission,13

Taking note of the recommendations addressed to the Government of Guatemala and the Unidad Revolucionaria Nacional Guatemalteca contained in the second report of the Director of the Mission, regarding the implementation of their commitments under the Comprehensive Agreement on Human Rights,8

Also taking note of the request of the parties regarding the immediate verification by the Mission of human rights aspects of the Agreement on Identity and Rights of Indigenous Peoples and the recommendation of the Secretary-General contained in his report on the Mission¹⁴ on resources required to allow the Mission to continue to fulfil

its mandate, including verification activities relating to human rights aspects of the Agreement,

Stressing once again the importance of mobilizing national and international resources to strengthen the Guatemalan system for the protection of human rights,

Welcoming, in that respect, the support of the donor community for the implementation of the agreements reached in the Guatemala peace process, including the Comprehensive Agreement on Human Rights, expressed in Guatemala and reiterated at the informal donors meeting on Guatemala held in Paris on 21 June 1995 under the auspices of the World Bank,

Acknowledging the efforts of the Secretary-General, the Group of Friends of the Guatemala peace process9 and the United Nations agencies and programmes concerned for their support to the Guatemala peace process,

Emphasizing the importance it attaches to the full observance by the parties of human rights and the other commitments they have undertaken,

Stressing the need to continue the existing momentum towards the early conclusion of an agreement on a firm and lasting peace.

Having considered the recommendation of the Secretary-General regarding the extension of the mandate of the Mission, contained in his report on the Mission,

- 1. Stresses the significance of the Agreement on Identity and Rights of Indigenous Peoples as an important step in the Guatemala peace process and a landmark in the International Decade of the World's Indigenous People;15
- Welcomes the report of the Secretary-General on the United Nations Mission for the Verification of Human Rights and of Compliance with the Commitments of the Comprehensive Agreement on Human Rights in Guatemala;14
- Takes note with satisfaction of the second report of the Director of the Mission;
- Decides to authorize the renewal of the mandate of the Mission for a further period of six months, that is, until 18 March 1996, in accordance with the recommendation of the Secretary-General;
- Welcomes the efforts of international and regional financial institutions aiming at mobilizing resources for the implementation of the Guatemala peace agreements, including the Comprehensive Agreement on Human Rights;
- 6. Also welcomes voluntary contributions already made to the Trust Fund for the Guatemala peace process established by the Secretary-General, and invites the international community to make further contributions to the
- 7. Calls upon the Government of Guatemala and the Unidad Revolucionaria Nacional Guatemalteca to implement the recommendations contained in the first16 and second reports of the Director of the Mission and to comply fully with their commitments under the Comprehensive Agreement on Human Rights and with the human rights aspects of the Agreement on Identity and Rights of Indigenous Peoples;
- Reiterates the importance of the undertaking by the parties, contained in the Comprehensive Agreement on

Human Rights, to provide their broadest support to the Mission and whatever cooperation it may need to carry out its functions, particularly with respect to the security of the members of the Mission;

- 9. Calls upon the parties to reach agreement on the item entitled "Socio-economic aspects and agrarian situation", currently under discussion in the negotiating process, and to strive for the earliest conclusion of an agreement on a firm and lasting peace;
- 10. Requests the Secretary-General to keep the General Assembly fully informed of the implementation of the present resolution.

49/243. Accreditation of non-governmental organizations to the Fourth World Conference on Women: Action for Equality, Development and Peace

The General Assembly,

Recalling Economic and Social Council resolution 1296 (XLIV) of 23 May 1968 on arrangements for consultation with non-governmental organizations.

Recalling also Economic and Social Council resolution 1987/20 of 26 May 1987, in which the Council decided that the Commission on the Status of Women should be designated as the preparatory body for world conferences on women,

Recalling further resolution 37/7 of 25 March 1993 of the Commission on the Status of Women, concerning preparations for the Fourth World Conference on Women: Action for Equality, Development and Peace,

Recalling General Assembly resolution 48/108 of 20 December 1993, by which the Assembly adopted modalities for participation in and contribution to the Conference and its preparatory process by non-governmental organizations,

Emphasizing that the rules for accreditation of nongovernmental organizations to the Conference, contained in the annex to resolution 48/108, should be applied transparently and fairly.

Reaffirming the importance of participation by nongovernmental organizations in the Conference and its preparatory process,

Noting that there is need for more time and opportunity for many non-governmental organizations to clarify their qualifications for accreditation to the Conference,

- 1. Requests the secretariat of the Fourth World Conference on Women: Action for Equality, Development and Peace to communicate immediately in writing with each non-governmental organization which, by 15 March 1995, had applied for accreditation to the Conference but had not yet been accredited, listing the reasons why the secretariat had not forwarded the name of the organization to the Commission on the Status of Women for accreditation;
- 2. Also requests the secretariat of the Conference to invite those non-governmental organizations referred to in paragraphs 1 above and 4 below to submit, within four weeks of the date of transmittal of the secretariat's written communication, further relevant information concerning their qualifications for accreditation;

- 3. Requests that the secretariat of the Conference be responsible for the receipt and evaluation, in accordance with the provisions of the annex to General Assembly resolution 48/108, of all previously supplied information, as well as that submitted by non-governmental organizations under the terms of paragraph 2 above;
- 4. Requests the secretariat of the Conference to extend the deadline for application for accreditation by non-governmental organizations until 28 April 1995, to continue to consider applications received by that date and to ensure that those applications are considered in a transparent manner, in accordance with the criteria set forth in the annex to resolution 48/108:
- 5. Also requests the secretariat of the Conference, prior to the convening of the substantive session of 1995 of the Economic and Social Council, to prepare a list of those non-governmental organizations referred to in paragraphs 1 and 4 which, considering all available information, appear to have met the criteria set forth in the annex to resolution 48/108 for accreditation to the Conference;
- 6. Further requests the secretariat of the Conference to provide a list of those non-governmental organizations referred to in paragraphs 1 and 4 which the secretariat does not recommend for accreditation, together with the reasons for non-recommendation, to all members of the Economic and Social Council no later than one week prior to the substantive session of 1995 of the Council;
- 7. Authorizes the Economic and Social Council, at its substantive session of 1995, to decide on all pending proposals for accreditation of non-governmental organizations:
- 8. Requests the secretariat of the Conference, after the final consideration by the Economic and Social Council of the list of the non-governmental organizations referred to in paragraphs 1 and 4, promptly to notify those organizations of the final determination made by the Council.

49/244. World Week of Peace

The General Assembly,

Cognizant of the fact that the promotion of peace and the prevention of war are among the primary goals of the United Nations.

Recognizing that the Preamble to the Charter of the United Nations states that the peoples of the United Nations are determined to save succeeding generations from the scourge of war, which twice in our lifetime has brought untold sorrow to mankind,

Recalling that the United Nations was established to prevent war and seek peace through peaceful means and through negotiation, as well as to promote international cooperation,

Recalling also its resolution 47/120 A of 18 December 1992, in which it welcomed the report of the Secretary-General entitled "An Agenda for Peace", 17 stressing the importance of preventive diplomacy and peace-keeping operations,

Recalling that 1995 has been proclaimed the United Nations Year for Tolerance, 18

Recognizing the important role that Disarmament Week, which will be observed concurrently with the World Week of Peace, is playing in promoting international peace and security,

Recognizing also that the United Nations is universal in nature and is the only instrument for global interdependence and cooperation that has the moral authority and the influence to promote and maintain world peace,

Recognizing further the importance of promoting the culture of peace,

Concerned that recent conflicts between States have brought with them deplorable ethnic strife, destruction and displacement of individuals and communities,

Deeply concerned at the large proportion of civilians, especially women and children, who have been injured or killed during the armed conflicts that have increased in recent years,

Recognizing that civil society organizations are now playing a more important role in promoting tolerance and understanding,

Convinced that a short period of peace resulting from a cease-fire or a truce can offer opportunities for building a just and lasting peace,

Noting with satisfaction the valuable initiative taken by the United Nations Children's Fund to facilitate "days of tranquillity" and "corridors of peace", which have been used to provide humanitarian relief, such as immunization, health care, food and clothing, to children trapped by armed conflicts.

- 1. Decides to proclaim the World Week of Peace, beginning on 24 October 1995, in solemn commemoration of the fiftieth anniversary of the United Nations;
- 2. Approves the Proclamation of the World Week of Peace, the text of which is annexed to the present resolution;
- 3. Invites all Member States to begin this task of cooperation with their own citizens and with civil society organizations, so as to give maximum publicity and assistance to the launching of the proclamation of a universal week of truce or cease-fire during the commemoration of the fiftieth anniversary of the United Nations;
- 4. Requests the Secretary-General to ensure the broadest possible dissemination of this resolution through the Department of Public Information of the Secretariat;
- 5. Also requests the Secretary-General to report on the implementation of the present resolution to the General Assembly at its fiftieth session.

Proclamation of the World Week of Peace

Whereas the General Assembly has decided unanimously to proclaim the World Week of Peace in commemoration of the fiftieth anniversary of the United Nations,

Whereas the promotion of peace and the prevention of war are among the primary goals of the United Nations,

Whereas, in welcoming "An Agenda for Peace", the United Nations

has rededicated itself to the effort to establish a universal peace according to the purposes and principles of the Charter of the United Nations, signed at San Francisco,

Whereas, in increasing the size and scope of its peace-keeping operations, the United Nations has demonstrated its commitment to the task of peace-keeping and peacemaking,

Whereas the World Week of Peace offers a special opportunity for Governments, civilian organizations, local communities and individuals to take part in new initiatives for the commendable goal of conflict resolution, cease-fires and truces, and for a period of universal peace that could be used for the humanitarian relief that has become so critically necessary,

Accordingly,

The General Assembly

Solemnly proclaims the World Week of Peace, beginning on 24 October 1995, to coincide with the commemoration of the fiftieth anniversary of the United Nations.

49/252. Strengthening of the United Nations system

The General Assembly,

Recognizing that the fiftieth anniversary of the United Nations is an occasion for re-examination and strengthening of the United Nations system, as the United Nations prepares for the challenges of the twenty-first century.

Determined to strengthen the role, capacity, effectiveness and efficiency of the United Nations system and thus improve its performance in order to realize the full potential of the Organization, in accordance with the principles and purposes of the Charter of the United Nations, and to respond more effectively to the needs and aspirations of the Member States,

Conscious of the importance of a viable financial basis and adequate and predictable resources for the effective functioning of the United Nations system,

Encouraged by the ongoing efforts to improve the administration, management and performance of the United Nations system,

Noting that important work is already proceeding in the Ad Hoc Open-ended Working Group on an Agenda for Development, the High-level Open-ended Working Group on the Financial Situation of the United Nations, the Open-ended Working Group on the Question of Equitable Representation on and Increase in the Membership of the Security Council, the Informal Open-ended Working Group on An Agenda for Peace and the Consultations on Prospective New Modalities for Financing Operational Activities for Development, all of which report to the General Assembly,

Noting also that the Secretary-General and a number of United Nations bodies, as well as independent commissions, institutions, scholars and other experts, have studied the United Nations system and recommended a variety of measures designed to revitalize, strengthen and reform the United Nations system,

- 1. Decides to establish an open-ended high-level working group of the General Assembly, under the chairmanship of the President of the General Assembly and with two vice-chairmen to be elected by the working group, and that the group may establish, as necessary, sub-groups open to the participation of all Member States;
- 2. Decides also that the working group will undertake a thorough review of the studies and reports of the relevant United Nations bodies and submissions of Member States and observers, as well as studies and reports of independent

commissions, non-governmental organizations, institutions, scholars and other experts, on subjects relating to the revitalization, strengthening and reform of the United Nations system, to be selected by the working group with the assistance of the Secretariat, and, without in any way duplicating or impeding the work of the other working groups referred to above, specify by consensus those ideas and proposals drawn therefrom that it concludes are appropriate for the purpose of revitalization, strengthening and reform of the United Nations system in fulfilment of the principles and purposes of the Charter of the United Nations;

3. Requests the bureau of the working group to maintain regular contacts with the bureaux of the working groups mentioned above;

- 4. Requests the working group to commence its substantive work during the fiftieth session of the General Assembly and submit a report on its work before the end of that session;
- 5. Requests the Secretary-General to provide, within existing resources, to be supplemented by a trust fund to which voluntary contributions could be solicited, full assistance to the working group, including the facilities and support services necessary for it to conduct its work;
- 6. Decides to include in the provisional agenda of its fiftieth session an item entitled "Strengthening of the United Nations system".

The General Assembly,

Having considered the report of the Secretary-General on the financing of the United Nations Observer Mission Uganda-Rwanda and the United Nations Assistance Mission for Rwanda² and the related report of the Advisory Committee on Administrative and Budgetary Questions,³

Recalling Security Council resolutions 846 (1993) of 22 June 1993 and 872 (1993) of 5 October 1993, by which the Council established, respectively, the United Nations Observer Mission Uganda-Rwanda and the United Nations Assistance Mission for Rwanda, as well as the subsequent resolutions by which the Council extended the mandate of the Assistance Mission, the most recent of which was resolution 997 (1995) of 9 June 1995,

Recalling also its resolution 48/245 of 5 April 1994 on the financing of the Observer Mission, its resolution 48/248 of 5 April 1994 and its decisions 48/479 A of 23 December 1993 and 48/479 B of 14 September 1994 on the financing of the Assistance Mission and its resolution 49/20 A of 29 November 1994 and its decision 49/481 of 6 April 1995 on the financing of the Observer Mission and the Assistance Mission,

Reaffirming that the costs of the Assistance Mission are expenses of the Organization to be borne by Member States in accordance with Article 17, paragraph 2, of the Charter of the United Nations,

Recalling its previous decisions regarding the fact that, in order to meet the expenditures caused by the Assistance Mission, a different procedure is required from that applied to meet expenditures of the regular budget of the United Nations,

Taking into account the fact that the economically more developed countries are in a position to make relatively larger contributions and that the economically less developed countries have a relatively limited capacity to contribute towards such an operation,

Bearing in mind the special responsibilities of the States permanent members of the Security Council, as indicated in General Assembly resolution 1874 (S-IV) of 27 June 1963, in the financing of such operations,

Mindful of the fact that it is essential to provide the Assistance Mission with the necessary financial resources to enable it to fulfil its responsibilities under the relevant resolutions of the Security Council,

- 1. Takes note of the status of contributions to the United Nations Assistance Mission for Rwanda as at 16 June 1995, including the contributions outstanding in the amount of 66,539,201 United States dollars, and urges all Member States concerned to make every possible effort to ensure the payment of their outstanding assessed contributions;
- 2. Expresses concern about the financial situation with regard to peace-keeping activities, particularly as regards

- the reimbursement of troop- and equipment-contributing countries, due to overdue payments by Member States of their assessments, particularly Member States in arrears;
- 3. Urges all Member States to make every possible effort to ensure payment of their assessed contributions to the Assistance Mission promptly and in full;
- 4. Endorses the observations and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions, subject to the provisions of the present resolution, and urges the Secretary-General to take the recommendations into account in the management of this operation and the formulation of future budget proposals;
- 5. Requests the Secretary-General to take all necessary action to ensure that the Assistance Mission is administered with a maximum of efficiency and economy;
- 6. Decides to appropriate to the Special Account for the United Nations Assistance Mission for Rwanda a total amount of 143,417,100 dollars gross (141,461,900 dollars net) for the operation of the Assistance Mission for the period from 10 December 1994 to 9 June 1995, inclusive of the commitment authority of 60 million dollars gross (58,542,300 dollars net) authorized under the provisions of General Assembly resolution 49/20 A and 80 million dollars gross (79,502,500 dollars net) authorized under the provisions of Assembly decision 49/481;
- 7. Decides also, as an ad hoc arrangement, to apportion the additional amount of 83,417,100 dollars gross (82,919,600 dollars net) for the period from 10 December 1994 to 9 June 1995, taking into account the amount of 30 million dollars gross (29,271,150 dollars net) already apportioned in accordance with resolution 49/20 A and 30 million dollars gross (29,271,150 dollars net) already apportioned in accordance with General Assembly decision 49/481 among Member States in accordance with the composition of groups set out in paragraphs 3 and 4 of Assembly resolution 43/232 of 1 March 1989, as adjusted by the Assembly in its resolutions 44/192 B of 21 December 1989, 45/269 of 27 August 1991, 46/198 A of 20 December 1991 and 47/218 A of 23 December 1992, and its decision 48/472 A of 23 December 1993, the scale of assessments for the year 19944 to be applied against a portion thereof, that is, 10,083,386 dollars gross (10,023,248 dollars net), which is the amount pertaining on a pro rata basis to the period ending 31 December 1994, and the scale of assessments for the year 19955 to be applied against the balance, that is, 73,333,714 dollars gross (72,896,352 dollars net), for the period from 1 January to 9 June 1995;
- 8. Decides further that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraph 7 above, their respective share in the Tax Equalization Fund of the estimated additional staff assessment income of 497,500 dollars approved for the period from 10 December 1994 to 9 June 1995, 60,138 dollars being the amount pertaining on a pro rata basis to the period ending 31 December 1994, and the balance, that is, 437,362 dollars, for the period from 1 January to 9 June 1995;
- 9. Decides, as an interim measure, pending presentation of the revised cost estimate by the Secretary-General

and the report of the Advisory Committee thereon, to appropriate to the Special Account for the United Nations Assistance Mission for Rwanda a total amount of 109,951,900 dollars gross (107,584,300 dollars net) for the operation of the Assistance Mission for the period from 10 June to 31 December 1995;

- 10. Decides also, as an ad hoc arrangement, to apportion the amount of 99,628,200 dollars gross (97,508,000 dollars net) for the maintenance of the Assistance Mission for the period from 10 June to 8 December 1995 in accordance with the scheme set out in the present resolution;
- 11. Decides further that, in accordance with the provisions of resolution 973 (X), there shall be set off against the apportionment among Member States, as provided for in paragraph 10 above, their respective share in the Tax Equalization Fund of the estimated staff assessment income of 2,120,200 dollars approved for the period from 10 June to 8 December 1995;
- 12. Decides that there shall be set off against the apportionment among Member States, as provided for in paragraph 10 above, their respective share in the unencumbered balance for the period from 5 April to 9 December 1994, the exact amount to be determined by the Advisory Committee no later than 14 July 1995;

The General Assembly,

Having considered the relevant reports on human resources management submitted by the Secretary-General during the resumed forty-ninth session of the General Assembly,7

Noting with concern the conference room paper on the practice of using retirees in the United Nations Secretariat,

1. Reiterates its support for the Secretary-General towards the development of a management environment and culture in the Organization that is supportive of having

staff members perform to their maximum potential, effectiveness and efficiency;

- 2. Takes note with appreciation of the statement on the status of women in the secretariats of the United Nations system adopted by the Administrative Committee on Coordination at its first regular session of 1995, and requests members of the Committee to report on the implementation of the proposals contained therein;
- 3. Requests the Secretary-General to develop a comprehensive policy on the use of retirees that includes appropriate internal controls to ensure that the compensation received by those retirees does not exceed the existing cap on those payments and to report thereon to the General Assembly at its fifty-first session;
- 4. Also requests the Secretary-General to ensure that the policy will be consistent with the Regulations of the United Nations Joint Staff Pension Fund;
- 5. Decides that, pending consideration of the policy on the use of retirees during the fifty-first session of the General Assembly, no former staff member who is in receipt of a pension benefit from the United Nations Joint Staff Pension Fund shall receive from any United Nations funds more than 12,000 United States dollars in total in any calendar year;
- 6. Authorizes on an exceptional basis during the fiftieth session a derogation from the decision in paragraph 5 above with a view to maintaining the maximum effectiveness of conference services.

The General Assembly,

Having considered the report of the Secretary-General on the financing of the United Nations Angola Verification Mission⁹ and the related report of the Advisory Committee on Administrative and Budgetary Questions, 10

- 12. Taking into account the fact that the economically more developed countries are in a position to make relatively larger contributions and that the economically less developed countries have a relatively limited capacity to contribute towards such an operation,

Bearing in mind the special responsibilities of the States permanent members of the Security Council, as indicated in General Assembly resolution 1874 (S-IV) of 27 June 1963 in the financing of such operations,

amount of 3,251,200 United States dollars gross (3,123,600 dollars net) for the operation of the Mission of Observers from 16 December 1994 to 26 April 1995, inclusive of the amount of 1,759,700 dollars gross (1,711,800 dollars net) authorized under the terms of paragraph 1 (a) of General Assembly resolution 48/229 of 23 December 1993 on unforeseen and extraordinary expenses for the biennium 1994-1995 and the amount of 651,600 dollars gross (611,600 dollars net) authorized with the concurrence of the Advisory Committee under the terms of section IV, paragraph 2, of Assembly resolution 49/233 A of 23 December 1994;

- Decides also, as an ad hoc arrangement, to apportion the amount of 3,251,200 dollars gross (3,123,600 dollars net) for the period from 16 December 1994 to 26 April 1995 among Member States in accordance with the composition of groups set out in paragraphs 3 and 4 of General Assembly resolution 43/232 of 1 March 1989, as adjusted by the Assembly in its resolutions 44/192 B of 21 December 1989, 45/269 of 27 August 1991, 46/198 A of 20 December 1991 and 47/218 A of 23 December 1992 and its decision 48/472 A of 23 December 1993, the scale of assessments for the year 19944 to be applied against a portion thereof, that is, 394,100 dollars gross (378,600 dollars net), which is the amount pertaining on a pro rata basis to the period ending 31 December 1994, and the scale of assessments for the year 1995⁵ to be applied against the balance, that is, 2,857,100 dollars gross (2,745,000 dollars net), for the period from 1 January to 26 April 1995, inclusive;

Invites voluntary contributions to the Mission of Observers in cash and in the form of services and supplies acceptable to the Secretary-General, to be administered, as appropriate, in accordance with the procedure established by the General Assembly in its resolutions 43/230 of 21 December 1988, 44/192 A of 21 December 1989 and 45/258 of 3 May 1991;

49/241. Payment of repatriation grant to staff members living in their home country while stationed at duty stations located in another country

The General Assembly,

Having considered the report of the Secretary-General on payment of repatriation grant to staff members living in their home country while stationed at duty stations located in another country,³⁹

Recalling section II.D of its resolution 48/224 of 23 December 1993 on the United Nations common system, in which it requested the International Civil Service Commission to study further the practices of the organizations of the United Nations common system regarding the granting of expatriate entitlements to staff members living in their home country while stationed at duty stations located in another country, with a view to harmonizing the practices of the organizations with those of the United Nations, and to make recommendations thereon to the General Assembly at its fifty-first session,

Noting the decision of the United Nations Administrative Tribunal in Judgement No. 656, Kremer, Gourdon,

- 1. Reiterates its decision that the repatriation grant and other expatriate benefits are limited to staff who both work and reside in a country other than their home country;
- 2. Approves the amendments to the Staff Regulations of the United Nations contained in the annex to the present resolution:

Amendments to the Staff Regulations of the United Nations

Article III

Salaries and related allowances

Replace the first sentence of regulation 3.2 (a) with the following text:

"Regulation 3.2: (a) The Secretary-General shall establish terms and conditions under which an education grant shall be available to a staff member residing and serving outside his or her recognized home country whose dependent child is in full-time attendance at a school, university or similar educational institution of a type that will, in the opinion of the Secretary-General, facilitate the child's reassimilation in the staff member's recognized home country."

Article V

Annual and special leave

Replace regulation 5.3 with the following text:

"Regulation 5.3: Eligible staff members shall be granted home leave once in every two years. However, in the case of designated duty stations having very difficult conditions of life and work, eligible staff members shall be granted home leave once in every twelve months. A staff member whose home country is either the country of his or her official duty station or the country of his or

her normal residence while in United Nations service, shall not be eligible for home leave."

Annex IV to the Staff Regulations

Repatriation grant

Replace the paragraph with the following text:

"In principle, the repatriation grant shall be payable to staff members whom the Organization is obligated to repatriate and who at the time of separation are residing, by virtue of their service with the United Nations, outside their country of nationality. The repatriation grant shall not, however, be paid to a staff member who is summarily dismissed. Eligible staff members shall be entitled to a repatriation grant only upon relocation outside the country of the duty station. Detailed conditions and definitions relating to eligibility and requisite evidence of relocation shall be determined by the Secretary-General."

Affirming that the International Tribunal must be assured of secure and stable financing so that it may fulfil its role in full and effectively,

Having considered the report of the Secretary-General on the financing of the International Tribunal⁴⁰ and the related report of the Advisory Committee on Administrative and Budgetary Questions,⁴¹

- 1. Endorses the observations and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions, subject to the provisions of the present resolution;
- 2. Decides, subject to the completion of the reclassification process, to approve the three posts of senior investigators to undertake substantive high-level investigations and to oversee the nine investigation teams in the Office of the Prosecutor, pending a further review of the question by the Advisory Committee in the context of estimates for the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 for the biennium 1996-1997;
- 3. Requests the Secretary-General to review the staffing requirements of the electronic support services and communications in the Registry to ensure that its organizational structure is commensurate with the tasks to be performed;
- 4. Reaffirms that questions related to the rules of procedure and evidence of the International Tribunal are matters to be decided by the International Tribunal;
- 5. Requests the Secretary-General to provide, in the context of the next budget presentation for the International Tribunal, additional information on the costs of ensuring free legal assistance, as outlined in paragraph 30 of the report of the Advisory Committee;
- 6. Also requests the Secretary-General to include in the context of the next budget presentation for the International Tribunal information and/or proposals for the longterm requirements for the carrying out of sentences and for the protection of witnesses;
- 7. Requests the International Tribunal and the International Court of Justice to continue negotiations on common administrative arrangements with the aim of obtaining economies of administrative services;
- 8. Requests the International Tribunal to establish guidelines to govern recourse to and use of expertise in the Chambers;
- 9. Notes that the estimated requirements for payment to the host Government for detention facilities for the accused reflect actual fixed and estimated variable costs in the biennium 1994-1995;
- 10. Emphasizes the importance of ensuring that recruitment for the International Tribunal is implemented strictly in accordance with the Staff Regulations and Rules of the United Nations, taking account of Articles 8, 100 and 101 of the Charter of the United Nations, and that, in recruiting consultants and experts, the International Tribunal should avail itself of sources of expertise on as wide a geographical basis as possible;
 - 11. Expresses its appreciation to the Governments

and others that have provided voluntary contributions to the International Tribunal;

- 12. Invites Member States and others to make further voluntary contributions to the International Tribunal that are acceptable to the Secretary-General;
- 13. Requests the Secretary-General to issue specific guidelines on the requirements for receipt of contributions and application of funds for the International Tribunal;
- 14. Also requests the Secretary-General to include in future budget presentations for the International Tribunal information on voluntary contributions in cash and in kind and to indicate where they are assigned;
- 15. Reaffirms that the acceptance of voluntary contributions in kind or in personnel, as well as voluntary financial contributions, must be consistent with the need to ensure the impartiality and independence of the International Tribunal at all times and that such contributions should be considered supplementary to the assessed contributions;
- 16. Requests the Secretary-General to include detailed information in his next report on the International Tribunal on the acceptance and use of voluntary contributions, particularly those in kind or in personnel, pursuant to paragraph 15 above;
- 17. Reaffirms the role of the General Assembly, as set out in Article 17 of the Charter, as the organ to consider and approve the budget of the Organization and the apportionment of its expenses among Member States;
- 18. Again expresses its concern that advice given to the Security Council by the Secretariat on the nature of the financing of the International Tribunal did not respect the role of the General Assembly as set out in Article 17 of the Charter;
- 19. Reaffirms that the expenses of the International Tribunal shall be met through additional resources on the basis of assessed contributions and that they shall be financed through a separate special account outside the regular budget;
- 20. Decides to appropriate to the special account for the International Tribunal referred to in General Assembly resolution 47/235 a total amount of 43,991,600 dollars gross (39,095,900 dollars net) for the period from 1 January 1994 to 31 December 1995, inclusive of the commitment authority of 26,175,000 dollars authorized under the provisions of Assembly resolutions 48/251 of 14 April 1994 and 49/242 A of 13 April 1995 and Assembly decisions 49/471 A and B of 23 December 1994 and 6 April 1995, respectively, and the amount of 276,200 dollars expended in 1993:

- 22. Decides further to apportion the amount of 21,995,800 dollars gross (19,547,950 dollars net) for the period from 1 January 1994 to 31 December 1995 among Member States in accordance with the scale of assessments for the year 19944 to be applied against a portion thereof,

- 26. Requests the Secretary-General to submit a performance report at the end of each biennium but no later than May 1996 and May 1998 respectively;
- 27. Decides to review the mode of financing of the International Tribunal at its fifty-second session;

- 2. Expresses its continued appreciation for the decision of the Government of Kuwait to defray two thirds of the cost of the Observation Mission, effective 1 November 1993:
- 3. Endorses the observations and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions;
- 4. Requests the Secretary-General to take all necessary action to ensure that the Observation Mission is administered with a maximum of efficiency and economy;
- 5. Urges all Member States to make every possible effort to ensure payment of their assessed contributions to the Observation Mission promptly and in full;
- 6. Approves the amount of 33 million dollars gross (31,876,800 dollars net) for the maintenance of the Observation Mission for the period from 1 May to 31 October 1994, two thirds of this amount, equivalent to 21,251,200 dollars, to be funded from voluntary contributions from the Government of Kuwait;

- 10. Also decides, as an ad hoc arrangement, to apportion the amount of 4,806,600 dollars gross (4,426,000 dollars net) among Member States for the period from 1 to 30 June 1995 in accordance with the scheme set out in the present resolution;

The General Assembly,

Taking note of the reports of the Secretary-General on the financing of the United Nations Protection Force⁴⁸ and the related reports of the Advisory Committee on Administrative and Budgetary Questions,⁴⁹ pending a detailed consideration of these reports at the fiftieth session of the General Assembly,

Recalling Security Council resolutions 727 (1992) of 8 January 1992 and 740 (1992) of 7 February 1992, in which the Council endorsed the sending of a group of military liaison officers to Yugoslavia to promote maintenance of the cease-fire,

Recalling also Security Council resolution 743 (1992) of 21 February 1992, by which the Council established the Force, and the subsequent resolutions by which the Council extended its mandate,

Recalling further Security Council resolution 981 (1995) of 31 March 1995, by which the Council established the United Nations Confidence-Restoration Operation in Croatia, which is known as UNCRO, for a period terminating on 30 November 1995,

Recalling Security Council resolution 982 (1995) of 31 March 1995, by which the Council extended the mandate of the United Nations Protection Force in Bosnia and Herzegovina for an additional period terminating on 30 November 1995,

Recalling also Security Council resolution 983 (1995) of 31 March 1995, by which the Council decided that the United Nations Protection Force within the former Yugo-

slav Republic of Macedonia should be known as the United Nations Preventive Deployment Force and that its mandate would continue for a period terminating on 30 November 1995.

Recalling further all the Security Council resolutions providing for an increase in the authorized strength of the United Nations Protection Force, of which the latest is resolution 998 (1995) of 16 June 1995, which authorized an increase in United Nations Peace Forces/United Nations Protection Force personnel by up to 12,500 additional troops to provide the Force with a rapid reaction capacity,

Recalling its resolution 46/233 of 19 March 1992 on the financing of the Force and its subsequent resolutions and decisions thereon, the latest of which was resolution 49/228 of 23 December 1994,

Reaffirming that the costs of the Force are expenses of the Organization to be borne by Member States in accordance with Article 17, paragraph 2, of the Charter of the United Nations,

Recalling its previous decisions regarding the fact that, in order to meet the expenditures caused by the Force, a different procedure is required from the one applied to meet expenditures of the regular budget of the United Nations,

Taking into account the fact that the economically more developed countries are in a position to make relatively larger contributions and that the economically less developed countries have a relatively limited capacity to contribute to such an operation,

Bearing in mind the special responsibilities of the States permanent members of the Security Council, as indicated in General Assembly resolution 1874 (S-IV) of 27 June 1963, in the financing of such operations,

Noting with appreciation that voluntary contributions have been made to the Force by certain Governments,

Mindful of the fact that it is essential to provide the Force with the necessary financial resources to enable it to fulfil its responsibilities under the relevant resolutions of the Security Council,

- 1. Takes note of the status of contributions to the United Nations Protection Force as at 10 July 1995, including the contributions unpaid in the amount of 862.2 million United States dollars, representing 22.5 per cent of the total assessed contributions from the inception of the Force to the period ending 30 June 1995, notes that some 16 per cent of the membership has paid its assessed contributions in full, and urges all other Member States concerned, particularly those in arrears, to ensure the payment of their outstanding assessed contributions;
- 2. Expresses concern about the financial situation with regard to peace-keeping activities, particularly as regards the reimbursement of troop contributors, which is due to overdue payments by Member States of their assessments;
- 3. Urges all Member States to make every possible effort to ensure the payment of their assessed contributions to the Force promptly and in full;
- 4. Endorses the observations and recommendations contained in the reports of the Advisory Committee on Administrative and Budgetary Questions;
- 5. Requests the Secretary-General to take all necessary action to ensure that the Force is administered with a maximum of efficiency and economy;

- 6. Decides to utilize the special account established by its resolution 46/233 for the recording of income and expenditures relating to the United Nations Protection Force, the United Nations Confidence-Restoration Operation in Croatia, the United Nations Preventive Deployment Force and the United Nations Peace Forces headquarters;
- 7. Also decides to appropriate to the special account referred to in paragraph 6 above the amount of 404,194,500 dollars gross (401,106,600 dollars net) for the period from 1 April to 30 June 1995, authorized and apportioned under the terms of its resolution 49/228;
- 8. Further decides to appropriate to the special account a total amount of 673,657,500 dollars gross (668,511,000 dollars net) for the operation of the Force for the period from 1 July to 30 November 1995;
- 9. Decides, as an ad hoc arrangement, to apportion the amount of 673,657,500 dollars gross (668,511,000 dollars net) for the period from 1 July to 30 November 1995 among Member States in accordance with the composition of groups set out in paragraphs 3 and 4 of General Assembly resolution 43/232 of 1 March 1989, as adjusted by the Assembly in its resolutions 44/192 B of 21 December 1989, 45/269 of 27 August 1991, 46/198 A of 20 December 1991 and 47/218 A of 23 December 1992 and its decision 48/472 A of 23 December 1993, and taking into account the scale of assessments for the year 1995 as set out in Assembly resolution 49/19 B of 23 December 1994;
- 10. Also decides that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraph 9 above, their respective share in the Tax Equalization Fund of the estimated staff assessment income of 5,146,500 dollars approved for the Force for the period from 1 July to 30 November 1995, inclusive;
- 11. Takes note of the fact that the Secretary-General has estimated that an overall level of resources for the reinforcement of the Force with a rapid reaction capacity, not to exceed 297,112,600 dollars gross (275,290,800 dollars net), will be required for the period from 1 July to 31 December 1995 and that the General Assembly will carry out a detailed consideration of all reports of the Secretary-General⁴⁸ at its fiftieth session;
- 12. Decides, in the context of section IV, paragraph 3, of its resolution 49/233 A of 23 December 1994, to authorize the Secretary-General to enter into commitments for the reinforcement of the Force with a rapid reaction capacity, up to the amount of 100 million dollars gross (99,569,800 dollars net) for the period from 1 July to 30 November 1995;
- 13. Also decides, as an ad hoc arrangement, to apportion the amount of 100 million dollars gross (99,569,800 dollars net) for the period from 1 July to 30 November 1995 among Member States in accordance with the composition of groups set out in paragraphs 3 and 4 of resolution 43/232, as adjusted by the General Assembly in its resolutions 44/192 B, 45/269, 46/198 A and 47/218 A and its decision 48/472 A, and taking into account the scale of assessments for the year 1995 as set out in Assembly resolution 49/19 B;
- 14. Further decides that, in accordance with the provisions of resolution 973 (X), there shall be set off against the apportionment among Member States, as provided for in paragraph 13 above, their respective share in the Tax

- Equalization Fund of the estimated staff assessment income of 430,200 dollars approved for the Force for the period from 1 July to 30 November 1995, inclusive;
- 15. Takes note of the decision of the Secretary-General to establish a sub-account of the Special Account for the United Nations Protection Force for the purposes described in paragraph 15 (c) of document A/49/540/Add.4;
- 16. Invites voluntary contributions to the sub-account of the Special Account for the United Nations Protection Force in cash and in the form of services and supplies acceptable to the Secretary-General, to be administered in accordance with the Financial Regulations and Rules of the United Nations;
- 17. Decides to defer consideration of the treatment of the unencumbered balances arising in respect of the period from 1 July 1993 to 30 September 1994 until it has an opportunity at its fiftieth session to examine fully the reports contained in documents A/49/540/Add.2 and A/49/540/Add.3 and any update of document A/49/540/Add.3 and the related reports of the Advisory Committee;
- 18. Invites voluntary contributions to the Force in cash and in the form of services and supplies acceptable to the Secretary-General, to be administered, as appropriate, in accordance with the procedure established by the General Assembly in its resolutions 43/230 of 21 December 1988, 44/192 A of 21 December 1989 and 45/258 of 3 May 1991;
- 19. Decides to include in the provisional agenda of its fiftieth session an item entitled "Financing of the United Nations Protection Force, the United Nations Confidence-Restoration Operation in Croatia, the United Nations Preventive Deployment Force and the United Nations Peace Forces headquarters".

The General Assembly,

Recalling its resolution 3101 (XXVIII) of 11 December 1973 and its subsequent resolutions relating to the composition of the existing groups, the latest of which is resolution 47/218 A of 23 December 1992, and its decision 48/472 A of 23 December 1993,

Having received the request of Belarus for reclassification from group B to group C,

- 1. Welcomes with great satisfaction the voluntary decision made by the Government of Portugal to reclassify Portugal from group C to group B;
- 2. Decides, as an ad hoc arrangement, to note the voluntary decision made by the Government of Portugal and to place Portugal among the Member States referred to in paragraph 3 (b) of its resolution 43/232 of 1 March 1989 and, in accordance with that decision, to apportion its share of the costs of peace-keeping operations financed through assessed contributions on the basis of the proportion determined by the scale of assessments in the following manner: 35 per cent beginning 1 July 1995, 50 per cent in 1996, 70 per cent in 1997, 85 per cent in 1998 and 100 per cent in 1999 and subsequent years;

3. Also decides to consider the request of Belarus for reclassification from group B to group C at its resumed forty-ninth session and to take action thereon no later than at its fiftieth session.

Decides, as a special ad hoc arrangement, to place Belarus among the Member States referred to in paragraph 3 (c) of General Assembly resolution 43/232 of 1 March 1989, on the understanding that the reduction in the United States dollar amounts to be assessed on Belarus beginning 1 July 1995 shall be equal to the additional United States dollar amounts assessed on Portugal in accordance with Assembly resolution 49/249 A, on the basis that this decision will be adjusted as appropriate to conform with any future relevant decisions adopted by the Assembly;
- 2. Takes note of the stated intention of Belarus concerning the treatment of its arrears.

The General Assembly,

Recalling its resolutions 45/258 of 3 May 1991, 47/218 A of 23 December 1992, 48/226 A, B and C of 23 December 1993 and 5 April and 29 July 1994, respectively, and decisions 48/489 of 8 July 1994 and 49/469 of 23 December 1994,

Having considered the reports of the Secretary-General on the support account for peace-keeping operations⁵¹ and the related reports of the Advisory Committee on Administrative and Budgetary Questions,⁵²

Reaffirming the need to continue to improve the admin-

istrative and financial management of peace-keeping operations,

- 1. Endorses the observations and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions,⁵³ subject to the provisions of the present resolution;
- 2. Decides that support account funds shall be used for the sole purpose of financing human and non-human resource requirements for backstopping and supporting peace-keeping operations at Headquarters, and that any change to this limitation will require the prior approval of the General Assembly;
- 3. Decides also to maintain the current methodology of financing the support account at the rate of 8.5 per cent of the estimated cost of the civilian staff component of each peace-keeping operation, on the understanding that this percentage shall be reviewed annually and for the first time no later than the spring of 1996, taking into account the report to be submitted by the Board of Auditors;
- 4. Affirms that upon the approval of a peace-keeping budget the amounts thus approved with regard to the support account are funds appropriated and therefore available to the Secretary-General, subject to specific use and purpose as specified by the General Assembly;
- 5. Also affirms that the level of resources is clearly a function of the income in the support account and that, therefore, it is the responsibility of the Secretary-General to ensure that, at any one time, the level of income to the support account is not exceeded;
- 6. Decides that once a year, for its consideration and approval, the Secretary-General shall submit to the General Assembly, through the Advisory Committee, a report on the use of the resources in the support account during the past calendar year and on the proposed expenditure for the following twelve-month period beginning 1 July, specifying the proposed establishment of posts and the projected expenditure for non-post requirements by category of expenditure, including, for the former, the grade structure in tabular form;
- 7. Decides also, taking into account the above-mentioned responsibility of the Secretary-General to ensure that expenditure remains within the level of income, to authorize the Secretary-General to redeploy and discontinue posts, according to functional requirements, and requests him to report thereon every six months to the General Assembly for information purposes;
- 8. Decides further that posts funded from the support account shall be filled and managed in compliance with the Charter of the United Nations, the Financial Regulations and Rules of the United Nations, the Staff Regulations and Rules of the United Nations and relevant General Assembly resolutions, including, where appropriate, the classification and advertisement of posts approved for more than ninety days;
- 9. Requests the Board of Auditors to report on an interim basis to the General Assembly by 31 October 1995 on the management of the support account, including, interalia, the appropriateness of the funding level in view of actual experience, taking into account actions taken by relevant intergovernmental bodies, consistency in the use of human resources for purposes authorized by the Assem-

bly and confirmation that contractual arrangements for the employment of personnel are consistent with the temporary nature of the posts;

- Welcomes the contribution by Member States, on a non-reimbursable basis, of personnel to fill backstopping positions within the Department of Peace-keeping Operations, and reiterates its request to the Secretary-General contained in paragraph 7 of its resolution 48/226 C;
- 11. Authorizes, for the period from 1 July 1995, the continuation of the 346 posts previously authorized, and notes the redeployment of 10 posts (5 Professional and 5 General Service) from the Finance Management and Support Service of the Field Administration and Logistics Division, Department of Peace-keeping Operations, to the Accounts Division (3 Professional and 2 General Service) and the Peace-keeping Financing Division (2 Professional and 3 General Service), Department of Administration and Management;
- 12. Also authorizes, on an exceptional basis, for the period from 1 July 1995 to 31 January 1996, the conversion of the 61 positions under general temporary assistance to temporary posts exclusively for the purposes proposed by the Secretary-General in his report,⁵⁴ including, inter alia, staffing of the Civilian Police Unit, on the understanding that the contracts for the staff encumbering these posts will terminate on 31 January 1996 unless the General Assembly decides otherwise;
- 13. Decides that further consideration of these staffing requirements will be subject to review during the autumn part of its fiftieth session, based on additional information provided by the Secretary-General through established procedures on, inter alia, the 61 posts cited in paragraph 12 above (to include, inter alia, an organizational chart reflecting current number, grade and function of posts), and the report by the Board of Auditors requested in paragraph 3 above;
- 14. Authorizes the resources for general temporary assistance, including the position of Special Adviser to the Secretary-General (319,600 United States dollars), overtime (157,500 dollars), travel on official business (90,000 dollars), training (372,500 dollars) and common services (4,028,200 dollars) for the period from 1 April to 31 December 1995.

Financing of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994

The General Assembly,

Having considered Security Council resolution 955 (1994) of 8 November 1994, on the establishment of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994, in which the Council adopted the statute of the International Tribunal for Rwanda.

Having also considered Security Council resolution 977 (1995) of 22 February 1995, in which the Council decided that, subject to the conclusion of appropriate arrangements between the United Nations and the Government of the United Republic of Tanzania, the International Tribunal for Rwanda should have its seat at Arusha.

Having further considered the report of the Secretary-General on the financing of the International Tribunal for Rwanda⁵⁵ and the related observations and recommendations thereon presented by the Chairman of the Advisory Committee on Administrative and Budgetary Questions, 56

Taking into account the views expressed by Member States in the Fifth Committee of the General Assembly,⁵⁷

- 1. Endorses the observations and recommendations of the Advisory Committee on Administrative and Budgetary Questions as presented by its Chairman, subject to the provisions of the present resolution;
- 2. Emphasizes the importance of assuring secure and stable financing of the International Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Reponsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994 so that it may fulfil its role in full and effectively;
- 3. Decides that the expenses of the International Tribunal for Rwanda shall be met through additional resources on the basis of assessed contributions and that they shall be financed through a separate special account outside the regular budget;
- 4. Decides also to appropriate to the Special Account for the International Tribunal for Rwanda a total amount of 13,467,300 United States dollars gross (12,914,900 dollars net) for the period to 31 October 1995, inclusive of the commitment authority of 2,914,900 dollars authorized by the Advisory Committee;
- 5. Decides further, as an ad hoc and exceptional arrangement, that, notwithstanding the provisions of paragraph 12 of its resolution 49/20 B of 12 July 1995, Member States will waive their respective shares in the credits arising from previous budgets of the United Nations Assistance Mission for Rwanda in the total amount of 6,733,650 dollars gross (6,457,450 dollars net) and hence accept an equivalent increase in the assessments for a future budget period of the Assistance Mission in the same amount, to be transferred to the Special Account for the International Tribunal for Rwanda from the Special Account established for the United Nations Assistance Mission for Rwanda;
- 6. Decides to apportion the amount of 6,733,650 dollars gross (6,457,450 dollars net) for the period to 31 October 1995 among Member States in accordance with the scale of assessments for the year 1995 as set out in its resolution 49/19 B of 23 December 1994;

- 7. Decides also that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraph 6 above, their respective share in the Tax Equalization Fund of the estimated staff assessment income of 552,400 dollars approved for the International Tribunal for Rwanda for the period to 31 October 1995;
- 8. Decides further that appropriations for 1 November to 31 December 1995 and for the biennium 1996-1997 under the special account referred to in paragraph 3 above, the amount of which shall be determined during its fiftieth session, shall be financed equally through the modes of financing referred to in paragraphs 5 and 6 above, again notwithstanding the provisions of paragraph 12 of resolution 49/20 B;
- 9. Decides to consider the report of the Secretary-General further at its fiftieth session, together with updated information on the establishment of the International Tribunal for Rwanda and related requirements;
- 10. Requests the Secretary-General to submit to the General Assembly at its fiftieth session a report on requirements for the International Tribunal for Rwanda in the biennium 1996-1997;
- 11. Authorizes the Secretary-General to make the necessary arrangements, including the signing of a lease agreement and construction contracts for the premises of

- the International Tribunal for Rwanda and granting of contracts of up to twelve months for its staff, to ensure that it is provided with adequate facilities and necessary staff resources, and to report to the General Assembly thereon;
- 12. Welcomes contributions already made to the Voluntary Fund to support the activities of the International Tribunal for Rwanda established by Security Council resolution 955 (1994) and invites Member States and other interested parties to make voluntary contributions to the International Tribunal both in cash and in the form of services and supplies acceptable to the Secretary-General;
- 13. Decides to review the mode of financing of the International Tribunal for Rwanda at its fifty-second session;
- 14. Requests the Secretary-General to submit a performance report at the end of each biennium but no later than May 1996 and May 1998, respectively:
- 15. Decides to include in the provisional agenda of its fiftieth session the item entitled "Financing of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994".

At its 106th plenary meeting, on 20 July 1995, the General Assembly, on the recommendation of the Fifth Committee,77 decided to defer until its fiftieth session consideration of the report of the Secretary-General entitled "Reform of the internal system of justice in the United Nations Secretariat"78 and the note by the Secretary-General on the question, ⁷⁹ in the light of the recommenda-tions and observations of the Advisory Committee on Administrative and Budgetary Questions thereon.

49/492. Financing and liquidation of the United Nations Transitional Authority in Cambodia

At its 106th plenary meeting, on 20 July 1995, the General Assembly, on the recommendation of the Fifth Committee:80

- (a) Decided to defer until its fiftieth session consideration of the item entitled "Financing and liquidation of the United Nations Transitional Authority in Cambodia";
- (b) Reiterated its request to the Secretary-General, contained in paragraph 11 of its resolution 48/255 of 26 May 1994, to provide to the General Assembly a comprehensive evaluation of all aspects of the administration and manage-
