CONCLUSION OF EFFECTIVE INTERNATIONAL ARRANGEMENTS TO ASSURE NON-NUCLEAR-WEAPON STATES AGAINST THE USE OR THREAT OF USE OF NUCLEAR WEAPONS

Report of the First Committee

I. INTRODUCTION

- 1. The item entitled "Conclusion of effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons" was included in the provisional agenda of the forty-ninth session in accordance with General Assembly resolution 48/73 of 16 December 1993.
- 2. At its 3rd plenary meeting, on 23 September 1994, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.
- 3. At its 2nd meeting, on 13 October, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely, items 53 to 66, 68 to 72 and 153. The deliberations on those items took place at the 3rd to 10th meetings, from 17 to 24 October (see A/C.1/49/PV.3-10). Structured discussions of specific subjects on the adopted thematic approach took place from 25 to 27 and on 31 October and 1 November. Consideration of draft resolutions on those items took place at the 12th to 16th meetings, on 3, 4, 7 and 9 November. Action on draft resolution on those items took place at the 19th to 25th meetings, from 14 to 18 November (see A/C.1/49/PV.19-25).
- 4. In connection with item 60, the First Committee had before it the following documents:

- (a) Report of the Conference on Disarmament; 1/2
- (b) Letter dated 25 June 1994 from the Minister for Foreign Affairs of Egypt to the Secretary-General transmitting the texts of the documents adopted by the Eleventh Ministerial Conference of the Movement of Non-Aligned Countries, held at Cairo from 31 May to 3 June 1994 (A/49/287-S/1994/894) and Corr.1).

II. CONSIDERATION OF DRAFT RESOLUTION A/C.1/49/L.41

- 5. On 3 November, <u>Bangladesh</u>, <u>Colombia</u>, <u>Costa Rica</u>, the <u>Democratic People's</u> Republic of Korea, Iran (Islamic Republic of), <u>Madagascar</u>, <u>Myanmar</u>, <u>Nepal</u>, <u>Pakistan</u>, <u>Sri Lanka</u>, the <u>Sudan</u> and <u>Viet Nam</u> submitted a draft resolution entitled "Conclusion of effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons" (A/C.1/49/L.41), which was later also sponsored by <u>Turkmenistan</u>. The draft resolution was introduced by the representative of Pakistan at the 21st meeting, on 16 November.
- 6. At its 21st meeting, the Committee adopted draft resolution A/C.1/49/L.41 by a recorded vote of 142 to none, with 3 abstentions (see para. 7). The voting was as follows: $\underline{2}/$

III. RECOMMENDATION OF THE FIRST COMMITTEE

7. The First Committee recommends to the General Assembly the adoption of the following draft resolution:

Conclusion of effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons

The General Assembly,

Bearing in mind the need to allay the legitimate concern of the States of the world with regard to ensuring lasting security for their peoples,

<u>Convinced</u> that nuclear weapons pose the greatest threat to mankind and to the survival of civilization,

 ${\underline{\tt Welcoming}}$ the progress achieved in recent years in both nuclear and conventional disarmament,

<u>Noting</u> that, despite recent progress in the field of nuclear disarmament, further efforts are necessary towards the achievement of the goal of general and complete disarmament under effective international control,

<u>Convinced</u> that nuclear disarmament and the complete elimination of nuclear weapons are essential to remove the danger of nuclear war,

 $\underline{\text{Determined}}$ to abide strictly by the relevant provisions of the Charter of the United Nations on the non-use of force or threat of force,

Recognizing that the independence, territorial integrity and sovereignty of non-nuclear-weapon States need to be safeguarded against the use or threat of use of force, including the use or threat of use of nuclear weapons,

<u>Considering</u> that, until nuclear disarmament is achieved on a universal basis, it is imperative for the international community to develop effective

measures and arrangements to ensure the security of non-nuclear-weapon States against the use or threat of use of nuclear weapons from any quarter,

Recognizing that effective measures and arrangements to assure the non-nuclear-weapon States against the use or threat of use of nuclear weapons can contribute positively to the prevention of the spread of nuclear weapons,

Bearing in mind paragraph 59 of the Final Document of the Tenth Special Session of the General Assembly, $\underline{3}$ / the first special session devoted to disarmament, in which it urged the nuclear-weapon States to pursue efforts to conclude, as appropriate, effective arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons, and desirous of promoting the implementation of the relevant provisions of the Final Document,

Recalling the relevant parts of the special report of the Committee on Disarmament, $\underline{4}$ / submitted to the General Assembly at its twelfth special session, $\underline{5}$ / the second special session devoted to disarmament, and of the special report of the Conference on Disarmament submitted to the Assembly at its fifteenth special session, $\underline{6}$ / the third special session devoted to disarmament, as well as of the report of the Conference on its 1992 session, $\underline{7}$ /

Recalling also paragraph 12 of the Declaration of the 1980s as the Second Disarmament Decade, contained in the annex to its resolution 35/46 of 3 December 1980, which states, <u>inter alia</u>, that all efforts should be exerted by the Committee on Disarmament $\underline{4}$ / urgently to negotiate with a view to reaching agreement on effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons,

Noting the in-depth negotiations undertaken in the Conference on Disarmament and its Ad Hoc Committee on Effective International Arrangements to Assure Non-Nuclear-Weapon States against the Use or Threat of Use of Nuclear Weapons, 8/ with a view to reaching agreement on this item,

<u>Taking note</u> of the proposals submitted under that item in the Conference on Disarmament, including the drafts of an international convention,

Taking note also of the decision of the Tenth Conference of Heads of State or Government of Non-Aligned Countries, held at Jakarta from 1 to 6 September 1992, $\underline{9}$ / as well as the relevant recommendations of the Organization of the Islamic Conference reiterated in the Final Communiqué of the Twentieth Islamic Conference of Foreign Ministers, held at Istanbul from 4 to 8 August 1991, $\underline{10}$ / calling upon the Conference on Disarmament to reach an urgent agreement on an international convention to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons,

<u>Taking note further</u> of the unilateral declarations made by all nuclear-weapon States on their policies of non-use or non-threat of use of nuclear weapons against non-nuclear-weapon States,

Noting the support expressed in the Conference on Disarmament and in the General Assembly for the elaboration of an international convention to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons, as well as the difficulties pointed out in evolving a common approach acceptable to all,

 $\underline{\text{Noting also}}$ the greater willingness to overcome the difficulties encountered in previous years,

Recalling its relevant resolutions adopted in previous years, in particular resolutions 45/54 of 4 December 1990, 46/32 of 6 December 1991, 47/50 of 9 December 1992 and 48/73 of 16 December 1993,

- 1. Reaffirms the urgent need to reach an early agreement on effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons;
- 2. <u>Notes with satisfaction</u> that in the Conference on Disarmament there is no objection, in principle, to the idea of an international convention to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons, although the difficulties as regards evolving a common approach acceptable to all have also been pointed out;
- 3. Appeals to all States, especially the nuclear-weapon States, to work actively towards an early agreement on a common approach and, in particular, on a common formula that could be included in an international instrument of a legally binding character;

- 4. Recommends that further intensive efforts should be devoted to the search for such a common approach or common formula and that the various alternative approaches, including, in particular, those considered in the Conference on Disarmament, should be further explored in order to overcome the difficulties;
- 5. Recommends also that the Conference on Disarmament should actively continue intensive negotiations with a view to reaching early agreement and concluding effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons, taking into account the widespread support for the conclusion of an international convention and giving consideration to any other proposals designed to secure the same objective;
- 6. <u>Decides</u> to include in the provisional agenda of its fiftieth session the item entitled "Conclusion of effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons".
