### REVIEW OF THE IMPLEMENTATION OF THE DECLARATION ON THE STRENGTHENING OF INTERNATIONAL SECURITY

#### Report of the First Committee

Rapporteur: Mr. Rajab SUKAYRI (Jordan)

#### I. INTRODUCTION

1. The item entitled "Review of the implementation of the Declaration on the Strengthening of International Security" was included in the provisional agenda of the fiftieth session of the General Assembly in accordance with Assembly resolution 48/83 of 16 December 1993.

2. At its 3rd plenary meeting, on 22 September 1995, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.

3. At its 2nd meeting, on 12 October 1995, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely, items 57 to 78, 80 and 81. The deliberations on those items took place at the 3rd to 11th meetings, from 16 to 20 and on 25 and 26 October 1995. Structured discussions of specific subjects within the adopted thematic approach were held from 30 October to 3 November. Consideration of draft resolutions on the items took place at the 13th to 17th meetings, from 6 to 9 November. Action on the draft resolutions was taken at the 18th to 29th meetings, on 10, 13-17, 20 and 21 November.

4. In connection with item 60, the First Committee had before it the following documents:

(a) Report of the Secretary-General on the implementation of the Declaration on the Strengthening of International Security (A/50/310);

(b) Letter dated 19 May 1995 from the Permanent Representative of Portugal to the United Nations addressed to the Secretary-General (A/50/186);

(c) Letter dated 24 October 1995 from the Permanent Representative of Indonesia to the United Nations addressed to the Secretary-General (A/50/702-S/1995/900).

## II. CONSIDERATION OF DRAFT DECISION A/C.1/50/L.30

5. At the 16th meeting, on 8 November, the representative of Colombia, on behalf of the States Members of the United Nations that are members of the Movement of Non-Aligned Countries, introduced a draft decision entitled "Review of the implementation of the Declaration on the Strengthening of International Security" (A/C.1/50/L.30).

6. At its 22nd meeting, on 15 November, the Committee adopted draft decision A/C.1/50/L.30 by a recorded vote of 102 to 0, with 52 abstentions (see para. 7). The voting was as follows:
