I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 22 September 1995, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fiftieth session the item entitled "United Nations Relief and Works Agency for Palestine Refugees in the Near East" and to allocate it to the Special Political and Decolonization Committee (Fourth Committee).
- 2. The Fourth Committee considered the item at its 12th, 13th and 25th meetings, on 30 and 31 October and 30 November 1995 (see A/C.4/50/SR.12, 13 and 25). The general debate on the item took place at the 12th and 13th meetings, on 30 and 31 October.
- 3. For its consideration of the item, the Committee had before it the following documents:

- 6. Also at the same meeting, the Permanent Observer for Palestine made a statement (see A/C.4/50/SR.12).
- 7. At the 13th meeting, on 31 October, the Commissioner-General of UNRWA made a concluding statement (see A/C.4/50/SR.13).

- III. RECOMMENDATIONS OF THE SPECIAL POLITICAL AND DECOLONIZATION COMMITTEE (FOURTH COMMITTEE)
- 29. The Special Political and Decolonization Committee (Fourth Committee) recommends to the General Assembly the adoption of the following draft resolutions:

<u>United Nations Relief and Works Agency for Palestine Refugees</u> in the Near East

Assistance to Palestine refugees

The General Assembly,

Recalling its resolution 49/35 A of 9 December 1994 and all its previous resolutions on the question, including resolution 194 (III) of 11 December 1948,

<u>Taking note</u> of the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East covering the period from 1 July 1994 to 30 June 1995, $\underline{4}$ /

<u>Welcoming</u> the signature by the Government of the State of Israel and the Palestine Liberation Organization of the Declaration of Principles on Interim Self-Government Arrangements at Washington on 13 September 1993, 5/

Welcoming also the signature by the Government of the State of Israel and the Palestine Liberation Organization of the Interim Agreement on the West Bank and the Gaza Strip at Washington on 28 September 1995,

 $\underline{\text{Commending}}$ the work of the Multilateral Working Group on Refugees of the Middle East peace process,

- 1. <u>Notes with regret</u> that repatriation or compensation of the refugees, as provided for in paragraph 11 of its resolution 194 (III), has not yet been effected and that, therefore, the situation of the refugees continues to be a matter of concern;
- 2. Expresses its thanks to the Commissioner-General and to all the staff of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, recognizing that the Agency is doing all it can within the limits of available resources, and also expresses its thanks to the specialized agencies and to private organizations for their valuable work in assisting refugees;

- 3. <u>Notes with regret</u> that the United Nations Conciliation Commission for Palestine has been unable to find a means of achieving progress in the implementation of paragraph 11 of resolution 194 (III), <u>6</u>/ and requests the Commission to exert continued efforts towards the implementation of that paragraph and to report to the General Assembly as appropriate, but not later than 1 September 1996;
- 4. <u>Notes</u> the significant success of the peace implementation programme of the Agency since the signing of the Declaration of Principles on Interim Self-Government Arrangements;
- 5. <u>Urges</u> all Member States to extend and expedite aid and assistance with a view to the economic and social development of the Palestinian people and the occupied territories;

The General Assembly,

Recalling its resolutions 2252 (ES-V) of 4 July 1967, 2341 B (XXI) of 19 December 1967 and all subsequent related resolutions,

Recalling also Security Council resolutions 237 (1967) of 14 June 1967 and 259 (1968) of 27 September 1968,

<u>Taking note</u> of the report of the Secretary-General submitted in pursuance of its resolution 49/35 C of 9 December 1994, 9/35

Taking note also of the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East covering the period from 1 July 1994 to 30 June 1995, 4/

<u>Concerned</u> about the continuing human suffering resulting from the June 1967 and subsequent hostilities,

<u>Taking note</u> of the relevant provisions of the Declaration of Principles on Interim Self-Government Arrangements, signed in Washington on 13 September 1993 by the Government of the State of Israel and the Palestine Liberation Organization, $\underline{5}$ / with regard to the modalities for the admission of persons displaced in 1967,

- 1. Reaffirms the right of all persons displaced as a result of the June 1967 and subsequent hostilities to return to their homes or former places of residence in the territories occupied by Israel since 1967;
- 2. <u>Expresses the hope</u> for an accelerated return of displaced persons through the mechanism agreed upon by the parties in article XII of the Declaration of Principles on Interim Self-Government Arrangements;
- 3. <u>Endorses</u>, in the meanwhile, the efforts of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East to continue to provide humanitarian assistance, as far as practicable, on an emergency basis, and as a temporary measure, to persons in the area who are currently displaced and in serious need of continued assistance as a result of the June 1967 and subsequent hostilities;
- 4. <u>Strongly appeals</u> to all Governments and to organizations and individuals to contribute generously to the Agency and to the other intergovernmental and non-governmental organizations concerned for the above purposes;

<u>Taking note</u> of the agreement reached on 24 June 1994, embodied in an exchange of letters between the Agency and the Palestine Liberation Organization, $\underline{17}/$

Recalling its decision 48/417 of 10 December 1993 on the establishment of a working relationship between the Advisory Commission of the Agency and the Palestine Liberation Organization,

- 1. <u>Expresses its appreciation</u> to the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, as well as to all the staff of the Agency, for their tireless efforts and valuable work;
- 2. Expresses its appreciation also to the Advisory Commission of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, and requests it to continue its efforts and to keep the General Assembly informed on its activities, including the full implementation of decision 48/417;
- 3. <u>Acknowledges</u> the support of the host Governments and the Palestine Liberation Organization for the Agency in the discharge of its duties;

Notes that the new context created by the signing of the Declaration of Principles on Interim Self-Government Arrangements by the Government of the State of Israel and the Palestine Liberation Organization and subsequent implementation agreements has had major consequences for the activities of the Agency, which is henceforth called upon, in close cooperation with the United Nations Special Coordinator in the Occupied Territories, the specialized agencies and the World Bank, to continue to contribute towards the development of economic and social stability in the occupied territory;
