of Estonia, Latvia and Lithuania to the United Nations

ANNEX

Joint statement issued at Vilnius on 16 June 1996 by the
Heads of Government of the Republic of Estonia, the
Republic of Latvia and the Republic of Lithuania on the
Vienna conclusions of the Review Conference on the Treaty
on Conventional Armed Forces in Europe

During our meeting on 16 June 1996 at Vilnius, we, the Heads of Government of Estonia, Latvia and Lithuania, discussed the Vienna conclusions of the Review Conference on the Treaty on Conventional Armed Forces in Europe (CFE).

We welcomed the preservation of the CFE Treaty as one of the cornerstones of the European security.

We noted with satisfaction the strengthening of the mechanisms of verification and inspection as well as intensified exchange of military information agreed upon in the Review Conference.

We expressed our concern about the decisions which create conditions for an increase in the concentration of the armed forces in the Baltic region.

We noted the lack of political consultations before and during the CFE Treaty Review Conference between the CFE member States and other legitimately concerned countries.

We called for reiterated political support and increased technical assistance from the United States of America and West European countries pertaining to the integration of the Baltic States into the North Atlantic Treaty Organization and European institutions.
