### **Verification in all its aspects, including the role of the United Nations in the field of verification**

#### **Report of the First Committee**

## **I. Introduction**

1. The item entitled “Verification in all its aspects, including the role of the United Nations in the field of verification” was included in the provisional agenda of the fifty-fourth session of the General Assembly in accordance with Assembly resolution 52/31 of 9 December 1997.
2. At its 3rd plenary meeting, on 17 September 1999, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.
3. At its 2nd meeting, on 23 September 1999, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely, items 64, 65 and 67 to 85, which was held at the 3rd to 12th meetings, from 11 to 15 and from 18 to 20 October 1999 (see A/C.1/54/PV.3-12). Thematic discussions on the items were held, and draft resolutions were introduced and considered, at the 13th to 19th meetings, on 21 and 22 and from 25 to 29 October (see A/C.1/54/PV.13-19). Action on all draft resolutions was taken at the 20th to 27th meetings, on 1, 2, 4, 5, 8 and 9 November (see A/C.1/54/PV.20-27).
4. For its consideration of the item, the Committee had before it the following documents:
  - (a) Report of the Secretary-General on verification in all its aspects, including the role of the United Nations in the field of verification (A/54/166);

(b) Letter dated 5 August 1999 from the Permanent Representative of Japan to the United Nations addressed to the Secretary-General, transmitting the report of the Tokyo Forum for Nuclear Non-Proliferation and Disarmament (A/54/205-S/1999/853);

(c) Letter dated 15 October 1999 from the Permanent Representative of South Africa to the United Nations addressed to the Secretary-General, transmitting the communiqué of the meeting of Ministers for Foreign Affairs and Heads of Delegation of the Movement of Non-Aligned Countries, held in New York on 23 September 1999 (A/54/469-S/1999/1063);

(d) Letter dated 27 October 1999 from the Permanent Representative of Japan to the United Nations addressed to the Secretary-General, transmitting the Final Declaration of the Conference on Facilitating the Entry into Force of the Comprehensive Nuclear-Test-Ban Treaty, held at Vienna from 6 to 8 October 1999 (A/54/514-S/1999/1102).

## **II. Consideration of draft resolution A/C.1/54/L.29**

5. At the 19th meeting, on 29 October, the representative of Canada, on behalf of Austria, Bangladesh, Brazil, Canada, Chile, Croatia, Czech Republic, Finland, Germany, Hungary, Kazakhstan, Lithuania, New Zealand, Poland, the Republic of Korea, Singapore, Slovakia, Ukraine and Uruguay, subsequently joint by Denmark, Haiti, the Republic of Moldova and Turkey, introduced a draft resolution entitled "Verification in all its aspects, including the role of the United Nations in the field of verification" (A/C.1/54/L.29).

6. At its 24th meeting, on 5 November, the Committee adopted draft resolution A/C.1/54/L.29 without a vote (see para. 7).

## **III. Recommendation of the First Committee**

7. The First Committee recommends to the General Assembly the adoption of the following draft resolution:

### **Verification in all its aspects, including the role of the United Nations in the field of verification**

*The General Assembly,*

*Noting* the critical importance of, and the vital contribution that has been made by, effective verification measures in arms limitation and disarmament agreements and other similar obligations,

*Reaffirming* its support for the sixteen principles of verification drawn up by the Disarmament Commission,<sup>1</sup>

*Recalling* its resolutions 40/152 O of 16 December 1985, 41/86 Q of 4 December 1986, 42/42 F of 30 November 1987, 43/81 B of 7 December 1988, 45/65 of 4 December

1990, 47/45 of 9 December 1992, 48/68 of 16 December 1993, 50/61 of 12 December 1995 and 52/31 of 9 December 1997,

*Recalling also* the reports of the Secretary-General of 11 July 1986, 28 August 1990, 16 September 1992, 26 July 1993, 22 September 1995, 6 August 1997 and 9 July 1999, and the addenda thereto,<sup>2</sup>

1. *Reaffirms* the critical importance of, and the vital contribution that has been made by, effective verification measures in arms limitation and disarmament agreements and other similar obligations;

2. *Requests* the Secretary-General to report to the General Assembly at its fifty-sixth session on further views received from Member States pursuant to resolutions 50/61 and 52/31;

3. *Decides* to include in the provisional agenda of its fifty-sixth session the item entitled "Verification in all its aspects, including the role of the United Nations in the field of verification".
