LETTER DATED 13 SEPTEMBER 1963 FROM THE PERMANENT REPRESENTATIVE OF NIGERIA TO THE UNITED NATIONS ADDRESSED TO THE SECRETARY-GENERAL

I have the honour to inform you that the Government of the Federation of Nigeria has acceded to the partial nuclear test ban treaty concluded by the Governments of the United States of America, the United Kingdom and the Union of Soviet Socialist Republics.

Copies of this treaty were signed by the Foreign Minister of the Federation of Nigeria in Moscow, London and Washington on 30 August, 2 and 4 September, respectively.
