

I. Introduction

- 1. At its 1st and 2nd meetings, on 17 September 2003, the General Committee considered a memorandum by the Secretary-General relating to the organization of the fifty-eighth regular session and future sessions of the General Assembly, the adoption of the agenda and the allocation of items (A/BUR/58/1 and Corr.1 and Add.1). A summary of the discussions will appear in the summary records of the meetings (A/BUR/58/SR.1 and 2).
- 2. The General Committee took note of the provisions of the following resolutions which are reflected in the present document under the relevant sections:
- (a) Annex I (Guidelines on the Rationalization of the Agenda of the General Assembly) to General Assembly resolution 48/264 of 29 July 1994, entitled "Revitalization of the work of the General Assembly";
- (b) The annex to resolution 51/241 of 31 July 1997, entitled "Strengthening of the United Nations system";
- (c) Paragraph 1 of resolution 52/163 of 15 December 1997, entitled "Amendment to rule 103 of the rules of procedure of the General Assembly";
- (d) The annex to resolution 55/285 of 7 September 2001, entitled "Revitalization of the General Assembly: improving the efficiency of the General Assembly";
- (e) General Assembly resolution 56/509 of 8 July 2002, entitled "Amendments to rules 30, 31 and 99 of the rules of procedure of the General Assembly";
- (f) General Assembly resolution 57/301 of 13 March 2003, entitled "Amendment to rule 1 of the rules of procedure of the General Assembly and opening date and duration of the general debate".
- 3. The General Committee also took note of the report of the Secretary-General on the reform of the United Nations, entitled "Strengthening of the United Nations: an agenda for further change" (A/57/387 and Corr.1).

II. Organization of the session

A. General Committee

- 4. The General Committee took note of rule 40 of the rules of procedure and document A/56/1005 (annex, paras. 9 and 10) pertaining to the functions of the Committee.
- 5. The General Committee also took note that at the outset of each session, each Vice-President of the General Assembly should designate a liaison person for the duration of the session (resolution 55/285, annex, para. 20).

B. Rationalization of work

- 6. The General Committee took note of the following resolutions and report of the Secretary-General in relation to the administrative and financial functioning of the Organization:
- (a) Resolution 41/213 of 19 December 1986, entitled "Review of the efficiency of the administrative and financial functioning of the United Nations";
- (b) Resolution 48/264 of 29 July 1994, entitled "Revitalization of the work of the General Assembly";
- (c) Resolution 52/12 B of 19 December 1997, entitled "Renewing the United Nations: a programme for reform";
- (d) Report of the Secretary-General on the review of the efficiency of the administrative and financial functioning of the United Nations (A/56/82).
- 7. The General Committee also took note of paragraph 14 of the annex to General Assembly resolution 55/285, which reads as follows:
 - "14. As regards implementation of paragraph 7 of the annex to resolution 51/241, the President of the General Assembly, after consideration by the Assembly of the report of the Secretary-General on the work of the Organization, shall inform the Assembly of his assessment of the debate on the report in order for the Assembly to determine the need for further action."
- 8. The General Committee draws to the attention of the General Assembly that the Main Committees shall meet in substantive session only after the end of the general debate and that the First Committee and the Fourth Committee shall not meet simultaneously and may consider meeting in a sequential manner during the regular session of the General Assembly. This arrangement shall not apply if it affects their respective identities, programmes of work and effective consideration of their agendas (resolution 51/241, annex, paras. 31 and 36).

C. Opening and closing dates of the session

- 9. The General Committee recommends to the General Assembly that the fifty-eighth session of the Assembly recess on Tuesday, 16 December 2003 and close on Monday, 13 September 2004 (rule 2 of the rules of procedure and paragraph 4 of annex V to the rules of procedure).
- 10. The General Committee also recommends to the General Assembly that, during the main part of the session, the First, the Special Political and Decolonization (Fourth) and the Sixth Committees complete their work by Friday, 7 November, the Third Committee by Friday, 21 November, the Second Committee by Friday, 5 December and the Fifth Committee by Tuesday, 9 December 2003.

D. Schedule of meetings

11. The General Committee took note of the fact that in view of financial constraints, meetings at Headquarters are no longer serviced beyond 6 p.m. or on weekends, with the exception of the plenary of the General Assembly and the Security Council. Consequently, meetings of the Main Committees during the fifty-

- eighth session, including informal meetings, should start promptly at 10 a.m. and be adjourned by 6 p.m. during weekdays.
- 12. The General Committee also took note of the fact that measures introduced to reduce costs relating to overtime would be strictly enforced.
- 13. The General Committee recommends to the General Assembly that, in accordance with past practice, it waive the requirement that at least one third of the members of the Assembly in the case of plenary meetings and one quarter of the members of a Main Committee in the case of Main Committee meetings be present in order to declare a meeting open and to permit the debate to proceed. This recommendation is made on the understanding that such a waiver would not imply any permanent change in the provisions of rules 67 and 108 of the rules of procedure and that the requirement of the presence of a majority of the members for any decision to be taken would be maintained.

E. General debate

14. The General Committee draws to the attention of the General Assembly that the general debate in the Assembly shall open on the Tuesday following the opening of the regular session of the Assembly, that the general debate for the fifty-eighth session shall open on Tuesday, 23 September 2003, and end on Friday, 3 October 2003, that the general debate shall be held without interruption over a period of nine working days, and that the list of speakers for each day shall be completed and no speakers will be rolled over to the next day, notwithstanding the implications for hours of work. Furthermore, there shall be no time limits or specified themes for the general debate but the General Assembly will indicate a voluntary guideline of up to twenty minutes for each statement (resolution 57/301, para. 2, and resolution 51/241, annex, paras. 20 (e) and 21).

F. Conduct of the meetings, length of statements, explanations of vote, rights of reply, points of order and concluding statements

- 15. The General Committee draws the attention of the General Assembly to the relevant rules of procedure regarding the conduct of meetings, namely, rules 35, 68, 72, 73, 99 (b), 106, 109, 114 and 115.
- 16. The General Committee also draws to the attention of the General Assembly that explanations of vote should be limited to ten minutes; that when the same draft resolution is considered in a Main Committee and in plenary meeting, a delegation should, as far as possible, explain its vote only once, i.e., either in the Committee or in plenary meeting, unless that delegation's vote in plenary meeting is different from its vote in the Committee; and that delegations should exercise their right of reply at the end of the day whenever two meetings have been scheduled for that day and whenever such meetings are devoted to the consideration of the same item (decision 34/401, paras. 6-8 (A/520/Rev.15, annex VI)).
- 17. The General Committee recommends to the General Assembly that points of order be limited to five minutes.

- 18. The General Committee also recommends to the General Assembly that it review the recommendations contained in paragraph 22 of the annex to resolution 51/241 and paragraph 23 of document A/52/855, regarding the length of statements with a view to streamlining the procedures of the General Assembly and as another cost-saving measure.
- 19. The General Committee further recommends to the General Assembly that, in order to save time at the end of the session, the practice of making concluding statements in the General Assembly and its Main Committees should be dispensed with except for statements by the presiding officers (decision 34/401, para. 17 (A/520/Rev.15, annex VI)).

G. Records of meetings

- 20. The General Committee took note of the fact that, as at past sessions, during the fifty-eighth session verbatim records will continue to be provided for the plenary meetings of the General Assembly and the meetings of the First Committee, and summary records will be provided for the General Committee and the other Main Committees of the Assembly (see A/BUR/58/1, para. 24).
- 21. Furthermore, the General Committee draws to the attention of the General Assembly that the practice of reproducing statements in extenso as separate documents shall be discontinued for all its subsidiary organs that are entitled to summary records and that any exceptions to this rule may be made by the body concerned only if the statements are to serve as bases for discussion and if, after hearing a statement of the relevant financial implications, the body decides that one or more statements in extenso may be included in the summary record, or reproduced as separate documents or as annexes to authorized documents (resolution 38/32 E of 25 November 1983, paras. 8 and 9).
- 22. In this connection, the General Committee recommends to the General Assembly that the practice not to reproduce in extenso statements made in a Main Committee be maintained for the fifty-eighth session.

H. Resolutions

- 23. The General Committee brings to the attention of the General Assembly that:
 - Whenever possible, resolutions requesting the discussion of a question at a subsequent session should not call for the inclusion of a separate new item and such discussion should be held under the item under which the resolution was adopted (decision 34/401, para. 32 (A/520/Rev.15, annex VI)).
 - "Efforts should be made to reduce the number of resolutions adopted by the General Assembly. Resolutions should request reports of the Secretary-General only in cases where that would be indispensable for facilitating the implementation of these resolutions or the continued examination of the question."

- In order to ensure that resolutions have greater political impact, they should be short, in particular as regards the preambular parts, and should focus more on action-oriented operative paragraphs (resolution 57/270 B of 23 June 2003, para. 69).
- Whenever possible, for the adoption by the General Assembly of agreed texts of resolutions and decisions, informal consultations should be carried out with the widest possible participation of Member States (resolution 45/45, annex, para. 1 (A/520/Rev.15/Amend.1, annex VIII, para.1)).
- 24. The General Committee took note and decided to bring to the attention of the General Assembly that the Secretary-General encourages Member States to transmit all draft resolutions and decisions in electronic form as well as on paper and that the submitters are responsible for ensuring that the electronic and paper versions of the draft resolutions and decisions are identical in content.

I. Documentation

- 25. The General Committee draws the following to the attention of the General Assembly that:
 - The General Assembly, including its Main Committees, should merely take note of those reports of the Secretary-General or subsidiary organs which do not require a decision by the Assembly and should neither debate nor adopt resolutions on them, unless specifically requested to do so by the Secretary-General or the organ concerned (decision 34/401, para. 28 (A/520/Rev.15, annex VI)).
 - The General Assembly, while reaffirming paragraph 28 of annex VI to the rules of procedure of the Assembly, reiterates that the terms "takes note of" and "notes" are neutral terms that constitute neither approval nor disapproval (decision 55/488 of 7 September 2001, annex).
- 26. The General Committee also draws the attention of the General Assembly to resolution 57/283 B of 15 April 2003 regarding timely issuance of documents in the six official languages of the General Assembly.
- 27. The General Committee further draws the attention of the General Assembly to resolutions 48/264 and 55/285, in which the Assembly emphasized that restraint should be exercised in making requests for new reports and requested more integrated reports, and to resolution 57/270 B, in which it recognized the need to avoid requesting duplicative reports from the Secretary-General.
- 28. The General Committee draws to the attention of the General Assembly that:
 - Resolutions should request observations from States or reports by the Secretary-General insofar as they are likely to facilitate the implementation of the resolutions or the continued examination of the question (resolution 45/45, annex, para. 10 (A/520/Rev.15/Amend.1, annex VIII)).
 - Member States and entities of the United Nations system should make a serious effort to submit their replies and inputs to requests for information or views pursuant to resolutions of the General Assembly within the prescribed deadlines (resolution 55/285, annex, para. 17).

J. Questions relating to the programme budget

29. The General Committee draws the attention of the General Assembly to rule 153 of the rules of procedure, which reads as follows:

"No resolution involving expenditure shall be recommended by a committee for approval by the General Assembly unless it is accompanied by an estimate of expenditures prepared by the Secretary-General. No resolution in respect of which expenditures are anticipated by the Secretary-General shall be voted by the General Assembly until the Administrative and Budgetary Committee (Fifth Committee) has had an opportunity of stating the effect of the proposal upon the budget estimates of the United Nations."

- 30. The General Committee also draws the attention of the General Assembly to paragraphs 12 and 13 of its decision 34/401 (A/520/Rev.15, annex VI), which read as follows:
 - "12. It is imperative that Main Committees should allow sufficient time for the preparation of the estimate of expenditures by the Secretariat and for its consideration by the Advisory Committee on Administrative and Budgetary Questions and the Fifth Committee and that they should take this requirement into account when they adopt their programme of work.

"13. Furthermore:

- "(a) A mandatory deadline, not later than 1 December, should be established for the submission to the Fifth Committee of all draft resolutions with financial implications;
- "(b) The Fifth Committee should, as a general practice, consider accepting without debate the recommendations of the Advisory Committee on Administrative and Budgetary Questions on the financial implications of draft resolutions up to a prescribed limit, namely, \$25,000 on any one item;
- "(c) Firm deadlines should be set for the early submission of the reports of subsidiary organs which require consideration by the Fifth Committee;
- "(d) A minimum period of forty-eight hours should be allowed between the submission and the voting of a proposal involving expenditure in order to allow the Secretary-General to prepare and present the related statement of administrative and financial implications."
- 31. The General Committee further draws the attention of the General Assembly to regulation 5.9 of the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation (ST/SGB/2000/8; first adopted in resolution 37/234, annex; most recently amended in section III of resolution 53/207), which reads as follows:
 - "Regulation 5.9. No council, commission or other competent body shall take a decision involving either a change in the programme budget approved by the General Assembly or the possible requirement of expenditure unless it has received and taken account of a report from the Secretary-General on the programme budget implications of the proposal."
- 32. The General Committee draws the attention of the General Assembly to paragraph 6 of its resolution 35/10 A of 3 November 1980, which reads as follows:

- "6. Decides that all proposals affecting the schedule of conferences and meetings made at sessions of the General Assembly shall be reviewed by the Committee on Conferences when administrative implications are being considered under the requirements of rule 153 of the rules of procedure of the Assembly."
- 33. The General Committee also draws the attention of the General Assembly to section VI of its resolution 45/248 B of 21 December 1990 on procedures for administrative and budgetary matters, which states that the Assembly:
 - "1. Reaffirms that the Fifth Committee is the appropriate Main Committee of the General Assembly entrusted with responsibilities for administrative and budgetary matters;
 - "2. Reaffirms also the role of the Advisory Committee on Administrative and Budgetary Questions;
 - "3. Expresses its concern at the tendency of its substantive Committees and other intergovernmental bodies to involve themselves in administrative and budgetary matters;
 - "4. *Invites* the Secretary-General to provide all intergovernmental bodies with the required information regarding procedures for administrative and budgetary matters."

(See also section III, paras. 36 and 37.)

K. Observances and commemorative meetings

34. Considering past practice, the General Committee recommends to the General Assembly that it adopt a format for commemorative meetings that includes statements by the President of the General Assembly, the Secretary-General, the chairmen of the five regional groups and the representative of the host country.

L. Special conferences

- 35. The General Committee draws the attention of the General Assembly to the following:
 - "The Committee ... recommends that the General Assembly should instruct the Main Committees to review the number of special conferences of the United Nations already proposed and scheduled in their respective fields of activity prior to deciding upon the scheduling of new and additional special conferences, thus bearing in mind the relevant portions of General Assembly resolution 33/55." (recommendation 6 of the Committee on Conferences, adopted by the Assembly in decision 34/405 of 1 November 1979, para. (b)).
 - "... The decision of the General Assembly that no more than five special conferences should take place in a given year and that no more than one

- special conference should be convened at the same time should be strictly implemented."3
- "The existing principle that United Nations bodies should meet at their respective established headquarters, as provided for in General Assembly resolution 40/243 of 18 December 1985, should be strictly enforced. Whenever the Assembly accepts an invitation from the Government of a Member State to hold a conference or meeting away from established headquarters, the additional cost should be borne in full by that Government. The methods of budgeting these costs should be improved so as to ensure that all additional costs are accounted for."

III. Observations on the organization of the work of the General Assembly

- 36. With regard to rule 153 of the rules of procedure on the financial implications of resolutions and paragraph 13 (d) of decision 34/401, which requires a minimum period of forty-eight hours before action is taken on a proposal so as to allow the Secretary-General to prepare the programme budget implications of drafts before the General Assembly, the General Committee draws the attention of the Assembly to the fact that, in most cases, more than forty-eight hours are required for the Secretary-General to review the programme budget implications of proposals before the Assembly.
- 37. The General Committee also draws the attention of the General Assembly to the fact that, in accordance with rule 78 of the rules of procedure, proposals have to be submitted well in advance of their consideration, in order to ensure that copies have been circulated not later than the day preceding the meeting at which they will be considered.

IV. Adoption of the agenda

- 38. The General Committee considered the draft agenda of the fifty-eighth session submitted by the Secretary-General in his memorandum (A/BUR/58/1 and Corr.1 and Add.1). All the items contained in the draft agenda formed part of the following documents:
 - (a) Provisional agenda of the fifty-eighth regular session (A/58/150);
- (b) Supplementary list of items proposed for inclusion in the agenda of the fifty-eighth session (A/58/200);
 - (c) Requests for the inclusion of additional items (A/58/231 and A/58/232).
- 39. The General Committee took note of the relevant resolutions pertaining to the review of the agenda, namely, annex I to resolution 48/264, the annex to resolution 51/241 and the annex to resolution 55/285, and of paragraph 60 of resolution 57/270 B, in which the General Assembly stated that the General Committee should ensure better coordination of the agendas of the Second and Third Committees.

- 40. In addition, bearing in mind the extremely heavy workload of the General Assembly and the need to make the most effective use of scarce resources, the General Committee took note of the suggestion by the Secretary-General to consider deferring to a later session items for which decisions or action were not required at the current session (resolution 51/241, annex, paras. 23-26).
- 41. The General Committee took note of General Assembly decision 49/426 of 9 December 1994, whereby the Assembly decided that the granting of observer status in the Assembly should in the future be confined to States and to those intergovernmental organizations whose activities covered matters of interest to the Assembly (see also para. 52).
- 42. With regard to item 23 of the draft agenda (Building a peaceful and better world through sport and the Olympic ideal) and item 164 of the draft agenda (International Year of Sport and Physical Education), the General Committee decided to recommend that an item 23 entitled "Sport for peace and development" be included with a sub-item (a) entitled "Building a peaceful and better world through sport and the Olympic ideal" and a sub-item (b) entitled "International Year of Sport and Physical Education".
- 43. With regard to item 29 of the draft agenda (Question of the Comorian island of Mayotte), the General Committee decided to defer its consideration of the inclusion of the item to a later date.
- 44. With regard to item 92 of the draft agenda (Question of the Malagasy islands of Glorieuses, Juan de Nova, Europa and Bassas da India), the General Committee decided to recommend that the consideration of the item be deferred to the fifty-ninth session and that the item be included in the provisional agenda of that session.
- 45. In connection with item 163 of the draft agenda (Financing of the United Nations Mission in Côte d'Ivoire), the General Committee decided to recommend its inclusion.
- 46. In connection with item 165 of the draft agenda (Observer status for the Eurasian Economic Community in the General Assembly), the General Committee decided to recommend its inclusion.
- 47. In connection with item 166 of the draft agenda (Question of the representation of the Republic of China (Taiwan) in the United Nations), the General Committee decided not to recommend its inclusion.
- 48. In connection with item 167 of the draft agenda (Observer status for the GUUAM in the General Assembly), the General Committee decided to recommend its inclusion.
- 49. In connection with item 168 of the draft agenda (Observer status for the East African Community in the General Assembly), the General Committee decided to recommend its inclusion.
- 50. Taking into account paragraphs 42 to 49 above, the General Committee recommends to the General Assembly the adoption of the following agenda:⁵
