I. Introduction

1. The previous recommendations made by the Fifth Committee to the General Assembly under agenda item 119 appear in the report of the Committee contained in document A/58/571.
2. The Fifth Committee resumed its consideration of the item at its 30th meeting, on 23 December 2003. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary record (A/C.5/58/SR.30).
