**Plan of Implementation of the Decolonization Mandate 2006-07**

*Revised 15<sup>th</sup> January 2006*

**I. Introduction**

At the opening of the annual session of the Special Committee on Decolonization in February 2005, considerable emphasis was placed on the importance of moving into the implementation phase of the longstanding international mandates on decolonization. Many of these mandates originate in the Special Committee, and have been in place even before the First and Second International Decades for the Eradication of Colonialism.

To enter into this implementation phase, innovative strategies are necessary in order for the United Nations to fulfil its obligations to ensure the successful self-determination and subsequent decolonization of the remaining non self-governing territories through the assumption of a full measure of self-government.

To this end, the Special Committee in 2005 began to take a proactive approach with initiatives such as the *Special United Nations Mission to Bermuda*, the engagement of other United Nations bodies such as the *United Nations Development Programme (UNDP)* and the UN regional commissions, the expansion of the role of independent experts, and the adoption of resolutions which have, once again, called for specific actions to be undertaken by the wider UN system to speed up the decolonisation process. The fact that the *Second International Decade for the Eradication of Colonialism* has now passed its mid-point without sufficient realization of its plan of action only serves to underscore the urgency of accelerating the implementation phase.

In furtherance of this new approach, the Chairman of the Special Committee at the closing session of the committee in June 2005 announced that a document would be prepared outlining the actions called for by the United Nations in its various resolutions, and to be undertaken by the UN system, with the aim of developing a programme to implement these directives. This document would be designed to generate some positive movement, where dormancy had often been the norm. The present document represents that *Plan of Implementation of the Decolonisation Mandate 2006-07*, and serves to update the previous document for the period 2005-06 following extensive consultations with member States and senior officials of the U.N. Secretariat.

It is important to note that the accelerated implementation of the self-determination and decolonization mandate of the United Nations is in furtherance of the promotion of democratic governance and the universal realization of human rights. In this connection, the major human rights conventions, particularly the *International Covenant on Civil and Political Rights*; and the *International Covenant on Economic, Social and Cultural Rights*, all contain commitments to promote the right to self-determination among peoples.

The *Millennium Declaration* also rededicated the international community to the support of all efforts to promote the right to self-determination of peoples of the remaining non self-governing territories. Accordingly, proposals contained in the Secretary-General's Report "*In Larger Freedoms: towards development, security and human rights for all*," in relation to the creation of the democracy fund and the establishment of a more explicit link between the democratic governance of UNDP and the Electoral Assistance Division, also encompass the evolution of the self-determination process which remains a matter of the fulfilment of democratic governance.

Further, the Heads of State and Government in the *2005 World Summit Outcome* re-dedicated itself to ensuring the self-determination of peoples which remain under the colonial condition, and respect for human rights and fundamental freedoms.

## **II. Organization of the Areas of Implementation**

The *Plan of Implementation (POI)* is derived from the myriad of resolutions adopted by the General Assembly, the Economic and Social Council (ECOSOC) and the Special Committee on Decolonization, and are organized into eight areas of focus:

- Information Regarding Non Self-Governing Territories (NSGTs)
- Participation of NSGTs in the UN Review Process on Decolonization
- Analysis of the existing political and constitutional arrangements in the NSGTs
- Visiting Missions
- Protection, Conservation, Ownership and Control of Natural Resources
- Educational Advancement
- Development of Self-Government
- Support to NSGTs from the United Nations System

Specific activities under these areas to be undertaken in implementation of the mandate are outlined in the Annex to the present report in the Table entitled "*Plan of Implementation (POI) of the Decolonization Mandate 2006-07*." The table includes the specific references to key resolutions calling for implementation of the *Decolonization Declaration*.

## **III. Implementing Bodies**

The implementing bodies and institutions which have been identified to undertake the specific actions called for in the resolutions are listed as follows:

- Decolonization Unit, Department of Political Affairs (DU/DPA)
