I. INFORMATION ON THE TERRITORIES

A. The Territories in general

Introduction

1. Information concerning the Territories, as well as an account of the action taken in respect of these Territories, is already contained in the Report of the Special Committee on Territories under Portuguese administration and in the previous reports of the Special Committee to the General Assembly. Supplementary information on recent developments is set out below.

Political and constitutional

2. In 1964 further measures were taken towards the completion of the institutional framework for the political and economic integration of the Overseas Territories with Portugal. The Publication of a decree (No. 45,830 of 25 July 1964) providing for representation of the Overseas Territories in the Corporative Chamber,
