Report of the Advisory Committee on Administrative and Budgetary Questions

1. The Advisory Committee on Administrative and Budgetary Questions has considered the report of the Secretary-General on the United Nations Office for Partnerships (A/62/220). During its consideration of the report, the Committee met with representatives of the Secretary-General, who provided additional information.

2. The Advisory Committee recalls that the United Nations Democracy Fund (UNDEF) was created in 2005 by the Secretary-General and was placed under the management and administration of the United Nations Fund for International Partnerships (UNFIP). Subsequently the United Nations Office for Partnerships evolved, managing UNFIP and UNDEF and providing partnership advisory services to the United Nations system and State and non-State actors (see A/62/220, paras. 1, 2 and 5). Information on projects funded through UNFIP and UNDEF by programme area, as at 31 December 2006, is shown as annexes I and II to the report of the Secretary-General. Upon enquiry, the Committee received updated information from UNFIP on the status of cash transfers and project implementation, which is attached to the present report (see annexes I and II below).

3. The Advisory Committee notes that from 1998, when it was launched, to 2006, the United Nations Foundation made allocations to UNFIP in a total amount of \$994.4 million for 400 projects implemented by 39 United Nations agencies in 123 countries, in such areas as children's health, women and population, the environment, and peace, security and human rights; starting in 2000, projects were implemented within the overall framework of the Millennium Development Goals. Of the total allocations referred to above, \$561 million was contributed by other donors. An additional \$335 million was generated from implementing agencies (see A/62/220, para. 7). **In this connection, the Committee notes with appreciation that in addition to the commitment of \$1 billion by Robert E. (Ted) Turner, the United Nations Foundation has been working on a second phase that could yield another \$1 billion from other partners to support United Nations causes** (see A/62/220, para. 98).



4. UNDEF became fully operational in 2006 and has now been included, for the first time, in the report of the United Nations Office for Partnership. In 2006, a total of \$36 million was approved for 125 projects in some 80 countries, focusing on civil and political rights, voters' education, political-party capacity development and strengthening the participation of women in political processes (see A/62/220, para. 4). Upon enquiry, the Advisory Committee was informed that of the 125 approved projects, two were cancelled. The Committee notes that UNDEF has introduced an online projects application system that facilitates access for civil society organizations (see A/62/220, para. 42).

5. The United Nations Office for Partnerships seeks to serve as a gateway between the United Nations system and the private sector, foundations and civil society. The partnership-building activities undertaken by the Office, in line with the mandate of the 2005 World Summit Outcome, are aimed at educating the public about the work of the Organization and engaging new partners for the United Nations. The Office received almost 500 enquiries from prospective partners in 2006 (see A/62/220, paras. 5 and 54-58).

6. The Advisory Committee recalls that in its report A/57/7/Add.6, paragraphs 6 and 7, it commented on project management, monitoring and evaluation by UNFIP. The Committee observed that the monitoring and evaluation process for projects appeared to be onerous and suggested that UNFIP focus more on measuring the impact and objectives of the projects, and that it provide evidence of progress in its next report. In this regard, the Advisory Committee takes note of the efforts made by UNFIP to improve management and streamline procedures, including the new programme guidelines promulgated in March 2005 (see A/61/189, paras. 68-69), the introduction of results-based budgeting and performance reports since 2003 (see A/59/170, para. 61), the issuance of the Handbook on Budget and Finance in October 2002 (see A/58/173, para. 67) and follow-up to the observations of the Board of Auditors (see A/60/327, para. 55). **In this connection, the Committee welcomes the inclusion of a section on lessons learned in the report of the Secretary-General (A/62/220, paras. 88-97), and notes in particular the emphasis placed on simplifying the administration and management of grants and ensuring full accountability.**

7. The Advisory Committee also notes that UNDEF is in the process of developing its own monitoring and evaluation strategy, drawing on experience of UNFIP and UNDP, and that UNDEF has reserved 10 per cent of each grant for evaluation (see A/62/220, para. 44). UNDEF also intends to put in place streamlined procedures to facilitate thorough assessments of projects at the national level (see A/62/220, para. 92). **The Committee looks forward to progress in this respect by UNDEF to be reflected in the next report.**

8. **The Advisory Committee recommends that the General Assembly take note of the report of the Secretary-General.**
