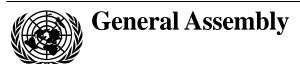

Overview

- 19.1 The programme is under the responsibility of the Economic Commission for Europe (ECE).
- 19.2 The Economic and Social Council, in its resolution 36 (IV), established ECE and assigned to it responsibilities for coordinating and promoting international economic cooperation in Europe. Further direction to the programme is provided by the workplan on ECE reform (E/ECE/1434/Rev.1), adopted by the Commission on 2 December 2005. Taking into account also the role of the regional commissions as set out in Economic and Social Council resolution 1998/46 and the goals and commitments contained in the United Nations Millennium Declaration (General Assembly resolution 60/1) and in the Plan of Implementation of the World Summit on Sustainable Development, the main objectives of the ECE work programme for the period 2008-2009 will be: (a) to promote the economic integration of ECE countries at the pan-European level, taking into account the enlargement of the European Union and the various integration initiatives under way in the eastern part of the ECE region; (b) to foster sustainable development and promote economic prosperity in the countries of the region by, in particular, promoting the conditions for sustained growth and trade and improving the environment; and (c) to contribute to the economic and environmental dimensions of security in Europe.
- 19.3 The ECE reform resulted in a major restructuring of the programme of work, with substantial programme shifts based on priorities agreed upon by ECE member States. The reform also streamlined the ECE governance structure, which in turn provides for more accountability and transparency. It further emphasized the need to strengthen cooperation with other organizations (both within and outside the United Nations) active in the region in order to maximize synergy, avoid duplication and ensure effective complementarity of work.
- 19.4 The revised ECE programme of work is designed around eight subprogrammes, namely, environment, transport, statistics, sustainable energy, trade, timber and forestry, housing, land management and population, and the newly established subprogramme on economic cooperation and integration aimed at promoting sustained growth, innovation for development and higher competitiveness, in particular in countries of the region with economies in transition. The core strategy focuses on the negotiation and implementation of conventions, norms, standards and guidelines; the organization of policy debate and the exchange of experience in the key areas of ECE work, including supporting policy analysis, studies and statistics; the provision of technical assistance and policy advice; and capacity-building to support the implementation of the ECE norms and standards in countries with economies in transition. Moreover, the implementation of the core strategy will contribute not only to economic integration in the region as a whole, but also to a reduction in disparities and the prevention of the emergence of new dividing lines in Europe. The normative work of ECE will promote greater regulatory compatibility among ECE member States throughout the region. Furthermore, it will have a positive impact on the rest of the world, as many ECE-developed agreements and standards (in particular in the areas of transport, trade facilitation, statistics, energy and environmental protection) become more accepted for use in countries of other regions.
- 19.5 In line with ECE reform, more attention will be given to promoting intersectoral activities, particularly in the areas of transport and environment, trade and transport, energy and transport, and energy and environment. Particular attention will also be paid to the gender dimension of development as it relates to the agreed conclusions on women in the economy adopted at the ECE regional 10-year review of the Beijing Declaration and Platform for Action.
- 19.6 The policy debate and exchange of experiences within ECE will facilitate the identification of best policies for strengthening subregional and regional integration and monitoring progress made in the region on achieving the internationally agreed development goals, including the Millennium

- Development Goals, as well as supporting their effective implementation within the work areas of ECE.
- 19.7 Technical cooperation activities of ECE will focus on Eastern Europe, the Caucasus and Central Asia, and South-Eastern Europe. They will aim at improving national capacity to implement legally binding instruments and other regional standards and finding solutions to transboundary problems. Following the new impetus provided by the International Conference on Strengthening Subregional Economic Cooperation in Central Asia and the Future Role of the United Nations Special Programme for the Economies of Central Asia, held in Astana in May 2005, the United Nations Special Programme for the Economies of Central Asia, jointly executed with the Economic and Social Commission for Asia and the Pacific (ESCAP), will be further strengthened in each of the agreed areas of cooperation.
- 19.8 ECE will continue to integrate the security dimension in its relevant subprogrammes with a view to contributing to the review and implementation of those commitments that correspond to its areas of expertise, as agreed in the memorandum of understanding with the Organization for Security and Cooperation in Europe and in the workplan set up between the two organizations.
- 19.9 The expected accomplishments and indicators of achievement for ECE in the biennium 2008-2009 are set out, together with required resources, under the programme of work, as well as under executive direction and management.
- 19.10 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown in table 19.1 below (see also the output information for each subprogramme).

- 19.11 The overall resources required for the biennium 2008-2009 for this section amount to \$57,110,000, before recosting, reflecting: (a) a net decrease of \$83,600 under post resources for subprogramme 3, Statistics, which relates to the proposed establishment of one post for an Associate Statistician at the P-2 level to support the strengthening of the methodological work called for in the ECE reform programme and the implementation of methodological activities related to price statistics and short-term economic statistics, and the proposed abolition of one General Service (Other level) post; and (b) a net increase of \$83,600 under non-post resources, which relates mainly to an overall increase in official travel of staff in order to meet increasing demand to participate in environment-related meetings in locations where the use of the Internet or audio/videoconference facilities is not possible; and supplies and materials, furniture and equipment in order to replace obsolete office automation equipment, offset by an overall decrease under consultants and experts.
- 19.12 During the biennium 2008-2009, the projected extrabudgetary resources of \$23,745,200, or 29.3 per cent of the total resources available to this programme, will be utilized to supplement resources from the regular budget, primarily to finance the organization of workshops, seminars and symposiums for the countries in the region, particularly in countries with economies in transition; to support the implementation of the conventions on the environment adopted within the framework of ECE; to support cooperative agreements signed by various ECE member States on

- transport; and to share best practices and stimulate contacts in various other areas of the programme of work.
- 19.13 Pursuant to General Assembly resolution 58/269, resources identified for monitoring and evaluation would amount to \$951,800, funded entirely from the programme budget for the biennium 2008-2009, reflected under executive direction and management and under each subprogramme. Findings from evaluations are used to readjust the direction and methods of work and in the preparation of results statements for the programme performance report.
- In its resolution 60/248, the General Assembly welcomed the workplan on reform of ECE adopted by the Commission in its decision of 2 December 2005, decided that the Commission should implement the adopted measures outlined in its decision and, to that end, requested the Secretary-General to allocate the requisite resources within section 19 of the programme budget for the biennium 2006-2007. Pursuant to the recommendations of the Commission, as subsequently endorsed by the Economic and Social Council, the Secretariat revised the programme of work of the Commission for the biennium 2006-2007 during 2006 and redistributed the approved post and non-post resources among the revised subprogrammes. Programmatic adjustments proposed in the report of the Secretary-General on revisions to the biennial programme plan for 2006-2007 (A/61/125) were considered by the Assembly in its resolution 61/235. The redistribution of resources was carried out within the level of resources approved by the Assembly at its sixtieth session under section 19 of the programme budget for 2006-2007. Those redeployments were subsequently reported in the context of the first performance report on the budget (A/61/593) and approved by the Assembly in its resolution 61/253.
- 19.15 The percentage distribution of resources under this section would be as shown in table 19.2.

- 19.16 Unlike the practice for the other regional commissions, resources for administration and conference and general services for ECE are not included under its own programme budget. The resources associated with those requirements are administered by the United Nations Office at Geneva and are consolidated under section 28E, Administration, Geneva, in respect of administration and general services, and under section 2, General Assembly and Economic and Social Council affairs and conference management, in respect of conference-servicing costs.
- In order to permit a comparison among regional commissions while at the same time maintaining the advantages of integrated management and avoiding duplication of effort, the estimated resources (at current rates) to be provided by the United Nations Office at Geneva to ECE for general, administrative, conference and library services during the biennium 2008-2009 are summarized in table 19.5.

A. Policymaking organs

- 19.18 The governance structure of ECE has been reformed in accordance with the workplan on ECE reform (E/ECE/1434/Rev.1) adopted by ECE member States on 2 December 2005 and by the General Assembly in its resolution 60/248. The Commission, which reports to the Economic and Social Council, provides strategic direction to the work of the ECE Secretariat and is a forum for high-level policy dialogue on economic development for the region. It meets once every two years for three working days. In the intersessional period, the Executive Committee is entrusted with the implementation of the overall policy set by the Commission. It meets regularly and as often as necessary to perform its governance role through, inter alia, the review and approval of programmes of work and subsidiary structures of the sectoral committees, ensuring coherence and coordination among subprogrammes. The eight sectoral committees act as governing bodies for the eight subprogrammes: the Committee on Environmental Policy (subprogramme 1); the Inland Transport Committee (subprogramme 2); the Conference of European Statisticians (subprogramme 3); the Committee on Economic Cooperation and Integration (subprogramme 4); the Committee on Sustainable Energy (subprogramme 5); the Committee on Trade, (subprogramme 6); the Timber Committee (subprogramme 7); and the Committee on Housing and Land Management (subprogramme 8). These bodies meet for two to three days annually to provide guidance to ECE on work relating to their respective sectors.
- The Group of Experts on the Programme of Work has been disbanded as a result of the reform of 19.19 the governance structure of ECE. The Executive Committee has assumed its responsibilities in accordance with the workplan on ECE reform.

B. Executive direction and management

Resource requirements (before recosting): \$5,875,300

- 19.20 In order to fulfil its responsibilities in terms of executive direction and overall management of ECE, the Office of the Executive Secretary has the following functions:
 - (a) To feed the debate on the strategic direction of ECE and to develop a forward-looking strategy for adjusting ECE activities to respond to emerging and foreseeable needs and priorities of its member States;
 - (b) To coordinate and prepare the ECE biennial programme plan and priorities and the programme budget; to ensure efficient and inclusive processes for the planning, monitoring and evaluation of the subprogrammes; and to encourage the undertaking of self-evaluations and the use of evaluation findings;
 - (c) To service meetings of the Commission and its Executive Committee, including preparation of relevant documentation; to ensure an interface between the Executive Committee and the bureaux of the sectoral committees; and to ensure follow-up to decisions of the Commission and the Executive Committee;
 - (d) To ensure and report on the implementation of the ECE reform programme and the resolutions and decisions of the General Assembly and the Economic and Social Council that are relevant to the work of ECE, including the regional follow-up to United Nations global conferences and events, in accordance with the Commission's role as a regional outpost of the United Nations, pursuant to Economic and Social Council resolution 1998/46;
 - (e) To contribute, in close cooperation with the other regional commissions, to the United Nations reform discussion and implementation, in particular in relation to improving systemwide coherence in United Nations development work;
 - (f) To cooperate and coordinate with other international organizations and United Nations departments, in particular within the framework of relevant inter-agency coordination processes;
 - (g) To contribute to relevant reports of the Secretary-General for the General Assembly, the Economic and Social Council and other bodies and to provide other inputs requested by United Nations Headquarters;
 - (h) To foster relationships with member Governments and keep abreast of the needs and priorities of ECE member States;
 - (i) To foster gender mainstreaming in ECE subprogrammes;
 - (j) To provide guidance and direction for the work of the secretariat; to increase transparency and interdivisional cooperation; to improve the process for budget preparation and human resources management; to ensure compliance with the Performance Appraisal System; to issue guidelines and directives for the substantive divisions of the secretariat; and to provide clearance for ECE publications and key documents prepared for the sectoral committees and other subsidiary bodies of ECE.
- 19.21 The executive direction and management component comprises the Office of the Executive Secretary, the Information Unit and the Programme Planning, Monitoring and Evaluation Unit. The Information Unit, which comprises one P-4 post and one General Service (Other level) post, works to increase the visibility of ECE and to increase knowledge about and use of ECE products through the dissemination of information about its activities to the ECE membership and the public at

large. Such dissemination is carried out through various channels, such as publications, the Internet and contact with the media.

19.22 The objectives and expected accomplishments under executive direction and management are expected to be achieved on the assumption that: (a) there are no major shortfalls in funding that might affect the assistance provided, the recruitment of staff and the timely delivery of products and services; (b) there is active participation and support of ECE member States; and (c) other organizations are willing and able to cooperate.

Outputs

- 19.23 During the biennium, the following outputs will be delivered:
 - (a) Servicing of intergovernmental and expert bodies (regular budget):

 - a. Parliamentary documentation: documents for meetings of the Executive Committee (60); documents for meetings relating to global conferences or to cross-sectoral issues (2); documents for the biennial session of the Commission, including one on gender and the economy (8); report of the biennial session of the Commission (1); documents for meetings on regional progress in the follow-up to the 10-year review of the Beijing Declaration and Platform for Action (5);
 - (b) Other substantive activities (regular budget):
 - (i) Recurrent publications: catalogue of ECE publications (2); Compendium of Legal Instruments, Norms and Standards (2); ECE annual report (2);
 - (ii) Non-recurrent publications: Women's Access to Economic and Financial Resources and their Role in Economic Growth in Central Asia and the South Caucasus (1);
 - (iii) Fact-finding missions: good offices and special missions, including on behalf of the Secretary-General (2);
 - (iv) Booklets, fact sheets, wallcharts, information kits: "UNECE Weekly"; "What UNECE Does for You" (2); video clip on ECE (2); other information materials (12);
 - (v) Press releases, press conferences: press conferences on ECE activities (2); press releases on ECE activities (2);
 - (vi) Technical material: maintenance of gender website (2); maintenance of website providing access to information and documents related to ECE as a whole (2);
 - (vii) Contribution to joint outputs: contribution of substantive inputs to various reports for the General Assembly, the Economic and Social Council and related bodies (2);
 - (c) Technical cooperation (regular budget and extrabudgetary): training courses, seminars and workshops: expert meetings on mainstreaming gender into economic policies (under the Special Programme for the Economies of Central Asia group on gender and economy, financed through an approved United Nations Development Account project as well as the ECE trust fund);
 - (d) Conference services, administration, oversight (regular budget):

- (i) Programme planning, budget and accounts: coordination and preparation of the ECE biennial programme plan and programme budget;
- (ii) Evaluations: promotion of the undertaking of self-evaluations and the use of evaluation findings;
- (iii) Preparation and administration of the programme of publications.

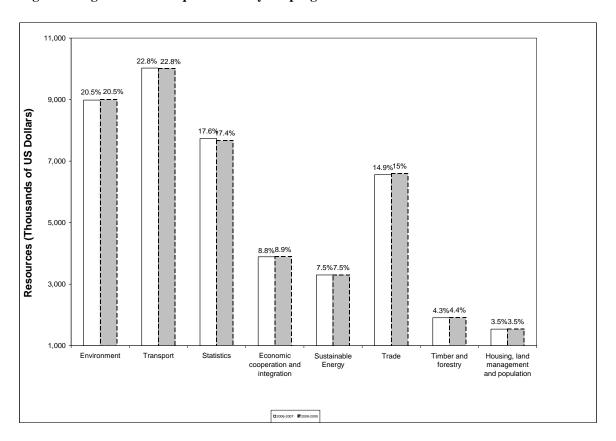

Subprogramme 1 **Environment**

Resource requirements (before recosting): \$9,002,800

19.25 The work under the subprogramme will be carried out by the Environment, Housing and Land Management Division. The programme of work has been formulated by drawing on subprogramme 1 of programme 16 of the biennial programme plan for the biennium 2008-2009. The work of the subprogramme will focus on: (a) implementing the results of environmental conferences, in particular the "Environment for Europe" Ministerial Conference, so as to better integrate environmental concerns in the formulation of policies at the national, regional and local levels and also in the cross-border dimension; (b) strengthening the implementation of ECE multilateral environmental agreements and assisting the Eastern European, Caucasian and Central Asian and South-Eastern European countries to apply them in practice; and (c) carrying out environmental performance reviews, in particular second reviews, in order to provide recommendations, advice and support to the ECE member countries with economies in transition to meet regional environmental standards.

19.28 The amount of \$9,002,800, reflecting an increase of \$17,200, is required for the continuation of 32 posts and related non-post resources comprising consultants and experts and travel of staff. The increase of \$17,200 under non-post resources reflects increased requirements for travel of staff in order to meet increasing demand to participate in environment-related meetings in locations where the use of the Internet or audio/videoconference facilities is not possible.

Subprogramme 2 Transport

Resource requirements (before recosting): \$10,019,000

19.29 The work under the subprogramme will be carried out by the Transport Division. The programme of work has been formulated by drawing on subprogramme 2 of programme 16 of the biennial programme plan for the biennium 2008-2009. The work of the subprogramme will aim at further updating and improving existing ECE legal instruments and recommendations governing inland transport in the region. The extension of the geographical scope of the ECE legal instruments on transport, particularly in the areas of vehicle construction, border crossing, transport of dangerous goods and road safety will be promoted. Increased attention will be given to the implementation of legal instruments and recommendations, including through subregional cooperation, capacitybuilding activities and advisory services. Subregional cooperation will be promoted and assistance will be provided in planning and developing road and rail transport infrastructures in Eastern and South-Eastern European, Caucasian and Central Asian countries. Furthermore, emphasis will be placed on subregional cooperation for the development of Euro-Asian transport links, including through landlocked developing countries, in cooperation with ESCAP, and of other transport infrastructures in Eastern and South-Eastern Europe, as well as on promoting transport links with Africa and the Middle East, including across the Mediterranean, in cooperation with the Economic Commission for Africa and the Economic and Social Commission for Western Asia.

19.32 The amount of \$10,019,000, reflecting a net decrease of \$4,900, is required for the continuation of 37 posts and related non-post resources comprising consultants and experts, travel of staff and contractual services. The net decrease of \$4,900 under non-post resources results from an increase of \$18,000 for travel of staff in order to meet increasing demand to participate in transport-related meetings, particularly those related to the development of transport infrastructure in Eastern Europe, the Caucasus and Central Asia, in locations where the use of the Internet or audio/videoconference facilities is not possible, fully offset by a decrease of \$22,900 for contractual services reflecting the increased use of in-house facilities for printing and the fact that the Road and Rail Censuses will not be produced in hard copy in 2008-2009, but will be made available electronically only.

19.33 The work under the subprogramme will be carried out by the Statistical Division. The work of the subprogramme will focus on developing international statistical standards and methodology and promoting their application through the production and dissemination of guidelines and best practices and on providing technical advice to assist national statistical offices in the implementation of these standards, in particular the ECE Fundamental Principles of Official Statistics. In addition, through its joint activities with the major players in the field of statistics, the subprogramme will continue to play a coordination role for the international statistical activities in the region. The amount of \$7,665,600, reflecting a net decrease of \$67,500, comprises: (a) \$7,530,000 for the continuation of 29 posts, reflecting a decrease of \$83,600 resulting from the proposed establishment of one Professional post, Associate Statistician, at the P-2 level, offset by the proposed abolition of one General Service (Other level) post; and (b) \$135,600 for non-post requirements, reflecting an increase of \$16,100, comprising requirements for consultants and experts (\$20,200) and for travel of staff (\$115,400). Subprogramme 6 Trade

19.45 The work under the subprogramme will be carried out by the Trade and Timber Division. The work of the subprogramme will aim at reducing barriers to trade in goods and services caused by differences in regulatory approaches and differences in the procedures, standards and documents used by governments and businesses for trade. More concretely, it will develop and promote: (a) simple, transparent and effective processes for global commerce; (b) a predictable, transparent and harmonized regulatory environment for commerce and business; and (c) trade in agricultural produce supported by agreed-upon, clear and easy-to-use commercial quality standards. 19.48 The amount of \$6,591,600, reflecting an increase of \$35,800, is required for the continuation of 24 posts and related non-post resources comprising consultants and experts, travel of staff, contractual services and supplies and materials. Subprogramme 7 Timber and forestry

Resource requirements (before recosting): \$1,911,900

19.49 The work under the subprogramme will be carried out by the Timber Section of the Trade and Timber Division. The programme of work has been formulated by drawing on subprogramme 7 of programme 16 of the biennial programme plan for the period 2008-2009. The subprogramme will focus on maintaining the monitoring and analysis functions of the subprogramme while strengthening the policy and cross-sectoral dimension, notably as regards institutions in countries with economies in transition, the sound use of wood, wood energy and illegal logging. Furthermore, it will provide regional inputs to global programmes, notably the Forestry Department of the Food and Agriculture Organization of the United Nations (FAO) and the United

Nations Forum on Forests. It will continue to work closely with the Ministerial Conference on the Protection of Forests in Europe.

19.53 The work under the subprogramme will be carried out by the Environment, Housing and Land Management Division. The programme of work has been formulated by drawing on subprogramme 8 of programme 16 of the biennial programme plan for the period 2008-2009. The work of the subprogramme will focus on analysing the existing housing situation, maintenance, renewal and new construction, reviewing housing policies and providing policy recommendations. It will carry out capacity-building activities at the national and local levels to contribute to efficient and transparent governance and improvement of the urban environment. It will also continue to support the upgrading of land and real estate systems in order to provide secure ownership in land, investment and other private and public rights in real estate. The subprogramme will organize information exchanges and meetings that assist countries in population-related policymaking and facilitate the implementation of the final documents of regional and global conferences on population issues. Regional cooperation in data collection and research on the determinants of demographic choices, ageing and gender relations will be promoted. This cooperation will contribute to capacity-building at the national level.

 - (vi) Facilitating the linking of ECE activities with the work of the relevant United Nations country teams, when appropriate;
 - (vii) Preparation of relevant inputs to the reports of the Secretary-General to the Economic and Social Council, the General Assembly and other intergovernmental bodies, as may be required by Headquarters.

Advisory Committee on Administrative and Budgetary Questions (A/60/7 and Corr.1)

The Committee welcomes the projected increase in internal printing planned for the 2006-2007 biennium and requests ECE to limit the use of external printing to exceptional cases. The Committee requests ECE to report on progress in this area in the proposed programme budget for the biennium 2008-2009 (para. V.50).

In view of the considerably large and modern printing facilities within the United Nations Office at Geneva, ECE printed publications are almost entirely produced internally. The same holds true for electronic CD-ROM publications, which are produced within the Office or even by ECE itself.

In 2008-2009, the use of external printing would be limited to those that cannot be done in-house, e.g., the printing of the OECD explanatory brochures for agricultural quality standards, which is proposed to be transferred from OECD to ECE, as requested in the ECE reform programme. The brochures come in the form of loose-leaf pages printed on high-quality paper with high-quality photos kept in loose-leaf binders of a non-standard size. The binders cannot be produced and printed in-house, and the non-standard high-quality paper has to be purchased externally.

Brief description of the recommendation

Action taken to implement the recommendation

Nevertheless, in the light of the recent investments in information and communications technology and videoconferencing infrastructure and the improved connectivity of United Nations offices worldwide, the Committee is of the opinion that resources for travel should be decreasing rather than increasing. It requests that all efforts be made to limit travel, to combine trips and to use alternative methods of communication whenever possible. Savings should be reported in the next performance report (para. V.51).

Travel is undertaken by ECE staff when the use of the Internet or audio/videoconference facilities is not possible. To the extent possible, missions are scheduled back-to-back to save on travel costs.

In 2006, ECE hosted 44 videoconferences (averaging 90 minutes each) and participated in 15 videoconferences hosted by the United Nations Conference on Trade and Development, compared with 34 organized in 2005 and 25 in 2004. Additionally, ECE staff regularly participated in videoconferences hosted by the United Nations Office at Geneva and by Headquarters (for meetings with the Office of Human Resources Management).

While there is no discernible reduction in the cost of travel, the use of information and communications technology infrastructure has contributed to maintaining these costs at a minimum.

The Committee welcomes requests ECE to report on the use of videoconferencing and other means of electronic communication in the proposed programme budget for the biennium 2008-2009 (para. V.52).

Please refer to action taken to address paragraph V.51 of the report of the Advisory Committee above.

The Committee points out that other commissions could benefit from the experience and expertise of ECE in formulating a common policy and standard methodology for monitoring and evaluation for all regional commissions. The Committee reiterates the need to actively exchange best practices, lessons learned and tools developed among the regional commissions (para. V.53).

Biennial evaluations of subprogramme performance by the sectoral committees are being introduced in ECE. ECE will share lessons learned with other regional commissions.

The Committee considers this type of "routine" budgeting method inappropriate for this object of expenditure, the budget for which should be determined on a case-by-case basis and limited to specific activities for which necessary expertise is not available in-house. The Committee requests that special attention be paid to this matter and that the United Nations regulations on the use of consultants be applied strictly (para. V.54).

Requirements for the use of consultants in ECE are reviewed on a case-by-case basis and are limited to instances in which no similar or equivalent expertise is available in-house, in accordance with the United Nations rules on the use of consultants.

Estimated requirements for consultancy in 2008-2009 reflect a decrease from \$443,400 to \$398,800 (or 10 per cent), as compared with the 2006-2007 appropriation.

Brief description of the recommendation

Action taken to implement the recommendation

The Committee urges ECE to vigorously pursue its efforts to raise extrabudgetary funds and to report on the progress and/or difficulties experienced in this area in the proposed programme budget for the biennium 2008-2009 (para. V.55).

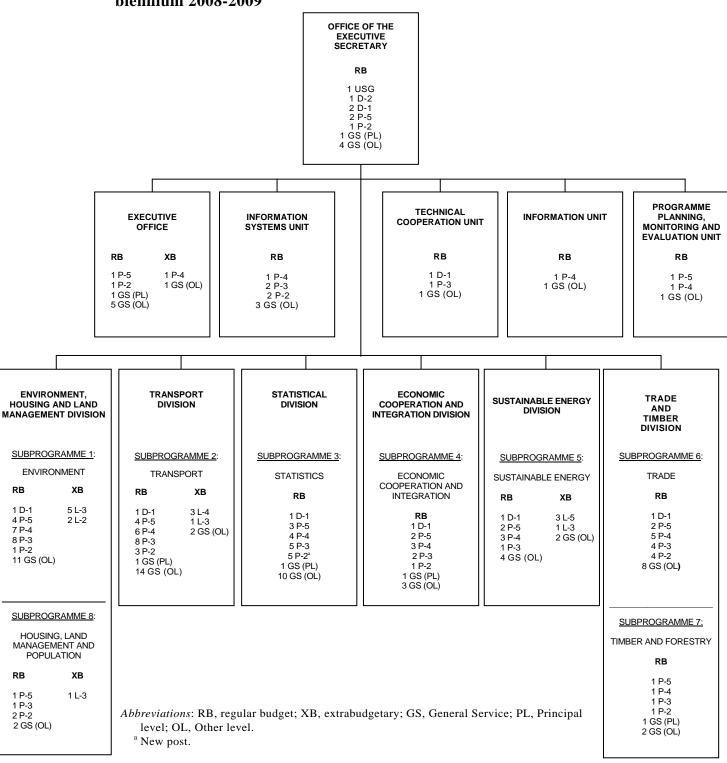
ECE will undertake a self-evaluation of its fund-raising activities in 2007 to decide whether an overall fund-raising strategy is necessary. Fund-raising efforts aimed at sectoral activities are usually addressed at the decentralized level, as divisions and regional advisers have better knowledge of and access to the institutions that are keen on supporting sector-based projects. Resource mobilization for cross-sectoral activities requires more coordinated interdivisional efforts and are normally carried out at the centralized level.

ECE has been successful in raising extrabudgetary funds in the current biennium. The estimated level of expenditures to be financed from extrabudgetary resources in 2006-2007 has been revised upward from some \$13.4 million reflected in the proposed programme budget for that biennium to \$23.4 million. In 2008-2009, extrabudgetary expenditures are currently projected at approximately \$23.7 million.

ECE strives to remain an attractive partner for donors. It limits its involvement to circumscribed areas of work where it has recognized expertise. Traditional donors recognize this and continue to contribute to projects they support. The problem, as previously pointed out, is to attract larger non-earmarked contributions. The fact that there are no developing countries in the ECE region makes it difficult for some donor countries to contribute.
