

Gratis personnel provided by Governments and other entities

Report of the Secretary-General

Summary

The present report is submitted in compliance with General Assembly resolutions 51/243 and 57/281 B and covers the period from 1 January 2006 to 31 December 2007.

The total number of type I and type II gratis personnel engaged in 2007 increased as compared with 2006. Interns continued to represent the majority of type I gratis personnel (86 per cent). In 2006 all type II gratis personnel, and in 2007 the majority of such personnel, were engaged by the Office for the Coordination of Humanitarian Affairs for emergency operations. In 2007, the Department of Peacekeeping Operations used nine type II gratis personnel for the monitoring of arms and armories in Nepal. For both type I and II gratis personnel, there was an improvement in geographic and gender representation during the reporting period.

The General Assembly is invited to take note of the present report.

I. Introduction

- 1. The present report is submitted pursuant to General Assembly resolutions 51/243 and 57/281 B, in which the Assembly requested the Secretary-General to provide a comprehensive report, on a biennial basis, on the use of gratis personnel. It updates the previous report (A/61/257/Add.1) and covers the period from 1 January 2006 to 31 December 2007. It continues with the methodology used in the previous report on gratis personnel. In order to allow for comparative analysis, data for each year are reported separately. In line with the request made by the General Assembly in its resolution 59/266 that the Secretary-General submit to it consolidated human resources reports, the present report is issued as an addendum to the report of the Secretary-General on the composition of the secretariat (A/63/310). The report on gratis personnel for the period from 1 January 2008 to 31 December 2009 will be submitted to the Assembly at its sixty-fifth session.
- 2. Gratis personnel are personnel provided to the Organization by Governments or other entities at no cost to the Organization. As explained in the first report of the Secretary-General on the subject (A/51/688 and Corr.1), certain categories of gratis personnel have long been established in the Organization and have a well-defined legal status and functions (associate experts, technical cooperation experts on non-reimbursable loans, and interns). These three categories constitute type I gratis personnel.
- In accordance with administrative instruction ST/AI/2000/9 on the United Nations internship programme, the purpose of the programme is threefold: (a) to provide a framework by which graduate and postgraduate students from diverse academic backgrounds may be assigned to United Nations offices, where their educational experience can be enhanced through practical work assignments; (b) to expose them to the work of the United Nations; and (c) to provide United Nations offices with the assistance of qualified students specialized in various professional fields. Associate experts, as explained in A/51/688 and Corr.1, are staff members at the junior professional level, subject to the provisions of the Charter and Staff Regulations; they cannot seek or accept instructions concerning the performance of their duties from any Government, including their own, or from any authority outside the Organization; conditions of service are specified in the letter of appointment, under the 200 series of the Staff Rules for technical assistance project personnel, on a fixed-term appointment, generally for a period not exceeding four years. The Secretary-General, in the same report, defined technical cooperation experts as those whose services are accepted on a non-reimbursable-loan basis from Governments to assist in the execution of the technical cooperation programme of the United Nations. They have the status of independent contractors and are not staff members; the contractual relationship of such persons to the United Nations is established by a special service agreement; non-reimbursable-loan personnel for technical cooperation projects can be engaged for up to four years.
- 4. Other categories constituting type II gratis personnel were not regulated until the adoption by the General Assembly of its resolutions 51/243 and 52/234, which placed strict conditions on the acceptance of type II gratis personnel. Those conditions, which are set out in the administrative instruction on gratis personnel (ST/AI/1999/6), include the requirement that type II gratis personnel be accepted on an exceptional basis only, for two purposes: (a) to provide expertise not available within the Organization and for very specialized functions, or (b) to provide

temporary and urgent assistance in the case of new and/or expanded mandates of the organization.

5. The eight statistical tables contained in the annex to the present report provide detailed data on each type of gratis personnel for 2006 and 2007, broken down by nationality, gender, categories of gratis personnel, department, function and duration of service.

II. Type I gratis personnel used during 2006 and 2007

- 6. Tables 1 to 4 of the annex contain data on type I gratis personnel (associate experts, technical cooperation experts and interns).
- 7. Analysis of the statistical data shows a 10 per cent overall increase in the number of type I gratis personnel cumulatively engaged in 2007 (1,952) as compared with 2006 (1,767), which was due primarily to a nearly 10 per cent increase in the number of interns (from 1,516 in 2006 to 1,675 in 2007).
- 8. Interns continued to constitute the majority of type I gratis personnel 86 per cent of all type I gratis personnel in 2006 and 86 per cent in 2007. The number of associate experts also increased from 233 in 2006 to 252 in 2007, and the number of technical cooperation experts from 18 in 2006 to 25 in 2007.
- 9. A positive trend has been noted over the reporting biennium with respect to the geographical representation of this type of gratis personnel. The number of Member States represented among type I gratis personnel increased from 120 in 2006 to 125 in 2007. Over the past four years (2004 to 2007), the increase in geographical representation among all type I gratis personnel is even more evident: the number of Member States represented among technical cooperation experts more than doubled (from 6 in 2004 to 14 in 2007); among interns, it increased by 10 per cent (from 110 in 2004 to 122 in 2007) and among associate experts by 21 per cent (from 23 Member States represented in 2004 to 28 in 2007).
- 10. Representation of women among type I gratis personnel remained high, increasing slightly from 61 per cent in 2004 and 60 per cent in 2006 to 64 per cent in 2007.
- 11. Four departments used more than 20 associate experts: the United Nations Office on Drugs and Crime (UNODC) (34 in 2006, 41 in 2007), the Office of the High Commissioner for Human Rights (OHCHR) (29 in 2006, 38 in 2007), the Office for the Coordination of Humanitarian Affairs (31 in 2006, 34 in 2007) and the Department of Economic and Social Affairs (25 in 2006, 21 in 2007). Those offices have a large field presence, and, given their technical cooperation portfolios, the use of associate experts is in line with donors' priorities in development cooperation. Technical cooperation experts were used by three departments in 2006 (the Department of Economic and Social Affairs, the Economic Commission for Europe (ECE) and the Economic and Social Commission for Asia and the Pacific (ESCAP)) and by four departments in 2007 (the Department of Economic and Social Affairs, ECE, ESCAP and the United Nations Office at Nairobi). A total of 31 departments or offices used interns in 2006 compared with 35 in 2007, with, respectively, 11 and 15 departments using 50 or more interns each.

12. There was an increase in the total number of associate experts working in the Secretariat in 2006 and 2007 when counted on a cumulative basis (taking account of both those who separated and were appointed each year). Throughout the reporting period (and during the previous biennium), their number remained relatively stable at 157 on average (2004 — 147; 2005 — 162; 2006 — 151; 2007 — 169). Similarly, the average number of new contracts issued annually for associate experts was stable, averaging 67 (2004 — 69; 2005 — 65; 2006 — 57; 2007 — 79).

III. Type II gratis personnel used during 2006 and 2007

- 13. Tables 5 to 8 of the annex provide cumulative data on type II gratis personnel.
- 14. The number of type II gratis personnel engaged during the reporting period by the Office for the Coordination of Humanitarian Affairs almost doubled (from 23 in 2006 to 45 in 2007). That increase resulted from a rise in 2007 in the number of small and mid-size emergencies, flash appeals and activities related to the coordination of emergency relief managed by the Office. Also, in 2007 the Department of Peacekeeping Operations used nine individuals for the monitoring of the management of arms and of the ceasefire agreements in the United Nations Mission in Nepal (UNMIN). It should be noted, however, that, compared with the previous biennium, the use of type II gratis personnel by the Office for the Coordination of Humanitarian Affairs decreased by nearly half (from 85 in 2004 to 45 in 2007).
- 15. The average duration of service of type II gratis personnel decreased from 4.3 months per year in 2006 to 3.9 months per year in 2007.
- 16. Type II gratis personnel engaged in 2006 represented six Member States. The 54 type II gratis personnel engaged in 2007 represented 10 Member States. There was an increase in the number of women among the type II gratis personnel engaged from 30 per cent of all such personnel in 2006 to 41 per cent in 2007. Over the past four years, the representation of women among this type of gratis personnel has increased, from 26 per cent in 2004 to 41 per cent in 2007.

IV. Conclusions

17. The increase in the number of gratis personnel in 2007 was accompanied by a decrease in the average duration of their service. The largest increase was in the number of interns. The data on the use of both types of gratis personnel during the

It also called for the establishment of standby arrangements with interested Governments and intergovernmental organizations for access to those relief capacities and resources, including personnel and funding support for the United Nations Disaster Assessment and Coordination Team.

reporting period show a sustained improvement in terms of geographical and gender representation and an increase in the number of engagements.
