

Financing of the United Nations peacekeeping forces in the Middle East: United Nations Disengagement Observer Force

Report of the Fifth Committee

I. Introduction

- 1. At its 2nd plenary meeting, on 19 September 2008, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-third session the item entitled "Financing of the United Nations peacekeeping forces in the Middle East: United Nations Disengagement Observer Force" and to allocate it to the Fifth Committee.
- 2. The Fifth Committee considered the item at its 43rd and 55th meetings, on 14 May and 25 June 2009. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/63/SR.43 and 55).
- 3. For its consideration of the item, the Committee had before it the following documents:
- (a) Report of the Secretary-General on the financial performance of the United Nations Disengagement Observer Force for the period from 1 July 2007 to 30 June 2008 (A/63/521);
- (b) Report of the Secretary-General on the budget for the United Nations Disengagement Observer Force for the period from 1 July 2009 to 30 June 2010 (A/63/686 and Corr.2);
- (c) Related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/746/Add.2).





II. Consideration of draft resolution A/C.5/63/L.61

- 4. At its 55th meeting, on 25 June, the Committee had before it a draft resolution entitled "Financing of the United Nations Disengagement Observer Force" (A/C.5/63/L.61), submitted by the representative of Sweden and Vice-Chairman of the Committee on the basis of informal consultations.
- 5. At the same meeting, the Committee adopted draft resolution A/C.5/63/L.61 without a vote (see para. 6).

III. Recommendation of the Fifth Committee

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

Financing of the United Nations Disengagement Observer Force

The General Assembly,

Having considered the reports of the Secretary-General on the financing of the United Nations Disengagement Observer Force¹ and the related report of the Advisory Committee on Administrative and Budgetary Questions,²

Recalling Security Council resolution 350 (1974) of 31 May 1974 regarding the establishment of the United Nations Disengagement Observer Force and the subsequent resolutions by which the Council extended the mandate of the Force, the latest of which was resolution 1848 (2008) of 12 December 2008,

Recalling also its resolution 3211 B (XXIX) of 29 November 1974 on the financing of the United Nations Emergency Force and of the United Nations Disengagement Observer Force and its subsequent resolutions thereon, the latest of which was resolution 62/264 of 20 June 2008,

Reaffirming the general principles underlying the financing of United Nations peacekeeping operations, as stated in General Assembly resolutions 1874 (S-IV) of 27 June 1963, 3101 (XXVIII) of 11 December 1973 and 55/235 of 23 December 2000,

Mindful of the fact that it is essential to provide the Force with the financial resources necessary to enable it to fulfil its responsibilities under the relevant resolutions of the Security Council,

- 1. Requests the Secretary-General to entrust the Head of Mission with the task of formulating future budget proposals in full accordance with the provisions of General Assembly resolutions 59/296 of 22 June 2005, 60/266 of 30 June 2006 and 61/276 of 29 June 2007, as well as other relevant resolutions;
- 2. Takes note of the status of contributions to the United Nations Disengagement Observer Force as at 30 April 2009, including the contributions outstanding in the amount of 17.0 million United States dollars, representing some 1 per cent of the total assessed contributions, notes with concern that only forty-five Member States have paid their assessed contributions in full, and urges all other Member States, in particular those in arrears, to ensure the payment of their outstanding assessed contributions;
- 3. Expresses its appreciation to those Member States that have paid their assessed contributions in full, and urges all other Member States to make every possible effort to ensure payment of their assessed contributions to the Force in full;
- 4. *Expresses concern* at the financial situation with regard to peacekeeping activities, in particular as regards the reimbursements to troop contributors that bear

additional burdens owing to overdue payments by Member States of their assessments;

- 5. Also expresses concern at the delay experienced by the Secretary-General in deploying and providing adequate resources to some recent peacekeeping missions, in particular those in Africa;
- 6. *Emphasizes* that all future and existing peacekeeping missions shall be given equal and non-discriminatory treatment in respect of financial and administrative arrangements;
- 7. Also emphasizes that all peacekeeping missions shall be provided with adequate resources for the effective and efficient discharge of their respective mandates;
- 8. Reiterates its request to the Secretary-General to make the fullest possible use of facilities and equipment at the United Nations Logistics Base at Brindisi, Italy, in order to minimize the costs of procurement for the Force;
- 9. *Requests* the Secretary-General to ensure that proposed peacekeeping budgets are based on the relevant legislative mandate;
- 10. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions,² subject to the provisions of the present resolution, and requests the Secretary-General to ensure their full implementation;
- 11. Recalls paragraph 10 of its resolution 62/264 and paragraph 12 of its resolution 62/265 and decides not to endorse the recommendation contained in paragraph 32 of the report of the Advisory Committee on Administrative and Budgetary Questions;
- 12. *Takes note* of paragraph 31 of the report of the Advisory Committee on Administrative and Budgetary Questions;
- 13. *Requests* the Secretary-General to ensure the full implementation of the relevant provisions of its resolutions 59/296, 60/266 and 61/276;
- 14. *Also requests* the Secretary-General to take all necessary action to ensure that the Force is administered with a maximum of efficiency and economy;
- 15. Further requests the Secretary-General, in order to reduce the cost of employing General Service staff, to continue efforts to recruit local staff for the Force against General Service posts, commensurate with the requirements of the Force;

Financial performance report for the period from 1 July 2007 to 30 June 2008

- 16. *Takes note* of the report of the Secretary-General on the financial performance of the Force for the period from 1 July 2007 to 30 June 2008;³
- 17. *Decides* to appropriate to the Special Account for the United Nations Disengagement Observer Force the amount of 2,517,200 dollars for the maintenance of the Force for the period from 1 July 2007 to 30 June 2008, in addition to the

amount of 41,586,600 dollars already appropriated for the Force for the same period under the provisions of General Assembly resolution 61/287 of 29 June 2007;

Financing of the additional appropriation for the period from 1 July 2007 to 30 June 2008

- 18. Also decides, taking into account the amount of 41,586,600 dollars already apportioned under the terms of its resolution 61/287, to apportion among Member States the additional amount of 2,517,200 dollars for the maintenance of the Force for the period from 1 July 2007 to 30 June 2008, in accordance with the levels updated in General Assembly resolution 61/243 of 22 December 2006, and taking into account the scale of assessments for 2007 and 2008, as set out in its resolution 61/237 of 22 December 2006;
- 19. Further decides that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraph 18 above, their respective share in the Tax Equalization Fund of the amount of 79,000 dollars, representing the additional staff assessment income for the Force for the period from 1 July 2007 to 30 June 2008;

Budget estimates for the period from 1 July 2009 to 30 June 2010

20. Decides to appropriate to the Special Account for the United Nations Disengagement Observer Force the amount of 47,020,300 dollars for the period from 1 July 2009 to 30 June 2010, inclusive of 45,029,700 dollars for the maintenance of the Force, 1,656,700 dollars for the support account for peacekeeping operations and 333,900 dollars for the United Nations Logistics Base;

Financing of the appropriation

- 21. Also decides to apportion among Member States the amount of 47,020,300 dollars at a monthly rate of 3,918,358 dollars, in accordance with the levels updated in General Assembly resolution 61/243, and taking into account the scale of assessments for 2009, as set out in its resolution 61/237, and for 2010,⁴ subject to a decision of the Security Council to extend the mandate of the Force;
- 22. Further decides that, in accordance with the provisions of its resolution 973 (X), there shall be set off against the apportionment among Member States, as provided for in paragraph 21 above, their respective share in the Tax Equalization Fund in the amount of 1,543,400 dollars, comprising the estimated staff assessment income of 1,338,000 dollars approved for the Force for the period from 1 July 2009 to 30 June 2010, the prorated share of 172,500 dollars of the estimated staff assessment income approved for the support account and the prorated share of 32,900 dollars of the estimated staff assessment income approved for the United Nations Logistics Base;
- 23. Decides that, for Member States that have fulfilled their financial obligations to the Force, there shall be set off against their apportionment, as provided for in paragraph 21 above, their respective share of other income in the total amount of 2,076,200 dollars in respect of the financial period ended 30 June

2008, in accordance with the levels updated in its resolution 61/243, and taking into account the scale of assessments for 2008, as set out in its resolution 61/237;

- 24. Also decides that, for Member States that have not fulfilled their financial obligations to the Force, there shall be set off against their outstanding obligations their respective share of other income in the total amount of 2,076,200 dollars in respect of the financial period ended 30 June 2008, in accordance with the scheme set out in paragraph 23 above;
- 25. *Emphasizes* that no peacekeeping mission shall be financed by borrowing funds from other active peacekeeping missions;
- 26. *Encourages* the Secretary-General to continue to take additional measures to ensure the safety and security of all personnel under the auspices of the United Nations participating in the Force, bearing in mind paragraphs 5 and 6 of Security Council resolution 1502 (2003) of 26 August 2003;
- 27. *Invites* voluntary contributions to the Force in cash and in the form of services and supplies acceptable to the Secretary-General, to be administered, as appropriate, in accordance with the procedure and practices established by the General Assembly;
- 28. *Decides* to include in the provisional agenda of its sixty-fourth session, under the item entitled "Financing of the United Nations peacekeeping forces in the Middle East", the sub-item entitled "United Nations Disengagement Observer Force".
