- 15.1 The biennial programme plan is based on the medium-term strategic and institutional plan for the period 2008-2013, which was approved by the Governing Council of the United Nations Human Settlements Programme (UN-Habitat) at its twenty-first session in its resolution 21/2 of 20 April 2007. The plan sharpens the programme's focus, promotes alignment and coherence and strengthens the catalytic role of UN-Habitat for the coordinated implementation of the Habitat Agenda and internationally agreed development goals relevant to human settlements.
- 15.2 Responsibility for human settlements is vested in UN-Habitat, which serves as the focal point for the implementation of the programme within the United Nations system. The current mandate of UN-Habitat is derived from the twin goals of the Habitat Agenda, resulting from the United Nations Conference on Human Settlements (Habitat II), namely, adequate shelter for all and sustainable human settlements development in an urbanizing world. The mandate of the programme is also derived from resolution 3327 (XXIX), in which the General Assembly established the United Nations Habitat and Human Settlements Foundation; resolution 32/162, in which the Assembly established the United Nations Centre for Human Settlements (Habitat); and resolution 56/206, by which the Assembly elevated the United Nations Centre for Human Settlements to the United Nations Human Settlements Programme. UN-Habitat is guided by its Governing Council, which reports every two years to the Assembly through the Economic and Social Council, and by the Committee of Permanent Representatives in Nairobi, which serves as a formal intersessional body. Important recent mandates are contained in the Declaration on Cities and Other Human Settlements in the New Millennium, which was adopted by the Assembly in its resolution S-25/2, other internationally agreed development goals, including those contained in the United Nations Millennium Declaration (resolution 55/2), such as the target of achieving a significant improvement in the lives of at least 100 million slum-dwellers by the year 2020, and the outcomes of the major United Nations conferences and international agreements since 1992, such as the target on water and sanitation of the Johannesburg Plan of Implementation. The

aforementioned two targets were subsequently reaffirmed by the General Assembly in the 2005 World Summit Outcome (resolution 60/1), which highlighted slum prevention as a priority issue. Additional mandates come from relevant legislative bodies regarding Agenda 21 (chaps. 7, 21 and 28) and relevant resolutions of the UN-Habitat Governing Council.

- 15.3 The world urban population is currently expanding at the rate of about 70 million per year. About 95 per cent of all urban growth is taking place in developing countries, where 1 billion people live in overcrowded and life-threatening slums. The current rate of urban growth is almost equal to the rate of slum formation in some developing countries, particularly in sub-Saharan Africa and some parts of Asia. Slums are the most visible manifestation of urban poverty and of the failure of sectorally focused policies and institutions in providing for the basic needs of people. In many cities, slums are no longer just marginalized neighbourhoods; they are the dominant type of human settlement characterizing many cities in the developing world. The main challenges are chaotic urban expansion, inadequate housing, lack of secure tenure, uncertain employment and lack of basic services, especially safe water and sanitation. Rapid urbanization in most developing countries is characterized by a deterioration in shelter conditions for the urban poor, while conflicts and disasters compound the daunting task of creating sustainable human settlements.
- 15.4 Central to meeting the challenge of urban poverty is the replacement of policies that foster social and physical exclusion with policies that recognize and respect the right of all, especially women, youth, people living in poverty and those belonging to vulnerable and disadvantaged groups, including disabled people, to an adequate standard of living for themselves and their families, including adequate food, clothing, housing, water and sanitation, and the continuous improvement of living conditions. In consultation and cooperation with Governments, UN-Habitat develops and strengthens mechanisms for monitoring the impact of human settlements policies and programmes on the lives and livelihoods of women, men, youth and children in cities, especially those in low-income areas and slums.
- 15.5 The vision of the medium-term strategic and institutional plan, on which the biennial programme plan is based, is to set the necessary conditions for concerted international and national efforts to stabilize the growth of slums and to set the stage for a subsequent reduction in and reversal of the number of slum-dwellers. The plan identified five substantive focus areas: effective advocacy, monitoring and partnerships; promotion of participatory urban planning, management and governance; promotion of pro-poor land and housing; environmentally sound basic infrastructure and services; and strengthened human settlements finance systems. Excellence in management was identified as a sixth focus area, which supports the implementation of others. The five substantive focus areas form the basis of an enhanced normative and operational framework consisting of a strengthened partnership and networking strategy and an integrated programme of activities at the global, regional, national and local levels. The medium-term strategic and institutional plan will be implemented at the global and national levels, in line with approved United Nations reforms, including support for enhanced harmonization, coherence and alignment of international development assistance. UN-Habitat will contribute to the improved coordination of activities through its strengthened participation in the United Nations country teams.
- 15.6 The activities of UN-Habitat for the period 2010-2011 are based on the implementation phases specified in the action plan of the medium-term strategic and institutional plan: the kick-start phase (2008), the roll-out phase (2009-2010), and the upscaling phase (2011-2013). In 2010, UN-Habitat will complete the rolling out of those activities of the plan that were begun in 2009, while the upscaling of those activities will commence in 2011.
- 15.7 The UN-Habitat programme of work consists of four strongly interlinked subprogrammes, namely: shelter and sustainable human settlements development; monitoring the Habitat Agenda; regional and technical cooperation; and human settlements financing. The interlinkages are reflected in the

close cooperation among the subprogrammes, with the global campaign on sustainable urbanization providing an entry point for all work programme activities. Enhanced collaboration among UN-Habitat units and sections will occur through an integrative and synergetic approach to better serve the Member States, particularly through the enhanced normative and operational framework concept. A strengthened programme review committee will also ensure the sharing of information among different subprogrammes, branches and sections in house and promote alignment and cohesion of the programmes.

- 15.8 While each subprogramme takes the lead in the implementation of specific focus areas, all are expected to contribute to each focus area. In keeping with resolution 19/2 adopted by the Governing Council in May 2003, the strategy of UN-Habitat in meeting its mandates rests on four pillars that correspond to its four subprogrammes:
- (a) Advocacy of agreed norms for improving the lives of poor people, particularly slum-dwellers, and building the capacity of central Governments and local authorities, using as a primary vehicle the global campaign on sustainable urbanization (subprogramme 1, Shelter and sustainable human settlements development);
 - (b) Information generation and knowledge management for assessing progress made in implementing the Habitat Agenda and monitoring conditions and trends in human settlements, with a particular focus on slum formation and the living conditions of slum-dwellers (subprogramme 2, Monitoring the Habitat Agenda);
 - (c) Operational activities focusing on technical assistance and capacity-building to test methods and concepts to be scaled up and transferred and to provide feedback to policymakers at all levels (subprogramme 3, Regional and technical cooperation);
 - (d) Facilitating pro-poor financing of housing and urban infrastructure and services that contribute to sustainable human settlements development and the improvement of the living conditions of slum-dwellers (subprogramme 4, Human settlements financing).
- 15.9 UN-Habitat will continue to mainstream cross-cutting issues comprising the gender perspective, partnerships and youth and to promote the empowerment of women in human settlements activities. The programme's efforts in promoting women's access to shelter were strengthened by the General Assembly in the 2005 World Summit Outcome (resolution 60/1, para. 58), which asserts women's free and equal right to own and inherit property and to security of tenure.
- 15.10 The work of UN-Habitat is concentrated in developing countries, countries with economies in transition and countries in need of effective post-conflict and post-disaster recovery and reconstruction. As the focal point for the implementation of the human settlements programme within the United Nations system, UN-Habitat will collaborate and cooperate with other United Nations organizations. Consultations have taken place among concerned entities of the Executive Committee on Economic and Social Affairs at the thematic cluster level. Those consultations are expected to lead to better coordination and more collaborative work among programmes in major common work areas of the United Nations Secretariat in the social and economic sectors. Outside the United Nations, UN-Habitat will also cooperate with Governments, local authorities, international financial institutions, regional development banks, the private sector and other Habitat Agenda partners. A significant mechanism for global advocacy on human settlements issues and cooperation with Governments and Habitat Agenda partners is the World Urban Forum, which is held every two years to address pressing issues in the area of human settlements. The fifth session of the World Urban Forum will be held in 2010.

- 15.11 The issue of publications has been reviewed as part of the programme of work. It is anticipated that recurrent and non-recurrent publications will be issued as shown in table 15.3 and as summarized in the output information for executive direction and management and for each subprogramme. The reduction in the number of publications reflects the medium-term strategic and institutional plan to sharpen programme focus and promotes alignment and coherence.

- 15.12 The overall resources required for the biennium 2010-2011 for this section amount to \$20,975,000 before recosting, reflecting an increase of \$173,400, or 0.8 per cent. The proposed changes, reflected in table 15.5 below, can be summarized as follows:

- (a) A net increase of \$16,200 under executive direction and management relates to non-post requirements covering the cost of maintenance of computer equipment in line with service-level agreements, partly offset by reduced requirements for furniture and equipment;
- (b) A net increase of \$151,400 under programme of work is the result of:
 - (i) An increase of \$149,900 in both post and non-post requirements under subprogramme 1 due to the proposed establishment of one post for a Training and Capacity-Building Officer at the P-3 level to support advocacy on networking and partnerships by integrating principles of sustainable urbanization in education programmes, curricula and learning modules;
 - (ii) A net decrease of \$26,300 in non-post requirements under subprogramme 2 because of a reduction in requirements for furniture and equipment, partly offset by additional requirements for travel;
 - (iii) A net decrease of \$7,500 in non-post requirements under subprogramme 3 as a result of a reduction in requirements for furniture and equipment, partly offset by additional requirements for maintenance of computer equipment and travel;
 - (iv) A net increase of \$35,300 in post requirements under subprogramme 4 arising from the reclassification of one Human Settlements Officer post from the P-4 to the P-5 level as Chief of Water and Sanitation, Section 2 (Asia and the Pacific and Latin America and the Caribbean), in order to strengthen programme delivery in the areas of access to and provision of adequate clean drinking water, improved sanitation and waste management in the Asia and the Pacific and Latin America and the Caribbean regions, partly offset by reduced requirements for furniture and equipment;
- (c) An increase of \$5,800 under programme support in non-post requirements.

- 15.13 During the biennium 2010-2011, expected extrabudgetary resources amount to \$334,502,100, or 94.0 per cent of the total resources available to the programme. The extrabudgetary resources are used to finance technical cooperation activities, which are a central feature of the programme. The amount reflects an increase of \$33,594,600 over the estimates for 2008-2009, owing mainly to a projected increase in country-level activities to support post-disaster and post-crisis relief,

recovery and reconstruction efforts and to strengthen the capacity of programme support in connection with, among other things, the International Public Sector Accounting Standards and enterprise resource planning. The existing arrangements for intergovernmental review and management of those extrabudgetary funds provide for the Governing Council of UN-Habitat to approve biennial budgets governing the use of such extrabudgetary resources.

- 15.14 The monitoring and evaluation functions of UN-Habitat are managed and coordinated by the Monitoring and Evaluation Unit. The Unit, which is organizationally placed under executive direction and management, is tasked with the responsibility of improving monitoring and evaluation systems and coordinating monitoring and evaluation activities of UN-Habitat towards planned objectives, realizing the expected accomplishments and improving the organizational accountability of UN-Habitat. It is estimated that for the biennium 2010-2011, resources for the conduct of monitoring and evaluation would amount to \$3,549,400, representing 53 work-months of staff in the Professional and higher category and 32 work-months in the General Service category, of which \$307,900 would be funded from the regular budget and \$3,241,500 from extrabudgetary resources.
- 15.15 The estimated distribution of resources under this section for the biennium 2010-2011 is as shown in table 15.4.

A. Policymaking organs

Resource requirements (before recosting): \$55,800

- 15.16 In its resolution 56/206, the General Assembly transformed the Commission on Human Settlements into the Governing Council of UN-Habitat, a subsidiary body of the Assembly, with effect from 1 January 2002. The Governing Council reports to the Assembly through the Economic and Social Council and provides overall policy guidance, direction and supervision to UN-Habitat. The Committee of Permanent Representatives to UN-Habitat was also transformed into an intersessional subsidiary body of the Governing Council. The objectives, functions and responsibilities of the Governing Council are set out in Assembly resolution 32/162 and in paragraph 222 of the Habitat Agenda, which was adopted at Habitat II.
- 15.17 The Governing Council is composed of 58 Member States, which have a membership term of four years. It holds its regular sessions biennially at the headquarters of UN-Habitat, in Nairobi. During the sessions, the Governing Council reviews the biennial programme of work of UN-Habitat, the budget of the United Nations Habitat and Human Settlements Foundation and the operational activities carried out by UN-Habitat. The sessions bring together representatives of Member States as well as Habitat Agenda partners, which comprise local authorities, non-governmental organizations, the private sector, the Global Parliamentarians on Habitat, women's groups, Youth for Habitat, trade unions, professionals and researchers, foundations and academies of science. The

Committee of Permanent Representatives normally meets eight times during a biennium, while its two working groups hold approximately 72 meetings in the two-year period. The Governing Council, the Committee of Permanent Representatives and the Committee's two working groups are serviced by the secretariat of the Governing Council under the Office of External Relations.

- 15.18 The provision of \$55,800 covers overtime requirements for substantive servicing of the meetings of the Governing Council of UN-Habitat (\$45,300) and hospitality requirements during its biennial sessions (\$10,500).

B. Executive direction and management

Resource requirements (before recosting): \$4,423,200

- 15.19 Executive direction and management falls under the responsibility of the Executive Director and includes the Deputy Executive Director, the Information Services Section, the Monitoring and Evaluation Unit, the Resource Mobilization Unit and the UN-Habitat liaison offices in New York, Geneva and Brussels. The Executive Director provides overall direction in the management of the implementation of the organization's work programme, mandate and goals and in its relations with Member States, United Nations offices, programmes, funds, agencies and other partners in coordinating the system-wide implementation of the Habitat Agenda, the Millennium Declaration targets and other relevant mandates.
- 15.20 During the biennium, the Executive Director will coordinate, drive, monitor and assess the implementation of activities outlined in the biennial work programme. The executive direction and management component is expected to lead and contribute to the focus area on excellence in management through the consolidation of a series of strategic and institutional changes focusing on programmatic alignment and coherence, improved knowledge and results-based management systems, holding managers accountable for results and supporting the role of governing bodies, including the Committee of Permanent Representatives, in reviews of programme performance.
- 15.21 In line with the medium-term strategic and institutional plan, UN-Habitat will place special emphasis on enhancing public awareness of and expanding knowledge on urbanization and urban poverty issues and trends through advocacy activities. The Global Campaign on Sustainable Urbanization, the fifth session of the World Urban Forum and the twenty-third session of the Governing Council will form an integral part of the advocacy role of UN-Habitat in mainstreaming the Habitat Agenda and building awareness of the urbanization and urban poverty agenda.
- 15.22 The Resource Mobilization Unit will adopt a strategic and coherent approach for fund-raising in line with the priorities identified in the medium-term strategic and institutional plan. The Unit will

support the development of multi-year funding agreements. It will also enhance the catalytic role of UN-Habitat and its ability to respond to critical environmental and humanitarian emergencies by engaging with Member States and partners on funding needs and expanding partnerships and alliances between UN-Habitat and international and regional institutions to increase funding and investments for improving human settlements.

- 15.23 The Monitoring and Evaluation Unit is responsible for monitoring the implementation of the work programme and evaluating its relevance, efficiency and effectiveness. The Unit will strengthen results-based monitoring, evaluation and reporting systems, coordinate and support the development of evaluation plans and ensure the effective delivery of key strategic evaluations. The Integrated Monitoring and Documentation Information System will be used as a tool for self-evaluation. Efforts will be increased to capture results information at the expected accomplishment level throughout the biennium. The Unit will also provide guidance and support on all other internal and external evaluations and ensure that the findings contribute to improved programme performance, accountability, organizational learning and new programme planning. In addition, the Unit will monitor implementation of the medium-term strategic and institutional plan and provide feedback and regular progress reports to the Committee of Permanent Representatives, in line with Governing Council resolution 21/2, as well as guide and support the midterm evaluation of the implementation of the medium-term strategic and institutional plan in 2011.
- 15.24 During the biennium, the Information Services Section will provide robust press and media services and outreach through the planning and organization of major global, regional and national media and advocacy events, including World Habitat Day and the World Urban Forum. As a result of the new branding strategy, the biennium will see targeted marketing of UN-Habitat publications and new products to strengthen partnerships. Knowledge management systems, especially Intranet-based tools, will be further strengthened. In order to enhance global awareness of issues related to human settlements, the Section will spearhead and support all advocacy activities, including those related to the Global Campaign on Sustainable Urbanization, resource mobilization and partnership-building.
- 15.25 The UN-Habitat liaison offices in New York, Geneva and Brussels will continue to perform their functions of coordinating, harmonizing and representing the programme. The liaison offices will participate in the work of the General Assembly, the Economic and Social Council and other intergovernmental bodies and in interdepartmental and inter-agency meetings to provide substantive support in meetings and policy dialogues on human settlements, as well as to carry out advocacy and outreach activities.


- 15.28 The amount of \$3,844,200 for posts would provide for the continuation of 14 posts (8 in the Professional and higher category and 6 General Service and Local level), reflected in table 15.9.
- 15.29 The amount of \$579,000 for non-post resources, including an increase of \$16,200, would provide largely for other staff costs, travel of staff, general operating expenses and other operational requirements. The increase in non-post resources relates primarily to the cost of maintenance of computer equipment in line with service-level agreements, partly offset by the reduction in the requirements for furniture and equipment.
- 15.30 During the biennium 2010-2011, expected extrabudgetary resources amounting to \$21,434,000 would provide for 31 posts (20 in the Professional and higher category and 11 General Service and Local level), as reflected in table 15.9, and non-post resources for travel of staff, consultants, general operating expenses and other operational requirements. The amount reflects an increase of \$4,957,800 compared to the estimates for 2008-2009, which is primarily the result of the creation of the Office of External Relations, the consolidation of UN-Habitat humanitarian affairs activities in the Geneva office, increasing the organization's information and communication capacity and the overall strengthening of the management and administrative services of the Executive Office, as well as a projected increase in the reimbursement of administrative support costs for services, payable from the extrabudgetary funds of UN-Habitat, provided by the United Nations Office at Nairobi.

- 15.35 The amount of \$5,575,800 for posts, reflecting an increase of \$145,300, would provide for the continuation of 22 posts (15 in the Professional and higher category and 7 Local level), as reflected in table 15.12, and for the establishment of one new post for a training and capacity-building officer at the P-3 level to support the advocacy component of the medium-term strategic and institutional plan by integrating principles of sustainable urbanization in education programmes, curricula and learning modules. The amount of \$598,800 in non-post resources reflects a net increase of \$4,600 to cover the requirements of the proposed additional post and to provide overall requirements for consultants and experts, travel of staff, contractual services, general operating expenses and other operating requirements.

- 15.36 During the biennium 2010-2011, expected extrabudgetary resources amounting to \$27,228,700, reflecting an increase of \$4,719,200, would provide for 36 posts (22 in the Professional and higher category and 14 General Service and Local level), as reflected in table 15.12, and the non-post resources to carry out operational projects and other substantive activities. The increase in resources is mainly to support programme delivery in the focus areas on participatory urban planning and governance and pro-poor land and housing, which include global programmes on secure tenure, housing and property rights, land and property administration, urban environmental management, urban governance, including decentralization, disaster prevention and management, safer cities, climate change mitigation and studies on building and construction technology that need to be evaluated against carbon emissions.

Subprogramme 2 Monitoring the Habitat Agenda

Resource requirements (before recosting): \$5,691,700

- 15.37 The responsibility for subprogramme 2 is vested in the Monitoring and Research Division. The core work of the subprogramme falls within the focus area on effective advocacy, monitoring and partnerships set out in the medium-term strategy and institutional plan. In terms of substantive content, the work of the subprogramme is cross-cutting and contributes to all the other substantive focus areas of the plan.
- 15.38 The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 2 of programme 12 of the strategic framework for the period 2010-2011.

- 15.41 The amount of \$5,059,500 would provide for the continuation of 23 posts (14 in the Professional and higher category and 9 Local level), as reflected in table 15.14. The amount of \$632,200 in non-post resources, reflecting a decrease of \$26,300, would provide mainly for consultants and experts, travel of staff, contractual services, general operating expenses and other operational requirements. The net decrease of \$26,300 is due mainly to reduced requirements under furniture and equipment, partly offset by an increase in other operational requirements.
- 15.42 During the biennium 2010-2011, expected extrabudgetary resources amounting to \$27,265,800, reflecting an increase of \$3,806,400, would provide for the continuation of 34 posts (22 in the Professional and higher category and 12 Local level), as reflected in table 15.14, and non-post resources to support the implementation of the focus area of the medium-term strategic and institutional plan on effective advocacy, monitoring and partnerships, which would include strengthening strategic partnerships, including with youth groups, as well as promoting and monitoring women's empowerment and gender mainstreaming in the area of human settlements.

Subprogramme 3 Regional and technical cooperation

Resource requirements (before recosting): \$1,748,400

- 15.43 Responsibility for the subprogramme is vested in the Regional and Technical Cooperation Division. To achieve the objective, UN-Habitat combines normative and operational functions. The normative functions include setting standards, proposing norms and principles and providing examples of best practices and good policies built on experience gained at the country level. In implementing the medium-term strategic and institutional plan, the Division will focus on all five substantive focus areas, namely, effective advocacy, monitoring and partnerships; promotion of participatory urban planning, management and governance; promotion of pro-poor land and housing; environmentally sound basic urban infrastructure and services; and strengthened human settlement finance systems at the country and regional levels through the enhanced normative and operational framework.
- 15.44 The subprogramme will be implemented in accordance with the strategy set out in subprogramme 3 of programme 12 of the strategic framework for the period 2010-2011.

- 15.47 An amount of \$1,580,600 for posts would provide for the continuation of five posts (4 in the Professional and higher category and 1 Local level), as reflected in table 15.16. The amount of \$167,800 in non-post resources, reflecting a decrease of \$7,500, would provide for consultants and experts, travel of staff, general operating expenses and other operational costs. The net decrease is due mainly to reduced requirements for furniture and equipment, partly offset by additional requirements for other operational costs.
- 15.48 During the biennium 2010-2011, expected extrabudgetary resources amounting to \$188,668,200, reflecting an increase of \$22,589,500, would provide for 46 posts (35 in the Professional and higher category and 11 General Service and Local level), as reflected in table 15.16, and non-post resources to support the implementation of all five focus areas of the medium-term strategic and institutional plan at the country level through technical assistance, capacity-building and implementation of demonstration projects in close cooperation with the United Nations country teams and the UN-Habitat programme managers to contribute to the visibility of human settlements issues and promote their mainstreaming in the United Nations development assistance frameworks, poverty reduction strategy papers and other national development policy documents.

Subprogramme 4 Human settlements financing

Resource requirements (before recosting): \$2,536,900

- 15.49 The responsibility of this subprogramme is vested in the Human Settlements Financing Division, which serves as the institutional anchor for the activities of the United Nations Habitat and Human Settlements Foundation. The Foundation is dedicated to working with Member States and domestic and international financial institutions to mobilize resources for affordable housing, water and sanitation and related infrastructure initiatives. The approach is to leverage existing local and international investments in those sectors, together with existing community savings, so as to attract private sector capital at a far greater scale of investment. In the implementation of the medium-term strategic and institutional plan, the Human Settlements Financing Division will take the lead on the focus areas on environmentally sound basic urban infrastructure and services and on strengthening human settlements finance systems as the principal areas of work and relate them to all the other focus areas.
- 15.50 The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 4 of programme 12 of the strategic framework for the period 2010-2011.

- 15.51 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) there will be continued financial commitment and support from international and regional development banks, bilateral development cooperation agencies and international donor facilities to strengthen the Foundation; (b) there will be support among Member States and domestic financial institutions at the country level to develop financial mechanisms for mobilizing domestic capital for slum upgrading; and (c) there will be political will to overcome institutional barriers and identify modalities for effective partnerships that result in financial commitments for both shelter and local-level infrastructure, especially for water and sanitation, in order to make a serious impact on the very large deficit in such provisions, which is holding back economic growth in developing countries.

Outputs

- 15.53 The amount of \$2,329,700 for posts, reflecting an increase of \$44,700, would provide for the continuation of nine posts (7 in the Professional and higher category and 2 Local level), as reflected in table 15.18. The increase is due to the proposed reclassification of one Human Settlements Officer post from the P-4 to the P-5 level as Chief of Water and Sanitation, Section 2 (Asia and the Pacific and Latin America and the Caribbean), in order to strengthen programme delivery in the areas of drinking water, sanitation and waste management. The incumbent would be responsible for planning and overseeing operations in Asian and Latin American countries related to implementation of the work programmes. The amount of \$207,200, reflecting a decrease of \$9,400, in non-post resources would provide primarily for travel of staff, general operating expenses and other operational requirements. The decrease is due mainly to the reduced requirements for furniture and equipment.
- 15.54 During the biennium 2010-2011, expected extrabudgetary resources amounting to \$50,996,600, would provide for 21 posts (13 in the Professional and higher category and 8 Local level), as reflected in table 15.18, and non-post resources earmarked mostly for field activities. The amount reflects a decrease of \$8,720,200 from the estimates for 2008-2009, due mainly to a reduction in project activities, slightly offset by the cost of one additional post. The extrabudgetary resources would support the implementation of the focus areas of the medium-term strategic and institutional plan on environmentally sound basic infrastructure and strengthening human settlements financing, which would involve working closely with partners to develop and apply innovative financial mechanisms for mobilizing resources for affordable and pro-poor housing and related environmentally sound infrastructure and services and to implement the innovative four-year pilot programme on experimental reimbursable seeding operations for low-income housing and infrastructure, as well as supporting the work on the Water for African Cities programme, with a special focus on the Lake Victoria Region Water and Sanitation Initiative.

D. Programme support

Resource requirements (before recosting): \$344,400

- 15.55 The implementation of the programme of work will be supported through a number of services, including human resources planning, financial management and programme planning and coordination. Programme support services are provided by the Programme Support Division, programme management officers in the regional offices of UN-Habitat and the Division of Administrative Services of the United Nations Office at Nairobi.

15.56 The amount of \$338,600 for post resources would provide for the continuation of one post at the P-4 level, as reflected in table 15.19. The new requirements of \$5,800 for non-post resources would provide for general operating expenses and other operational requirements.

15.57 During the biennium 2010-2011, expected extrabudgetary resources amounting to \$18,908,800 would provide for 59 posts (27 in the Professional and higher category and 32 Local level), as reflected in table 15.19, and non-post resources for travel of staff, consultants, general operating expenses and other operational requirements. The amount reflects an increase of \$6,241,900 from the estimate for 2008-2009, mainly to strengthen the capacity of the organization in the following areas: improving administrative efficiency, accountability and good governance and supporting the effective implementation in programmes and field projects of the enterprise resource planning system in support of the focus area on excellence in management.

The Board had recommended that the Administration coordinate with the United Nations Office at Nairobi to review the receivables due and request prompt payment from UNDP (para. 15).

Implemented. UN-Habitat recovered the full amount of the receivables from UNDP in January 2008.

The Board had recommended that UN-Habitat set up specific funding for end-of-service and after-service health insurance liabilities (para. 45).

Accepted. The General Assembly, by its resolution 61/264, decided to revert to the question of the funding for after-service health insurance for the United Nations at its sixty-third session. The Secretary-General's report on the proposed funding strategy for the United Nations is under preparation for submission to the Assembly. It is the intention of UN-Habitat to take appropriate action on the funding of its after-service health insurance liabilities, consistent with decisions to be made by the Assembly in respect of funding those liabilities for the United Nations.

The Board had recommended that UN-Habitat comply with the applicable regulation relative to consultants and service contracts (para. 78).

Implemented. UN-Habitat has examined several possible legal options and has established a new contractual agreement covering its operations in Afghanistan, a post-conflict environment, to address the concerns raised by the Board.

Office of Internal Oversight Services

In order to ensure sound financial and budget management in future technical cooperation projects, UN-Habitat should, in consultation with the United Nations Office at Nairobi, develop a procedures manual for financial and budgetary control of projects which outlines the respective responsibilities of UN-Habitat and the United Nations Office at Nairobi (AA2000/250/01^a).

Implemented. A draft operations manual was shared with the Office of Internal Oversight Services (OIOS), which closed the recommendation in February 2009.

To ensure that consultative boards are created only when required and to assist UN-Habitat divisions in establishing and operating consultative boards in a uniform manner, UN-Habitat should create policies and procedures dealing with when a consultative board is required, formulating the goals and objectives, how to establish them, criteria for

UN-Habitat is currently reviewing its delegation of authority systems and practices as part of its medium-term strategic and institutional plan. 
