- 18.1 The mandate of the Economic and Social Commission for Asia and the Pacific (ESCAP), which is to promote economic and social development in the Asian and Pacific region by fostering cooperation between its members and associate members, is derived from Economic and Social Council resolutions 37 (IV) and 414 (XIII), by which the Commission was established. The mandate of the Commission was subsequently elaborated in various resolutions adopted by the General Assembly, the Economic and Social Council and the Commission itself. In particular, the Commission, in the Shanghai Declaration, contained in its resolution 60/1, emphasized the need for regional cooperation and capacity-building to meet development challenges in an era of globalization and, in the Almaty Declaration: commemorating the sixtieth anniversary of the United Nations Economic and Social Commission for Asia and the Pacific, contained in its resolution 63/1, underscored its role as a regional development centre in providing an effective response to the changing needs of the countries in the Asian and Pacific region.
- 18.2 Asia and the Pacific is a region of diversity and disparity, which presents a mixed picture in terms of progress towards the achievement of the Millennium Development Goals. Based on overall figures, the region is the most dynamic and economically vibrant in the world. Trade and investment, which have grown exponentially, have contributed to lifting more than 300 million people out of extreme poverty. At the current rate of progress, the region is expected to achieve universal primary education by 2015.
- 18.3 Despite such impressive progress, the region still accounts for over 60 per cent of the world's poor (641 million) and almost 70 per cent of the total number of people (over 1.9 billion) without access to basic sanitation. Over 250,000 women die each year during pregnancy and childbirth, and some 660 million people lack access to clean water. In a region rich in energy resources, 800 million people live without electricity. Environmental sustainability is also becoming an increasingly alarming issue in the region, which is responsible for 34 per cent of global greenhouse gas emissions and is home to 7 of the 15 major global emitters of such emissions. Worldwide, 74 per cent of the casualties caused by natural disasters take place in countries in Asia and the Pacific,

and 8 of the 10 countries in the world most frequently hit by natural disasters are located in the region.

- 18.4 The notable progress made in some social and economic areas masks persistent disparities among countries. Of particular concern are the least developed countries, landlocked developing countries and the countries in Central Asia and the Pacific. For example, the least developed countries have among the highest rates of child and maternal mortality in the world and are not making enough progress towards realizing the Millennium Development Goals of reducing poverty and hunger and expanding access to water and sanitation. While trade, transport and infrastructure continue to develop rapidly, in some parts of the region the development of infrastructure remains limited. Much work remains to be done to address the social and environmental impacts of such changes and deficiencies. In addition, further expansion of trade and regional integration is hampered by the multitude of bilateral and subregional trade agreements involving ESCAP member countries.
- 18.5 The Asian and Pacific region has witnessed rising inequalities over the past 15 years. Income disparities have led, inter alia, to serious social and environmental inequities. An increasing proportion of the poor in the region live in areas in which the environment is under stress. In most countries, the poorest one fifth of the population has a rate of access to sanitation that is less than 35 per cent of that of the richest fifth. The high levels of inequality are diminishing growth prospects and eroding social cohesion in the region.
- 18.6 Within this regional context, the overall objective of the programme will be to promote inclusive and sustainable economic and social development in Asia and the Pacific, with a particular focus on supporting member States in achieving the internationally agreed development goals, including the Millennium Development Goals.
- 18.7 Acting in its dual role as a regional arm of the United Nations and as part of the institutional landscape in Asia and the Pacific, the Commission will continue to pursue the key objectives shared by all of the regional commissions, namely, to (a) foster economic integration at the subregional and regional levels; (b) promote the regional implementation of the internationally agreed development goals, including the Millennium Development Goals; and (c) support regional sustainable development by helping to bridge economic, social and environmental gaps among member States and subregions, including through trade and transport. In order to achieve those objectives, all of the regional commissions will continue to generate multilateral dialogue, knowledge-sharing and networking and work together to promote intraregional and interregional cooperation, both among themselves and through collaboration with other relevant organizations.
- 18.8 The preparation of the strategic framework for the biennium 2010-2011 benefited from the outcome of the review of the Commission's conference structure, as mandated by the Commission in its resolutions 58/1, 61/1 and 63/3. The review, which was facilitated by the Working Group on the Conference Structure of the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission, collected views from the full membership of ESCAP through survey questionnaires and a series of evaluations of past intergovernmental meetings conducted under the ESCAP conference structure. In addition, the review took into account the recommendations of an inspection carried out by the Office of Internal Oversight Services (E/ESCAP/64/30) and a series of evaluations of ESCAP, including an external evaluation undertaken in mid-2006, which was submitted to the Commission at its sixty-third session. The recommendations from the review reaffirmed the value of the Commission as an inclusive platform for the countries of the region to exchange views, experiences and information on major policies dealing with economic, social and environmental issues of common interest. The review also pointed to the need for ESCAP to sharpen the focus of its work, to strive for a more balanced approach to addressing the needs of its membership and to enhance cooperation with international and regional organizations, including those within the United Nations system, to

ensure greater synergies and complementarity in its work. The Commission, at its sixty-fourth session held in Bangkok in April 2008, adopted a new conference structure (see resolution 64/1) and endorsed the strategic framework for the period 2010-2011 with the aim of promoting a more responsive programme structure to address the emerging needs of the Asian and Pacific region. The strategic framework was subsequently endorsed by the General Assembly at its sixty-third session.

- 18.9 While many subprogrammes of the strategic framework for the period 2010-2011 reflect continuity in the direction of work already undertaken by ESCAP in the biennium 2008-2009, as a result of the above-mentioned review, a number of areas will receive greater emphasis during the period 2010-2011 in order to reflect the repositioning of the Commission as a leading regional hub for promoting cooperation among member States for the achievement of inclusive and sustainable economic and social development in Asia and the Pacific and in response to the Commission's call for the implementation of the recommendations contained in the external evaluation undertaken by ESCAP in 2006.
- 18.10 The focus of the objectives and expected results of the eight mutually supportive subprogrammes has been sharpened by the addition of a clear regional dimension in order to demonstrate the value added by the work of ESCAP.
- 18.11 Poverty reduction and sustainable development will serve as overarching goals and will be integrated into the work of all subprogrammes of ESCAP. In that regard, renewed efforts will be made to mainstream gender concerns across all subprogrammes and to promote gender equality and the concerns of vulnerable groups as central to poverty reduction and inclusive and sustainable development.
- 18.12 The Commission will strive to become a leading regional authority on policy analysis of macroeconomic, social and environmental fundamentals for inclusive and sustainable development, including by analysing the range of good practices in the region in order to promote regional cooperation and the development of tools and strategic policy options to assist member States in making informed decisions on development challenges. Analysis of trends affecting the region's development and progress in the implementation of global mandates will facilitate common approaches to development issues and consensus-building, including regional inputs to global processes.
- 18.13 Based on its normative and analytical work, ESCAP will carry out technical cooperation to facilitate subregional and regional cooperation in areas of priority to member States, building on the work of the United Nations country teams in addressing key development challenges, for example, through pioneering innovative solutions and South-South cooperation.
- 18.14 Greater priority will be accorded to mainstreaming the concerns of countries with special needs in the Asian and Pacific region, including the 32 least developed countries, landlocked developing countries, small island developing States and countries with economies in transition, in order to promote their economic and social prosperity. Given the extreme diversity and geographical spread of the region, efforts will be made to increase the depth and impact of the work of the Commission in each of its subregions and to enhance the monitoring and evaluation of its work in these areas.
- 18.15 In view of the vulnerability of the Asian and Pacific region to disasters, greater priority will be accorded to work on disaster risk reduction and to the need for regional cooperation and inter-agency partnerships in addressing them.
- 18.16 Given the strength of ESCAP as the regional forum in Asia and the Pacific with universal membership and convening authority for intergovernmental dialogue, in particular on transboundary development issues, the Commission will work in close cooperation and

coordination with other multilateral entities and specialized agencies, in particular the Asian Development Bank and subregional organizations.

- 18.17 The Commission will continue to engage with the Executive Committee on Economic and Social Affairs as a key global body for ensuring coherence on common thematic areas among entities of the United Nations Secretariat working in the social and economic sectors. Such consultations were held with regard to improving coordination and collaborative work in the formulation of the strategic framework for the period 2010-2011.
- 18.18 In support of system-wide coherence, ESCAP, as chair of the United Nations regional coordination mechanism in Asia and the Pacific, will give special attention to strengthening coordination, cooperation and synergies among United Nations and other intergovernmental entities working at the regional level. This will include working closely with entities of the United Nations Development Group, including the Regional Director's team, to enhance the analytical, normative and operational linkages of the United Nations system in order to strengthen the Organization's development pillar.
- 18.19 The expected accomplishments and indicators of achievement for the Commission in the biennium 2010-2011 are detailed, together with resources, under the programme of work, as well as under executive direction and management and programme support.
- 18.20 To enable ESCAP to ensure that the programme of work is fully aligned with the priorities of its membership and also cost-effective and efficient, a rigorous internal review of the existing and planned activities was undertaken. Through this review, which was complemented by the intensive intergovernmental review undertaken by the Advisory Committee of Permanent Representatives designated by the Members of the Commission, a series of committees and the Commission, outputs that are more responsive to the emerging needs of the ESCAP membership were established.
- 18.21 A review was undertaken of the value added by publications to the achievement of the expected accomplishments of each subprogramme under the programme of work. As a result of the review, the proposed publications programme of ESCAP for the period 2010-2011 has been streamlined in line with the strategic repositioning of the Commission. Priority is accorded to the quality of publications and their relevance to global and regional priorities. Further, the publications programme for the 2010-2011 biennium proposes an increase in the use of more cost-efficient and effective means of disseminating ESCAP policy analysis and research outcomes, such as technical papers for more targeted audience groups and an e-working paper series on development issues. The streamlining exercise has resulted in the overall reduction of recurrent and non-recurrent publications, such as shown below in summary and described in the outputs under each subprogramme.

- 18.22 The overall resources required for the biennium 2010-2011 for this section amount to \$94,625,800 before recosting, reflecting a net increase of \$2,210,000 (or 2.4 per cent), of which \$2,542,500

relates to net changes in connection with: (a) the delayed impact of 14 posts established in the biennium 2008-2009 (\$2,639,400); and (b) a net reduction under non-post resources relating to the discontinuation of non-recurrent provisions approved in 2008-2009, and other reductions resulting from reduced requirements for consultancy services, furniture and equipment, and grants and contributions (\$429,400). The net growth shown in table 18.5 can be summarized as follows:

- (a) The net decrease of \$796,800 under executive direction and management relates to:
  - (i) The outward redeployment of five posts from the former Least Developed Countries Coordination Unit to the programme of work, partly offset by the inward redeployment of one P-4 post from subprogramme 6, Social development, which is intended to strengthen and mainstream the priority needs of the least developed countries, landlocked developing countries and small island developing States into the relevant subprogrammes, in response to the mandate reflected in Commission resolution 64/1 (\$760,100);
  - (ii) Reductions under non-post resources resulting from the decentralization of resources previously allocated to the former Least Developed Countries Coordination Unit (\$36,700);
- (b) The net increase of \$3,426,700 under programme of work relates to:
  - (i) A decrease of \$785,200 under subprogramme 1, Macroeconomic policy and development, resulting from: the outward redeployment of four posts to other subprogrammes, partly offset by the inward redeployment of one P-3 post from executive direction and management to mainstream the poverty dimension in response to the Commission's request to promote poverty reduction as an overarching objective across all relevant subprogrammes (\$672,700); and reductions under non-post resources resulting from the mainstreaming to other subprogrammes of resources related to poverty reduction activities (\$112,500);
  - (ii) A net increase of \$365,000 under subprogramme 2, Trade and investment, resulting from: the inward redeployment of one P-5 post from the Asian and Pacific Centre for Transfer of Technology (APCTT) under subprogramme 5, Information and communications technology and disaster risk reduction, to implement the decision of the Commission to shift the work of APCTT to subprogramme 2 in order to emphasize the promotion of transfer of technologies for increased regional and international trade, particularly through South-South cooperation, and to take into account its new mandate, as contained in Commission resolution 64/3, to promote the transfer of clean technologies, particularly renewables for energy security and sustainable development in Asia and the Pacific (\$353,000); and a net increase for non-post resources, particularly consultancy services, for the organization of one additional expert group meeting, partly offset by decreased requirements for travel of staff in view of fewer trips planned to the meetings of the relevant bodies of the United Nations and other organizations related to trade and investment, and external printing under contractual services due to the increased use of electronic publishing and dissemination of publications (\$12,000);
  - (iii) A decrease of \$32,000 under subprogramme 3, Transport, resulting from reductions under non-post resources, particularly for consultancy services, owing to more reliance on expertise within the secretariat; travel of staff, mainly due to the discontinuation of travel related to tourism activities as a result of the revision of the programme structure of ESCAP; and external printing, due to the reduction in the number of hard-copy publications (\$32,000);

- (iv) A net increase of \$248,700 under subprogramme 4, Environment and development, resulting from: the delayed impact of one P-3 post established in the biennium 2008-2009, the inward redeployments of one P-4 post from subprogramme 1, Macroeconomic policy and inclusive development, and one Local-level post from executive direction and management, partly offset by the outward redeployment of one P-3 post to subprogramme 5, Information and communications technology and disaster risk reduction (\$276,900); and reductions under non-post resources, particularly for consultancy services, owing to more reliance on expertise within the secretariat; and external printing, due to the increased use of electronic publishing and dissemination of publications (\$28,200);
- (v) A net increase of \$196,700 under subprogramme 5, Information and communications technology and disaster risk reduction, resulting from: the inward redeployment of one P-3 post from subprogramme 4, Environment and development, and three Local-level posts, one from executive direction and management and two from programme support, partly offset by the outward redeployment of one P-5 post to subprogramme 2, Trade and investment, to strengthen the research and administrative support to this subprogramme and thereby address a mandate reflected in Commission resolution 64/2, on regional cooperation in the implementation of the Hyogo Framework for Action 2005-2015, and the Commission's decision to relocate the work of APCTT to subprogramme 2, Trade and investment (\$214,100); and net reductions under non-post resources, particularly for consultancy services owing to more reliance on expertise within the secretariat, and for external printing, due to the increased use of electronic publishing and dissemination of publications, partly offset by increased requirements for travel of staff due additional travel planned to be undertaken in connection with disaster risk reduction activities (\$17,400);
- (vi) A net increase of \$224,700 under subprogramme 6, Social development, resulting from: the inward redeployment of one P-3 post from executive direction and management, and one P-2 and one Local-level posts from subprogramme 1, Macroeconomic policy and inclusive development, partly offset by the outward redeployment of one P-4 post to executive direction and management to support the mainstreaming of gender equality in the work of the Commission and to ensure a more systematic and multisectoral approach to addressing poverty issues, as emphasized by the Commission in its resolution 64/1 (\$256,800); and reductions under non-post resources, particularly for consultancy services owing to more reliance on expertise within the secretariat, external printing, due to the increased use of electronic publication and dissemination of publications, and travel of staff in view of a reduction in the representational travel planned to be undertaken (\$32,100);
- (vii) A net increase of \$787,200 under subprogramme 7, Statistics, resulting from: (the inward redeployment of one P-5 post from executive direction and management, one P-4 post from subprogramme 1, Macroeconomic policy and inclusive development, and one Local-level post from programme support to strengthen the analytical work of the secretariat, particularly in connection with reporting on the status of the least developed and landlocked developing countries in meeting the internationally agreed development goals, including the Millennium Development Goals (\$764,500); and a net increase under non-post requirements, resulting from increased requirements for consultancy services in connection with the preparation of a flagship publication and for an additional expert group meeting, and travel of staff, partly offset by decreased requirements for external printing under contractual services in view of the decisions to limit the production of the Statistical Yearbook to one issue per biennium (\$22,700);

- (viii) A net increase of \$2,421,600 under subprogramme 8, Subregional activities for development, resulting from: the delayed impact of 11 posts established in the context of General Assembly resolution 63/260, on development-related activities, effective as at 1 January 2009, to be deployed to four of the five newly established components under the subprogramme, namely, the subregional offices for the Pacific, East and North-East Asia, North and Central Asia, and South and South-West Asia, as a result of the revision of ESCAP programme structure (\$2,402,100); and a net increase under non-post resources to reflect increased requirements for the newly established subregional offices (\$19,500);
- (c) The net decrease of \$419,900 under programme support relates to: the outward redeployment of three Local-level posts, namely, two to subprogramme 5, Information and communications technology and disaster risk reduction, and one to subprogramme 7, Statistics, to strengthen the research support capacity in relation to the secretariat's normative and analytical work, including capacity related to disaster risk reduction in particular (\$195,200); and net reductions under non-post resources (\$224,700).
- 18.23 During the biennium 2010-2011, the projected extrabudgetary resources of \$30,077,000 will be utilized to complement resources from the programme budget to provide practical, on-the-ground experience which will feed into the core normative and analytical work of ESCAP.
- 18.24 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation will amount to \$3,526,045, representing a total of 265 work-months of at the D-2/D-1, P-5, P-4/P-3, and P-2 levels and 150 work-months at the Local level, comprised of \$3,228,508 from regular budget resources and reflected under each subprogramme, and \$297,537 from extrabudgetary resources, including \$149,900 of non-post resources.
- 18.25 The distribution of post and non-post resources is summarized in tables 18.4 to 18.6.

## A. Policymaking organs

### *Resource requirements (before recosting): \$1,080,800*

- 18.26 The Commission, which in 2009 consists of 53 members and 9 associate member countries and territories, provides overall direction to the work of the secretariat and reports to the Economic and Social Council. It holds regular annual sessions, each of which comprises a senior officials' segment followed by a ministerial segment, to discuss and decide on important issues pertaining to inclusive and sustainable economic and social development in the region. An informal session among the heads of delegations may be organized during the ministerial segment of each Commission session, for which simultaneous interpretation will be provided.
- 18.27 As a result of Commission resolutions 61/1 and 64/1, on the restructuring of its conference structure, the Commission now has eight subsidiary bodies, namely the Committee on Macroeconomic Policy, Poverty Reduction and Inclusive Development, the Committee on Trade and Investment, the Committee on Transport, the Committee on Environment and Development, the Committee on Information and Communications Technology, the Committee on Disaster Risk Reduction, the Committee on Social Development and the Committee on Statistics. The total duration of the sessions of legislative organs amounts to a maximum of 54 meeting days per biennium (for the annual sessions of the Commission and 8 biennial sessions of the Committees). In addition to the subsidiary bodies of the Commission, the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission may have a maximum of 12 formal meetings per calendar year, to advise the Executive Secretary and to liaise between the Commission and the secretariat. Meetings of the Commission and its committees are normally held at the United Nations Conference Centre in Bangkok. If held at any other location at the invitation of a member Government, all additional costs would be borne by the host country.
- 18.28 Pursuant to its resolution 64/1, the Commission, at its sixty-seventh session in 2011, will undertake a midterm review of the functioning of the conference structure, focusing in particular on whether the structure has served the purpose of improving efficiency and attracting higher level and wider representation from members and associate members.

- 18.29 The amount of \$1,080,800 is required in connection with meetings of the Commission, its committees and other intergovernmental bodies. The provision covers the cost of, inter alia, temporary assistance for meetings, consultants and experts, and travel of supplementary conference-servicing staff and of a staff member from the Regional Commissions New York Office to attend the annual sessions of the Commission.

## B. Executive direction and management

### *Resource requirements (before recosting): \$5,023,900*

- 18.30 The executive direction and management component comprises the Office of the Executive Secretary and the United Nations Information Services. The Commission, by its resolution 64/1 on the restructuring of its conference structure, stressed that the priority needs of the least developed countries, landlocked developing countries and small island developing States should be mainstreamed into the work of all Committees subsidiary to the Commission. Hence, posts attached to the former Least Developed Countries Coordination Unit under executive direction and management have been redeployed to the programme of work in order to coordinate action on issues of concern to the least developed countries, landlocked developing countries and small island developing States, with a view to strengthening the planning and delivery of substantive activities to support the servicing of the subsidiary structure of the Commission.
- 18.31 The Office of the Executive Secretary provides overall policy direction to and management of the ESCAP secretariat, with the aim of ensuring that ESCAP plays a major role in promoting inclusive and sustainable economic and social development in the Asian and Pacific region and translates issues of global importance into regional action. The Office provides direction and guidance in coordinating work on the achievement of and follow-up to the internationally agreed development goals, including the Millennium Development Goals, and on other cross-cutting issues, such as poverty reduction, gender mainstreaming and sustainable development, throughout the substantive subprogrammes, while ensuring a balanced approach to addressing the needs of the members of the Commission.
- 18.32 United Nations Information Services promotes the visibility of the United Nations and ESCAP by disseminating information on their work to member States, the media and the general public. It is also responsible for two key outlets for ESCAP public information activities, that is, the contents of the ESCAP website and library services.

### External factors

- 18.33 The objectives and expected accomplishments under executive direction and management are expected to be achieved on the assumption that: (a) governmental and non-governmental counterparts at the national level will continue to be committed and assign priority to regional collaboration on socio-economic development issues; (b) entities within the United Nations system will remain committed and attach adequate resources to enhancing system-wide policy coherence; and (c) the international community will be responsive to and supportive of the needs and concerns of ESCAP member States, in accordance with the guidelines established by the General Assembly and the Economic and Social Council, as well as the internationally agreed development goals, including the Millennium Development Goals.

### Outputs

- 18.34 During the biennium 2010-2011, the following outputs will be delivered:


- 18.35 The amount of \$5,023,900, reflecting a net decrease of \$796,800, comprises: (a) \$4,642,900 for the funding of 22 posts (10 Professional and 12 Local level), reflecting a net decrease of \$760,100, due to the outward redeployment of five posts from the former Least Developed Countries Coordination Unit to other subprogrammes, partly offset by the inward redeployment of one P-4 post from subprogramme 6, Social development; and (b) \$381,000 for non-post requirements, reflecting a decrease of \$36,700 for, inter alia, consultants to provide expertise not available in the secretariat, the travel of staff to attend meetings, hold consultations and undertake public information-related activities; contractual services for external printing of public information materials, and other resources relating to the production of public information.
- 18.36 The proposed redeployment of posts is in response to the mandate provided by the Commission in resolution 64/1. The decrease of \$36,700 in non-post requirements is the result of the proposed decentralization of non-post resources previously allocated to the former Least Developed Countries Coordination Unit.
- 18.37 During the biennium 2010-2011, the projected extrabudgetary resources of \$200,000, reflecting a marginal increase of \$20,000, will complement resources from the regular budget to finance efforts to increase the outreach and organizational effectiveness of ESCAP. Resources will in that context be directed towards (a) ensuring the coordination and full inclusion of the newly established subregional offices in the programme activities of ESCAP, (b) strengthening knowledge management for greater development impact, including through enhancing web-based information, and (c) outreach activities to strengthen collaboration and partnership with other organizations at the regional and subregional levels. The extrabudgetary resources projected for the biennium 2010-2011 are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects.

- 18.41 The amount of \$7,197,100, reflecting a net decrease of \$785,200, comprises: (a) \$6,801,800 for the funding of 33 posts (18 Professional and 15 Local level), reflecting a net decrease of \$672,700, due to the outward redeployment of four posts (3 Professional and 1 Local level) to other

subprogrammes, partly offset by the inward redeployment of one P-3 post from executive direction and management; and (b) \$395,300 for non-post requirements, reflecting a decrease of \$112,500 for, inter alia, consultants to provide expertise not available in the secretariat; expert group meetings; travel of staff to attend various meetings of the relevant bodies of the United Nations and other organizations, undertake missions to collect country data and information and consult governments for needs assessment purposes; and contractual services for external printing, the preparation and launching of a flagship publication and macroeconomic forecasting services.

- 18.42 The proposed redeployment of posts aims to mainstream the poverty dimension in response to the Commission's request that poverty reduction be promoted as an overarching objective across all relevant subprogrammes. The decrease of \$112,500 in non-post requirements is mainly due to the mainstreaming of resources related to poverty reduction activities in other subprogrammes.
- 18.43 During the biennium 2010-2011, projected extrabudgetary resources of \$1,450,000 will provide practical, on-the-ground experience which will feed into the core normative and analytical work of the subprogramme, especially in regard to technical cooperation activities that support the achievement of the Millennium Development Goals, thereby responding to Commission resolution 64/6, on achieving the Millennium Development Goals in the ESCAP region, and resolution 64/7, on financing for the achievement of the Millennium Development Goals by 2015 in the ESCAP region. Extrabudgetary resources will enable the implementation of technical cooperation activities on policies and programmes in support of the achievement of the Millennium Development Goals, product certification, the development of sustainable agriculture of secondary crops for poverty alleviation and energy security, and the impact of economic integration on agriculture. The extrabudgetary resources projected for the biennium 2010-2011 are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects. The decrease of \$325,000, compared to the extrabudgetary estimates for the 2008-2009 biennium, is due to the reallocation of extrabudgetary resources earmarked for the promotion of social aspects of poverty reduction to other relevant subprogrammes, especially subprogramme 8, Subregional activities for development, and subprogramme 6, Social development.

- 18.44 Substantive responsibility for this subprogramme is vested in the Trade and Investment Division and is supported by the Asian and Pacific Centre for Transfer of Technology and the United Nations Asian and Pacific Centre for Agricultural Engineering and Machinery. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 2 of programme 15 of the strategic framework for the period 2010-2011.

- 18.45 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the global, regional and national environment will remain conducive to a continued expansion of collaboration on trade, investment and other financial issues; (b) national institutions will be willing to provide relevant information; and (c) adequate extrabudgetary resources will be mobilized to ensure the necessary outreach and depth of technical cooperation activities.

- 18.47 The amount of \$6,373,100, reflecting a net increase of \$365,000, comprises: (a) \$6,176,200 for the funding of 28 posts (17 Professional and 11 Local level), reflecting an increase of \$353,000, due to the inward redeployment of one P-5 post from subprogramme 5, Information and communications technology and disaster risk reduction; and (b) \$196,900 for non-post requirements, reflecting a net increase of \$12,000 for, inter alia, consultants to provide expertise in specialized areas not available in the secretariat and to undertake specialized studies as inputs to various publications, expert group meetings, and travel of staff to undertake missions to service the Ministerial Council and Standing Committee of the Asia-Pacific Trade Agreement and the annual sessions of the Governing Council and Technical Committee of APCAEM and APCTT.
- 18.48 The proposed redeployment of posts aims to address the decision of the Commission to shift the work of APCTT to subprogramme 2, Trade and investment, in order to emphasize the promotion of transfer of technologies for increased regional and international trade, particularly through South-

South cooperation, and to take into account its new mandate, as contained in Commission resolution 64/3, to promote the transfer of clean technologies, particularly renewables for energy security and sustainable development in Asia and the Pacific.

- 18.49 The net increase of \$12,000 in non-post requirements is the result of increased requirements for the organization of one additional expert group meeting, as well as for the consultancy services required for APCTT along with the shifting of its work to this subprogramme, partly offset by decreased requirements for general operating requirements.
- 18.50 During the biennium 2010-2011, projected extrabudgetary resources of \$3,850,000 will provide valuable, practical, on-the-ground experience which will feed into the core normative and analytical work of the subprogramme. In accordance with priorities established by the Commission, extrabudgetary resources will be dedicated to enhancing national capacities to: (a) participate in activities related to regional trade and investment agreements and mechanisms, including the Asia-Pacific Trade Agreement; (b) participate in Doha Round negotiations; (c) formulate and implement trade facilitation and e-commerce practices for enhancing international competitiveness; and (d) create a domestic policy environment conducive to the development of small and medium-sized enterprises and the mobilization of stable financial and investment flows. Extrabudgetary resources will also provide the means for two regional institutions subsidiary to ESCAP, namely, UNAPCAEM and APCTT, to continue their capacity-building work in their respective fields. The extrabudgetary resources projected for the biennium 2010-2011 are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects. The increase of \$390,000, compared to the extrabudgetary estimates for the 2008-2009 biennium, is due to: (a) the decision of the Commission to shift the work of APCTT from subprogramme 5, Information communications technology and disaster risk reduction, to this subprogramme; and (b) an estimated increase in staff costs in relation to UNAPCAEM, based in Beijing, and APCTT, based in New Delhi.

- 18.54 The amount of \$6,160,600, reflecting a decrease of \$32,000, comprises: (a) \$5,981,600 for the funding of 28 posts (16 Professional and 12 Local level); and (b) \$179,000 for non-post requirements, reflecting a decrease of \$32,000 for, inter alia, consultants to provide expertise not available in the secretariat for the preparation of the biennial review of developments in transport in Asia and the Pacific, expert group meetings on preparations for the Forum of Asian Ministers of Transport and on progress in road safety improvement in Asia and the Pacific, and external printing for the subprogramme's flagship publication, *Review of the Developments in Transport in Asia and the Pacific*.
- 18.55 The decrease of \$32,000 in non-post requirements relates largely to the discontinuance of travel related to tourism activities as a result of the revision of the ESCAP programme structure, and the reduction in the number of hard-copy publications when they are published electronically.
- 18.56 During the biennium 2010-2011, projected extrabudgetary resources of \$1,000,000 will provide valuable, practical, on-the-ground experience which will feed into the core normative and analytical work of the subprogramme to support: the ongoing implementation of the Regional Action Programme for Transport Development in Asia and the Pacific (Phase I: 2007-2011) which, inter alia, accords high priority to the promotion, development and upgrading of the Asian Highway; the promotion, development and operationalization of the Trans-Asian Railway; the development of intermodal transport infrastructure as an integral part of an international integrated intermodal transport system; the maintenance and management of transport infrastructure, including participation and financing by the private sector; the development of logistics service centres, including the promotion and development of inland container depots or dry ports; legal frameworks for international transport; integrated transport facilitation measures; and road safety. The extrabudgetary resources will contribute to the enhancement of the capacity of member countries to integrate inclusive and sustainable development in their transport policies and programmes. The extrabudgetary resources projected for the biennium 2010-2011, reflecting a marginal increase of \$50,000 from the extrabudgetary estimates for the 2008-2009 biennium, are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects.

## Subprogramme 4 Environment and development

*Resource requirements (before recosting): \$6,648,900*

- 18.57 Substantive responsibility for this subprogramme is vested in the Environment and Development Division. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 4 of programme 15 of the strategic framework for the period 2010-2011.

- 18.58 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) regional economy, social and environmental conditions and trends will continue to be conducive to the promotion of environmentally sustainable economic growth patterns; (b) national economic, social and political conditions in the target countries will remain stable; (c) governmental institutions and civil society organizations will have the necessary human and financial capabilities to ensure successful cooperation; and (d) adequate extrabudgetary resources will be mobilized to ensure the necessary outreach and depth of technical cooperation activities.

- 18.60 The amount of \$6,648,900, reflecting a net increase of \$248,700, comprises: (a) \$6,453,200 for the funding of 31 posts (17 Professional and 14 Local level), reflecting a net increase of \$276,900, due to the delayed impact of one P-3 post established in the biennium 2008-2009, and the inward redeployments of one P-4 post from subprogramme 1, Macroeconomic policy and inclusive development, and one Local level post from executive direction and management, partly offset by the outward redeployment of one P-3 post to subprogramme 5, Information and communications technology and disaster risk reduction; and (b) \$195,700 for non-post requirements, reflecting a decrease of \$28,200 for, inter alia, expert group meetings on the state of environmental sustainability in Asia and the Pacific, on monitoring of investment and results in water management in preparation for the Asia-Pacific Water Summit, and on widening energy access and enhancing energy security to achieve the Millennium Development Goals in Asia and the Pacific; travel of staff to meetings related to climate change, greening of economic growth, water, energy,

housing and development; and external printing for recurrent publications and for promotional materials on a knowledge hub on transboundary water resources.

- 18.61 The proposed inward redeployment of posts is intended to strengthen the ability of the subprogramme to address environmentally sustainable urban development issues, inter alia, engagement with key stakeholders, including networks of local governments and civil society associations, which was identified as a key lesson learned by the subprogramme during the 2006-2007 biennium, as well as to support analytical work on environmentally sustainable economic growth. The outward redeployment of one post is proposed to support the shift of responsibility for delivering the ESCAP programme of work in the area of disaster risk reduction from the Environment and Development Division to the Information and Communications Technology and Disaster Risk Reduction Division, under subprogramme 5.
- 18.62 The decrease of \$28,200 in non-post requirements relates to reductions in consultancy services owing to more reliance on in-house expertise for the delivery of the work programme, a reduction in the number of publications and increased use of electronic dissemination.
- 18.63 During the biennium 2010-2011, projected extrabudgetary resources of \$5,250,000 will provide valuable, practical, on-the-ground experience which will feed into the core normative and analytical work of the subprogramme and be used to implement activities to strengthen consensus among ESCAP member States on issues related to environmentally sustainable economic growth, and to improve the capacity of ESCAP member States to develop related policy and programme options. Further, in support of Commission resolution 63/6, concerning the implementation of intercountry energy cooperation to enhance energy security for sustainable development, and resolution 64/3, on promoting renewables for energy security and sustainable development in Asia and the Pacific, extrabudgetary resources will assist national capacity-building efforts for the implementation of effective policies and programmes on improving equitable access to energy, energy efficiency, clean and renewable energy, and effective management of energy resources, particularly for countries with special needs. Further, in support of meeting Millennium Development Goals 1 and 7, extrabudgetary resources will play a key role in activities to promote water security, enhanced access to water and sanitation and effective management of water resources, as well as to develop eco-efficient infrastructure and address climate change through the implementation of sustainable energy policies and programmes. The extrabudgetary resources projected for the biennium 2010-2011 are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects. The decrease of \$480,000, compared to the extrabudgetary estimates for the 2008-2009 biennium, is due to the reallocation of extrabudgetary resources under the Tsunami Trust Fund from this subprogramme to subprogramme 5, Information and communications technology and disaster risk reduction, partly offset by an increase in the funding made available for environmentally sustainable urban development issues and poverty.

- 18.67 The amount of \$5,268,900, reflecting a net increase of \$196,700, comprises: (a) \$5,113,500 for the funding of 24 posts (14 Professional and 10 Local level), reflecting a net increase of \$214,100, due to the inward redeployment of one P-3 post from subprogramme 4, Environment and development,

and three Local level posts, namely, one from executive direction and management and two from programme support, partly offset by the outward redeployment of one P-5 post to subprogramme 2, Trade and investment; and (b) \$155,400 for non-post requirements, reflecting a net decrease of \$17,400 for, inter alia: consultants to provide expertise in specialized areas not available in the secretariat, such as in space-based ICT connectivity for sustainable development; expert group meetings on ICT connectivity to promote inclusive economic and social development and accelerate poverty reduction in Asia and the Pacific, on enhancing the regional cooperation mechanism on space-based connectivity for sustainable development in Asia and the Pacific, and on comprehensive multi-hazard management and early warning, including at the community level, in Asia and the Pacific; travel of staff to undertake consultations with ESCAP member countries on issues related to ICT and disaster risk reduction.

- 18.68 The net increase of \$214,100 in post requirements reflects the proposed redeployments, which are intended to strengthen the research and administrative support to this subprogramme in view of the mandate given by the Commission, in resolution 64/2, to strengthen the capacity of ESCAP work in the area of disaster risk reduction, and the Commission's decision to relocate the work of APCTT to subprogramme 2, Trade and investment, in order to emphasize work on the affordable transfer of technologies for increased regional and international trade, using a South-South cooperative approach.
- 18.69 The net decrease of \$17,400 in non-post requirements is the result of reductions for consultancy services and for external printing, owing to a reduction in the number of publications and the increased use of electronic online publications, partly offset by increased requirements for travel of staff due additional travel in relation to the disaster risk reduction activities as part of the Commission's request for the secretariat to strengthen this area of work.
- 18.70 During the biennium 2010-2011, projected extrabudgetary resources of \$4,900,000 will provide valuable, practical, on-the-ground experience which will feed into the core normative and analytical work of the subprogramme. In the area of disaster risk reduction, extrabudgetary resources will support the implementation of technical cooperation work for the implementation of Commission resolution 64/2, on regional cooperation in the implementation of the Hyogo Framework for Action 2005-2015: Building the Resilience of Nations and Communities to Disasters in Asia and the Pacific. These include capacity-building workshops on multi-hazard disaster risk reduction, space applications for disaster management and collaboration with the Economic Commission for Latin America and the Caribbean and the World Bank in regard to multi-hazard disaster management and socio-economic assessment of disaster impacts. In the area of information and communications technology, extrabudgetary resources will support the organization of projects on ICT for socio-economic development and provide the means for APCICT to implement training programmes for government officials on ICT applications for development, disseminate analyses of human resource development in ICT, and provide advisory services in connection with a range of ICT capacity-building areas. The extrabudgetary resources projected for the biennium 2010-2011 are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects. The net increase of \$775,200, compared to the extrabudgetary estimates for the 2008-2009 biennium, is due to: (a) the reallocation of resources under the Tsunami Trust Fund from subprogramme 4, Environment and development, to this subprogramme and an expected increase in extrabudgetary resources to further strengthen the role and capacity of ESCAP in the area of disaster risk reduction, including through South-South cooperation; and (b) estimated increased staff costs and project expenditures for APCICT, based in Incheon, Republic of Korea, partly offset by the decision of the Commission to shift the work of APCTT from this subprogramme to subprogramme 2, Trade and investment.

- 18.72 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) relevant stakeholders at the national level will be prepared to provide the information necessary for the secretariat to review regional progress in the implementation of commitments agreed at United Nations intergovernmental processes pertaining to social development, population, ageing, disability, gender equality and health; (b) national institutions will be willing to pursue regional cooperation to build more inclusive societies; and (c) adequate extrabudgetary resources will be mobilized to ensure the necessary outreach and depth of technical cooperation activities.

- 18.74 The amount of \$6,969,400, reflecting a net increase of \$224,700, comprises: (a) \$6,756,400 for the funding of 33 posts (19 Professional and 14 Local level), reflecting a net increase of \$256,800, due to the inward redeployment of one P-3 post from executive direction and management, and one P-2 and one Local-level post from subprogramme 1, Macroeconomic policy and inclusive development, partly offset by the outward redeployment of one P-4 post to executive direction and management; and (b) \$213,000 for non-post requirements, reflecting a decrease of \$32,100 for, inter alia: consultants for the provision of expertise in specialized areas not available in the secretariat; expert group meetings on the implementation of the outcomes of the review in 2010 of the Beijing Platform for Action, the regional review of the implementation of the Madrid International Plan of Action on Ageing, the implementation of the Biwako Millennium Framework for Action and Biwako Plus Five, and social protection policies for emerging risks in Asia and the Pacific; travel of staff to undertake consultation with government officials and other stakeholders; and external printing for various publications and materials.
- 18.75 The proposed redeployment of posts are intended to support the mainstreaming of gender equality in the work of the Commission and to ensure a more systematic and multisectoral approach to addressing poverty issues, as emphasized by the Commission in its resolution 64/1. The decrease of \$32,100 in non-post requirements is the result of, inter alia, reductions for consultancy services owing to more reliance on in-house expertise, and for external printing owing to a reduction in the number of publications and the increased use of electronic online publications.

- 18.76 During the biennium 2010-2011, projected extrabudgetary resources of \$2,500,000 will provide practical, on-the-ground experience which will feed into the core normative and analytical work of the subprogramme and will enable the secretariat to expand the regional outreach of its services through publications, regional workshops and training courses to build national capacity and foster regional cooperation in priority areas identified by the legislative bodies. In the biennium, efforts will be directed towards the promotion of social protection and social justice and the implementation of Commission resolution 64/8, on the regional implementation of the Biwako Millennium Framework for Action and Biwako Plus Five towards an Inclusive, Barrier-free and Rights-based Society for Persons with Disabilities in Asia and the Pacific. Extrabudgetary resources will also support capacity-building in combating violence against women and gender mainstreaming. The extrabudgetary resources projected for the biennium 2010-2011 are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects. The increase of \$224,800, compared to the extrabudgetary estimates for the 2008-2009 biennium, is due to the reallocation of extrabudgetary resources earmarked for the promotion of poverty reduction from subprogramme 1, Macroeconomic policy and inclusive development, to this subprogramme, especially for carrying out activities related to the promotion of social protection and social justice, and an increase in funding made available to support the mainstreaming of gender equality in the work of the Commission.

- 18.80 The amount of \$4,795,000, representing a net increase of \$787,200, comprises: (a) \$4,609,800 for the funding of 24 posts (12 Professional and 12 Local level), reflecting an increase of \$764,500, due to the inward redeployment of one P-5 post from executive direction and management, one P-4 post from subprogramme 1, Macroeconomic policy and inclusive development, and one Local level post from programme support; and (b) \$185,200 for non-post requirements, reflecting a net increase of \$22,700 for, inter alia, consultants to provide expertise on statistical issues, including the most recent developments in methodologies used in relation to the Millennium Development Goals; expert group meetings on technical solutions for the dissemination of national official statistics in the ESCAP region, on data analysis for poverty reduction and other related pro-Millennium Development Goal policies, including gender equality, and on the development of new recommendations and/or guidelines for the Asian and Pacific region in the area of economic, social or environmental statistics; travel of staff to attend consultative meetings of the inter-agency and expert group on Millennium Development Goal indicators; and external printing, including of the subprogramme's flagship publication, *Statistical Yearbook for Asia and the Pacific*.

- 18.81 The proposed redeployment of posts is intended to strengthen the analytical work of the secretariat, particularly that related to reporting on the status of the least developed and landlocked developing countries in meeting the internationally agreed development goals, including the Millennium Development Goals.
- 18.82 The net increase of \$22,700 in non-post requirements is the result of increased requirements for consultancy services for the preparation of a flagship publication and a planned additional expert group meeting, partly offset by decreased requirements for external printing in view of the decision to limit the production of the Statistical Yearbook to one issue per biennium.
- 18.83 During the biennium 2010-2011, projected extrabudgetary resources of \$5,700,000 will provide valuable, practical, on-the-ground experience which will feed into the core normative and analytical work of the subprogramme, in response to Commission resolution 62/10, on strengthening statistical capacity in Asia and the Pacific. Extrabudgetary resources will enable the secretariat, including the Statistical Institute for Asia and the Pacific, to strengthen national capacity to: collect, compile, process, analyse, disseminate and use official statistics; to monitor progress towards development goals and the internationally agreed development goals, including the Millennium Development Goals; to develop and implement international statistical standards in the region; and to share information and good practices among statistical offices. The extrabudgetary resources projected for the biennium 2010-2011 are based on the known and projected level of funding at the time of budget submission for new and existing continuing projects. The increase of \$250,000, compared to the extrabudgetary estimates for the 2008-2009 biennium, is mainly due to an estimated increase in staff costs in relation to the Statistical Institute for Asia and the Pacific, based in Chiba, Japan, as well as an expected increase in support for ESCAP work in reporting on the status of the least developed and landlocked developing countries in meeting the internationally agreed development goals, including the Millennium Development Goals.

  - (b) The Administrative Services Division will continue to accord priority to improving support to enhance the achievement of human resources indicators and implementation of the Secretary-General's human resources management reform initiatives in order to create a more mobile, versatile and multi-skilled workforce through effective workforce planning, skilful management of staff development resources and efficient administration of entitlements and compensation; strengthen efficiency in the management of information technology resources, as well as further upgrading technological infrastructure for the roll-out of enterprise resource planning, enterprise content management and customer relationship management systems; strengthen the management of financial resources through the conduct of thorough approval processes for all accounts, ensuring accuracy of payment procedures, including payroll, and preparing for the SAS roll-out of the International Public Sector Accounting Standards; ensure the effective maintenance of building facilities, the provision of travel, procurement and central support services; strengthen the efficient utilization of the conference facilities; and continue to provide editorial services, translation services and interpretation services in the four official United Nations languages;

- (c) The Library provides information services to the entire secretariat and to delegations, as well as to outside users; these services encompass the collection of books, journals and materials related to the work of the substantive divisions, the collection of parliamentary documentation, meeting reports and documents and electronic access to documents and publications through the World Wide Web.

## Outputs

18.107 The outputs of the Programme Management Division include the following:

- (a) *Programme planning, budget and evaluation.* Provision of policy guidance, including interpretation of the regulations, rules and directives governing programme planning, budgeting, monitoring and evaluation, to ESCAP substantive divisions, subregional offices and regional institutions; overall coordination and management of the formulation of the strategic frameworks, programme budgets and programme of work of ESCAP; overall management and monitoring of the utilization of the financial resources of ESCAP, including budgetary performance reporting; central authority for certification of expenditures in accordance with the Financial Regulations and Rules of the United Nations; issuance of allotments, allocations and grants and management of special accounts; monitoring of the implementation of the programme of work, including provision of guidance and support on the Integrated Monitoring and Documentation Information System and in regard to programme performance reporting; management and conduct of strategic evaluations and provision of quality assurance support for evaluative reviews, including support for the development of management responses to evaluation outcomes; provision of training on results-based management tools and methodologies; promoting cooperation among programme planning offices of the regional commissions and with other entities members of the Executive Committee on Economic and Social Affairs in regard to joint programming, coordination and harmonization of work; servicing of the Commission's Committee of the Whole in relation to management issues, including programme planning, monitoring and evaluation; servicing of the Commission's working group on draft resolutions; servicing of sessions of the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission and its subsidiary working groups; servicing of audits, evaluations and inspections carried out by the Office of Internal Oversight Services with respect to areas under the purview of the Division;
- (b) *Management of technical cooperation programmes and funds.* Provision of policy guidance and programme management support to ESCAP substantive divisions, subregional offices and regional institutions in regard to the development and implementation of all technical cooperation programmes; management of the implementation of memorandums of agreement with development partners; management of the programme and project appraisal and approval processes; establishment and management of technical cooperation trust funds, including reporting arrangements; provision of procedural advice on technical cooperation and trust fund agreements; analysis of development assistance, donor trends and organization of consultations with donors and partners; inter-agency coordination with other United Nations and affiliated partners, including provision of secretariat services for the Asia-Pacific regional coordination mechanism and heads of agency meeting; provision of inputs, as a non-resident agency, for the United Nations development assistance frameworks and other related processes to ensure linkages with the work of the United Nations country teams; servicing of the annual sessions of the Commission in relation to technical cooperation issues, including pledging of contributions; development and implementation of resource mobilization strategies for technical cooperation; and management of the regular programme of technical cooperation and the United Nations Development Account.

18.108 The outputs of the Administrative Services Division include the following:

- (a) *Overall management.* Provision of management and coordination of all activities carried out by the Division; policy formulation in the area of utilization of human, financial, infrastructure and technology resources; establishment of managerial and administrative guidelines; negotiations towards and maintenance of effective host country relations; provision of organizational guidance and support in regard to the hosting of meetings, conferences, visits by dignitaries etc.;
- (b) *Human resources management.* Provision of advice in the interpretation of staff regulations, rules, policies and procedures; strategic advice relating to workforce planning, staff development, career development, talent management, retention and separation, with a view to creating a mobile, versatile workforce that exhibits the skills needed to achieve corporate goals and organizational effectiveness; engagement of consultants and individual contractors; provision of occupational health services, including leadership in promoting and maintaining organizational responses to potential pandemics; administration of allowances and benefits;
- (c) *Financial services.* Provision of advice in the interpretation of financial regulations, rules, policies and procedures; provision of advice relating to maximizing the cost-effectiveness of resources in areas under the purview of the Division and the utilization of financial services provided by other United Nations partners; management of relationships with the banking sector; execution of financial approval functions in accordance with established policy; maintenance of all accounts and issuance of financial statements; generation of all financial payments, including payroll and payments to vendors and other third parties; treasury services, in consultation with Treasury at Headquarters; monitoring and control of utilization of the Division's financial resources; maintenance of effective relationships with internal and external auditors and follow-through on the implementation of audit recommendations;
- (d) *Information, communications and technology management.* Provision of advice in the supply and utilization of information technology, giving due consideration to corporate ICT strategy, including the mandatory replacement and maintenance of software, hardware and telecommunications equipment, and development and maintenance of local software applications; collaboration and coordination of business requirements with Headquarters in regard to new, centrally developed applications, such as enterprise resource planning, enterprise content management and customer relationship management; in collaboration with Headquarters, implementation of the United Nations-wide enterprise data centre; augmentation of existing infrastructure to support secure remote access to internal data; implementation of a comprehensive disaster recovery strategy; maintenance of compliance with ISO 27001; collaboration and implementation of Voice over Internet Protocol (VoIP) technology; provision of ongoing operations support, including support for and maintenance of the Integrated Management Information System;
- (e) *General support services.* Provision of cost-effective management and maintenance of all building facilities, including advice on feasibility assessment, design and implementation of major repairs, renovations and/or construction initiatives; provision of procurement and travel services, including advice on the implementation of the procedures governing procurement and official travel entitlements; ensuring effective storage and inventory management, mail, pouch and courier services;
- (f) *Conference management.* Management of the United Nations Conference Centre, including advice on optimizing the utilization of the Centre, bearing in mind security constraints, support of legislative meetings and ad hoc intergovernmental meetings, conferences hosted by United Nations partners and member States; internal document reproduction services;

(g) *Conference services.* Provision of editorial, interpretation, translation and text-processing services in the four working languages of ESCAP.

- 18.109 The Library will deliver outputs in the biennium 2010-2011 that include library and information technology services as well as advisory and training services concerning the information system, which are provided in response to the work programme of the ESCAP secretariat, staff of the United Nations agencies in Bangkok and the public and private sectors.

- 18.110 The amount of \$38,421,300, reflecting a net decrease of \$419,900, comprises: (a) \$30,318,300 for the funding of 196 posts (54 Professional, 2 National Officer and 140 Local level), reflecting a decrease of \$195,200, due to the outward redeployment of three Local-level posts to other subprogrammes, as detailed below; and (b) \$8,103,000 for non-post requirements, reflecting a net decrease of \$224,700 for, inter alia, other staff costs, contractual services and other general operating requirements.
- 18.111 The decrease of \$195,200 for post requirements relates to the outward redeployment of three Local-level posts (2 to subprogramme 5, Information and communications technology and disaster risk reduction, and 1 to subprogramme 7, Statistics) intended to strengthen the research support capacity and thus benefit the secretariat's normative and analytical work in general and that related to disaster risk reduction in particular.
- 18.112 The net decrease of \$224,700 under non-post requirements relates mainly to reductions for one-time provisions approved in 2008-2009 to assist with the initial set-up of the new subregional offices established in the context of General Assembly resolution 63/260, on development-related activities, and general operating requirements resulting from greening initiatives, partly offset by increased requirements for contractual services resulting from the maintenance costs of corporate software purchased in the 2008-2009 biennium.
- 18.113 During the biennium 2010-2011, projected extrabudgetary resources of \$3,827,000 will provide for monitoring and evaluation activities, support to the regional institutions, and for the administration and management of the Tsunami Trust Fund activities. The increase of \$227,000, compared to the extrabudgetary estimates for the 2008-2009 biennium, is mainly due to the estimated increase in staff costs of services in support of extrabudgetary activities and an increase in the resources made available to support the regional institutions and the newly established subregional offices.

**Advisory Committee on Administrative and Budgetary Questions**  
(A/62/7 and Corr.1)

The Advisory Committee continues to emphasize the importance of reducing the relative weight of administrative support costs compared with the resources allocated to the substantive activities of the programme of work, which benefit the Member States directly. It remains convinced that there is room for further improvements in work processes, eliminating inefficiencies and duplications as well as for generating additional synergies among the regional commissions. It urges the commissions to continue to pursue such efforts vigorously (para. V.3).

During the past four bienniums, the percentage of the programme budget for programme support has decreased from 47.0 per cent in 2002-2003 to 40.6 per cent in the proposed programme budget for 2010-2011. This has been possible through maximizing efficiency gains in the programme support area. In 2004-2005, ESCAP abolished 12 Local-level posts, mainly in the programme support component, and in 2006-2007, 15 Local-level posts were abolished. In 2008-2009, 3 Local-level posts were abolished, amounting to a total reduction of 30 Local-level posts. Resources released have been utilized in the programme of work component.

For the 2010-2011 biennium, it is proposed to redeploy 3 Local-level posts from programme support to the programme of work area (2 posts to subprogramme 5, Information and communications technology and disaster risk reduction, and 1 post to subprogramme 7, Statistics) to enhance the implementation of services of direct benefit to member States in the area of disaster risk reduction given the increased vulnerability of the Asian and Pacific region to natural disasters.

Further, the regional commissions collaborate closely on a number of issues to benefit from and enhance existing synergies. At their most recent meeting, in September 2008, the chiefs of programme planning of the regional commissions agreed to closely coordinate the preparation of the programme budget for 2010-2011 in order to further harmonize processes and structures. In addition, ECE and ESCAP are considering options for the joint implementation of the United Nations Special Programme in Central Asia.

The Advisory Committee notes that most of the commissions are making steady progress in improving their performance but are still well below the organizational target of 120 days for the completion of recruitments of Professional staff. It encourages the commissions to take action to further reduce the number of days Professional posts remain vacant and to meet the organizational target (para. V.6).

The Committee acknowledges the need for travel and recognizes that videoconferencing and other electronic means of communications cannot always be substituted. It however recalls its view that the considerable investments made in communications infrastructure should lead to reduced requirements for travel. It also emphasizes that travel should always be justified on the basis of functional requirements and requests that the regional commissions continue to monitor official travel closely (para. V.10).

Recognizing that recruitment is a shared responsibility, involving recruiting managers, human resources professionals, other staff serving on interview panels, and members of the central review bodies, a number of parallel initiatives have been undertaken to improve and expedite the recruitment of Professional staff.

A process aimed at sensitizing managers to ensure that they play a proactive role in the recruitment process was initiated in 2006, and involves training on the drafting of vacancy announcements, preparation of written tests, the formulation of interview questions, and evaluation of candidates.

Meanwhile, nearly all staff members (95 per cent) who regularly participate on interview panels have completed the mandatory competency-based selection and interviewing training. In addition, workshops have been organized to brief members of the central review bodies and programme case officers on their roles and responsibilities in the recruitment process.

To further streamline and expedite the recruitment process, the central review bodies at ESCAP have, since August 2006, held virtual (electronic) meetings, which have facilitated and promoted strict adherence to deadlines for review and decision-making.

All requests for official travel by ESCAP staff members are assessed against established criteria, ensuring that only essential travel is undertaken in support of the achievement of expected accomplishments under the programme of work. Official travel is closely monitored and reported to the Executive Secretary on a biannual basis. Every effort is made, when possible, to hold videoconferences and other means of electronic communication in lieu of staff undertaking travel to attend meetings. From 2004 to 2007, the number of videoconferences increased by an average of 29 per cent per year (from 53 in 2004 to 114 in 2007). With the time difference of 12 hours between Bangkok and New York, ESCAP staff

have been attending videoconferences at night as a means of curtailing staff travel. While videoconferencing is possible for some meetings of short duration, it is not possible for videoconferencing to replace staff attendance at other meetings where interactive sessions of longer duration are a requirement.

Further, the formulation and implementation of the ESCAP programme of work entails close interaction with member States and other stakeholders. The large geographical area covered by ESCAP and its growing membership of 58 regional members and associate members are factors that also need to be taken into account. To enable ESCAP to effectively carry out its work requires a minimum level of official travel to ensure effective outreach and relevance. It should also be noted that Bangkok, where ESCAP is located, is situated farthest from Headquarters in New York. Many meetings related to ensuring coherence and the unified implementation of administrative, financial management and procurement policies are held in New York and hence the costs of attendance of ESCAP staff at those meetings are relatively higher than for other duty stations.


The Board recommends that the Administration develop strategies to reduce the vacancy rates of its conference centres (para. 231).

While the current political and security situation in Thailand continues to have an impact on the utilization of the United Nations Conference Centre, ESCAP is implementing a number of measures to improve its utilization, including the relocation of the staff cafeteria to the Centre's dining room, the renovation of the public foyer, and the conversion of some meeting rooms from fixed to flexible furniture to attract more clients. In addition, a cost reimbursement policy for the use of the Centre, aimed at facilitating greater usage by United Nations clients, is under development, and new promotional materials in the form of brochures and DVDs have been produced.
