- 19.1 The programme is under the responsibility of the Economic Commission for Europe (ECE).
- 19.2 Acting in its dual role as a regional outpost of the United Nations and part of its regional institutional landscape, ECE will continue to pursue the key objectives shared by all the regional commissions, namely, to foster economic integration at the subregional and regional levels, to promote the regional implementation of internationally agreed development goals, including the Millennium Development Goals, and to support regional sustainable development by contributing to the bridging of economic, social and environmental gaps among their member countries and subregions. To achieve those objectives, all regional commissions, through their convening power, will continue to generate multilateral dialogue, knowledge-sharing and networking at the regional level, and will work together to promote intraregional and interregional cooperation, both among themselves and through collaboration with other regional organizations.
- 19.3 Taking into account the role of the regional commissions as expressed above and the goals and commitments contained in the United Nations Millennium Declaration (General Assembly resolution 60/1) and in the Plan of Implementation of the World Summit on Sustainable Development, the main objectives of the ECE work programme for 2010-2011 will be (a) to support the integration of the countries of Eastern Europe, the Caucasus and Central Asia, as well as South-Eastern Europe, into the pan-European economy, taking into account the enlarged European Union and the various integration initiatives under way in the eastern part of the region; (b) to improve the quality of life and to contribute to the sustainable development of the region; and (c) to enhance competitiveness, in particular in the emerging market economies and low-income countries of the region, thereby contributing to their economic prosperity. ECE will engage and promote partnerships among all public and private stakeholders to achieve those objectives.

- 19.4 The ECE programme of work, in accordance with the decisions taken by member States as part of the 2005 workplan on ECE reform (E/ECE/1434/Rev.1), is designed around eight subprogrammes, namely, economic cooperation and integration, environment, housing, land management and population, statistics, sustainable energy, timber and forestry, trade, and transport. The core strategy focuses on (a) the implementation of existing legally binding instruments, norms, standards and guidelines, as well as the negotiation of new ones based on the needs of member States; (b) the provision of technical assistance, policy advice and capacity-building to support the implementation of those norms and standards by countries with economies in transition; and (c) the organization of a policy debate and the exchange of experiences in the areas of ECE expertise, including supporting policy analysis, studies and statistics.
- 19.5 ECE normative work will promote greater regulatory compatibility among its member States. It will therefore stimulate transboundary cooperation, in particular for the further opening of borders and the addressing of environmental challenges. At the same time, due account will be given to the region's concern for increased security. It will also have a positive impact on the rest of the world, as many ECE-developed agreements and standards (in particular in the areas of transport, trade facilitation and statistics) become more accepted for use in countries of other regions.
- 19.6 Particular attention will be given to advancing intersectoral activities, in particular between the energy, environment, timber, trade and transport sectors. Furthermore, ECE will focus on the gender dimension of development as it relates to women in the economy.
- 19.7 The policy debate and exchange of experiences among ECE member States will facilitate the identification of policies and good practices conducive to achieving the internationally agreed development goals, including the Millennium Development Goals.
- 19.8 ECE technical cooperation activities will be directed at the countries of Eastern Europe, the Caucasus and Central Asia, and South-Eastern Europe. They will contribute to improving national capacities to implement legally binding instruments and other regional norms and standards, and to resolving transboundary challenges. In that respect, ECE will strengthen its cooperation with the United Nations Development Programme at both the regional and the country levels. In addition, the United Nations Special Programme for the Economies of Central Asia, jointly executed with the Economic and Social Commission for Asia and the Pacific (ESCAP), will be further strengthened.
- 19.9 In order to improve coherence in the development work of the United Nations, consultations have taken place among the concerned entities of the Executive Committee of Economic and Social Affairs at the thematic cluster level. Those consultations are expected to lead to better coordination and more collaborative work among programmes in major common work areas of the Secretariat in the social and economic sectors.
- 19.10 Building upon the complementarity of mandates, functions and areas of expertise, ECE will strengthen its cooperation with key partners in the region, in particular with the European Commission and the Organization for Security and Cooperation in Europe, as well as with major subregional players.
- 19.11 The expected accomplishments and indicators of achievement for ECE in the biennium 2010-2011 are set out, together with required resources, under the programme of work, as well as under executive direction and management.
- 19.12 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown in table 19.3 below (see also the output information for each subprogramme).

- 19.13 The estimated decrease for 2010-2011 reflects a consolidation and reformulation of publications in an effort to further increase their quality and relevance. Several outputs of the programme were consolidated, reformulated and/or reorganized to rationalize outputs and to enhance overall programme performance reporting.

- 19.14 The overall resources required for the biennium 2010-2011 for this section amount to \$65,849,600, before recosting, reflecting a net increase of \$1,123,300 (or 1.7 per cent), of which \$1,071,700 relates to net changes in connection with post requirements, as follows: (a) the delayed impact of five posts for the biennium 2008-2009 (\$1,078,100); (b) the proposed establishment of an additional post at the P-3 level in subprogramme 2, Transport (\$166,400); and (c) a net reduction under non-post resources relating to the discontinuation of non-recurrent provisions approved in 2008-2009 and other reductions due to reduced requirements for consultancy services, furniture and equipment, and grants and contributions (\$121,200). The net growth shown in table 19.5 below can be summarized as follows:

- (a) The net increase of \$350,800 under executive direction and management relates to: (i) the delayed impact of one post at the P-4 level, effective 1 January 2009, established in the context of General Assembly resolution 63/260, on development-related activities (\$270,600); (ii) the inward redeployment of one post at the P-5 level from subprogramme 1, Environment, to the Information Unit, partially offset by the outward redeployment of one post at the P-4 level from the Information Unit to subprogramme 8, Housing, land management and population (\$59,200); and (iii) an increase for contractual services under non-post requirements for the translation, into languages of developing countries and countries with economies in transition, of documents and materials required for meetings and seminars that cannot be carried out in-house (\$21,000);
- (b) The net increase of \$710,800 under programme of work relates to:
 - (i) A net decrease of \$115,800 under subprogramme 1, Environment, resulting from the outward redeployment of one post at the P-5 level to the Information Unit of the executive direction and management component, partially offset by the inward redeployment of one post at the P-3 level from subprogramme 8, Housing, land management and population. The proposed outward redeployment of one post at the P-5 level to the executive direction and management component is intended to address a request from States members of ECE following the reform carried out in 2006 that ECE enhance its communications, public relations and contacts with the media in order to achieve an increase in the number and enhanced quality of targeted materials and publications available on the Internet and to enhance the production of printed materials;
 - (ii) A net increase of \$145,900 under subprogramme 2, Transport, resulting from the proposed establishment of one P-3 post, Economic Affairs Officer, to carry out work related to fuel standards and the work on global warming abatement in response to the

decision of the Governments that are members of the World Forum for Harmonization of Vehicle Regulations (\$166,300); partially offset by a decrease in external printing under non-post requirements due to the increased use of in-house printing (\$20,400);

- (iii) An increase of \$354,100 under subprogramme 3, Statistics, owing to the delayed impact of one post at the P-3 level established in the context of General Assembly resolution 63/260, on development-related activities, and one post at the P-2 level established in the biennium 2008-2009;
 - (iv) An increase of \$270,200 under subprogramme 5, Sustainable energy, due to the delayed impact of one post at the P-4 level, effective 1 January 2009, established in the context of Assembly resolution 63/260, on development-related activities;
 - (v) A net increase of \$56,500 under subprogramme 8, Housing, land management and population, resulting from the inward redeployment of one post at the P-4 level from the Information Unit of the executive direction and management component, partially offset by the outward redeployment of one post at the P-3 level to subprogramme 1, Environment. The inward redeployment of one post at the P-4 level is intended to address the need for higher-level support in servicing the Committee on Housing and Land Management with its enhanced programme element, which now includes energy efficiency of the housing sector linked to climate change. The outward redeployment of one P-3 post to subprogramme 1, Environment, is intended to address the need for an Economic Affairs Officer to undertake substantive work, including research on the economic aspects of environmental policy, analysis of trends and policies, provision of substantive input and technical guidance on economic issues to facilitate strategic decisions by the Chief of the Environment, Housing and Land Management Division and the section chiefs;
 - (c) A net increase of \$61,700 under programme support relates to: (i) the delayed impact of one post at the P-3 level, effective 1 January 2009, established in the context of General Assembly resolution 63/260, on development-related activities (\$183,500); and (ii) decreased requirements under non-post requirements for consultants, furniture and equipment, and grants and contributions (\$333,100), partially offset by increased requirements for data-processing services under contractual services (\$211,300).
- 19.15 During the biennium 2010-2011, projected extrabudgetary resources of \$26,559,300 will complement resources from the regular budget to finance various substantive and technical cooperation activities, including consultancy services, expert groups, travel, technical advisory services, training, workshops, seminars, and field projects. Projected 2010-2011 expenditures are based on or known and projected level of funding at the time of budget submission for new and existing continuing projects.
- 19.16 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$1,040,000, representing a total of 62 work-months by Professional staff at the D-1, P-5, P-4/P-3 and P-2 levels and 17 work-months at the level of General Service (Other level), funded from regular budget resources and reflected under each subprogramme.
- 19.17 The distribution of resources under this section would be as shown in tables 19.4-19.6.

19.18 Unlike the practice for the other regional commissions, resources for administration and conference and general services for ECE are not included under its own programme budget. The resources associated with those requirements are administered by the United Nations Office at Geneva and are consolidated under section 28E, Administration, Geneva, in respect of administration and general services, and under section 2, General Assembly and Economic and Social Council affairs and conference management, in respect of conference-servicing costs.

19.19 In order to permit a comparison among regional commissions while at the same time maintaining the advantages of integrated management and avoiding duplication of effort, the estimated resources (at current rates) to be provided by the United Nations Office at Geneva to ECE for general, administrative, conference and library services during the biennium 2010-2011 are summarized in table 19.7.

A. Policymaking organs

19.20 The governance structure of ECE has been reformed in accordance with the workplan on ECE reform (E/ECE/1434/Rev.1) adopted by ECE member States on 2 December 2005 and by the General Assembly in its resolution 60/248. The Commission, which reports to the Economic and Social Council, provides strategic direction to the work of the ECE Secretariat and is a forum for high-level policy dialogue on economic development for the region. It meets once every two years

for three working days. In the intersessional period, the Executive Committee is entrusted with the implementation of the overall policy set by the Commission. It meets regularly and as often as necessary to perform its governance role through, inter alia, the review and approval of programmes of work and subsidiary structures of the sectoral committees, ensuring coherence and coordination among subprogrammes. The eight sectoral committees act as governing bodies for the eight subprogrammes: the Committee on Environmental Policy (subprogramme 1); the Inland Transport Committee (subprogramme 2); the Conference of European Statisticians (subprogramme 3); the Committee on Economic Cooperation and Integration (subprogramme 4); the Committee on Sustainable Energy (subprogramme 5); the Committee on Trade (subprogramme 6); the Timber Committee (subprogramme 7); and the Committee on Housing and Land Management (subprogramme 8). These bodies meet for two to three days annually to provide guidance to ECE on work relating to their respective sectors.

B. Executive direction and management

Resource requirements (before recosting): \$7,022,300

- 19.21 In order to fulfil its responsibilities in terms of executive direction and overall management of ECE, this component has the following functions:
- (a) To feed the debate on the strategic direction of ECE and to develop a forward-looking strategy for adjusting ECE activities to respond to emerging and foreseeable priorities of its member States;
 - (b) To foster relationships with member Governments and keep abreast of the needs of ECE member States;
 - (c) To coordinate the planning and ensure the implementation of the ECE programme of work, to provide guidance and direction for the work of the Secretariat, and to promote transparency and interdivisional cooperation;
 - (d) To service meetings of the Commission and its Executive Committee, including the preparation of relevant documentation, and to ensure follow-up to their decisions; and to ensure an interface between the Executive Committee and the bureaux of the sectoral committees;
 - (e) To ensure efficient and inclusive processes for the monitoring and evaluation of the work of the subprogrammes, including the biennial evaluations of subprogramme performance by sectoral committees; and to encourage the undertaking of self-evaluations and the use of evaluation findings;
 - (f) To ensure the implementation of the resolutions and decisions of the General Assembly and the Economic and Social Council that are relevant to the work of ECE, including the regional follow-up to United Nations global conferences and events, in accordance with the Commission's role as a regional outpost of the United Nations, pursuant to Economic and Social Council resolution 1998/46;
 - (g) To provide clearance for ECE publications and key documents prepared for the sectoral committees and other subsidiary bodies of ECE;
 - (h) To contribute to increasing the visibility of ECE and knowledge about and use of ECE products through the dissemination of information about its activities;

- (i) To contribute, in close cooperation with the other regional commissions, to the United Nations reform discussion and implementation, in particular in relation to improving system-wide coherence in United Nations development work;
- (j) To cooperate and coordinate with other international organizations and United Nations departments, in particular within the framework of relevant inter-agency coordination processes;
- (k) To contribute to relevant reports of the Secretary-General for the General Assembly, the Economic and Social Council and other bodies and to provide other inputs requested by United Nations Headquarters;
- (l) To foster gender mainstreaming in ECE subprogrammes;
- (m) To ensure effective financial and human resources management as well as compliance with the Performance Appraisal System.

19.22 The executive direction and management component comprises the Office of the Executive Secretary, the Programme Planning, Monitoring and Evaluation Unit and the Information Unit.

External factors

- 19.23 The objectives and expected accomplishments under executive direction and management are expected to be achieved on the assumption that: (a) there are no major shortfalls in funding that might affect the assistance provided, the recruitment of staff and the timely delivery of products and services; (b) there is active participation and support of ECE member States; and (c) other organizations are willing and able to cooperate.

Outputs

19.24 During the biennium 2010-2011, the following final outputs will be delivered:

- (b) Other substantive activities (regular budget):
 - (i) Recurrent publications: catalogue of ECE publications (2); Compendium of Legal Instruments, Norms and Standards (2); ECE annual report (2); report on the progress made in achieving the Millennium Development Goals in the ECE region (1); update on the progress made in achieving the Goals in the ECE region (1);

 - (iii) Field projects: project on mainstreaming gender into economic policies related to the Working Group on Gender and Economy of the United Nations Special Programme for the Economies of Central Asia, in collaboration with ESCAP (1);
- (d) Conference services, administration, oversight (regular budget):
 - (i) Programme planning, budget and accounts: coordination and preparation of the ECE biennial programme plan (1); coordination and preparation of the ECE programme budget (1);
 - (ii) Evaluations: coordination and quality assurance in relation to the biennial evaluations of subprogramme performance by sectoral committees (1); promotion of the undertaking of self-evaluations and the use of evaluation findings (1).

- 19.25 The proposed resources for executive direction and management, which amount to \$7,022,300, reflecting a net increase of \$350,800, comprise: (a) \$6,427,200 for the funding of 18 posts (11 Professional and 7 General Service), reflecting a net increase of \$329,800 owing to the delayed impact of one post at the P-4 level, effective 1 January 2009, established in the context of General Assembly resolution 63/260, on development-related activities (\$270,600); and the inward redeployment to the Information Unit of one post at the P-5 level from subprogramme 1, Environment, partially offset by the outward redeployment of one post at the P-4 level from the Information Unit to subprogramme 8, Housing, land management and population (\$59,200); and (b) \$595,100 for non-post requirements, reflecting an increase of \$21,000 relating to contractual services.
- 19.26 The inward redeployment of one post at the P-5 level from subprogramme 1, Environment, is intended to address a request from member States of ECE following the reform carried out in 2006 that ECE enhance its communications, public relations and contacts with the media in order to achieve an increase in the number and enhanced quality of targeted materials and publications available on the Internet and to enhance the production of printed materials. The outward redeployment of one post at the P-4 level to subprogramme 8, Housing, land management and

population, is intended to address the need for higher-level support in servicing the Committee on Housing and Land Management with its enhanced programme element, which now includes energy efficiency of the housing sector linked to climate change.

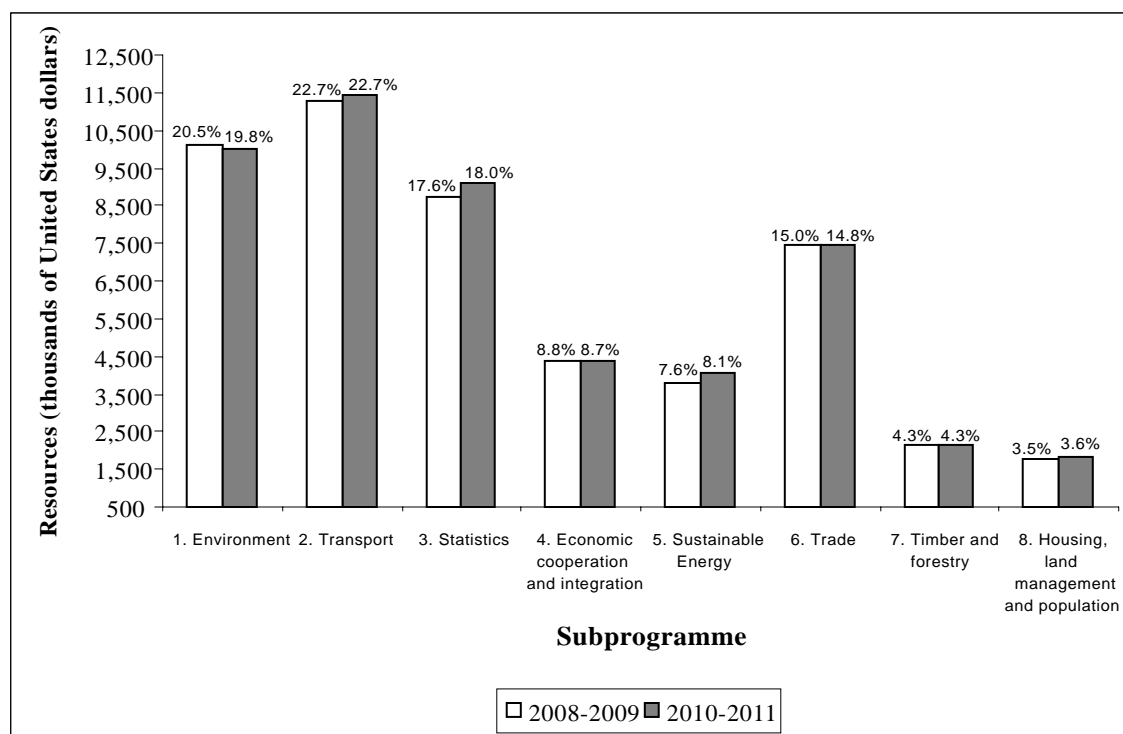
- 19.27 The increase of \$21,000 for external printing under contractual services is due to additional requirements for the translation into languages of developing countries and countries with economies in transition of documents and materials required for meetings and seminars that cannot be carried out by Conference Services.
- 19.28 During the biennium 2010-2011, projected extrabudgetary resources of \$10,200 under executive direction and management will finance the activities related to the 15-year review of the Beijing Declaration and Platform for Action and the follow-up to the global Beijing review event. Projected 2010-2011 extrabudgetary resources are based on currently available funds in the trust fund. No indication has been received concerning the availability of additional funding.

- 19.32 The proposed resources for subprogramme 1, Environment, which amount to \$10,006,000, reflecting a net decrease of \$115,800, comprise: (a) \$9,841,500 for the funding of 32 posts (21 Professional and 11 General Service), reflecting a net decrease of \$115,800 due to the outward redeployment of one post at the P-5 level to the Information Unit of the executive direction and management component, partially offset by the inward redeployment of one post at the P-3 level from subprogramme 8, Housing, land management and population; and (b) \$164,500 for non-post requirements relating to consultants and experts and travel of staff.

- 19.37 The proposed resources for subprogramme 2, Transport, which amount to \$11,419,700, reflecting a net increase of \$145,900, comprise: (a) \$11,247,100 for the funding of 38 posts (23 Professional and 15 General Service), reflecting an increase of \$166,300 due to the proposed establishment of

one P-3 post, Economic Affairs Officer; and (b) \$172,600 for non-post requirements, reflecting a decrease of \$20,400 relating to contractual services.

- 19.38 The proposed new P-3 post would be responsible for work related to fuel standards and on global warming abatement in response to the decision of the Governments that are members of the World Forum for Harmonization of Vehicle Regulations.
- 19.39 The decrease of \$20,400 for external printing under contractual services reflects printing requirements that would be met from in-house resources.
- 19.40 During the biennium 2010-2011, projected extrabudgetary resources of \$4,192,100 will: (a) enable the supervision, on behalf of the Contracting Parties to the Convention, of the application of the TIR Customs transit regime, including the operation of the TIR guarantee system and the fulfilment of the functions entrusted to it by the TIR Administrative Committee; (b) undertake activities relating to the TEM and TER projects; (c) implement the Transport, Health and Environment Pan-European Programme; and (d) enable the organization of capacity-building workshops. - 19.70 During the biennium 2010-2011, projected extrabudgetary resources of \$614,600 will: (a) finance the preparations of country profiles on the housing sector, land administration reviews and policy guidelines, including capacity-building activities to implement them, as well as support the work on energy efficiency in housing and the project on the management of multifamily housing; and (b) enable the coordination of the Generations and Gender Programme and the carrying out of expert missions to member States, as well as capacity-development activities in support of the ECE regional implementation strategy of the Madrid International Plan of Action on Ageing. The projected decrease in extrabudgetary resources for 2010-2011 is due to one project having been completed in 2008, partially offset by additional known funding for new and existing projects.

D. Programme support

Resource requirements (before recosting): \$8,425,900

- 19.71 The programme support component comprises the Executive Office, the Information Systems Unit, and the Technical Cooperation Unit. Services provided under this heading relate to budget and finance, human resources management, general and technical services, conference services, information technology services and coordination of functions for intersectoral and cross-sectoral activities.

Outputs

- 19.72 During the biennium 2010-2011, the following outputs will be delivered by the Executive Office and, for information-technology-related support, by the Information Systems Unit:
- (a) Overall management: coordination of administrative support, including human resources, financial and budgetary support provided to ECE as a whole, and provision of guidance and supervision on control, monitoring and reporting on the implementation of the ECE programme budget;
 - (b) General and technical service:
 - (i) Determination of ECE policy related to information technology strategies and acquisition plans; planning and coordination of informatic and telematic resources; collaborative work with service providers; and supervision, monitoring and control of all outsourced information technology operations;
 - (ii) Project management and establishment of information technology resources, provision of information technology services (Internet/Intranet, development of core ECE systems and groupware applications) to ECE divisions in support of the substantive programmes to improve cooperation with member States and other international organizations in the area of the collection, dissemination and communication of information;
 - (iii) Acquisition of information technology equipment and other equipment and furniture, materials and supplies; desktop configuration and installation, including security measures such as anti-virus software; provision of help desk services to ECE as a whole; installation of new infrastructure systems and services such as an archiving/documentation infrastructure or a Web content management system;

- (iv) Operation and coordination of functions related to the Integrated Management Information System (or the future enterprise resource planning system) within ECE;
- (c) Conference services:
 - (i) Establishment and management of the ECE programme of meetings, related documentation, facilities and services required in close coordination with conference services at Geneva; arrangements for ECE meetings hosted outside Geneva by member Governments; and informal meetings held outside Geneva within the context of the ECE programme of workshops for countries with economies in transition;
 - (ii) Preparation and organization of the biennial session of ECE, the sessions of the ECE Executive Committee and required documentation and meetings services;
 - (iii) Preparation and administration of the programme of publications;
- (d) Programme budget and accounts:
 - (i) Preparation of the biennial programme budget and financial performance reports in liaison with the Office of Programme Planning, Budget and Accounts;
 - (ii) Financial control and certification of all accounts under the responsibility of ECE in cooperation with the Office of Programme Planning, Budget and Accounts and the Financial Resources Management Service at the United Nations Office at Geneva;
 - (iii) Administration of technical cooperation activities and extrabudgetary resources within ECE, including regional advisory services under budget section 22, Regular programme of technical cooperation;
- (e) Human resources management:
 - (i) Administration of ECE staff and other personnel, including recruitment, placement and career development, in coordination with the Human Resources Management Service of the United Nations Office at Geneva and the Office of Human Resources Management at Headquarters;
 - (ii) Identification of staff training needs, including the provision of training to upgrade professional skills and in-house training in computer applications and arrangements for appropriate courses in cooperation with the Staff Development and Learning Service, United Nations Office at Geneva;
 - (iii) Staff-management relations in the context of the ECE Sectoral Assembly and elected staff representatives;
- (f) Technical cooperation management:
 - (i) Reporting on technical cooperation issues and activities for the biennial sessions of ECE and meetings of the Executive Committee;
 - (ii) Supporting and coordinating the monitoring and evaluation of ECE technical assistance activities in cooperation with the Programme Planning, Monitoring and Evaluation Unit, promoting the application of the evaluation findings and ensuring that those activities are in line with the ECE technical cooperation strategy;
 - (iii) Leading and providing secretariat support to the work of the ECE Working Group on Technical Cooperation and ensuring follow-up to that work;

- (iv) Promoting and facilitating fund-raising in cooperation with ECE divisions and regional advisers, in particular the preparation of proposals for possible funding from the Development Account;
- (v) Supporting and coordinating multisectoral/intersectoral technical assistance activities relating to ECE areas of expertise, including those developed within a subregional framework;
- (vi) Facilitating the linking of ECE activities with the work of the relevant United Nations country teams, when appropriate;
- (vii) Preparation of relevant inputs to the report of the Secretary-General to the Economic and Social Council, the General Assembly and other intergovernmental bodies, as may be required by Headquarters.

- 19.73 The proposed resources for programme support, which amount to \$8,425,900, reflecting a net increase of \$61,700, comprise: (a) \$5,547,600 for the funding of 20 posts (10 Professional and 10 General Service), reflecting an increase of \$183,500 owing to the delayed impact of one post at the P-3 level, effective 1 January 2009, established in the context of General Assembly resolution 63/260, on development-related activities; and (b) \$2,878,300, reflecting a net decrease of \$121,800 for non-post requirements relating to consultants and experts, contractual services, furniture and equipment, and grants and contributions.
- 19.74 The net decrease of \$121,800 under non-post requirements is the net result of decreased requirements for consultancy services, as the provision of external specialized expertise in the area of information and communications technology is planned to be obtained through the use of contractual services; reduced requirements for the acquisition and replacement of office furniture and equipment, in line with the replacement/useful life cycle of the equipment; and decreased requirements under grants and contributions, reflecting a reduction in the cost of some of the services provided by the Information and Communication Technology Service of the United Nations Office at Geneva and the International Computing Centre; partially offset by increased requirements for contractual services to implement a Web Content Management System project and to upgrade all of the desktops in response to information technology security concerns.
- 19.75 During the biennium 2010-2011, projected extrabudgetary resources of \$2,207,500 will: (a) support and coordinate multisectoral/intersectoral technical cooperation activities relating to ECE areas of expertise (trade and trade facilitation, transport, energy, environment, public-private partnerships, competitiveness and innovation), including those developed within a subregional framework such as the United Nations Special Programme for the Economies of Central Asia; and

(b) supplement the Executive Office staff in providing administrative support for the extrabudgetary activities of ECE. Projected 2010-2011 extrabudgetary resources are based on a current and projected level of funding for a new project under the Technical Cooperation Unit and additional staffing requirement of the Executive Office under the programme support component.

Advisory Committee on Administrative and Budgetary Questions
(A/62/7 and Corr.1)

The Advisory Committee continues to emphasize the importance of reducing the relative weight of administrative support costs compared with the resources allocated to the substantive activities of the programme of work, which benefit the Member States directly. It remains convinced that there is room for further improvements in work processes, eliminating inefficiencies and duplications as well as for generating additional synergies among the regional commissions. It urges the commissions to continue to pursue such efforts vigorously (para. V.3)

The Advisory Committee encourages the commissions to take action to further reduce the number of days Professional posts remain vacant and to meet the organizational target (para. V.6)

The United Nations Office at Geneva provides administrative support to ECE. ECE will continue to work closely with the Office in order to introduce improvements in work processes. Further, ECE will continue to coordinate with the regional commissions in order to enhance synergies.

Concerning information and communications technology (ICT) processes, ECE is actively coordinating with Headquarters, notably the Office of Information and Communications Technology and other offices away from Headquarters on ICT-related matters such as information technology infrastructure, global projects and ICT standards. For the latter, it should be noted that ECE continues to follow all standards as outlined and approved by the Office of Information and Communications Technology. Any new ICT projects/initiatives are documented in a "business case", presented to the in-house information technology committee and subsequently, if needed, to the global Project Review Committee at Headquarters. Regarding the relationship with the United Nations Office at Geneva on information technology-related matters, the Office's Information and Communication Technology Service and ECE have put in place a service agreement (since 2002), which is revised and adapted on an annual basis.

For upcoming staff retirements at the Professional level and above, ECE supervisors/ Programme Case officers are requested to start the vacancy announcement preparation as early as 10 months before the retirement due date, in order to allow for its circulation 6 to 8 months before the retirement date.

*Brief description
of the recommendation*

The Advisory Committee recalls its view that the considerable investments made in communications infrastructure should lead to reduced requirements for travel. It also emphasizes that travel should always be justified on the basis of functional requirements and requests that the regional commissions continue to monitor official travel closely (para. V.10).

*Action taken to implement
the recommendation*

For unforeseen vacancies due to transfers, promotions and resignations, programme managers are requested to promptly start the vacancy announcement preparation once ECE management has been notified of the status of the incumbency of the post.

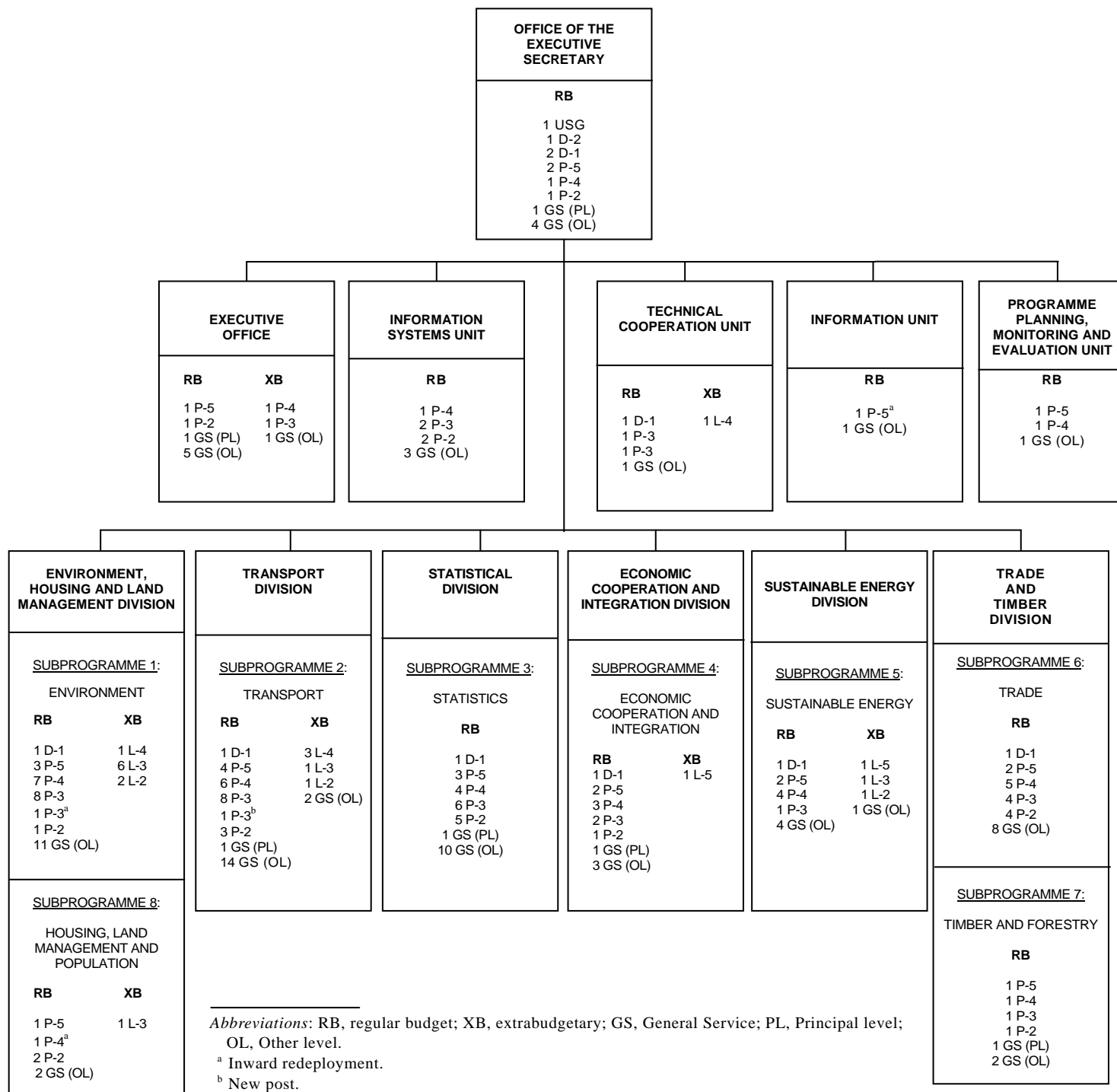
Travel is normally undertaken when the use of Internet or audio/videoconference facilities is not possible or would not provide the desired results. To the extent possible, missions continue to be planned back-to-back to save on travel costs.

In 2008, ECE hosted 27 videoconferences and participated in approximately 30 hosted by the United Nations Office at Geneva and by Headquarters for meetings with the Department of Management.

While there is no discernible reduction in staff travel costs, the use of information and communications technology infrastructure has actually contributed to reducing the overall increase in such costs resulting from the growing need for ECE staff to participate in meetings, the higher cost of travel in general and in particular in Central Asia, where travel is expensive.
