- 9.1 The overall objective of the programme is to promote and support international cooperation in the pursuit of sustained economic growth, the eradication of poverty and hunger, and sustainable development for all. While focused on advancing the development pillar, the programme also seeks to contribute to a mutually reinforcing relationship among the three pillars of the United Nations work: peace and security, development and human rights.
- 9.2 The programme is under the responsibility of the Department of Economic and Social Affairs. Its key programmatic thrusts are: (a) to provide substantive support to the bodies established under the Charter of the United Nations dealing with development issues, namely, the General Assembly, the Economic and Social Council and its related functional commissions, and expert bodies, and (b) to analyse development prospects globally.
- 9.3 The programme has put development issues at the centre of global deliberations and helped Member States to forge a shared vision of development based on internationally agreed development goals, as identified in the outcomes of the major United Nations conferences and summits, that are collectively referred to as the United Nations development agenda.
- 9.4 In the biennium 2010-2011, the programme will continue to mobilize and provide practical support to help translate those commitments into action. It will focus on the delivery of four main functions: (a) research and analysis on development issues and support to the global statistical system; (b) normative and policy support to United Nations intergovernmental processes; (c) assistance in capacity development and active promotion of capacity-building activities in order to support implementation of global conference outcomes at the country level; and (d) fostering collaboration and partnerships within the United Nations system and with civil society and the private sector.
- 9.5 Fulfilling those functions requires strengthened analytical and monitoring capacity, in particular to identify and address cross-cutting policy challenges and to support both national development strategies and accountability and monitoring mechanisms at the intergovernmental level. Strategic

integration is also essential, in order to promote a coherent implementation process for the internationally agreed development goals. This includes enhancing horizontal linkages across the subprogrammes of programme 7 to enable more effective and flexible support to Member States in pursuing the development agenda, in cooperation with entities of the Executive Committee on Economic and Social Affairs, to which the programme provides strategic support and ensures its stronger linkages with the United Nations Development Group, other executive committees and various other partners.

- 9.6 The programme will continue to emphasize the mainstreaming of gender perspectives into all policies and programmes, and to provide advice and support in this field to the entire Organization, Member States and others. Consultations have taken place among concerned entities of the Executive Committee on Economic and Social Affairs at the thematic cluster level. Those consultations are expected to lead to better coordination and more collaborative work among programmes in major common work areas of the United Nations Secretariat in the social and economic sectors.
- 9.7 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized below in table 9.3 and as described in the output information for each subprogramme.

- 9.8 The overall regular budget resources required for the biennium 2010-2011 for this section amount to \$169,644,300 before recosting, reflecting an increase of \$4,109,900 (or 2.5 per cent). The growth shown in table 9.5 below can be summarized as follows:
  - (a) A decrease of \$153,900 under policymaking organs which relates to: (a) the discontinuation of the one-time provision of \$108,100 for the activities of the Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey Consensus, authorized by the Assembly in its resolution 61/191; and (b) a reduction of \$45,800 from the provision for sessions of the United Nations Forum on Forests, which is due to the change in frequency of the Forum sessions from annual to biennial in accordance with Economic and Social Council resolution 2006/49;
  - (b) An increase of \$320,100 in executive direction and management, which results mainly from the full funding of one P-5 post, approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities;
  - (c) A net increase of \$2,812,300 under programme of work relating to:
    - (i) A net increase of \$185,000 in subprogramme 1 owing to the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities (\$299,800), and an increase under contractual services, partly offset by the abolition of one General Service (Other level) post (\$149,700) to rationalize and streamline the post structure through process reengineering and the optimization of mandates, delivery schedules and methods;

- (ii) The increase of \$1,474,800 in subprogramme 2 owing to the full funding of five posts (1 P-5, 2 P-4 and 2 P-3) approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities and an increase of \$26,500 mostly under contractual services;
- (iii) A net increase of \$148,400 in subprogramme 3 mainly attributable to the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities (\$299,800) to support the secretariat of the Permanent Forum on Indigenous Issues, partly offset by abolition of one General Service (Other level) post to rationalize and streamline the post structure through process re-engineering and the optimization of mandates, delivery schedules and methods (\$149,600);
- (iv) A net decrease of \$3,000 in subprogramme 4 owing to the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities (\$299,900), partly offset by abolition of two General Service (Other level) posts (\$299,300), and a decrease of \$3,600 for related computer equipment;
- (v) A net increase of \$238,600 in subprogramme 5 owing to the full funding of one P-3 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities, partly offset by the decrease of \$10,200 under consultants, reflecting the reduced requirements in external specialized expertise;
- (vi) A net increase of \$148,400 in subprogramme 6 owing to the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities (\$299,900), partly offset by abolition of one General Service (Other level) post (\$149,700) and the related decrease of \$1,800 for replacement of computer equipment;
- (vii) A decrease of \$10,200 in subprogramme 7 owing to the reduced requirements under consultants, resulting from more reliance on in-house expertise;
- (viii) A net decrease of \$10,200 in subprogramme 8 owing to the reduction of \$41,000 under consultants, partly offset by an increase of \$30,800 under general temporary assistance, representing actual requirements on the basis of previous pattern of expenditure;
- (ix) A net increase of \$345,800 in subprogramme 9 owing to the full funding of one P-5 post, approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities (\$350,900), partly offset by a small decrease of \$5,100 under ad hoc expert groups;
- (x) A net increase of \$294,700 in subprogramme 10 owing to the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities (\$299,900), partly offset by a decrease of \$5,200 under consultants;
- (d) A decrease of \$68,600 under programme support results mainly from the reduction of non-post requirements, largely under general temporary assistance and bringing requirements in line with expenditure patterns.
- 9.9 The overall purpose of the technical cooperation activities of the Department of Economic and Social Affairs is to support the efforts of the developing countries and countries with economies in transition, to strengthen national capacities and to promote the sharing of development expertise

and best practices. The Department's technical cooperation functions represent an integral component of its overall work programme, intimately linked to the normative and analytical functions it carries out in the specific economic and social areas covered by its programme of work. Across these areas, the mission of the Department's technical cooperation programme is to facilitate and support national efforts to meet in an integrated way the commitments, targets and goals of international conferences, including the Millennium Summit, the International Conference on Financing for Development, the World Summit on Sustainable Development, the World Summit on Social Development, the Fourth World Conference on Women, and others. Based on its experience in carrying out its technical cooperation programme, the Department provides feedback to the intergovernmental processes on the progress and barriers faced in achieving these goals, thereby helping to link international policy deliberations and national policy implementation.

- 9.10 During the biennium 2010-2011, total projected extrabudgetary resources amounting to \$133,929,000 will complement resources from the regular budget to finance various substantive and technical cooperation activities, including consultancy, expert groups, travel, technical advisory services, training, workshops, seminars and field projects. With respect to the Department's capacity development programme, which is resourced largely through bilateral and multilateral contributions from donor countries, the Department expects a decline of \$17,360,300, in the biennium 2010-2011 in comparison with the biennium 2008-2009, given the current funding constraints faced by the Department's traditional donor base owing to the ongoing financial crisis and market instability. While the long-term impact of the crisis is yet to be determined, the Department anticipates that donors will not be in a position to maintain the same level of support to the ongoing programmes and new and emerging initiatives in 2010-2011. In response to this decline, the Department will augment its outreach to emerging donors, as well as explore innovative collaborations with research institutes, think tanks, and non-governmental organizations, which can partner collaboratively in the implementation of the capacity development work.
- 9.11 Evaluation is an integral part of the programme cycle and, in this regard, the resources allocated to programme implementation will be used to some extent to evaluate the Department's major outputs and activities. Pursuant to resolution 58/269, it is estimated that \$1,110,800 under the regular budget will be dedicated to such activities, while no extrabudgetary resources are projected. The exact scale of evaluation activities in the biennium 2010-2011 will be determined during the course of the biennium based on the implementation of evaluation plans developed for all substantive subprogrammes. The staff time devoted to self-assessment and self-evaluation under each subprogramme is estimated to be 89 work-months.
- 9.12 The estimated percentage distribution of the total resources to be made available to the Department in the biennium 2010-2011 will be as follows:

- 9.13 Provision is made for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes, the substantive servicing of which is the responsibility of the Department of Economic and Social Affairs and which are deemed to require specific provisions.
- 9.14 The amount of \$2,686,300 includes a decrease of \$153,900, comprising: (a) the discontinuation of the one-time provision of \$108,100 for the activities of the Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey Consensus, authorized by the Assembly in its resolution 61/191; and (b) a reduction of \$45,800 from the provision for sessions of the United Nations Forum on Forests, as a result of the change in frequency of the Forum sessions from annual to biennial in accordance with Economic and Social Council resolution 2006/49.

# Standing intergovernmental organs and expert bodies

### **Statistical Commission**

### Resource requirements (before recosting): \$106,000

9.15 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I). Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) and 1566 (L), are to assist the Council in: (a) promoting the development of national statistics and the improvement of their comparability; (b) coordinating the statistical work of the specialized agencies; (c) developing the central statistical services of the Secretariat; (d) advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical

information; and (e) promoting the improvement of statistical methods in general. The Commission consists of 24 representatives of Member States elected by the Economic and Social Council for a period of four years.

9.16 Bearing in mind General Assembly resolution 50/227 and the need to provide for more continuity in the Statistical Commission's decision-making and oversight of the global statistical process, and with the aim of enabling the Commission to follow up on the statistical implications of the major United Nations conferences and summits, the Council, in its resolution 1999/8, decided that the Commission should meet annually for a period of four working days in New York, beginning in 2000. The forty-first and forty-second sessions of the Statistical Commission are scheduled to be held in 2010 and 2011, respectively.

# **Commission on Population and Development**

### Resource requirements (before recosting): \$121,700

- 9.17 The Population Commission was established by the Economic and Social Council in its resolution 3 (III). Its terms of reference were initially set out in Council resolution 150 (VII). In its resolution 49/128, the General Assembly decided that the revitalized Population Commission should be renamed the Commission on Population and Development and that it should meet on an annual basis. The Commission consists of 47 representatives of Member States elected by the Economic and Social Council for a period of four years (Council decision 1995/320). It normally meets annually for a period of five working days. The forty-third and forty-fourth sessions of the Commission are scheduled to be held in 2010 and 2011, respectively.
- 9.18 Under its terms of reference the Commission is to assist the Economic and Social Council by: (a) arranging for studies and advising the Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance as well as addressing any population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; (b) monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and global levels, identifying reasons for success and failure, and advising the Council thereon; and (c) reviewing the findings of research and analysis pertaining to the interrelationships between population and development at the national, regional and international levels and advising the Council thereon.

### **Commission for Social Development**

### Resource requirements (before recosting): \$202,900

9.19 The Social Commission was established as a functional commission of the Economic and Social Council by the Council in its resolution 10 (II). As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI), renamed it the Commission for Social Development to clarify its role as a preparatory body of the Council for the entire range of social development policy. Following the convening of the World Summit for Social Development in 1995, the Council, by its resolution 1995/60, decided that the Commission should review, on a periodic basis, issues related to the follow-up and implementation of the Copenhagen Declaration on Social Development and the Programme of Action adopted by the Summit. By its resolution 1996/7, the Council decided to expand the membership of the Commission from 32 to 46 representatives of Member States, elected by the Council also decided by its resolution 2005/11 that the Commission would be organized in a series of two-year action-oriented

implementation cycles that would include a review segment and a policy segment. The forty-eighth and forty-ninth sessions of the Commission for Social Development are scheduled to be held in 2010 and 2011, respectively.

#### **Commission on the Status of Women**

#### Resource requirements (before recosting): \$236,900

- 9.20 The Commission on the Status of Women was established as a functional commission of the Economic and Social Council by the Council in its resolution 11 (II). The original membership of 15 representatives of Member States was increased to 18 in 1951, to 21 in 1961 and to 32 in 1966. By its resolution 1989/45, the Council decided to enlarge the membership in 1990 to 45 representatives elected by the Council for a period of four years. The Commission reports to the Council on matters concerning the promotion of women's rights in the political, economic, social and educational fields and makes recommendations to the Council on problems requiring immediate attention in the field of women's rights. It meets annually in New York for 10 working days. The fifty-fourth and fifty-fifth sessions of the Commission on the Status of Women are scheduled to be held in 2010 and 2011, respectively.
- 9.21 The Commission has a central role within the United Nations system in monitoring the implementation of the Beijing Declaration and Platform for Action and in advising the Economic and Social Council thereon. In its resolution 1996/6, the Council gave the Commission a catalytic role in mainstreaming gender perspectives in policies and programmes and confirmed its existing mandates. In its resolution 2006/9, the Council decided that the Commission would consider one priority theme at each session for the period 2007-2009, based on the Beijing Platform for Action and the outcome of the twenty-third special session of the General Assembly. The Commission would hold an interactive high-level round table in parallel chambers, two interactive expert panels on the priority theme of each session, as well as a panel on an emerging issue, a panel on the priority theme of the subsequent session, and an interactive dialogue to review a theme from an earlier session. Under Council resolutions 76 (V), 3041 (XI) and 1983/27, the Secretary-General is mandated to prepare lists of confidential and non-confidential communications on the status of women for submission to the Commission on the Status of Women.

#### **Commission on Sustainable Development**

#### Resource requirements (before recosting): \$528,300

9.22 The Commission on Sustainable Development was established as a functional commission of the Economic and Social Council by the Council in its decision 1993/207. Its functions are set out in General Assembly resolution 47/191. The Commission is composed of 53 representatives of Member States elected by the Council for a period of three years, and meets annually for a period of two to three weeks. The Commission reports to the Council and provides recommendations to the Assembly through the Council. As a consequence of the World Summit on Sustainable Development and Council resolution 2003/61 on the future programme of work of the Commission on Sustainable Development, the work of the Commission is organized in a series of two-year action-oriented implementation cycles, which include a review session and a policy session. It will continue to meet annually as in the past; every second year will be reserved for intergovernmental negotiations. The review session will focus on the results of the implementation of the programme of work by Governments, international organizations and major groups at the national and regional levels and will establish the topics to be negotiated in the following year's session of the Commission. The overall workload of the Commission will remain unchanged. The eighteenth and nineteenth sessions of the Commission on Sustainable Development are scheduled to be held in 2010 and 2011, respectively.

### **Committee for Development Policy**

#### Resource requirements (before recosting): \$354,800

- 9.23 The Economic and Social Council, in annex I to its resolution 1998/46, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) and 1079 (XXXIX) and decision 1995/215, the Committee for Development Policy, and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts with expertise drawn from the fields of economic development, social development and environmental protection who reflect adequate geographical and gender balance. Its membership includes experts who are able to make a contribution on emerging issues and the multilateral process. The experts are nominated by the Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years.
- 9.24 The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. The Council decides on the programme of work of the Committee. The Committee meets in annual session for five working days and submits its report to the Council at its substantive session in July. The General Assembly, the Secretary-General and the subsidiary bodies of the Council may propose, through the Council, issues for consideration by the Committee. With respect to the submission of its report to the Council, the Council to introduce the report and respond to any queries raised. The twelfth and thirteenth sessions of the Council to Development Policy are scheduled to be held in 2010 and 2011, respectively.

#### **Committee of Experts on Public Administration**

### Resource requirements (before recosting): \$332,200

9.25 The Committee of Experts on Public Administration was established by the Economic and Social Council in its resolution 2001/45 and consists of 24 experts appointed in their personal capacity by the Council upon the nomination of the Secretary-General. It convened its first session at United Nations Headquarters from 22 to 26 July 2002 and holds annual one-week sessions since 2003 in accordance with Council resolution 2003/60. The Committee is the successor of the former Meeting of Experts on the United Nations Programme in Public Administration and Finance. Its role is to support Member States in building capacity to meet the basic needs of their populations through the discussion of themes relating to the role of the public sector in the development process. The ninth and tenth sessions of the Committee of Experts on Public Administration are scheduled to be held in 2010 and 2011, respectively.

### **Committee of Experts on International Cooperation in Tax Matters**

### Resource requirements (before recosting): \$351,300

9.26 By its resolution 2004/69, the Economic and Social Council decided to rename the Ad Hoc Group of Experts on International Cooperation in Tax Matters the Committee of Experts on International Cooperation in Tax Matters. The Committee comprises 25 members nominated by Governments who act in their expert capacity. They are appointed by the Secretary-General, after notification of the Council, for a term of four years and are drawn from the fields of tax policy and tax administration. Their appointment reflects adequate equitable geographical distribution, representing different tax systems. As from 2005, the Committee meets on a yearly basis for a period of five days in Geneva. The sixth and seventh sessions of the Committee of Experts on International Cooperation in Tax Matters are scheduled to be held in 2010 and 2011, respectively.

- 9.27 The Committee of Experts is mandated to: (a) keep under review and update as necessary the United Nations Model Double Taxation Convention between Developed and Developing Countries and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries; (b) provide a framework for dialogue with a view to enhancing and promoting international tax cooperation among national tax authorities; (c) consider how new and emerging issues could affect international cooperation in tax matters and develop assessments, commentaries and appropriate recommendations; (d) make recommendations on capacity-building and the provision of technical assistance to developing countries and countries with economies in transition; and (e) give special attention to developing countries and countries with economies in transition in dealing with all the above issues. The Committee submits its report on the work of its annual session to the Economic and Social Council at its substantive session.
- 9.28 By its resolution 2006/48, the Council noted the creation of four subcommittees on substantive matters, namely, treaty abuses, mutual assistance in collecting tax debts, definition of permanent establishment, and exchange of information, and two working groups, on international tax arbitration and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries. At its second session, the Committee established a new subcommittee on dispute resolution (replacing the former working group on tax arbitration) and a new working group on treatment of Islamic financial instruments, while the subcommittee on mutual assistance in collection of taxes completed its work.

### **United Nations Forum on Forests**

### Resource requirements (before recosting): \$100,900

- 9.29 By its resolution 2000/35, the Economic and Social Council established the United Nations Forum on Forests as an intergovernmental subsidiary body of the Council, to serve as a permanent policy and political forum, with the main objective of promoting the management, conservation and sustainable development of all types of forests, and to strengthen long-term political commitment to that end. The Forum is composed of all States Members of the United Nations and members of the specialized agencies with full and equal participation, including voting rights.
- 9.30 The Forum works on the basis of a multi-year programme of work and is mandated to perform a set of principal functions related to: supporting efforts to achieve the shared global objectives on forests; facilitating the implementation of a non-legally binding instrument on all types of forests; policy development; international coordination among organizations, instruments and institutions; monitoring, assessment and reporting; and strengthening political commitment. The Economic and Social Council, in its resolution 2006/49, decided: (a) to strengthen the international arrangement on forests and set shared global objectives on forests to achieve progress by 2015; and (b) that, following its seventh session in 2007, the Forum shall meet biennially for a period of up to two weeks on the basis of a focused multi-year programme of work adopted by the Forum at its seventh session. The ninth session of the United Nations Forum on Forests is scheduled to be held in 2011.

#### **Permanent Forum on Indigenous Issues**

#### Resource requirements (before recosting): \$351,300

9.31 The Economic and Social Council, in its resolution 2000/22, decided to establish, as a subsidiary organ of the Council, a permanent forum on indigenous issues, consisting of 16 members, 8 members to be nominated by Governments and elected by the Council and 8 members to be appointed by the President of the Council following formal consultation with the Bureau and the regional groups, through their coordinators. Nominations are decided on the basis of broad consultations with indigenous organizations, taking into account the diversity and geographical

distribution of the indigenous people of the world as well as the principles of transparency, representative and equal opportunity for all indigenous people, including internal processes, when appropriate, and local indigenous consultation processes. All members serve in their personal capacity as independent experts on indigenous issues for a period of three years, with the possibility of re-election or reappointment for one further period. States, United Nations bodies and organs, intergovernmental organizations and non-governmental organizations in consultative status with the Council may participate as observers. Organizations of indigenous people may also participate as observers, in accordance with the procedures that have been applied in the Working Group on Indigenous Populations of the Subcommission on the Promotion and Protection of Human Rights.

9.32 The Economic and Social Council decided that the Permanent Forum shall hold an annual session of 10 working days at the United Nations Office at Geneva or at United Nations Headquarters or at such other place as the Permanent Forum may decide in accordance with the existing Financial Regulations and Rules of the United Nations. The ninth and tenth sessions of the Permanent Forum on Indigenous Issues are scheduled to be held in 2010 and 2011, respectively.

# **B.** Executive direction and management

# Resource requirements (before recosting): \$6,781,300

- 9.33 The Under-Secretary-General for Economic and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and approved programme of work. He serves as convener of the Executive Committee on Economic and Social Affairs as well as the Programme Manager of the Development Account. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs, the Assistant Secretary-General for Economic Development, and the Assistant Secretary-General and Special Adviser to the Secretary-General on Gender Issues and Advancement of Women.
- 9.34 The Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs supports the Under-Secretary-General by providing substantive support to the Economic and Social Council and other relevant intergovernmental bodies. He also serves as Secretary of the United Nations System Chief Executives Board for Coordination (CEB). The Assistant Secretary-General for Economic Development assists the Under-Secretary-General by providing expert advice on development issues and by overseeing and coordinating data analysis and information, and is also responsible for the overall coordination of technical cooperation activities.
- 9.35 The functions of the Special Adviser on Gender issues and Advancement of Women, who reports directly to the Secretary-General on gender equality issues, including the progress made by departments and offices within the United Nations system in mainstreaming a gender perspective in all areas of work are programmed under subprogramme 2, Gender issues and advancement of women. The Special Adviser, assisted by the Focal Point for Women in the Secretariat, supports and advises programme managers in their efforts to meet General Assembly-mandated targets on gender balance. As Chairperson of the Inter-Agency Network on Women and Gender Equality, the Special Adviser provides leadership in the area of gender mainstreaming in both the substantive and operational areas.
- 9.36 The Office of the Under-Secretary-General provides support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Assistant Secretary-General for Economic Development on the planning, coordination, management and assessment of the programme of work of the Department.

The Office also assists the Under-Secretary-General in his or her capacity as the Programme Manager of the Development Account.


9.37 The amount of \$5,426,100 provides for 16 posts (1 Under-Secretary-General, 2 Assistant Secretary-General, 7 Professional and 6 General Service (Other level)) and reflects an increase of \$350,900, resulting from the full funding of one P-5 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related

activities. The amount of \$1,355,200 for non-post requirements, reflecting a decrease of \$30,800, provides, inter alia, for: general temporary assistance, overtime, consultants, travel of staff, and the United Nations contribution to the activities of the Non-Governmental Liaison Service. The decrease of \$30,800 under general temporary assistance reflects actual requirements, consistent with expenditure patterns of recent bienniums.

# **External factors**

9.41 The amount of \$12,856,000, including a net increase of \$150,100, provides for 46 posts, including 28 Professional and above and 18 General Service posts, to service meetings of intergovernmental and other bodies, such as the Second Committee of the General Assembly, the Economic and Social Council, the Committee on Non-Governmental Organizations and ad hoc advisory groups on African countries emerging from conflict; preparation of parliamentary documentation, publications and technical material (website, newsletters, brochures) for these meetings; organization of technical cooperation activities (seminars, workshops, field projects); support for

the triennial comprehensive review process; and provision of substantive servicing and support to the biennial Development Cooperation Forum and the annual ministerial review. The net increase of \$150,100 results from: (a) the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development related activities (\$299,800); partly offset by (b) abolition of one General Service (Other level) post to rationalize and streamline the post structure through process re-engineering and optimization of mandates delivery schedules and methods (\$149,700). The amount of \$839,900 for non-post requirements, reflecting an increase of \$34,900, provides mostly for: (a) consultants; (b) experts groups; (c) travel of staff; (d) contractual services; and (e) contribution by the United Nations to the CEB Subcommittee on Nutrition. The increase of \$34,900 is largely attributable to additional requirements for contractual services for redesigning and updating the Internet-based Economic and Social Council home page in several official languages.

9.42 During the biennium 2010-2011, projected extrabudgetary resources of \$1,529,500 will be used:
(a) to ensure multi-stakeholder participation in the annual ministerial review preparatory process;

- 9.46 The amount of \$12,093,100, reflecting an increase of \$1,448,300, provides for 42 posts, which include: (a) 1 Assistant Secretary-General, 8 Professional and above and 4 General Service posts in the Office of the Special Adviser on Gender Issues; and (b) 19 Professional and above and 10 General Service posts in the Division for the Advancement of Women. These posts are required to coordinate inter-agency work on gender mainstreaming; women, peace and security; violence against women and improvement of the status of women throughout the United Nations system; service the Inter-Agency Network on Women and Gender Equality; service gender equality agenda items in intergovernmental meetings, support the Bureau of the Commission on the Status of Women; organize the participation of non-governmental organizations in gender equality activities of the Organization; monitor and report on follow-up and implementation of the Beijing Platform for Action; carry out outreach activities through publications and events and provide technical assistance to Member States on request. The increase of \$1,448,300 results from the full funding of five posts (1 P-5, 2 P-4 and 2 P-3) approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development related activities. The amount of \$793,300 for non-post requirements, reflecting a net increase of \$26,500, provides primarily for: (a) consultants; (b) experts groups; (c) travel of staff; (d) contractual services; and (e) other operating expenses. The net increase of \$26,500 is the result of additional requirements for contractual services for webcasting in connection with the interactive panels and round tables, partly offset by a decrease of related consultancy requirements.
- 9.47 During the biennium 2010-2011, projected extrabudgetary resources of \$2,644,300 under this subprogramme will be used: (a) to support the programme of work, in particular with regard to the implementation of the Beijing Declaration and Platform for Action, the outcome of the twenty-

9.51 The amount of \$16,426,800, reflecting a net increase of \$150,200, provides for 60 posts, including 40 Professional and above and 20 General Service posts. The posts are required to provide normative, analytical and operational support to Member States and intergovernmental and non-governmental organizations on a broad range of socio-economic issues through monitoring of national and global trends and emerging issues; substantive servicing of intergovernmental meetings; promotion of dialogue with major stakeholders; preparation of reports and publications; organization of expert group meetings, seminars, and panel discussions; and provision of advisory services. The net increase of \$150,200 results from: (a) the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of

development-related activities (\$299,800) to support the secretariat of the Permanent Forum on Indigenous Issues; partly offset by (b) abolition of one General Service (Other level) post to rationalize and streamline the post structure through process re-engineering and optimization of mandates delivery schedules and methods (\$149,600). The amount of \$1,323,400 for non-post requirements, reflecting a small decrease of \$1,800, provides, inter alia, for: (a) general temporary assistance; (b) consultants; (c) experts groups; (d) travel of staff; (e) contractual services; and (f) the contribution to the share of the costs of the Committee for the Promotion and Advancement of Cooperatives.

9.56 The amount of \$17,200,300, reflecting a net increase of \$600, provides for 59 posts, including 38 Professional and above and 21 General Service posts, to provide substantive support to Member States and the intergovernmental processes on sustainable development through the collection of national information, empirical research, analytical reports, expert consultations, technical

assistance and addressing the various priority themes considered by the Commission on Sustainable Development in follow-up of the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21, the Johannesburg Plan of Implementation, the Barbados Programme of Action for the Sustainable Development of Small Island Developing States, and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States. The net increase of \$600 results from: (a) the full funding of one P-4 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development related activities (\$299,900); partly offset by (b) abolition of two General Service (Other level) post to rationalize and streamline the post structure through process reengineering and optimization of mandates delivery schedules and methods (\$299,300). The amount of \$964,900 for non-post requirements, reflecting a decrease of \$3,600, provides, inter alia, for: (a) general temporary assistance; (b) consultants; (c) experts groups; (d) travel of staff; (e) contractual services; and (f) furniture and equipment.

- 9.61 The amount of \$31,277,900, reflecting an increase of \$248,800, provides for 124 posts, including 69 Professional and above and 55 General Service posts, to provide substantive servicing to the Statistical Commission and assist national and international statistical systems in the areas of: (a) statistical capacity-building; (b) standards and methodological development; (c) coordination of international statistical activities; and (d) data dissemination. The increase of \$248,800 results from the full funding of one P-3 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development related activities. The amount of \$2,497,300 for non-post requirements, reflecting a decrease of \$10,200, provides, inter alia, for: (a) general temporary assistance; (b) consultants; (c) experts groups; (d) travel of staff; (e) contractual services; and (f) the contribution to the Department's share of the costs of the International Computing Centre for technical services for server support and statistical application development and hosting. The decrease of \$10,200 under consultants reflects the reduced requirements in external specialized expertise for preparation of handbooks, manuals and reports.
- 9.62 During the biennium 2010-2011, projected extrabudgetary resources of \$5,620,000 under this subprogramme will be used: (a) to create UN-data, a new portal which enables free access to United Nations system-wide statistics through innovative and user-friendly formats and interfaces, and to provide technical assistance to member States on statistical dissemination; and (b) to support the project on comparative analysis of national statistical systems, financing the preparatory work and travel to an International Conference on National Statistical Systems, focusing in particular on the measurement of climate change. The additional resources of about \$1.6 million in comparison with the 2008-2009 biennium result from increased number of technical cooperation projects on providing direct assistance to national statistical offices.

9.67 During the biennium 2010-2011, projected extrabudgetary resources of \$205,000 under the Trust Fund for Population and Development will be used to strengthen the work of the Population Division in the areas of data collection and dissemination.

- 9.75 The amount of \$12,669,900 provides for the continuation of 49 posts, including 24 Professional and above and 25 General Service posts, to support the work of the Committee of Experts on Public Administration and Member States in strengthening governance and public administration capacity by producing the planned outputs in support of normative activities, such as substantive servicing of intergovernmental bodies and production of parliamentary documentation as well as other mandated outputs, including but not limited to ad hoc expert group meetings, recurrent and non-recurrent publications, the organization of special events, the production of technical materials, the backstopping of projects and the provision of advisory support and training. The amount of \$781,200 for non-post requirements, reflecting a net decrease of \$10,200, provides mainly for: (a) general temporary assistance; (b) consultants; (c) expert groups; (d) travel of staff; (e) contractual services; and (f) other operating requirements. The net decrease of \$10,200 results from the reduction for external specialized expertise for the preparation of studies and reports; partly offset by increased requirements for general temporary assistance to assist in the preparation of the United Nations Public Service Day and to compile documents for nominations to the United Nations Public Service Awards.
- 9.76 During the biennium 2010-2011, projected extrabudgetary resources of \$23,210,500 under this subprogramme will be used to support technical cooperation activities, including needs assessment and diagnostic missions, as well as the production of guidelines, manuals and training materials; seminars, workshops and policy dialogues; and field projects at the country, regional and interregional level, and advisory services to regional centres. The decline in financing of technical cooperation projects in 2010-2011 is attributable mainly to the current funding constraints faced by the Department's traditional donor base owing to the ongoing financial crisis and market instability.

9.80 The amount of \$2,611,900, reflecting an increase of \$350,900, provides for eight posts, including six Professional and above and two General Service posts, to provide overall coordination on forest-related activities within the United Nations system, specialized agencies and the Collaborative Partnership on Forests; provide substantive servicing of intergovernmental and expert bodies; prepare the Secretary-General's reports on agenda items of the sessions; monitor and report progress towards the achievement of the global objectives on forests; produce publications and outreach materials on sustainable forest management; and provide substantive

servicing to the United Nations Forum on Forests. The staff complement of the United Nations Forum on Forests secretariat has been strengthened through secondments from international and regional organizations, institutions and instruments as well as through voluntary contributions. The increase of \$350,900 results from the full funding of one P-5 post approved by the General Assembly in resolution 63/260 in the biennium 2008-2009 for the strengthening of development-related activities.

- 9.81 The amount of \$839,400 for non-post requirements, reflecting a decrease of \$5,100, provides, inter alia, for: (a) consultants; (b) expert groups; (c) travel of staff; and (d) other operating expenses. The decrease of \$5,100 reflects the reduced requirements for expert group meetings.
- 9.82 During the biennium 2010-2011, projected extrabudgetary resources of \$3,014,000 under this subprogramme will be used to support (a) substantive inputs in fostering international cooperation and continued policy development and dialogue among Governments; (b) follow-up on international forest-related developments, including monitoring progress on the achievement of the global objectives on forests and policy advice to Governments, the International Year of Forests, as well as enhancing cooperation among international organizations and providing substantive support to intersessional activities and expert groups; and (c) facilitation of the participation of country representatives and major groups in the meetings of the United Nations Forum on Forests and related sessions, forestry-related international forums and servicing of the multi-disciplinary Collaborative Partnership on Forests.

# Subprogramme 10 Financing for development

#### Resource requirements (before recosting): \$7,356,200

9.83 Substantive responsibility for the subprogramme is vested within the Financing for Development Office. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 10 of programme 7 of the strategic framework for the period 2010-2011.

- 9.86 The amount of \$6,966,800, reflecting an increase of \$299,900 provides for 23 posts, including 16 Professional and above and 7 General Service posts to provide support to the intergovernmental processes entrusted with the follow-up to the outcomes of the 2002 International Conference on Financing for Development and the 2008 Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey Consensus; prepare analytical reports on the implementation of the Monterrey Consensus, the financing for development goals set out in the 2005 World Summit Outcome, and the Doha Declaration; promote coherence, coordination and cooperation within the United Nations system, including the international financial and trade institutions, on issues related to financing for development, and organize, in collaboration with experts from the official and private sectors, academia and civil society, multi-stakeholder events aimed at better enabling Member States to implement their commitments as agreed upon in the Monterrey Consensus, the Doha Declaration and related outcomes; and provide substantive support to the work of the Committee of Experts on International Cooperation in Tax Matters. The decrease of \$5,200 under consultants results from reduced requirements in an external specialized expertise for the preparation of studies and reports.
- 9.87 During the biennium 2010-2011, projected extrabudgetary resources of \$502,500 will be used to support: (a) participation of all relevant stakeholders, including Governments, civil society and the private sector, in the financing for development follow-up processes; (b) organization, in collaboration with experts from the public and private sectors, academia and civil society, of workshops, multi-stakeholder consultations, panel discussions and other activities aimed at better enabling member countries to implement their commitments as agreed in the Monterrey Consensus and Doha Declaration on Financing for Development; and (c) provision of technical assistance for national capacity-building in financial sector development, tax cooperation and fiscal management areas.

9.89 The amount of \$4,201,500 provides for the continuation of 17 posts, including 7 Professional and above and 10 General Service posts, to assist the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of personnel, finance and general administration, together with administrative and programme support for the implementation of the operational programmes of the Department, including the Development Account, technical cooperation activities and extrabudgetary projects. The amount of \$4,479,500 for non-post requirements, reflecting a decrease of \$68,600 provides largely for: (a) general temporary assistance; (b) contractual services/data-processing services; and (c) general operating expenses and other operating requirements of the Department. The decrease of \$68,600 relates to general temporary assistance, consistent with recent expenditure patterns on temporary needs during periods of peak

workload and on staff replacement on sick or other prolonged leave; and decreases under communications.

#### 2. Communications and Information Management Service

#### Resource requirements (before recosting): \$2,925,600

- 9.90 The Communications and Information Management Service, reporting to the Under-Secretary-General, is responsible for providing information technology and communications services to the Department, including the development and coordination of access to electronic information resources in the economic and social fields. The Service has four main responsibilities: to formulate policies and strategies in the areas of knowledge management, electronic technical cooperation, website communications, publishing and electronic administration; to advance those policies and strategies through concrete information system projects; to acquire, manage and produce electronic information content; and to support operations in the form of network administration, computer help desk, database administration, information technology asset management and videoconferencing.
- 9.91 The service produces an electronic newsletter on the work of the Department entitled DESA News, which is distributed to all staff in the Department and to other interested parties on the web, every two months; and a weekly electronic bulletin entitled DESAlert, which is distributed to departmental and Secretariat staff, permanent missions, resident coordinators and country teams as well as other interested parties. It designs and builds information systems and customizes enterprise applications to support the programmatic objectives of the Department. In order to ensure the Department's involvement in Secretariat policy and normative bodies, including the Information and Communications Management Committee chaired by the United Nations Chief Information Technology Officer, the Publications Board, the Working Group on Electronic Publications and the United Nations Secretariat Task Force on Knowledge Management.

9.92 The amount of \$2,753,000 provides for the continuation of 10 posts, including 7 Professional and above and 3 General Service posts to provide communications and information management services to the Department, including knowledge-sharing; knowledge and information policy formulation; web publishing; preparation and dissemination of electronic newsletters and alerts; website development; multilingual web content planning, coordination and preparation; publications support; management of electronic web forums; systems analysis and development; database design, construction and management; network administration; second-tier computer helpdesk support; information technology asset management and videoconferencing. The amount

of \$172,600 for non-post requirements largely provides for: (a) contractual services; (b) supplies and materials; and (c) acquisition and replacement of office automation equipment.

# Advisory Committee on Administrative and Budgetary Questions (A/62/7/Add. 40)

The Committee considers that splitting responsibility for the subprogramme between the Office of the Special Adviser on Gender Issues and Advancement of Women and the Division for the Advancement of Women lacks clarity and does not provide clear leadership. Furthermore, it appears that the Office of the Special Adviser on Gender Issues and Advancement of Women and the Division for the Advancement of Women may address overlapping issues. The Committee questions whether the organizational structure is designed to optimize efficient utilization of its existing staffing component of 37 posts (1 ASG, 1 D-2, 3 D-1, 5 P-5, 5 P-4, 3 P-3, 5 P-2/1, 14 GS (Other level)). It believes that the impact of the activities of the subprogramme could be enhanced through a more focused and coherent approach, and that there is a need to review and streamline its organizational arrangements. The Committee recommends that the Secretary-General be requested to carry out such a review and to submit fully justified proposals for a new structure in the proposed programme budget for the biennium 2010-2011 (para. 36).

The responsibilities of the Office of the Special Adviser on Gender Issues and Advancement of Women and the Division for the Advancement of Women are distinct and complementary. The two are co-located and work together in a collaborative manner.

In particular, the Special Adviser is responsible for advising the Secretary-General and Deputy-Secretary-General on gender issues and to help ensure system-wide implementation of the Beijing Platform for Action in close cooperation with the Division for the Advancement of Women (Beijing Platform for Action, para. 326).


In contrast, the Division for the Advancement of Women was established to service the Commission on the Status of Women — a task which remains at the core of its work. The substantive servicing of agenda items on gender equality in the Economic and Social Council and the second and third Committees of the General Assembly is also part of the work of the Division for the Advancement of Women. This work is not done by any other entity, including the Office of the Special Adviser. There is no overlap or duplication. In addition, the Division works to disseminate and follow-up on the outcomes of intergovernmental processes, including through the inter-agency context.

The Committee recommends that the Secretary-General be requested to present, in the context of the proposed programme budget for the biennium 2010-2011, the arrangements for coordination in the area of statistics within the Secretariat and with outside entities. The Secretary-General should elaborate on the means by which the Department of Economic and Social Affairs can fully discharge its central role and provide guidance to the Organization in this area of work (para. 27). Strong coordination processes are in place in the field of statistics (some of which for quite some time). Most visible in recent times is the United Nations Statistics Division leadership in producing an annual Millennium Development Goals report.

The general key mechanisms for coordination are (i) the annual meetings of the Statistical Commission, (ii) biannual meetings of the Committee on the Coordination of Statistical Activities, where chief statisticians of international organizations participate and (iii) the biannual meetings of the "Statistics Cluster" of the Executive Committee on Economic and Social Affairs, where the Statistical Programme managers of the United Nations Secretariat units participate.

While the Statistical Commission decides on statistical policy (statistical norms/standards) and gives guidelines to international organizations for all areas where coordination is needed, the Committee on the Coordination of Statistical Activities is the forum where all practical aspects of the coordination of the international statistical programmes with respect to data management, methodological work and technical cooperation are discussed. The Executive Committee on Economic and Social Affairs Cluster in Statistics more specifically serves to coordinate the programme budget preparation and implementation, in particular Development Account.

The United Nations Statistics Division of the Department of Economic and Social Affairs is the secretariat of all the above-mentioned bodies. It leads the global programme, in three key areas: (a) the development of statistical norms and standards which are presented to the Statistical Commission; (b) the global data collection and dissemination; here recently the United Nations Statistics Division developed the innovative tool of the United Nations-data portal (based on an extensive cooperative effort of the United Nations system); (c) coordination between multilateral and bilateral donors on statistical capacity-building programmes, including the development of global training materials (handbooks, software, etc).
