- 17A.1 The programme of work described below is based on programme 14, Economic and social development in Africa, of the strategic framework for the period 2010-2011. The Economic Commission for Africa (ECA) is responsible for the implementation of the programme of work under this section.
- 17A.2 The overall objective of the programme is to assist African countries in formulating and implementing policies and programmes that will lead to sustainable economic growth and social development, with particular emphasis on poverty reduction, as envisaged in the New Partnership for Africa's Development (NEPAD) and in the internationally agreed development goals, including those contained in the United Nations Millennium Declaration and in the outcomes of other major United Nations conferences and international agreements.
- 17A.3 The mandate for the programme derives from Economic and Social Council resolution 671 A (XXV), by which the Council established ECA. This mandate has been further elaborated by the General Assembly and the Economic and Social Council in a number of resolutions, as well as by the Commission in resolutions 718 (XXVI), 726 (XXVII), 779 (XXIX) and 809 (XXXI). Further mandates have emanated from NEPAD and the outcomes and decisions of global conferences, including the 2005 World Summit Outcome.
- 17A.4 The maintenance of an environment of peace and security is one of Africa's foremost development imperatives. In addition, four major challenges need to be addressed, namely, accelerating the achievement of the Millennium Development Goals, speeding up the pace of regional integration, benefiting from globalization and strengthening human and institutional capacity. This process is disrupted by recurring natural disasters and the HIV/AIDS pandemic on the continent.
- 17A.5 Recent attempts to tackle the above-mentioned challenges at the regional level have resulted in changes in Africa's institutional landscape. For instance, in addition to leading Africa's political agenda, the African Union is involved in the socioeconomic development and integration of the

continent and in enhancing the role of Africa in the global economy. ECA, with its proven record and experience on the ground, is well placed to partner the African Union in support of Africa's development, especially in the implementation of NEPAD. ECA is therefore committed to pursuing the implementation of the joint United Nations-African Union Declaration, signed in 2006, which provides a framework for supporting a 10-year capacity-building programme for the African Union.

- 17A.6 Since its repositioning in 2006, ECA has strived to achieve results in two related and mutually supportive areas: (a) promoting regional integration in support of the vision and priorities of the African Union; and (b) meeting Africa's special needs and emerging global challenges. ECA will consolidate the gains resulting from its repositioning by scaling up its action towards achieving greater effectiveness and impact in programme delivery. To that end, it will continue to improve its working methods with a view to becoming more flexible and efficient and delivering better results, in line with the Secretary-General's vision for the United Nations. In doing so, the Commission will draw on and apply the appropriate lessons learned from the implementation of the programmes of work for the biennium 2006-2007 and the biennium 2008-2009, as well as from the implementation of the ECA business plan 2007-2009.
- 17A.7 The Commission will develop a markedly stronger subregional presence by empowering its subregional offices to play an enhanced role in the delivery of its work programme. The offices will, inter alia, take the lead in shaping the ECA agenda at the subregional level, promote and support specific subregional priorities and programmes, and operate as subregional nodes for knowledge management and networking.
- 17A.8 Building and strengthening partnerships is integral to the ECA strategic orientation. The Commission will therefore foster better and more focused partnerships with other organizations on the basis of its comparative advantages. In addition to the regional economic communities, other core partners will include the African Union and the African Development Bank (AfDB), and the main collaborative mechanism would be the resuscitated African Union-ECA-AfDB Joint Secretariat. Furthermore, the African Union, the NEPAD secretariat and the regional economic communities now participate fully in the United Nations regional consultation meetings convened by ECA in support of NEPAD priorities. ECA will also continue to be involved in the work of the Executive Committee on Economic and Social Affairs as the main vehicle for ensuring policy and programme coherence and enhanced synergies in the context of the 2005 World Summit Outcome. It will also collaborate in that regard with members of the United Nations Development Group in strengthening the links between the normative and operational activities of the United Nations system.
- 17A.9 On the basis of its two pillars, ECA will conduct its work through 10 subprogrammes arranged to avoid duplication of functions, promote complementarities, eliminate inconsistencies and place the required emphasis on important sectors. The subprogrammes are focused on the following themes: trade, finance and economic development; food security and sustainable development; governance and public administration; information and science and technology for development; economic cooperation and regional integration; gender and women in development; subregional activities for development; development planning and administration; statistics; and social development.
- 17A.10 The programme directions will continue to be underpinned by the commitment to make ECA a knowledge-based organization on the cutting edge of development thinking in the region and a motivating force behind a network of researchers, practitioners and policymakers engaged in the production, sharing and dissemination of knowledge. Through the implementation of its knowledge management initiative, ECA has prepared the ground for operating as a knowledge-based organization by acquiring the necessary information management systems and tools and building its human resources capabilities. ECA will now build on those achievements with a view to

providing knowledge services to partners and clients effectively and to fully positioning itself as a centre of excellence in respect of knowledge about African development.

- 17A.11 The Commission will continue to undertake research and policy analysis to support informed decision-making and policy formulation in the region and assist the process of consensus-building in regard to major international initiatives. Demand-driven advisory services will also be used to help improve regional capacity to design and implement development policies. The Commission will ensure the continued high quality of its outputs by strengthening its quality-assurance processes, thereby ensuring relevance, responsiveness to client needs and accountability for compliance with stipulated processes and standards.
- 17A.12 Member States are increasingly demanding that the United Nations play a key role in their economic and social development. To that end, ECA will seek to strengthen its analytical capacity with a view to deepening its normative work. One of the areas in which its member States could benefit from a stronger analytical capacity on the part of ECA is the tracking and monitoring of internationally agreed goals and outcomes. Strengthening the statistical capacity of member States will be the key to measuring the progress made towards achieving those goals and outcomes, notably the Millennium Development Goals.
- 17A.13 In terms of promoting human development, ECA will deepen its analytical work on strengthening human capacity for development, the use of science and technology for Africa's development, gender equality and HIV/AIDS, as well as its work on global threats and challenges such as climate change, especially with regard to their socio-economic implications. In addition, ECA will contribute to efforts aimed at addressing the fragile situation of countries in or emerging from conflict. In dealing with those issues, it will place continued emphasis on addressing the special needs of the least developed, landlocked and island developing countries of Africa.
- 17A.14 Throughout its work programme, ECA will maintain its support for the achievement of cross-cutting outcomes and results, especially by continuing to mainstream gender concerns across subprogrammes and supporting measures related to improved governance, appreciable post-conflict development and an approach to development that is more focused on human rights.
- 17A.15 Furthermore, ECA will provide stronger and more coherent support in connection with the advancement of South-South cooperation as a key instrument for enhancing capital inflows to Africa, a source for the transfer of technology and skills to the continent and a way of increasing diversity in opportunities for development cooperation. To that end, the Commission will intensify its analytical work aimed at improving the understanding of new trends in development cooperation and at strengthening programmes for the promotion of trade and investment among developing countries.
- 17A.16 The programme contains a number of salient new features which reflect the efforts made to intensify further the work of ECA in some priority areas in response to new or revised mandates from relevant intergovernmental bodies. Key among these are the new activities proposed in the areas of food security, agriculture and climate change, statistics and statistical capacity-building in response to the growing demands for assistance by member States. In this regard, ECA will scale up its assistance to member States in implementing the relevant mandates contained in the Decision of the Assembly of Heads of State and Government of the African Union on climate change and food security; the outcome of the High-level Conference on World Food Security held in Rome in June 2008; the African Charter on Statistics and other recent decisions and mandates by the ECA Conference of Ministers. Appropriate resource allocations are proposed to ensure that these priorities are adequately addressed in the implementation of the programme.
- 17A.17 Another significant feature in the budget proposal for the biennium 2010-2011 is the provision of resources under executive direction and management for the enhanced Coalition for Dialogue on

Africa, the successor arrangement to the Big Table and Global Coalition for Africa, which was established in June 2007 to continue the policy dialogue on strengthening ownership of the African development agenda in the context of mutual accountability.

- 17A.18 An in-depth review of publications as a part of the programme of work was undertaken in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 17A.3 and as described in the output information for each subprogramme.

- 17A.19 The overall resources under this section amount to \$129,856,800 before recosting, reflecting a net growth of \$3,026,000, or 2.4 per cent, compared with the revised appropriation for the biennium 2008-2009. The net increase is mainly the result of the delayed impact of the new posts approved in the 2008-2009 biennium for: (a) the Office of the Executive Secretary and subprogramme 7, Subregional activities for development, in furtherance of the ECA subregional presence; and (b) the Office of Strategic Planning and Programme Management, subprogramme 7, subprogramme 9, Statistics, and programme support under the terms of General Assembly resolution 63/260, on development-related activities. The increase in post resources is offset by net reduced requirements for non-post resources, including temporary assistance for meetings, general temporary assistance, consultants and experts, as is summarized below:

- (a) An increase of \$369,500 under Executive direction and management, consisting of: (i) an increase of \$209,900 under post resources due to the delayed impact of one P-4 and one National Officer post established in the Office of the Executive Secretary and the Office of Strategic Planning and Programme Management in the biennium 2008-2009; and (ii) an increase of \$159,600 in non-post resources for contractual services (\$154,400) and supplies and materials (\$5,200);
- (b) An increase of \$3,432,900, under programme of work, consisting of: (i) an increase of \$3,420,300 under post resources due to the delayed impact of posts established in the biennium 2008-2009, relating to eight new P-4 posts for economics affairs officers, five posts at the Local level for information assistants and 11 National Officer posts distributed among the five ECA subregional offices to lead the delivery of operational activities and to support the enhanced mandate of those offices (\$1,877,100), as well as six posts for subprogramme 9, Statistics (\$1,543,200); and (ii) a net increase of \$12,600 in non-post requirements, relating largely to increases for travel of staff and general operating expenses, offset by decreases for other staff costs, consultants and experts;
- (c) A net decrease of \$776,400 under programme support, consisting of: (i) an increase of \$44,300 under post resources due to the delayed impact of one National Officer post approved for human resources management as of 2009; and (ii) a net decrease of \$820,700 under non-post resources, consisting of decreases largely for contractual services, general

operating expenses, supplies and materials and furniture and equipment, partly offset by increases under other staff costs, and for contributions to joint activities.

- 17A.20 In the biennium 2010-2011, the projected extrabudgetary resources of \$38,439,300, which represent 19.9 per cent of the overall requirements for section 17A and are mobilized mostly from bilateral sources under agreements between the ECA and global and regional institutions and organizations concerned with African development, will complement resources from the regular budget to finance technical cooperation activities in the broad priority areas, including building capacity to meet the Millennium Development Goals, integrated water resources management, improving good governance systems, harnessing information and communications technology for socio-economic development, strengthening capacity in relation to trade negotiations, integrating gender concerns into development policies and programmes and providing support to member States and the regional economic communities in the implementation of NEPAD. The projected increase of \$1,300,800 in extrabudgetary resources compared to the current biennium is based on results expected from the ECA repositioning exercise and the institution of an appropriate strategy for the mobilization of extrabudgetary resources. The number of posts to be financed from extrabudgetary resources in the 2010-2011 biennium is estimated at 72, as reflected in table 17A.6, which is 18 fewer than the posts financed in the 2008-2009 biennium. While a decrease is projected in the post resources for the biennium 2010-2011, increases are projected under non-post resources, basically for consultants and experts and fellowships, grants and contributions, and relate largely to enhancing the capacity of member States in various areas, strengthening the position and participation of Africa in international trade negotiations, intensifying analytical work in priority areas, enhancing the development and dissemination of knowledge tools and generating common positions in order to accelerate the implementation of priority commitments identified under NEPAD and by the World Summit on Sustainable Development, among others. These outputs are described under the various subprogrammes.
- 17A.21 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation are estimated at \$1,350,600, representing 93.5 work months estimated at \$1,164,900 for staff and \$185,700 for non-post requirements. This amount consists of \$1,205,600 from the regular budget and \$145,000 financed from extrabudgetary resources.
- 17A.22 The percentage distribution of total resources under this section for the biennium 2010-2011 is shown in table 17A.4.

## A. Policymaking organs

### *Resource requirements (before recosting): \$912,000*

- 17A.23 By its resolution 826 (XXXII), the Commission established the structure and functioning of its intergovernmental machinery, comprising the Conference of African Ministers responsible for Economic and Social Development and Planning and its Technical Committee of the Whole, as well as the Conference of African Ministers of Finance, convened biennially in alternate years, and the seven functional and sectoral subsidiary organs of the Commission. At its thirty-fourth session, in 2001, the Commission decided that the Conferences should be merged and henceforth meet annually. With the repositioning exercise of ECA which began in 2006, the subsequent institutional changes involved a review of the Commission's intergovernmental machinery which resulted in the elimination of overlapping bodies, creation of new organs and greater congruence between the intergovernmental bodies of ECA and those of the African Union. Consequently, the intergovernmental machinery of ECA now consists of organs focused on overall development issues at the subregional and regional levels and several subsidiary organs composed of experts. The approved organs are enumerated in the two broad clusters below.

#### 1. Organs dealing with overall development issues

##### *Conference of African Ministers of Finance, Planning and Economic Development and its Committee of Experts*

- 17A.24 The Conference of African Ministers of Finance, Planning and Economic Development provides the legislative mandate and policy guidance to the work of the Commission, considers and endorses the work programme of the ECA secretariat, serves as a forum for articulating the position of Africa on development issues on the agenda of the United Nations and decides on the recommendations of its subsidiary bodies and of the Executive Secretary.

- 17A.25 Since 2001, the Conference of Ministers has met on an annual basis. Its Committee of Experts meets prior to the Conference and provides it with technical support. The Bureaux of both bodies comprise a representative of each of the five subregions of the continent, namely, North Africa, East Africa, Southern Africa, West Africa and Central Africa, and consist of a chairman, three vice-chairmen and a rapporteur.

*Intergovernmental Committee of Experts of the subregional offices*

- 17A.26 The Intergovernmental Committee of Experts of each of the five ECA subregional offices meets annually prior to, and reports to, the Conference of African Ministers of Finance, Planning and Economic Development. Each Committee oversees the overall formulation and implementation of the programme of work and priorities of the respective subregional office and makes recommendations on issues concerning economic and social development in the subregion concerned and on the promotion and strengthening of subregional economic cooperation and integration. Whenever the need arises, meetings are held back-to-back with major ministerial conferences of the regional economic communities in order to provide a platform for subregional ministerial caucuses to address specific subregional development challenges. The outcomes of such meetings are brought to the attention of the Conference of African Ministers of Finance, Planning and Economic Development.

**2. Functional and sectoral subsidiary organs of the Commission**

*Committee on Women and Development*

- 17A.27 The role of the Committee on Women and Development as an advisory forum of experts and policymakers is to provide guidance to the Commission in its work on the importance of gender equality and the role of women in development. It also provides a platform for advocacy and for assessing follow-up and implementation by the African Governments of the global and regional platforms for action for the advancement of women. In particular, it addresses issues relating to the economic empowerment of women, protection of their legal and human rights and their increased access to education and health. It meets on a biennial basis.

*Committee on Development Information, Science and Technology*

- 17A.28 The Committee on Development Information, Science and Technology aims to strengthen the role of the Commission in assisting its member States to develop their national information and communication infrastructure and to integrate science and technology in their development programmes and strategies by bringing together experts and policymakers to provide it with advice in that regard. The Committee is composed of experts in such fields as planning, information and communications technology, geoinformation systems and science and technology. The Committee meets biennially.

*Committee on Food Security and Sustainable Development*

- 17A.29 The Committee on Food Security and Sustainable Development serves as a forum of experts that provides advice to the Commission in the interlinked areas of food security and environment. In this regard, it provides a platform for advocacy and assessment of follow-up activities by the Governments of African countries to regional and global plans of action, such as relevant decisions and outcomes of the World Summit on Sustainable Development. The Committee meets on a biennial basis.

*Committee on Human and Social Development*

- 17A.30 The mission of the Committee on Human and Social Development is to promote human and social development in African countries. The Committee conducts development and follow-up activities pertaining to global conferences and regional action programmes. It reviews major trends and issues of regional interest regarding human and social development. The Committee meets biennially.

*Committee on Trade, Regional Cooperation and Integration*

- 17A.31 The Committee on Trade, Regional Cooperation and Integration promotes the implementation of measures designed to strengthen economic cooperation and integration among African countries. It coordinates and harmonizes economic policies among African countries as a prerequisite for accelerating regional economic integration. In view of the importance of trade in regional cooperation and integration, the Committee also focuses on intra-African and international trade. It comprises experts in the field of international trade and integration drawn from Governments and the private sector. The Committee meets on a biennial basis.

*Committee on Governance and Popular Participation*

- 17A.32 The objective of the Committee on Governance and Popular Participation is to provide guidance on the establishment of an enabling environment for sound economic and corporate governance in Africa. The Committee focuses on interventions needed to enhance democratic governance practices, promote the adoption of human rights international standards, improve post-conflict management, mainstream the role of civil society and encourage the private sector development. The Committee meets on a biennial basis.

*Committee on Statistics*

- 17A.33 The Committee on Statistics, composed of experts and policymakers in the field of statistics, is responsible for providing strategic direction to the work of the Commission on statistical development in Africa. The Committee meets on a biennial basis.
- 17A.34 With the exception of the Commission, which meets in a seven-day annual session, all intergovernmental organs of the Commission meet for a duration of from three to six days.

- 17A.35 The resource requirements in the amount of \$912,000 provide for the temporary assistance for meetings, overtime, communications and supplies and materials required for servicing the sessions of the Commission and its subsidiary bodies.

## B. Executive direction and management

### *Resource requirements (before recosting): \$10,126,900*

- 17A.36 Executive direction and management comprises the Office of the Executive Secretary, the Office of Strategic Planning and Programme Management and the Information and Communication Service.
- 17A.37 The Office of the Executive Secretary provides overall strategic direction and leadership for the efficient management and effective implementation of the ECA programme of work while ensuring the optimal use of resources. The Executive Secretary and the Deputy Executive Secretary work together to provide strategic direction, policy guidance and leadership to the formulation of regional strategies and programmes in line with the priorities of NEPAD and the Millennium Development Goals.
- 17A.38 The Office maintains and manages effective partnerships and collaboration with major African continental organizations, in particular the African Union and AfDB, the regional economic communities and other key stakeholders in order to promote synergies in policies and activities in respect of major regional development issues and concerns for Africa. It fosters African ownership and policy consensus-building on emerging and urgent development issues facing the continent, and promotes policy advocacy on Africa in the international community. The Office promotes the effective coordination of the role of the United Nations in Africa by holding regular consultations with organizations of the United Nations system working in Africa to promote concerted action on activities of the United Nations system in the region. It also strengthens collaboration with the other regional commissions with a view to sharing experiences and coordinating and harmonizing actions on issues of mutual and collective interest.
- 17A.39 The Office of the Executive Secretary also provides policy direction in regard to the organization of the annual session of the Commission and ensures effective action on the resolutions and decisions of the Commission, the Economic and Social Council and other intergovernmental organizations, with particular emphasis on the priorities set out in NEPAD and the Millennium Development Goals. It provides policy guidance to the five ECA subregional offices to ensure that they are responsive to the needs of member States and their major intergovernmental institutions, including the regional economic communities. In addition, it ensures that there are effective synergies between them and the substantive divisions at ECA headquarters. Furthermore, the Office oversees special initiatives, such as the African Development Forum, the Coalition for Dialogue on Africa, the Partners Forum, the mutual accountability process and the Africa/Organization for Economic Cooperation and Development (OECD) high-level policy forums designed to reinforce the work of the Commission and thus provide further impetus to Africa's development agenda. The Office also plays a critical leadership and oversight role in terms of ECA support to the African Peer Review Mechanism and the overall NEPAD process. It leads the resource mobilization efforts of the Commission in the context of the ECA partnership agenda and ensures that the resources mobilized are put to effective use in advancing the development of Africa.
- 17A.40 The Office of Strategic Planning and Programme Management provides leadership in the Commission's programme planning and implementation process and the preparation of programme budget proposals. The Office also coordinates, guides and supervises the extrabudgetary technical cooperation programme of ECA and its relevant fund-raising activities. In addition, the Office coordinates the implementation of a quality-enhancement system to ensure the delivery of high-quality outputs and activities.
- 17A.41 The Information and Communication Service provides drafting, editing, dissemination and communication advice and services for ECA corporate and divisional activities; facilitates

communications between ECA and its key constituents and regional and international partners as well as the media; raises awareness of ECA policy positions on Africa's core development challenges and the steps needed to address them; and disseminates information on the work of ECA to stakeholders and partners.

17A.44 The resource requirements under posts estimated at \$9,022,300, reflecting an increase of \$209,900, provide for 40 posts (21 Professional category and above and 19 Local level and National Officer). The increase of \$209,900 is due to the delayed impact of: (a) one new P-4 post for an Economics Affairs Officer, established in the biennium 2008-2009 in the Office of the Executive Secretary to



support the coordination of ECA subregional offices (\$165,600); and (b) one new National Officer post established as of 2009 in the Office of Strategic Planning and Programme Management under the terms of General Assembly resolution 63/260, on development-related activities (\$44,300).

- 17A.45 The amount of \$1,104,600 for non-post requirements, reflecting an increase of \$159,600, relates to other staff costs, consultants and experts, travel of staff, contractual services and supplies and materials. The increase of \$159,600 is due largely to: (a) contractual services (\$154,400) for (i) the new provision for technical backstopping of the Coalition for Dialogue on Africa secretariat, (ii) the provision for monitoring and evaluation expertise and (iii) an increase in the activities of the Information and Communication Service; and (b) the purchase of supplies for upgrading the internal and external websites of ECA and of books and magazines.
- 17A.46 The extrabudgetary resources of \$1,603,300, to be provided through the United Nations Trust Fund for African Development, bilateral agreements and programme support, will be used, inter alia, to provide support services for substantive programmes and projects in the areas of planning, monitoring and evaluation, and for initializing the operations of new policies, strategies and procedures for the effective control and utilization of programme resources from both regular budgetary and extrabudgetary sources. It will most specifically be used to implement related training on monitoring and evaluation, and to organize meetings of the Partners Forum to ensure that donors and partners, both current and potential, are able to appraise fully the efficiency and transparency of ECA in delivering agreed programmes and projects outputs.

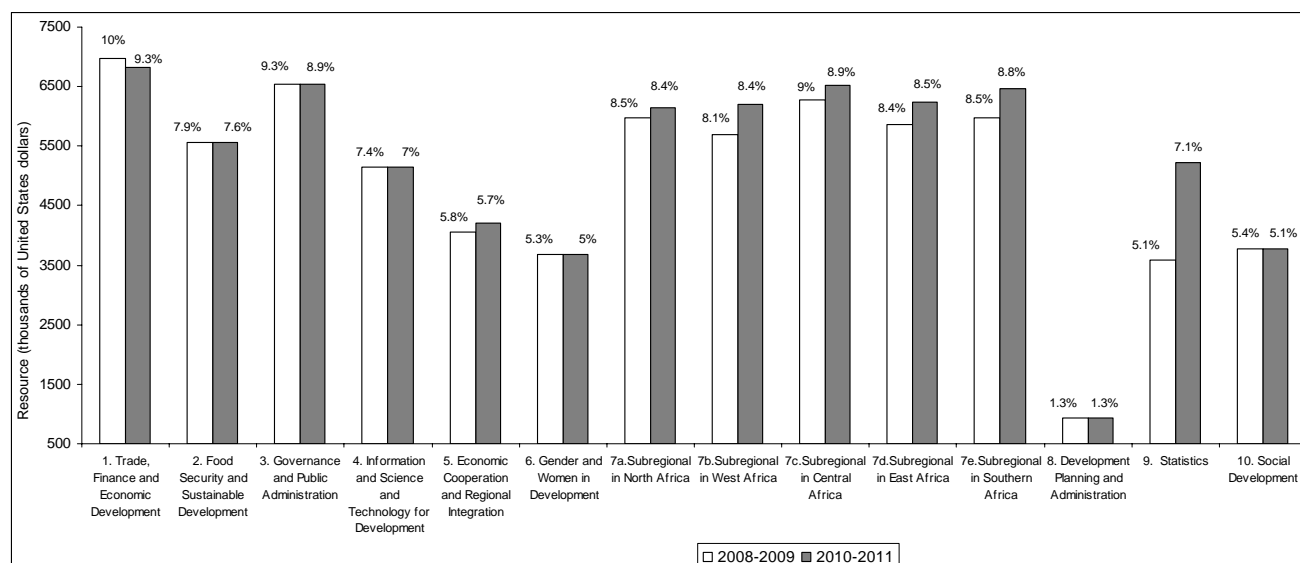

- 17A.47 The activities under this subprogramme are under the responsibility of the Trade, Finance and Economic Development Division. The subprogramme will focus on applied research and the provision of advisory services and policy recommendations to member States with a view to addressing the challenges in achieving increased economic growth for sustainable development. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 1 of programme 14 of the strategic framework for the period 2010-2011.

- 17A.48 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) member States and national policymakers will be supportive of the Commission's efforts and extend full cooperation as regards the incorporation of growth-enhancing policies in their national policies; (b) the development partners will honour their commitments made, for example, in the Group of Eight (G-8) Plan of Action, the Monterrey Consensus and the Millennium Declaration; (c) international development partners and communities will be willing to pursue the Doha Development Agenda with pro-development actions and the complementary Aid for Trade initiative will be fully operationalized; (d) the final economic partnership agreements between African countries and the European Union will deliver on their commitment to being pro-development and will strengthen and expand regional markets; and (e) the global macroeconomic and political environment will not deteriorate.

17A.50 The resource requirements of \$6,206,800 for posts will provide for the continuation of 26 posts (18 Professional category and above and 8 Local level). The amount of \$622,200 for non-post requirements, which reflects a net decrease of \$144,300, will provide for other staff costs, consultants and experts, travel of staff and contractual services. The net decrease of \$144,300 is due to a decrease of \$156,900 under consultants and experts, resulting from the redeployment to subprogramme 5, Economic cooperation and regional integration, of resources for ad hoc expert groups convened under the subprogramme, offset by additional requirements of \$12,600 for contractual services related to printing and other services for the regional preparatory meeting of the African least developed countries, to be held in Cotonou in 2010.

17A.51 The extrabudgetary resources of \$6,822,400, which are to be funded from bilateral sources and include provision for four posts, are for operational activities designed to: (a) enhance the capacity of member States in the design and implementation of sound macroeconomic policies; and (b) strengthen Africa's position and participation in international trade negotiations. These resources will finance the production of key outputs, such as the Economic Report on Africa (one in 2010, one in 2011), the enhancement of Africa's participation in the World Trade Organization negotiations and the achievement of macroeconomic convergence of member States, which are important elements that will undoubtedly strengthen Africa's position and increase its leverage during trade negotiations and talks. The estimated extrabudgetary resources will ensure the provision by ECA of advisory services to member States, the utilization of expertise and consultancy services to ensure maximum efficiency in reaching and addressing the concerns expressed by African countries in such areas as industrial policy and capacity for macroeconomic analysis and forecasting in Africa, the holding of ad hoc expert group meetings, the undertaking of country assessment studies, the production of several publications, the substantive servicing of inter-agency meetings, and the organization of the annual conferences of African economists and of training workshops. In accordance with the provisions of General Assembly resolution 35/217, the proposed establishment of an extrabudgetary post at the D-1 level under this subprogramme will be submitted separately to the Advisory Committee on Administrative and Budgetary Questions for its concurrence.

## Subprogramme 2

### Food security and sustainable development

**Resource requirements (before recosting): \$5,565,100**

- 17A.52 The activities under this subprogramme are under the responsibility of the Food Security and Sustainable Development Division. In response to the sustainable development challenges in Africa identified in the 2005 World Summit Outcome, the Plan of Implementation of the World Summit on Sustainable Development (“Johannesburg Plan of Implementation”) and the NEPAD framework, the strategy of the subprogramme will continue to emphasize policies and strategies for structural agricultural transformation and rural development, taking into account the integrated approach to the economic, social and environmental dimensions of sustainable development, with a particular focus on land, water, forests and bioenergy resources, urban-rural linkages and human settlements. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 2 of programme 14 of the strategic framework for the period 2010-2011.

17A.55 The resource requirements of \$5,241,600 for posts will provide for the continuation of 23 posts (14 Professional category and above and 9 Local level). 17A.56 The extrabudgetary resources of \$8,069,000, to be provided through bilateral agreements, include provision for 1 P-5, 1 P-4, 1 P-3 and 2 Local level posts. 17A.60 The resource requirements of \$6,110,100 for posts will provide for the continuation of 27 posts (16 Professional category and above and 11 Local level). An amount of \$430,600 for non-post requirements will provide for other staff costs, consultants and experts, travel of staff and contractual services.

17A.61 The extrabudgetary resources of \$2,842,000, which are to be provided through the United Nations Development Programme (UNDP) (\$500,000), the United Nations Trust Fund for African Development (\$100,000) and bilateral agreements (\$2,242,000), include provision for 1 P-3 and 1 Local level post. The resources will be used to continue to provide assistance to member States through the revised scope of the work of the subprogramme, which extends to conceptual, analytical and methodological challenges and will require consultancy services to meet expected accomplishments and build internal capacity. - 17A.70 The resource requirements of \$3,624,100 for posts will provide for continuation of 16 posts (9 Professional category and above and 7 Local level). The amount of \$582,600 for non-post requirements, reflecting an increase of \$156,900, will provide for overtime, consultants and experts, travel of staff and contractual services. The increase of \$156,900 relates entirely to the provision for ad hoc expert group meetings which has been redeployed from subprogramme 1.
- 17A.71 The extrabudgetary resources of \$1,345,000, which are to be provided through bilateral agreements, are intended to help address the needs of the member States, regional economic communities, the African Union/NEPAD and other stakeholders with specialized skills, better outreach capabilities and, ultimately, a development impact. They will finance such activities as: (a) consultancy and individual contractor services in connection with various publications (see para. 17A.69 (b) above); (b) maintenance of the Observatory on Regional Integration in Africa; (c) attendance at the continental road safety conference (2011); and (d) technical cooperation activities, including training courses, seminars and workshops, fellowships and field projects (see para. 17A.69 (c) above).

### **Subprogramme 6**

#### **Gender and women in development**

**Resource requirements (before recosting): \$3,686,100**

- 17A.72 The activities under this subprogramme are under the responsibility of the African Centre for Gender and Social Development. The subprogramme will have an increased focus on gender-based research and analytical work, as well as on technical cooperation activities to support policymaking and on promoting gender equality and empowerment of women as it relates to their social and economic advancement. The strategy will also focus on providing support to member States and their intergovernmental institutions in the implementation of regional and global platforms for action on gender equality. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 6 of programme 14 of the strategic framework for the period 2010-2011.

- 17A.75 The resource requirements of \$3,214,500 for posts will provide for the continuation of 12 posts (8 Professional category and above and 4 Local level). Non-post requirements of \$471,600 will cover overtime, consultants and experts, travel of staff and contractual services.
- 17A.76 The extrabudgetary resources of \$3,638,900, which are to be provided through bilateral agreements, will complement the regular budget in the effective delivery of programmed outputs. The activities to be financed will include: (a) consultancy services to undertake work relating to publications and ad hoc expert groups (see paras. 17A.74 (a) and (b) above); (b) travel to participate in various meetings, and data collection, analysis of data and information for the preparation of various reports; and (c) fellowships and grants and field projects (see para. 17A.74 (c) above).

- 17A.78 The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 7 of programme 14 of the strategic framework for the period 2010-2011.

- 17A.81 The resource requirements of \$4,494,100 for posts, reflecting an increase of \$267,200, will provide for 23 posts (12 Professional category and above and 11 Local level and National Officer). The increase of \$267,200 is the result of the delayed impact of the four new posts (1 P-4, 1 Local level and 2 National Officer) established in the 2008-2009 biennium.
- 17A.82 Non-post requirements of \$1,654,900, reflecting a net decrease of \$98,100, will provide for other staff costs, consultants and experts, travel of staff, contractual services, general operating expenses, supplies and materials and furniture and equipment. The net decrease is mainly attributable to a decrease in the number of ad hoc expert group meetings, offset by additional resources for travel of staff in the subregion and an increase in participation in ad hoc expert group meetings and other operating costs.
- 17A.83 The extrabudgetary resources of \$350,000, which are to be provided from bilateral sources, will be instrumental in creating the enabling environment to bring about economic harmonization of trade, social and poverty issues in this subregion. They will provide for technical cooperation outputs under the subprogramme, in particular for field projects (see para. 17A.80 (c) above).

17A.86 The resource requirements of \$4,620,900 for post resources, reflecting an increase of \$432,800, will provide for 22 posts (12 Professional category and above and 10 Local level and National Officer). The increase of \$432,800 is the result of the delayed impact of five new posts (2 P-4, 2 National Officer and 1 Local level) established in the 2008-2009 biennium. The amount of \$1,580,100 for non-post requirements, reflecting a net increase of \$67,700, will provide for other staff costs, consultants and experts, travel of staff, contractual services, general operating expenses, supplies and materials, and furniture and equipment. The net increase of \$67,700 is largely attributable to: (a) additional resources for travel of staff in the subregion and the increased demand for ECA participation in meetings and activities related to the multi-year programme, offset by a decrease in the provision for other staff costs due to reduced requirements for freelance interpretation and translation in English and French and consultants and experts in the light of a decrease in the number of expert group meetings.

17A.87 The extrabudgetary resources of \$690,000 proposed for this subprogramme, which are to be met from bilateral sources during the biennium 2010-2011, will address the scaling up of operational

activities and capacity-building initiatives in favour of member States, the regional economic communities and intergovernmental organizations in order to meet the growing demand for ECA outreach functions in the context of the ongoing repositioning efforts. The activities to be financed from extrabudgetary resources include the field projects described in paragraph 17A.85 (c) above.

17A.90 The resource requirements of \$4,525,100 for posts, reflecting an increase of \$267,200, will provide for 22 posts (12 Professional category and above and 10 Local level and National Officer). The increase of \$267,200 is the result of the delayed impact of four new posts (1 P-4, 2 National Officer and 1 Local level) established in the biennium 2008-2009. The amount of \$1,987,100 for non-post requirements, which reflects a net decrease of \$28,000, will provide for other staff costs, consultants and experts, travel of staff, contractual services and other general operating expenses. The net decrease is largely attributable to the reduced requirements for other staff costs for freelance interpretation and translation in English, French, Spanish and Portuguese and for general temporary assistance as more use is made of existing staff, and a reduction in the number of ad hoc expert group meetings, offset by additional resources for travel of staff for coverage of the subregion and the increased demand for ECA participation in meetings and activities related to the multi-year programme.

17A.91 The extrabudgetary resources of \$350,000 will cover the implementation of the activities of the subprogramme, which is guided by the principle of a repositioned ECA, especially in the area of regional and economic integration. The extrabudgetary resources will be used to finance the advisory services, training courses, seminars and workshops and field projects described in paragraph 17A.89 (c) above.

17A.94 The resource requirements of \$4,691,600 for posts, reflecting an increase of \$432,800, will provide for 22 posts (12 Professional category and above and 10 Local level and National Officer). The increase of \$432,800 is the result of the delayed impact of five new posts (2 P-4, 2 National Officer and 1 Local level) established in the 2008-2009 biennium. The amount of \$1,545,900 for non-post requirements, which reflects a net decrease of \$56,000 for operational requirements, is mainly attributable to reduced requirements for consultants and experts due to a decrease in the number of expert group meetings proposed and in contractual services as the new National Officer post approved in 2008-2009 biennium to perform information and communications technology functions under this subprogramme obviates the need for a technician for hardware maintenance and software development, offset by additional travel of staff due to the coverage of the subregion and the increased demand for ECA participation in meetings and activities related to the multi-year programme.

17A.95 The estimated \$600,000 in extrabudgetary resources, which are to be met from bilateral sources, will help to ensure the quality and timely delivery of the programmed outputs of the subprogramme, which will serve to enhance the capacity of member States and the regional economic communities to design and implement sound policies and programmes for accelerated poverty reduction in the subregion. The resources will be used to finance a forum on climate change and its impact on food security in East Africa, group training and field projects, as described in paragraphs 17A.93 (b) and (c) above.

17A.98 The resource requirements of \$4,978,600, reflecting an increase of \$477,100 for posts, will provide for 25 posts (13 Professional category and above and 12 Local level and National Officer). The increase of \$477,100 is the result of the delayed impact of six new posts (2 P-4, 3 National Officer and 1 Local level) established in the biennium 2008-2009. Non-post requirements of \$1,482,700, which reflect a net increase of \$13,500, will provide for other staff costs, consultants and experts, travel of staff, contractual services and other operating requirements. The net increase of \$13,500 is largely attributable to additional resources for travel of staff due to the increased demand for ECA participation in meetings and activities related to the multi-year programme, offset by reduced requirements for other staff costs for freelance interpretation and translation and consultants and experts, owing to a decrease in the number of expert group meetings.

17A.99 The extrabudgetary resources of \$500,000, which are to be provided from bilateral sources, will be used to scale up the operational activities and the capacity-building initiatives of the subprogramme for member States, the regional economic communities and intergovernmental organizations. The activities to be financed will include the workshops and field projects described in paragraph 17A.97 (c) above and the organization of a forum on the role of the private sector in development.

- 17A.105 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) member States and their national statistical systems will be supportive of the national strategies for the development of statistics and provide resources for statistical operations, including censuses and surveys; (b) regional partners, under the African Statistical Coordination Committee and the Statistical Commission for Africa, namely, AfDB, the African Union Commission, the African Capacity Building Foundation and the regional economic communities, will continue to extend their full collaboration for the implementation of joint activities, including the joint publication and databases, for example, the ECA/AfDB/African Union Commission African Statistical Yearbook, African Statistical Journal and African Statistical Database, and that they are supportive of ECA leadership in the implementation of the Reference Regional Strategic Framework; and (c) international partners including United Nations entities, especially the United Nations Statistics Division, Partnerships in Statistics for Development in the 21st Century (PARIS21), the World Bank, Google.org, Capacity Building International (InWent) of Germany, French Cooperation and the European Union, will continue to support the activities of the African Centre for Statistics, national statistical programmes and those of the regional economic communities.

- 17A.107 The resource requirements in the amount of \$4,679,900 for posts, which reflect an increase of \$1,543,200, will provide for the continuation of 23 posts (12 Professional category and above and 11 Local level). The increase of \$1,543,200 is the result of the delayed impact of six new posts (2 P-5, 2 P-4 and 2 P-3) established as of 2009 under the terms of General Assembly resolution 63/260, on development-related activities. Non-post resources of \$542,700, which reflect an increase of \$100,900, will provide for other staff costs, consultants and experts, travel of staff and contractual services. The increase relates largely to additional requirements for consultants and experts in connection with expert group meetings and travel of staff.
- 17A.108 The extrabudgetary resources of \$500,000, which are to be provided from bilateral sources, will contribute to: enhanced capacity of member States to produce and use economic, demographic and environmental statistics, including gender-disaggregated and gender-responsive statistics in support of regional integration and the Millennium Development Goals; and increased harmonized statistics and macroeconomic convergence for better economic management. The activities to be financed from extrabudgetary resources include: handbook on harmonized price indices and harmonized national accounts (2010); joint ECA/UNFPA handbook on the development of Millennium Development Goal indicators from censuses and surveys; joint ECA/United Nations Statistics Division website of the African Statistical Knowledge Networks Newsletter, statistical profiles of national statistics offices, experts and online resources; development and installation of the joint ECA/AfDB databases, including data for the publications, Millennium Development Goal indicators, censuses, household surveys and gender statistics; visiting fellows to support the work of ECA in various areas of statistics, including economic statistics, agricultural statistics and climate change and population censuses and surveys; fourth Forum on African Statistical Development (2010), which will be organized to increase synergies between donors and partners and to review the level of support received by national statistics offices using the Light Reporting Mechanism; development of promotional material for African Statistics Day; organization of two forums on African statistical development; and organization of the group training and field projects described in paragraph 17A.106 (c) above.

## Subprogramme 10

### Social development

**Resource requirements (before recosting): \$3,773,900**

- 17A.109 The activities under this subprogramme are under the responsibility of the African Centre for Gender and Social Development. Under this subprogramme, provisions have been foreseen for the African Institute for the Prevention of Crime and the Treatment of Offenders. The subprogramme aims to strengthen the capacity of African countries to design, implement and monitor policies and programmes for reducing poverty and addressing social development issues, such as inequality and the marginalization of vulnerable groups of African society. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 10 of programme 14 of the strategic framework for the period 2010-2011.

- 17A.110 The subprogramme will achieve its objective and expected accomplishments on the assumption that: (a) member States will be committed to the implementation of regional and international policy frameworks for social development, especially African Union protocols and conventions and the NEPAD agenda; (b) partners will be supportive of ECA efforts and willing to scale up their collaboration to support ECA, member States and the regional economic communities; and (c) measures will be undertaken by member States to provide the subprogramme with data and reports in a timely manner.

**Outputs**

- 17A.111 During the biennium 2010-2011, the following outputs will be delivered:
- (a) Servicing of intergovernmental and expert bodies (regular budget):
    - (i) Substantive servicing of meetings: second session of the Committee on Human and Social Development (4);

- 17A.112 The resource requirements in the amount of \$3,104,800 provide for 12 posts (9 Professional category and above and 3 Local level). Non-post resources of \$669,100 will provide for other staff costs, consultants and experts, travel of staff, contractual services and grants and contributions to the United Nations African Institute for the Prevention of Crime and the Treatment of Offenders.
- 17A.113 The extrabudgetary resources of \$1,397,000, which are to be provided from bilateral sources, will cover operational activities designed to enhance national and regional capacity to design, implement and monitor social policies and programmes for accelerating progress towards achieving the Millennium Development Goals and for the effective delivery of social services. The activities of the subprogramme will include research work and studies, field trips, training seminars and workshops, technical services, production of flagship publications and, in some instances, short-term expert services.

## D. Programme support

### *Resource requirements (before recosting): \$45,362,200*

- 17A.114 Programme support services encompass the functions and structures relating to: management and development of human resources; publications and conference management of the United Nations Conference Centre in Addis Ababa; documentation, archive and record management; finance, library and management of central support services, including general services, information technology services, facilities management and the United Nations Health-Care Centre under the Division of Administration.
- 17A.115 The Division of Administration will continue to provide the above-mentioned services to the ECA secretariat, its five subregional offices and the African Institute for Economic Development and Planning and will coordinate with United Nations agencies based in Ethiopia in regard to United Nations common services. In particular, ECA will strengthen its activities to promote the use of the United Nations Conference Centre in Addis Ababa by boosting its marketing activities, and by continuous development and revision of the rates charged. Other activities will include: provision of conference services, interpretation and verbatim reporting services; translation and editorial services; text processing, desktop publishing, proofreading and referencing services; documentation, reproduction, publication, archiving and distribution services; commercial and



procurement services; travel management services; shipping and transportation services; protocol and visa services; stores, property and inventory management services; facilities management, including maintenance and new construction projects; library and information and communications technology services.

- 17A.116 In addition, during the 2010-2011 biennium, the Division of Administration will continue to play a pivotal role in supporting the ECA secretariat, subregional offices and the African Institute for Economic Development and Planning, as well as the co-located United Nations agencies, within the framework of the new United Nations reform structure and initiatives, thereby enhancing the effectiveness of the programme of work, staff productivity and administrative decision-making. The domains of knowledge management and telecommunications have become critical for supporting the growing need for robust, reliable and secure data communications with United Nations Headquarters, the five offices in the subregions and the African Institute for Economic Development and Planning, both in the region and globally. The Division will continue to work closely with the Office of Central Support Services in the coordination, oversight and management of the construction of additional office facilities at ECA, expected to be completed in 2011, including the follow-up of standardized access control projects.

## Outputs

- 17A.117 During the biennium 2010-2011, the following outputs will be delivered:

- (a) Administrative support services: provision of authoritative interpretation of financial policy and procedures, financial reporting, accounting policies and systems; modernization and integration of financial systems; improvement of financial reporting; and strengthening of accountability within the Commission. The activities to be undertaken will include: provision of overall financial management, guidance and advice on the proper utilization of resources, in compliance with the financial and staff rules and regulations; preparation of monthly, yearly and biennial financial statements; preparation of bank reconciliation and approval of payments; recording of accounting transactions and provision of guidance and advice to the subregional offices; processing, review and approval of all payments, including salaries and staff benefits; and provision of information technology support for financial control and reporting;
- (b) Human resources management: recruitment and placement; staff administration in relation to conditions of service of ECA staff, including the staff of the five ECA subregional offices; staff services, including reviewing and processing a range of entitlements and benefits; career development activities designed to strengthen the skills and competency of the staff; United Nations Health-Care Centre; and staff/management relations. The activities to be undertaken will include: staff selection decisions; administration of staff entitlements; maintenance of human resources databases, establishment of a skills and competency inventory, and introduction of automated services to improve service delivery, reduce transaction costs and enhance client orientation; advice and guidance to staff members and management on proper application of the established performance management system; guidance to staff and management on performance appraisal rebuttals, grievances, and disciplinary and other administrative reviews; provision of training to upgrade staff skills to meet new demands and enhance cross-occupational mobility in order to attain the vision of the Secretary-General to develop a versatile, multi-skilled, mobile and experienced workforce; and conduct of programmes to support an organizational culture that ensures high standards of conduct and working relationships;
- (c) Conference services: in the repositioned ECA, priority has been given to improving conference facilities, with conference and language servicing, publications, documentation

and reproduction grouped under one umbrella, the Publications and Conference Management Section. The Section will provide meetings, interpretation and verbatim reporting services; translation and editorial services; and documentation and publication services, including text processing. The major areas of focus of the Section in the biennium 2010-2011 will be to: (i) develop commercial management strategies to promote the use of the United Nations Conference Centre in Addis Ababa by boosting marketing strategies and activities; (ii) continue to benefit from the best practices developed by documentation and language services (e-Meets, Documents, Conference and Production Management System, etc.) already in place; (iii) develop realistic charge rates, draw up the utilization policy for the United Nations Conference Centre in Addis Ababa and ensure full recovery of costs of non-calendar meetings and services; (iv) continue to improve the quality of ECA publications and other documents, including the quality and timeliness of translation and editing, by establishing realistic lead times; and (v) strengthen coordination with the African Union Commission and AfDB in identifying future areas of collaboration in the areas of conference services;

- (d) Library services: provision of enhanced information and knowledge management support to the ECA programme by leveraging its information resources, services, systems and networks and by promoting the use of emerging techniques and strategies in information and knowledge services through the development of digital and virtual library platforms and networks. Library services expects to accomplish in the biennium 2010-2011: (i) enhanced technical information support for all ECA programmes and activities, through the expansion of access to relevant and quality online electronic and print-based information services; (ii) fully functional document, record and archive management operations, including a full-text digital institutional repository of all ECA publications, documents and other outputs; (iii) increased exchange of information and networking within the region on ECA mandated areas, through policy advocacy and knowledge-networking activities; (iv) enhanced support and training in relation to United Nations documentation for United Nations depository libraries in Africa; (v) effective policy analysis, advocacy and capacity-building in relation to information and knowledge management; and (vi) enhanced awareness of and accessibility to library resources by staff through the effective dissemination of information, using the Intranet and Internet, bibliographies and other current awareness services, including African Development Topics, ECA Library alerts and the contents of the Journal;
- (e) Technical cooperation management: activities include management of technical cooperation projects and funds and mobilization of extrabudgetary resources; provision of guidance and support to the substantive divisions in developing higher quality demand-driven technical cooperation projects which are clearly linked to the Commission's normative and analytical work and clearly feed into the achievement of the Commission's expected accomplishments; project appraisal; monitoring and evaluation of technical cooperation projects; management of projects funded from the United Nations Development Account; and provision of guidance and support to the substantive divisions in extrabudgetary project and budget-related matters. Other activities include support for the mobilization of technical assistance and financial resources for technical cooperation projects; development and implementation of a fund-raising strategy to broaden the funding base for technical cooperation; review and finalization of project documents and preparation of specific grant agreements in line with donor specifications; organization of consultations with donors and partners and analysis of donor trends for funding; servicing of the regular meetings of the ECA Partners Forum on technical cooperation issues, including pledging of contributions; and dissemination of information on the Commission's technical cooperation work;
- (f) Information technology services: provision of the overall computing, telecommunications and office automation support for the information and communications technology infrastructure;

provision of software and hardware support and services which will fully satisfy the evolving requirements of ECA, its five subregional offices and the African Institute for Economic Development and Planning; and provision of information and communications technology services to co-located United Nations organizations and of support for their information and communications technology operational requirements, in accordance with the United Nations common services agreement. During the 2010-2011 biennium, the Information Technology Services Section will focus on tangible returns in four core areas of ECA activity: (i) continuing support for strengthening the information and communications technology capacity of its subregional offices; (ii) increasing the quality and quantity of services to enhance the programme of work of substantive divisions and the subregional offices; (iii) enhancing administrative and programme support management; and (iv) facilitating the sharing, dissemination and utilization of data, applications and institutional knowledge capital;

- (g) Integrated Management Information System (IMIS): IMIS has reached a maturity level and its planned migration to an enterprise resource planning system involves building dedicated hardware and software platforms able to accommodate data cleaning, consistency checks and data preparation for the migration. IMIS remains essential, until its planned phase-out. There are a number of ongoing tasks to be carried out in the 2010-2011 biennium, such as the maintenance, operation and support of IMIS infrastructure at ECA headquarters and the subregional offices, as well as analysis, design, development, delivery, maintenance and support of the ECA workflow and document management systems. New technologies and initiatives, inter alia, will also be part of the mix, so that advantage may be taken of such new technologies as virtualization, faster servers, better load balancing and more secure applications, including operating system, database and communication applications;
- (h) Central support services: coordinate the preparation of the ECA procurement plan and manage the implementation of the procurement process in a transparent and cost-effective manner; travel, logistics and transportation services, including the management of all ECA travel activities as they relate to official travel of staff, dependants, participants and all others with official travel status; facilities management (including maintenance) through the provision of operation and maintenance services; archive and record management through the effective preservation of institutional memory and the facilitation of seamless access to information needed for decision-making, knowledge management, evidence, programme analysis and activity reporting; inventory and stores services management; and administration and monitoring of commercial activities in the ECA compound, including travel agency, catering services, fuelling station, wastepaper disposal, car wash and disposal of United Nations property.

- 17A.118 The resource requirements of \$24,894,000 for posts, reflecting an increase of \$44,300, will provide for 233 posts (53 Professional category and above and 180 Local level and National Officer). The increase is due to the delayed impact of 1 National Officer post, approved as of 1 January 2009. The amount of \$20,468,200 for non-post requirements, which reflects a net decrease of \$820,700, will provide for other staff costs, travel of staff, contractual services, other operating requirements, supplies and materials, furniture and equipment and grants and contributions. The net decrease of \$820,700 is due primarily to recent expenditure experience relating to decreases for operating requirements, partly offset by increases under other staff costs and grants and contributions.
- 17A.119 The extrabudgetary resources of \$5,844,700 for programme support, earned from United Nations organizations and from extrabudgetary activities carried out by ECA, will provide for 1 P-4, 2 P-3, 1 P-2 and 45 Local level posts as well as non-post resources. The Division of Administration will continue to provide support services for substantive programmes and projects in various areas of their work programmes during the biennium 2010-2011.

(b) Working on tailored-monitoring and evaluation guidelines to support the results-based management strategy of ECA;

(c) Fast-tracking the implementation of multi-year programmes;

(d) Strengthening the business processes and culture at ECA, including operationalization of business tools, such as the ECA automated project management operating system, the mission reporting system and online monitoring and evaluation training modules;

(e) Setting up more proactive approaches and alternative strategies, as well as more focused partnerships, to help mobilize additional resources to complement core funding from the regular budget;

(f) Strengthening the ECA African Centre for Statistics, both in terms of staffing and operational resources.

**Report of the Board of Auditors**

(A/63/5, vol. 1, chap. II)

The Board recommends that the Administration develop strategies to reduce the vacancy rates of its conference centres (para. 231).

Reports on achievements in regard to the United Nations Conference Centre in Addis Ababa were submitted to the General Assembly at its sixty-second session, through the Committee on Conferences. Utilization statistics show that the vacancy rate at the Conference Centre was reduced from 58 per cent in 2005 to 40 per cent in 2006, to about 30 per cent in 2007 and to about 24 per cent in 2008.

Strategies implemented during the period 2006-2008 to increase the utilization rate and reduce the vacancy rate at the United Nations Conference Centre in Addis Ababa comprised aggressive marketing efforts, including the following:

(a) Active participation in international conventions and exhibitions (IMEX, International Congress and Convention Association) to attract meeting organizers of global standard;

*Brief description of the recommendation**Action taken to implement the recommendation*

The Board recommends that the Administration make the conditions for using the conference centres more flexible, monitor their occupation and develop their commercial management in accordance with the rules set by the Organization (para. 236).

The Board recommends that ECA request the assistance of the Procurement Division in implementing a code of ethics and the signing of declarations of independence of all staff involved in procurement (annex I, recommendation 26).

(b) Establishing linkages with similar centres in Nairobi, Bangkok and Arusha to share best practices and discuss possible partnership options;

(c) Advertising in specialized magazines (i.e., Ethiopian Airlines inflight magazine) and development of promotional tools, such as brochures and pamphlets for distribution;

(d) updating the Centre's website to make it more attractive.

These marketing efforts will be maintained.

Measures taken at ECA regarding more flexibility in the usage of facilities at the United Nations Conference Centre in Addis Ababa were reported to the General Assembly which, by its resolution 61/236, welcomed such positive developments. Clients of the Conference Centre now include international and local associations; this contributes to increasing the utilization rate of the Centre while complying with headquarters minimum operating security standards.

The United Nations Conference Centre in Addis Ababa, however, finds itself in an increasingly competitive and challenging market in view of the ongoing construction in Addis Ababa of a major conference centre at the African Union Commission, and the conference facilities built as part of a number of four- and five-star hotels being completed in the city. In addition, the large and well-equipped conference venues for intra-African meetings that exist in the same geographical area in tourist-friendly cities like Nairobi and Arusha are real sources of competition.

Consequently, an optimum target of an 80 per cent utilization rate for the United Nations Conference Centre in Addis Ababa, if achieved, cannot reasonably be sustained.

ECA will initiate action in the first quarter of 2009.

*Brief description of the recommendation*

The Administration agreed with the Board's recommendation that ECA, in consultation with the other regional commissions, United Nations Headquarters and the United Nations Development Group, develop policies and guidelines to foster regional inter-agency coordination among the United Nations agencies. The Board also recommends that ECA participate in all United Nations country team meetings, which serve as a platform for sharing information and hence would minimize the risk of duplication of effort (annex I, recommendation 64).

*Action taken to implement the recommendation*

Inter-agency coordination among United Nations agencies and organizations is carried out in the context of the Regional Coordination Mechanism. The Mechanism is meant to enhance the efficiency and coherence of the United Nations system in supporting the African Union and its NEPAD programme. The Regional Coordination Mechanism comprises nine thematic clusters used to operationalize its activities. All United Nations agencies and organizations, including UNDP, actively participate in the Regional Coordination Mechanism process. The Regional Coordination Mechanism meets every year to take stock of its achievements and challenges and those of its cluster system so as to critically analyse its successes and shortcomings. It also addresses structural, systemic, operational and governance issues, as well as those related to resource mobilization, capacity-building, monitoring and evaluation, and communication, outreach and advocacy. The most recent (ninth) meeting of the Regional Coordination Mechanism, was held on 21 and 22 October 2008. The Deputy Secretary-General of the United Nations chaired the meeting, which was attended by all United Nations agencies and organizations, including UNDP and ESCWA. The independent assessment of the Regional Coordination Mechanism reaffirmed its relevance in responding to the needs of the African regional and subregional organizations and enhancing the coordination of United Nations support to these organizations.

**Cooperation and coordination among United Nations agencies.** The Regional Coordination Mechanism moved from consultation to coordination at its most recent meeting in October 2008. The Regional Coordination Mechanism secretariat in the NEPAD and Regional Integration Division at ECA has been repositioned to assume its role as a strategic coordinator for enhanced and strengthened support to the African Union and its NEPAD programme. Concrete accomplishments are:



*Brief description of the recommendation**Action taken to implement the recommendation*

(a) Enhanced United Nations leadership and involvement in the Regional Coordination Mechanism process. The Deputy Secretary-General of the United Nations has chaired the meetings of the Regional Coordination Mechanism since 2007; attendance by United Nations agencies and organizations is increasingly at the higher level; and the regional commissions have started to attend the meetings of the Regional Coordination Mechanism (ESCWA in 2008);

(b) Improved coordination of the clusters, increased interaction within and among clusters and sharpened focus of cluster activities for greater relevance and effectiveness. Most clusters have developed a business plan that enables United Nations agencies and organizations to work together, the exchange and sharing of information has increased among clusters and the Regional Coordination Mechanism has instituted a working day prior to its meetings only for the clusters to enable them to discuss issues of common interest.

**Cooperation and coordination between United Nations agencies and African organizations.** Concrete accomplishments are:

(a) Increased participation of the African Union Commission, the NEPAD secretariat, the regional economic communities and AfDB in the Regional Coordination Mechanism. The African Union Commission and the NEPAD secretariat are attending at the highest level. The African Union Commission is represented by the Chairperson and the Commissioners; the level of participation of AfDB and the regional economic communities is also remarkable;

(b) Increased involvement of the African Union Commission and the NEPAD secretariat in cluster meetings and activities. AfDB and the regional economic communities also participate regularly in the Regional Coordination Mechanism or cluster meetings. As a result, there is enhanced communication between ECA and some cluster conveners on the one hand, and the NEPAD secretariat, the African Union

Commission, AfDB and the regional economic communities, on the other;

(c) Advocacy and support for NEPAD at the national, regional and global levels have increased.

ECA and its subregional offices are increasingly exploring ways of replicating the Regional Coordination Mechanism at the subregional level.

ECA actively takes part, through its Office of Strategic Planning and Programme Management and relevant substantive divisions, in the work of the United Nations country team in Addis Ababa. As it would be impossible for ECA to participate in all United Nations country team meetings given the large number of such teams in Africa, it takes advantage of its organizational structure, which includes five subregional offices working in their respective subregions as its operational arms in the field, to take part actively in the work of the country teams. This is particularly true in the host countries of the subregional offices, especially in the context of the common country assessment and United Nations Development Assistance Framework formulation process. This has resulted in enhanced collaboration and coordination between ECA working at the regional and subregional levels and other United Nations agencies working at the country level, especially in the context of the ongoing United Nations reform and in furtherance of the objective of delivering as one. Indeed, the United Nations country teams have provided the platform for the subregional offices to engage at the country level so as to ensure that integration issues feature in the various processes of the United Nations Development Assistance Framework and to further the attainment of the Millennium Development Goals from a subregional perspective. Building on the success and achievements of the Regional Coordination Mechanism, ECA is also considering the possibility of establishing a subregional coordination framework that would be similar to the common country assessment and the United Nations

*Brief description of the recommendation**Action taken to implement the recommendation*

The Board recommends that ECA follow up with the concerned agencies and organizations the outstanding rentals for 2004. The Board also recommends that ECA include in the memorandums of understanding a clause that specifies the payment terms as well as a penalty clause in respect of late rental payments (annex I, recommendation 115).

The Board recommends that ECA, on an annual basis, attach an addendum signed by both parties to each memorandum of understanding, containing an indication of the specific area size, a description of space rented and the approved rental rate to be charged for the specific period (annex I, recommendation 116).

The Administration agreed with the Board's recommendation that it exert more effort in assessing and monitoring strict adherence to the administrative instructions on hiring, remunerating and evaluating the performance of consultants and individual contractors (annex I, recommendation 129).

Development Assistance Framework country-level process. Work is also under way with regard to regional director teams, offering further opportunities for greater United Nations coordination and collaboration so as to minimize the risk of duplication at the regional and subregional levels.

ECA has developed new paragraphs, including a penalty clause in respect of late rental payments, in the memorandum of understanding. Hence, signed memorandums with all United Nations agencies have been modified, except for three — UNDP, the Office of the United Nations High Commissioner for Human Rights and the United Nations Educational, Scientific and Cultural Organization — which have challenged the appropriateness of such clauses. After consultation with the Office of Legal Affairs, the clause on penalty charges has been dropped. Instead, a new, revised memorandum of understanding, prepared by the Office of Legal Affairs, is to be utilized.

It has been agreed that, instead of a signed addendum, a receipt, signed by the head of the concerned agency, will be used. The receipt contains all of the information required, such as the specific area size, a description of the space and rates. The receipt used during the first quarter of 2007 has considerably reduced the clearance time, which now takes less than a week.

The Human Resources Services Section has redesigned the workflow to take into consideration the repositioning of ECA, as well as the requests of clients for a more responsive process in terms of feedback. The new workflow shows the strategic role of the Office of Strategic Planning and Programme Management in the review and endorsement of the relevance of requests from a programmatic point of view.

The Human Resources Services Section has gone further in the streamlining of recruitment, remuneration and monitoring of consultants, automating the process so as to fast-track it and remove bottlenecks through the establishment of a pre-screened and

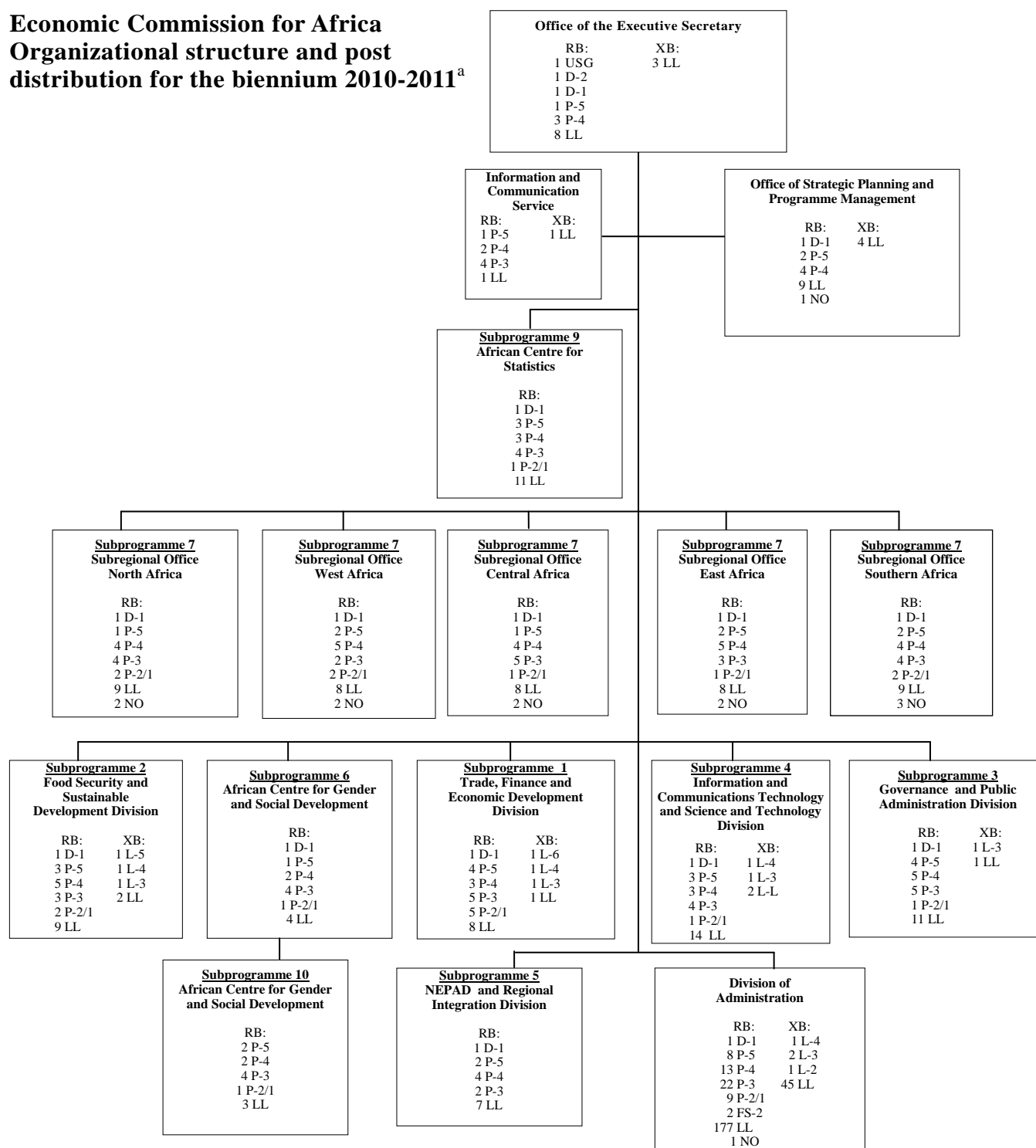
pre-approved roster of consultants. A database has been built, with the collaboration of the Information Technology Services Section. The database is in the final stage of development and is expected to be implemented early in 2009.

The Human Resources Services Section has designed extensive training for all clients on the engagement of consultants and individual contractors. Training was delivered in the course of 2008 to all ECA divisions and subregional offices.

Actions have resulted in a reduction of the turnaround time for checking case completeness.

## Section 17B

### Regional Commissions New York Office

*Resource requirements (before recosting): \$1,926,200*

- 17B.1 The Regional Commissions New York Office serves as the focal point for all aspects of the substantive and operational activities of the five regional commissions with departments, offices, funds and programmes at United Nations Headquarters. On behalf of the regional commissions, it also maintains regular contact with permanent missions of Member States, relevant intergovernmental and non-governmental organizations, liaison offices of organizations of the United Nations system and the public in New York. The Office provides substantive and representational activities to the General Assembly and the Economic and Social Council under agenda items relevant to the work of the regional commissions. Through its participation in these global intergovernmental meetings, the Office ensures that the mandates and activities of the regional commissions, which address a wide range of economic and social issues, are taken into account in the deliberations and recommendations of the General Assembly and the Economic and Social Council and their subsidiary bodies. It participates in inter-agency and intersecretariat meetings, such as the United Nations System Chief Executives Board for Coordination and the United Nations Development Group and their subsidiary bodies, as well as the Executive Committee on Economic and Social Affairs, to ensure proper, consistent, efficient and cost-effective representation of all regional commissions and relevant United Nations organizations, including the funds and programmes and the specialized agencies. It provides the commissions with an analysis and synthesis of developments as they occur during intergovernmental and inter-agency meetings held at Headquarters, as well as policy recommendations relating to these developments. The Office assists in identifying global trends, challenges and opportunities that have a bearing on the work and positioning of the regional commissions and provides strategic advice in this regard. It acts as the global coordinating secretariat for the cooperative and interregional activities among the regional commissions, services the meetings of the executive secretaries and provides support for the functions of the current Coordinator of the regional commissions.

#### Outputs

- 17B.2 During the biennium 2010-2011 the following outputs will be delivered:
- (a) Servicing of intergovernmental and expert bodies (regular budget):
    - (i) Substantive servicing of meetings: provision of substantive and representational activities to the General Assembly and the Economic and Social Council under agenda items relevant to the work of the regional commissions; representation of the five regional commissions at Headquarters at intergovernmental meetings; secretariat of the meetings of the executive secretaries;
    - (ii) Parliamentary documentation: annual report of the Secretary-General on regional cooperation in the economic, social and related fields, submitted to the Economic and Social Council at its substantive session;
  - (b) Other substantive activities (regular budget):
    - (i) Exhibits, guided tours, lectures: briefings or acting as a channel of information among the regional commissions, Headquarters, funds and programmes, permanent missions of Member States in New York, liaison offices of specialized agencies at Headquarters and the general public on the work of the regional commissions;

- (ii) Technical material: provision of analysis and synthesis of relevant developments occurring in intergovernmental and inter-agency meetings held at Headquarters or attended by the Office on behalf of the commissions, as well as policy recommendations relating thereto; provision of advice on global trends, challenges and opportunities that have a bearing on the work and positioning of the regional commissions;
- (iii) Booklets, fact sheets, wallcharts, information kits: publication, in print and on the United Nations website, of a biennial newsletter which is circulated to delegations, relevant entities within the United Nations and funds, programmes and agencies of the United Nations system, other relevant institutions and the general public;
- (iv) Participation in meetings of the United Nations System Chief Executives Board for Coordination and other inter-agency meetings and activities, and contribution to joint activities: representation of the five regional commissions at inter-agency and intersecretariat meetings held at Headquarters; acting as the coordinating secretariat for interregional cooperation, which includes supporting the role of the current Coordinator of the regional commissions, providing global advice at annual meetings of the chiefs of programme planning of the commissions, acting as a clearing house for the project proposals of the commissions financed from the United Nations Development Account and representing the commissions at meetings of the Steering Committee of the United Nations Development Account.

- 17B.3 The amount of \$1,812,400, reflecting an increase of \$116,100, provides for six posts (4 Professional category and above and 2 General Service) in the Regional Commissions New York Office. The increase results from the delayed impact of a new P-3 post established as of 1 January 2009. The amount of \$113,800 for related non-post requirements, reflecting a net decrease of \$1,200, will provide for other staff costs, travel of staff, contractual services and other operating requirements. The net decrease is due to a decrease under general operating expenses, offset in part by an increase under contractual services.
