Standards of accommodation for air travel

Report of the Secretary-General

Summary

The present report of the Secretary-General on the standards of accommodation for air travel is submitted in accordance with General Assembly resolutions 42/214, 45/218 A and 63/268 and decisions 44/442 and 46/450, as well as decision 57/589, in which the Assembly requested the Secretary-General to submit a report to it on a biennial basis. The present report provides information on standards of accommodation for air travel for the two-year period ended 30 June 2010 and comparative statistics for the two-year period ended 30 June 2008.

I. Introduction

1. The United Nations standards of accommodation for air travel are governed by a series of General Assembly resolutions and decisions, including resolutions 42/214, 45/248 A and 53/214 and decisions 40/555, 44/442, 46/450 and 57/589. Pursuant to the discretionary authority vested in the Secretary-General to authorize exceptions to air travel on a case-by-case basis and business-class travel by air in special circumstances that warrant it, the Secretary-General promulgated administrative instruction ST/AI/2006/4 for the purpose of implementing the various staff rules relating to the standards of accommodation for air travel and the exceptions thereto.

2. In the past, certain categories of exceptions to the standards have been established, including, but not limited to, the following: travel of eminent persons; travel of prominent individuals who are donating their services to the Organization free of charge; travel under circumstances that have been deemed to be arduous or under which, for medical reasons, it has been deemed appropriate to upgrade the accommodation of air travel; travel of the personal aides and security officials travelling with the Secretary-General, his wife or his personal representatives; and travel under circumstances when the normal standard of accommodation is not available and it is considered prudent to authorize an upgrade.

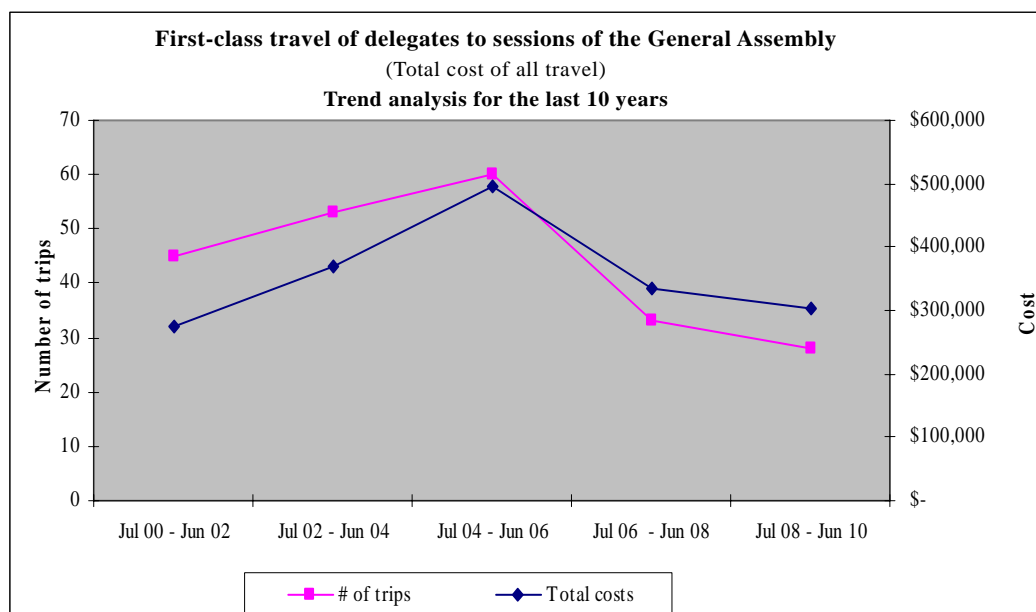
3. In its resolution 63/268, the General Assembly endorsed the recommendations contained in report of the Advisory Committee on Administrative and Budgetary Questions A/63/715 which, *inter alia*, called for future reports on this matter to contain analysis of the trends in the number of exceptions and provide analysis of the trends for the last 10 years and possible explanations as appropriate.

II. Travel of delegations

4. In accordance with General Assembly resolution 42/214, payment of first-class accommodation by air is limited to the heads of delegations of the least developed countries to the regular and special sessions of the Assembly. During the reporting period, 28 first-class trips were approved at a cost of \$309,380, compared with 33 trips at a cost of \$334,105 for the period from 1 July 2006 to 30 June 2008.

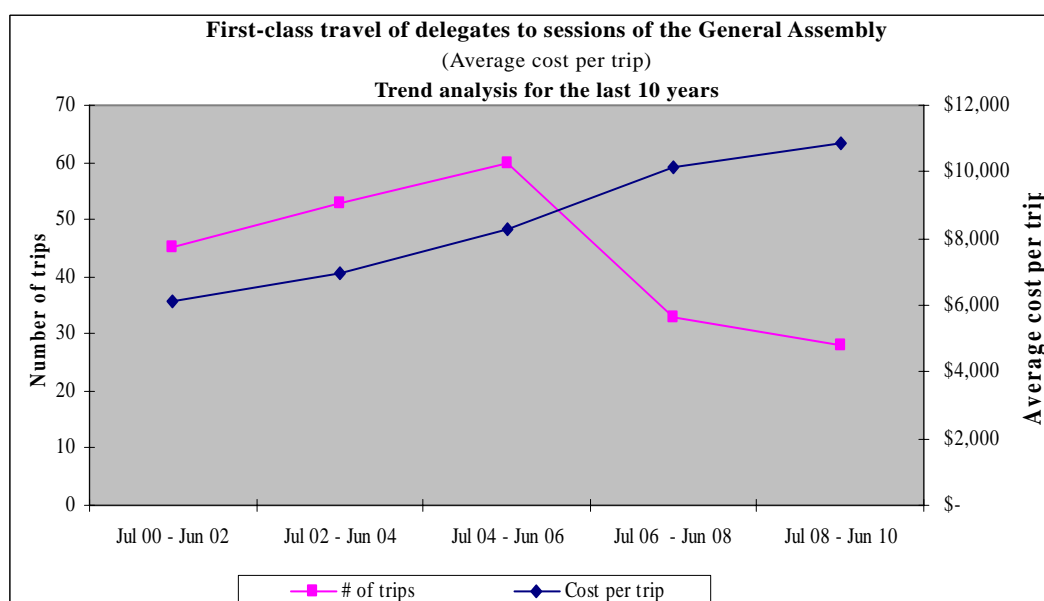
5. As figure I shows, the number of trips and hence the cost for the travel of delegates of the General Assembly peaked during the 2004-2006 biennium and has been falling since. The main reason for the peak in the period from 2004 to 2006 was the World Summit that was held in 2005 during the sixtieth session of the Assembly.

6. On the other hand, as figure II shows, the average cost per trip has steadily been rising. With respect to the increased trend noted in the average trip cost, this pattern is consistent with the global industry trend, owing in large part to the added cost of security measures, fuel surcharges and operating costs which have been passed along to the consumer. In addition, certain markets lack competition to drive costs downward and currency fluctuation is also a factor.

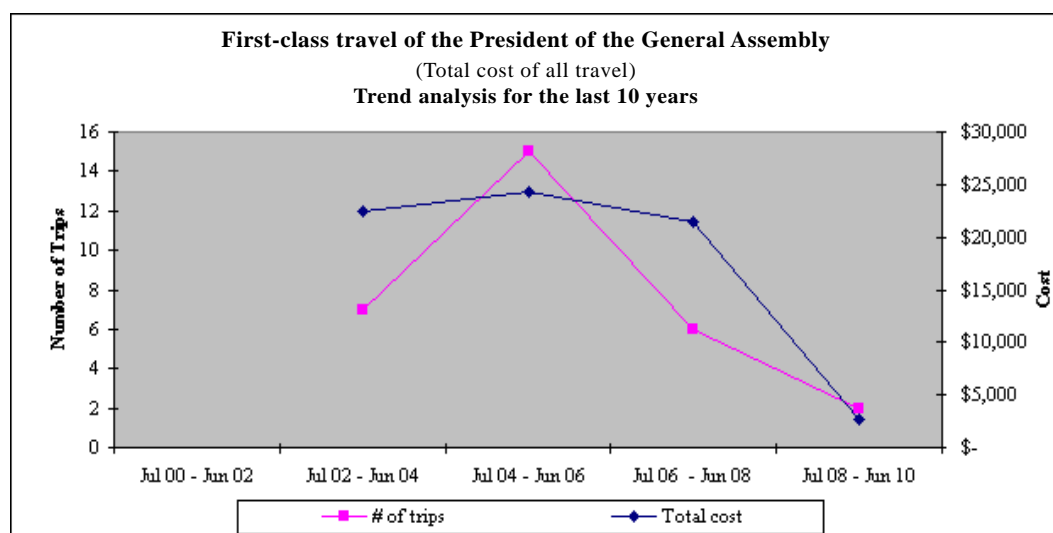


III. Travel of the President of the General Assembly

7. To strengthen the ability of the President of the General Assembly to effectively and efficiently discharge the responsibilities of the Office, the Assembly, by resolution 53/214 decided that its President, consistent with the approved programme budget, should have full authority to use the funds provided in the budget for the Office. During the reporting period, two trips were incurred at an additional cost of \$2,759 compared with six trips at a cost of \$21,466 in the period from 1 July 2006 to 30 June 2008. Detailed information on travel authorized by the President is provided in annex VII to the present report.

8. As with the case of the travel of delegates to the General Assembly sessions, the trend for the President of the Assembly peaked in 2004-2006 and has since declined (see figure III). One of the explanations given was that the cost of the travel of the President of the Assembly has been met by some Governments.

IV. Exceptions authorized by the Secretary-General

9. By General Assembly resolution 42/214, the Secretary-General was authorized to exercise his discretion in making exceptions to allow first-class air travel on a case-by-case basis. Such discretionary authority is also exercised in accordance with paragraph 4.5 of ST/AI/2006/4 when, in the opinion of the Secretary-General, special circumstances warrant it. In exercising such authority, the Secretary-General takes into consideration, inter alia, the following circumstances:

(a) A medical condition that may necessitate a level of comfort not available in the standard of accommodation to which the traveller is entitled. Such cases are referred to the Director of the Medical Services Division for recommendation. Advanced age alone is not considered sufficient justification to grant an exception;

(b) The normal standard of accommodation is unavailable and, owing to the exigencies of service, the traveller is required to travel on a particular date. Cases also arise when accommodation at the normal standard of entitlement is not

available and the cost of daily subsistence allowance while the traveller waits for the next available seat would be greater than the cost of the higher standard of travel;

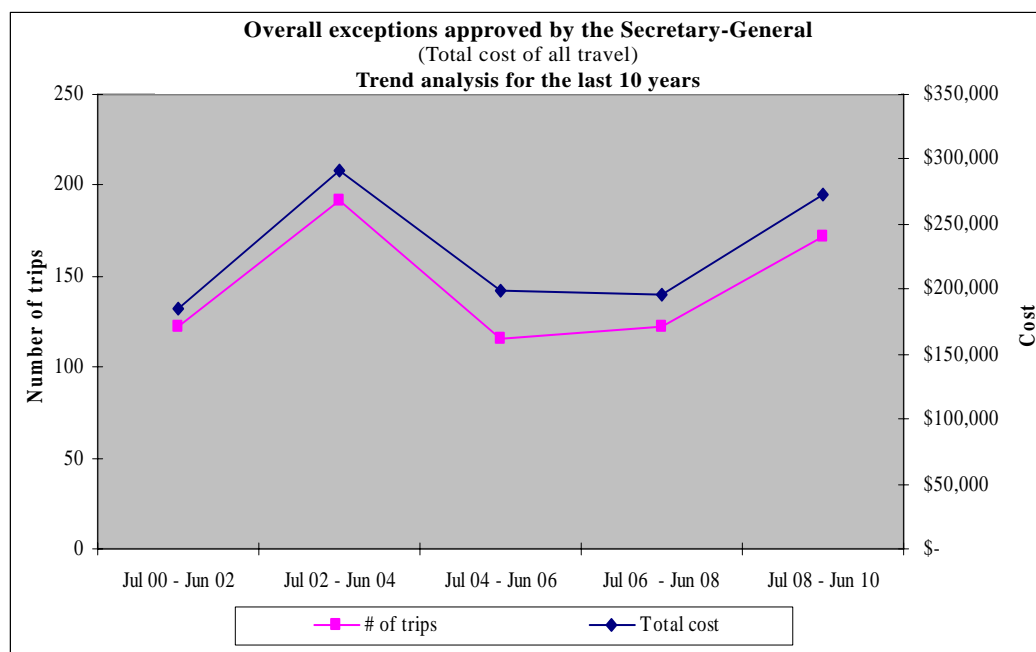
(c) The traveller is considered an eminent person, such as a former Head of State, or a prominent international figure in the political, humanitarian or cultural arenas;

(d) The traveller is a prominent person who is donating his or her services free of charge to the Organization and, in some cases, at a loss in personal income. Such individuals may be accorded the standard of accommodation to which they are accustomed;

(e) The traveller, after completing a full day of work, is required to travel through the night in order to resume work, attend meetings or present a paper at another location on the following morning or immediately upon arrival. Where such cases involve arduous journeys, it has been deemed reasonable that the standard of accommodation accorded the traveller should provide the best rest possible while travelling, or provide the conditions most conducive to work while flying, or both.

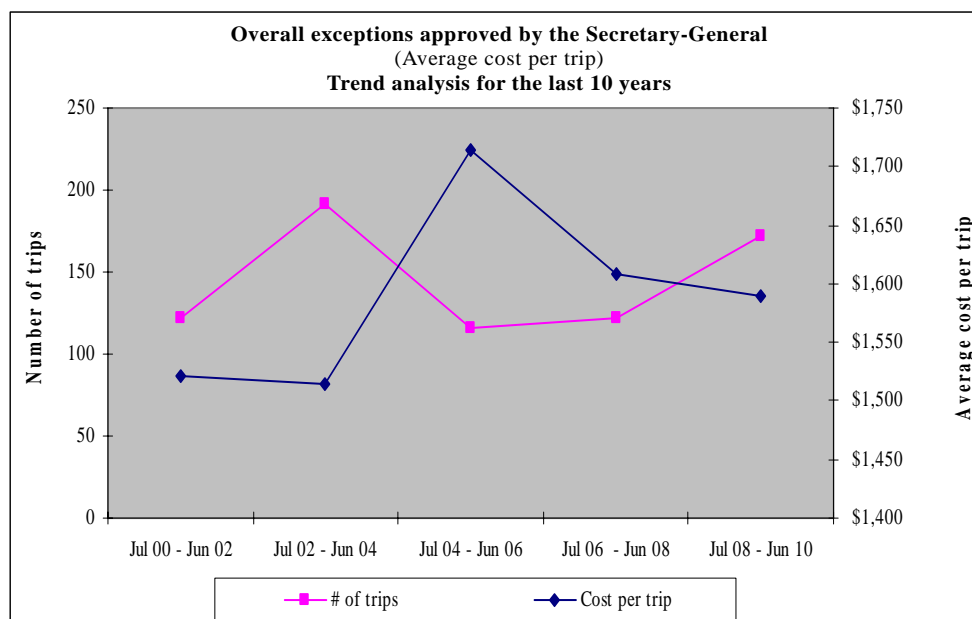
10. As figure IV shows the number of trips and the total cost of the exceptions authorized by the Secretary-General (such as medical, normal standard, eminent and prominent, categories of exception) has not varied greatly over the years.

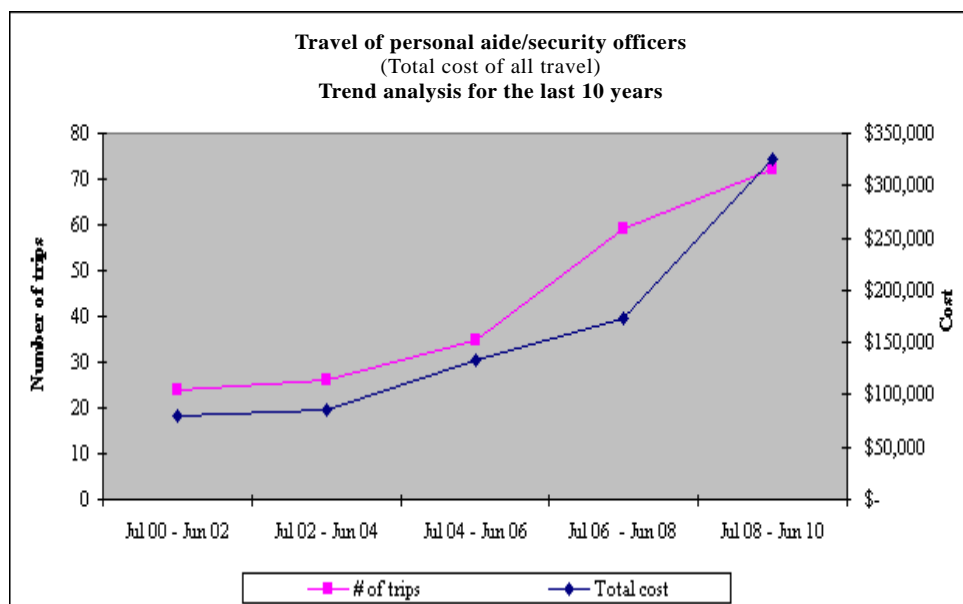
11. As figure V shows, the trend for the average cost per trip for the last 10 years has not shown significant fluctuations, in fact the range is between \$1,500 and \$1,700.

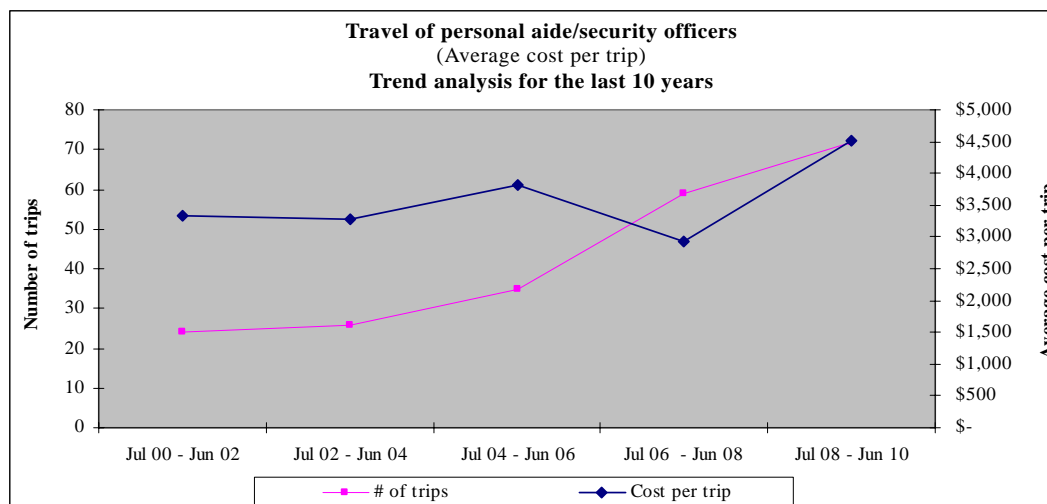
12. Exception is also granted where the traveller is a personal aide or provides security services to the Secretary-General, his wife or to any other official authorized to travel above the standard accommodation that would normally be provided. In the two-year period ended 30 June 2010, there has been an increase in the number of trips taken by such personnel, with 72 trips at an additional cost of \$325,103, compared to 56 trips for an additional cost of \$172,499 in the previous period, as shown in figure VI.

13. As figure VII shows the cost per trip for the personal aide/security officer has been constant, except for the period from 2008 to 2010 where a significant increase was experienced. The major reason for this is a higher number of longer trips undertaken, combined with the global industry trends referred to in paragraph 6.

14. On 18 March 1998, the Secretary-General decided that, as an exception, all travel of the Deputy Secretary-General should be in first class, in keeping with his/her special status. With regard to practical arrangements, efforts are first made to obtain upgrades to first class against payment of the full business-class fare. Where this is not feasible, the first-class fare is paid. For the two-year period ended 30 June 2008, 17 such trips were authorized for the Deputy Secretary-General at a cost of \$61,683, compared with 21 trips, at an additional cost of \$139,936, for the period under review.

15. Figures VIII and IX illustrate trends that are consistent with the global industry trends referred to in paragraph 6.

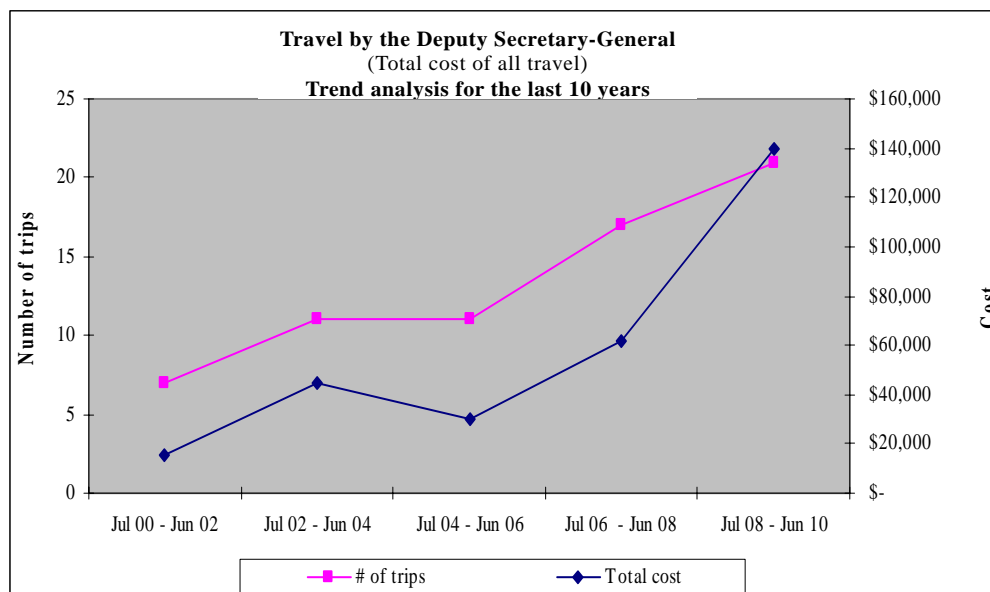
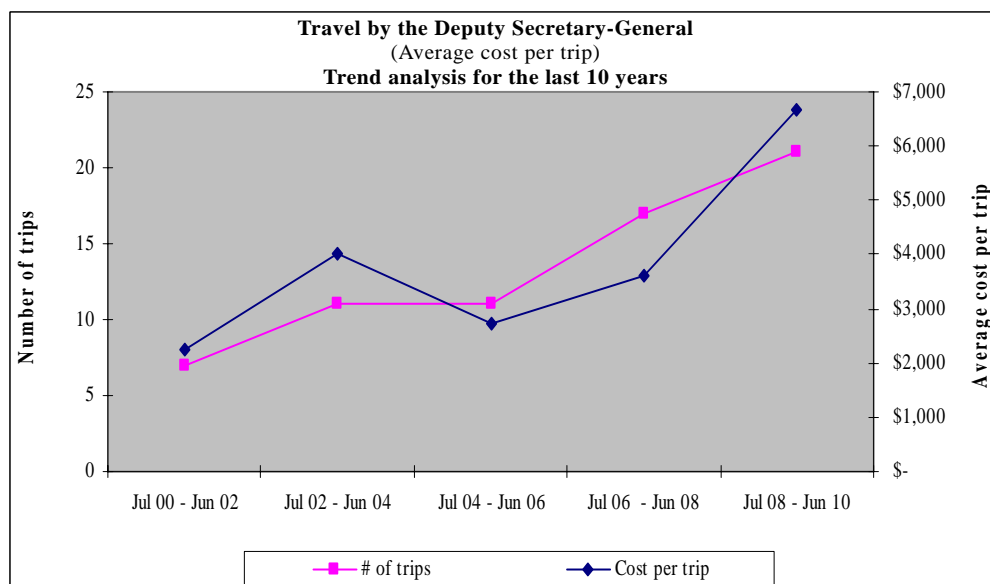

16. A summary of the exceptions authorized in respect of the United Nations during the period under review is contained in table 1 below and a summary of those authorized during the two-year period ended 30 June 2008 appears in table 2. Annexes I to VI to the present report provide detailed information on the number, nature, reason and the additional cost of the exceptions authorized on the basis of the above-mentioned factors, during the period from 1 July 2008 to 30 June 2010.

17. A summary of the exceptions authorized in respect of other United Nations entities during the period under review is contained in table 3 below and a summary of those authorized during the two-year period ended 30 June 2008 appears in table 4. Details of exceptions authorized for the United Nations Development Programme; the United Nations Children's Fund; the United Nations Institute for Training and Research; the United Nations University; the United Nations Office for Project Services; and the United Nations Population Fund for the current period are contained in annexes VIII, IX, X, XI, XII and XIII, respectively.

18. Figures X and XI show the number of trips and the cost per travel of the other United Nations entities, as well as the cost average per trip for the last eight years.

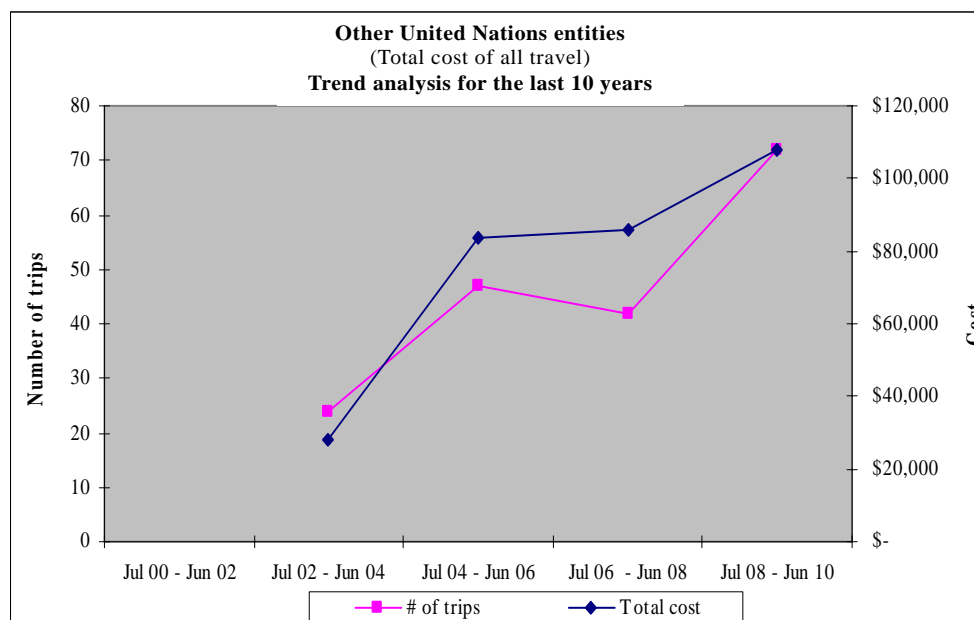
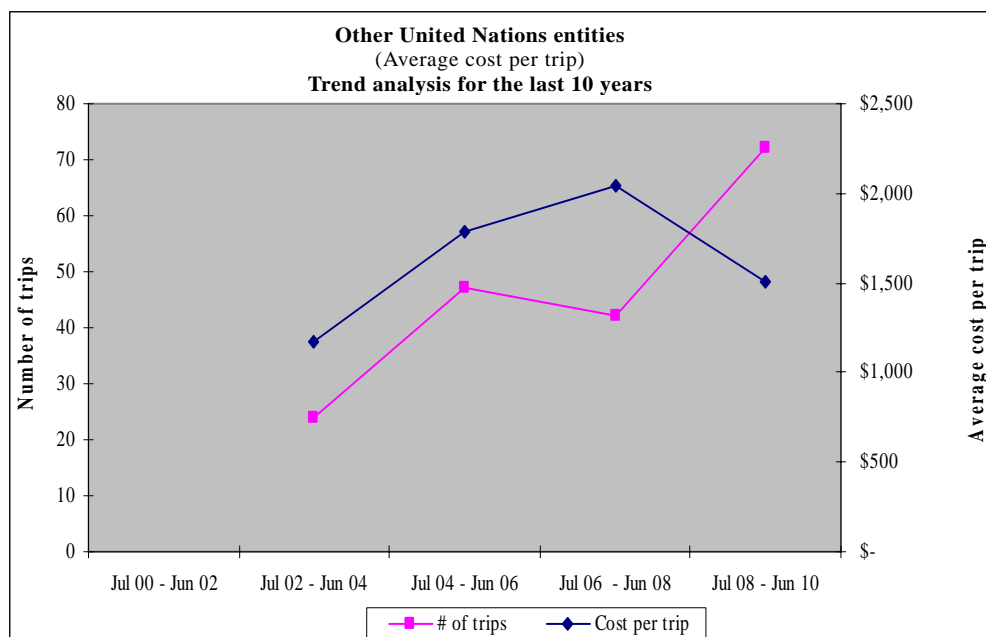
