Summary

The present report of the Secretary-General is submitted pursuant to General Assembly resolutions concerning human resources management, the most recent of which are resolutions 57/305, 59/266, 60/238, 61/244 and 63/250.

The report presents a demographic analysis of the composition of the staff of the Secretariat (44,134) from 1 July 2009 to 30 June 2010.

I. Introduction

1. The present annual report of the Secretary-General on the composition of the Secretariat is submitted pursuant to General Assembly resolutions concerning human resources management, the most recent of which are resolutions 57/305, 59/266, 60/238, 61/244 and 63/250.

2. This report presents a demographic analysis¹ of the global staff of the Secretariat, which totalled 44,134 as at 30 June 2010. The report has been designed to present this demographic information, which, in previous years, was often set out in text, in easier to understand figures and tables.

3. Table 1 provides an overview of the report showing chapters, populations and demographic variables. Table 2 provides an overview of trends by demographic variables from 2006 to 2010. In table 3, a summary of the major changes in information presented in the present report compared to the previous 2009 (A/64/352) report is shown. Table 4 shows the number of staff in the Secretariat and related entities in the United Nations system.

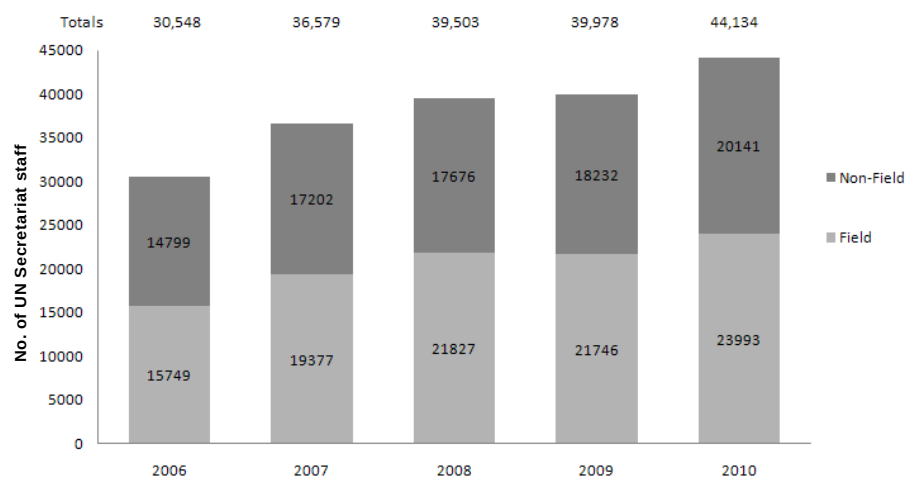

The total population of the staff of the Secretariat² as at 30 June 2010 was 44,134,³ comprised of all categories of staff holding permanent/probationary, fixed-term and temporary contracts recruited internationally and locally. In 2010, the all staff population includes an additional 1,450 staff of the Secretariat (see table 5) who are administered by the United Nations Development Programme (UNDP) (not recorded in the Integrated Management Information System (IMIS)) and who were not previously included in reports on the all staff population.⁴

5. The all staff population includes staff members from 187 Member States (see annex, table 1.A).

6. Figure I below shows the five-year trend for all staff in total and by non-field operations (departments/offices, regional commissions, tribunals) versus field operations. Table 5 details changes in the number of staff from 30 June 2009 to 30 June 2010.

B. Entity

7. All staff of the Secretariat are employed in four entity groups (departments/offices, regional commissions, tribunals and field operations). Field offices of the Office for the Coordination of Humanitarian Affairs, the United Nations Office on Drugs and Crime (UNODC) and other departments/offices are included in their respective departments/offices. Field operations⁵ refer to peacekeeping missions and certain special political missions. Table 1.B (see annex) details the respective entities in the four groups and their staff, showing departments/offices by headquarters and other locations.

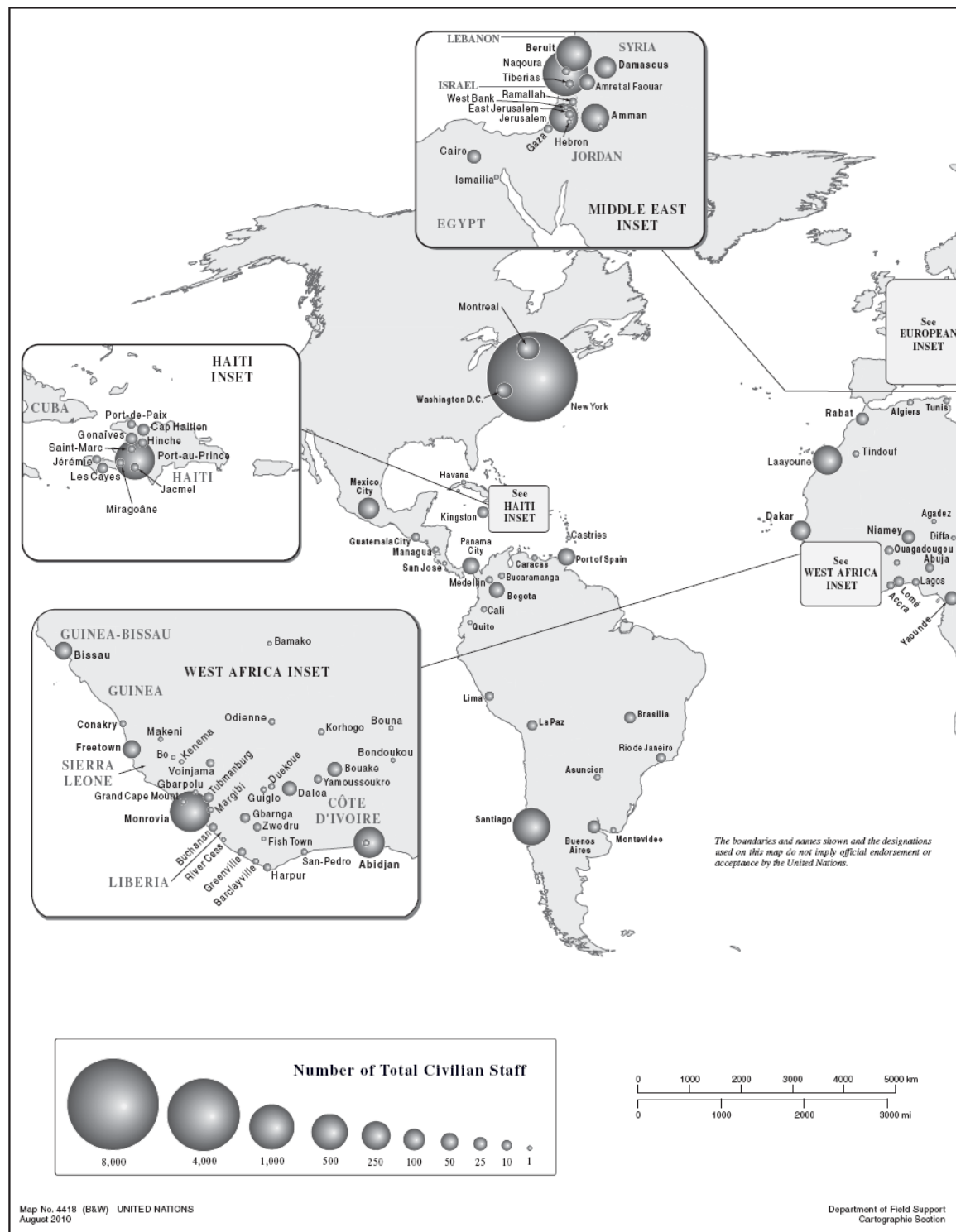

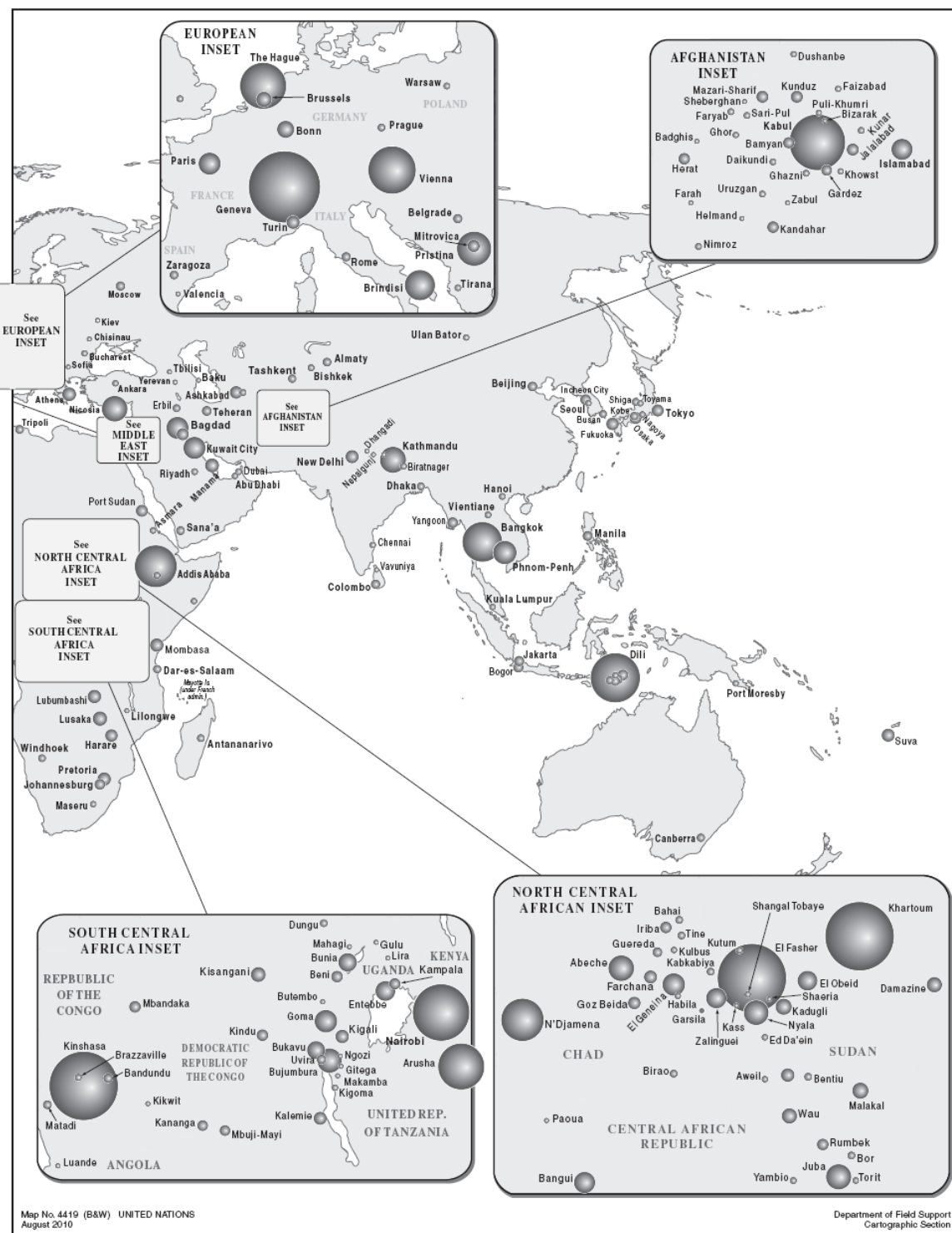

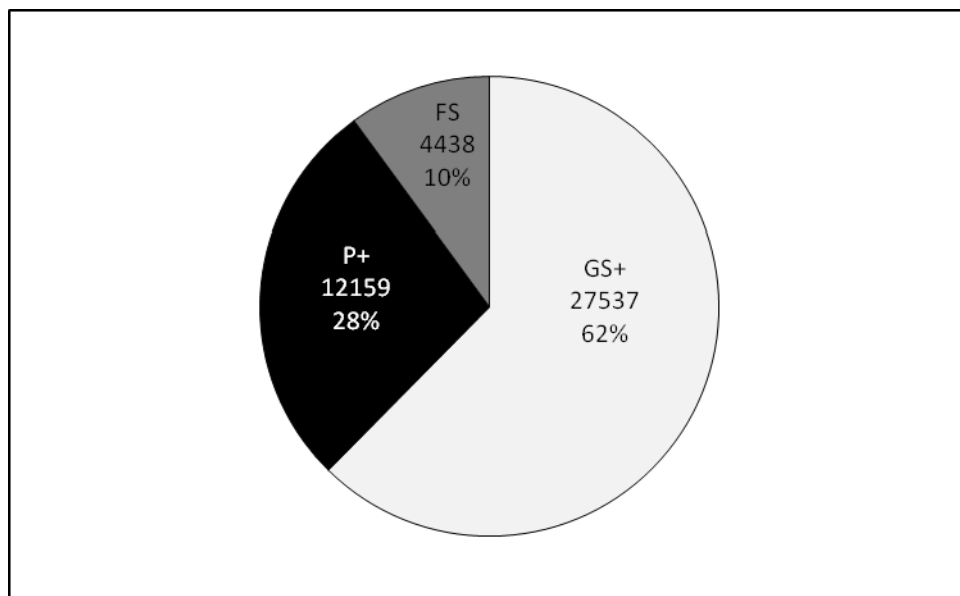

(Population: 12,159 of 44,134)

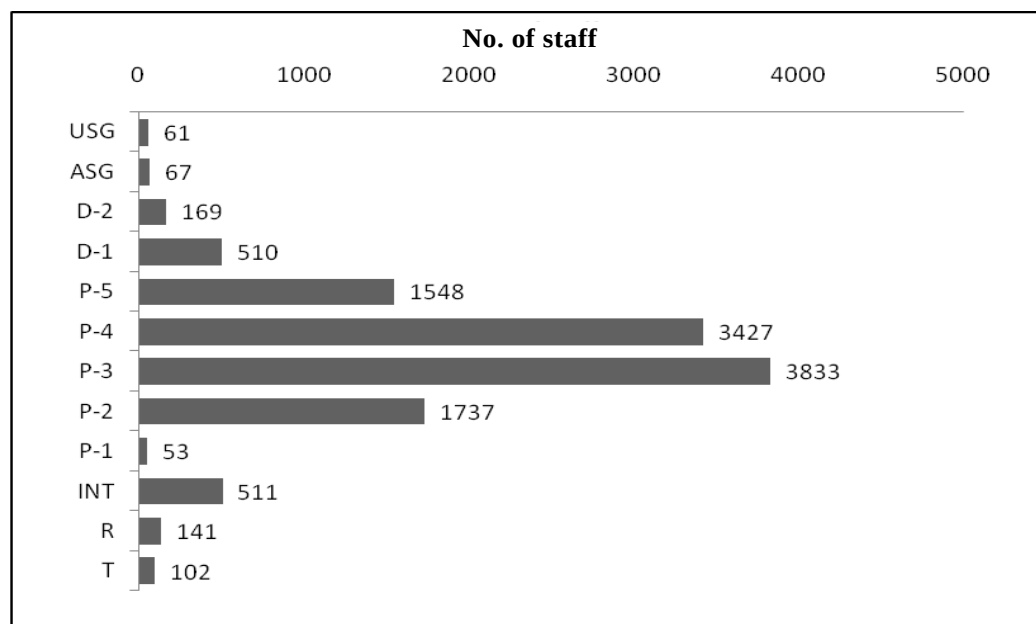
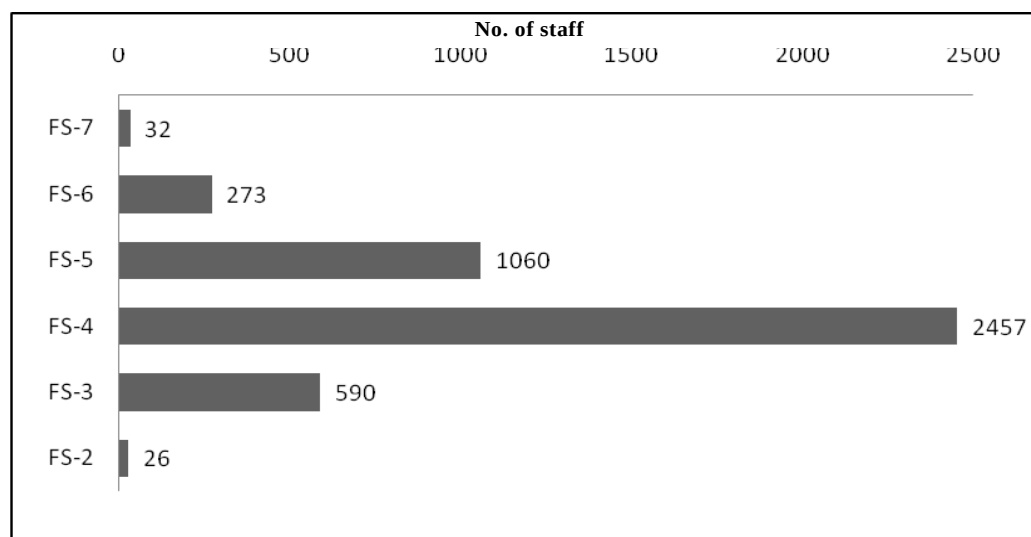

(Population: 4,438 of 44,134)

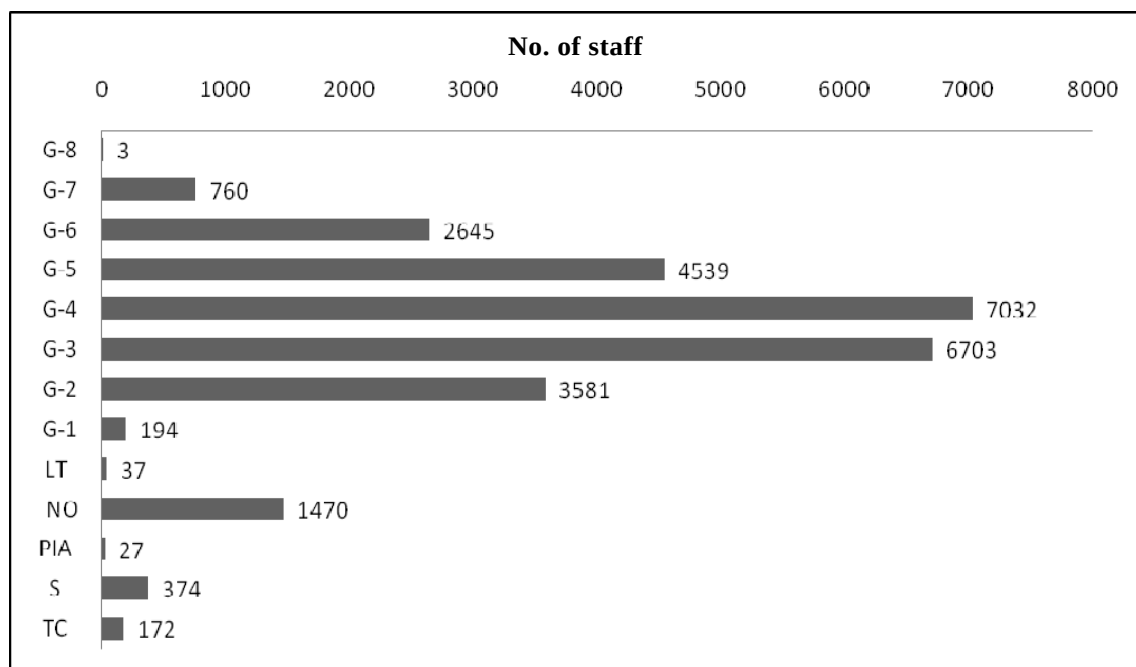

(Population: 26,067 of 44,134)



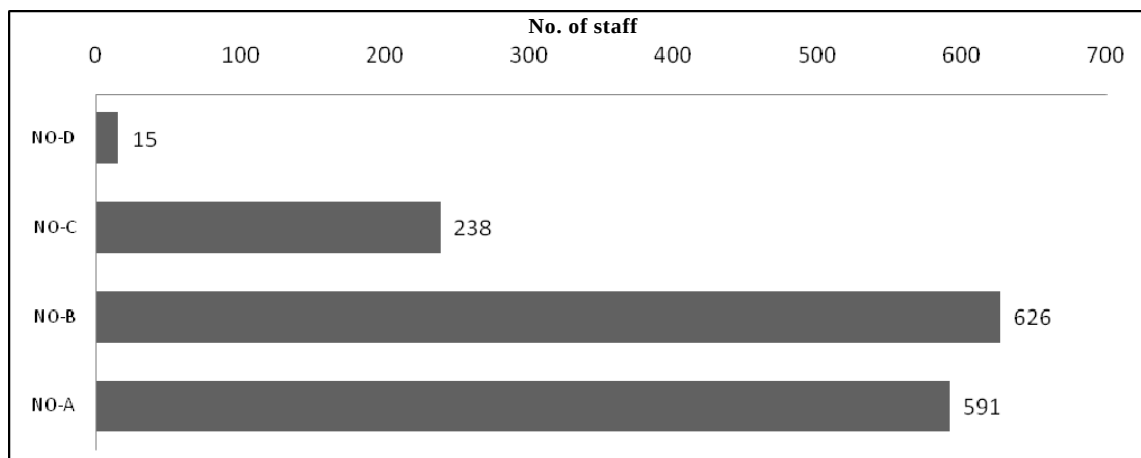

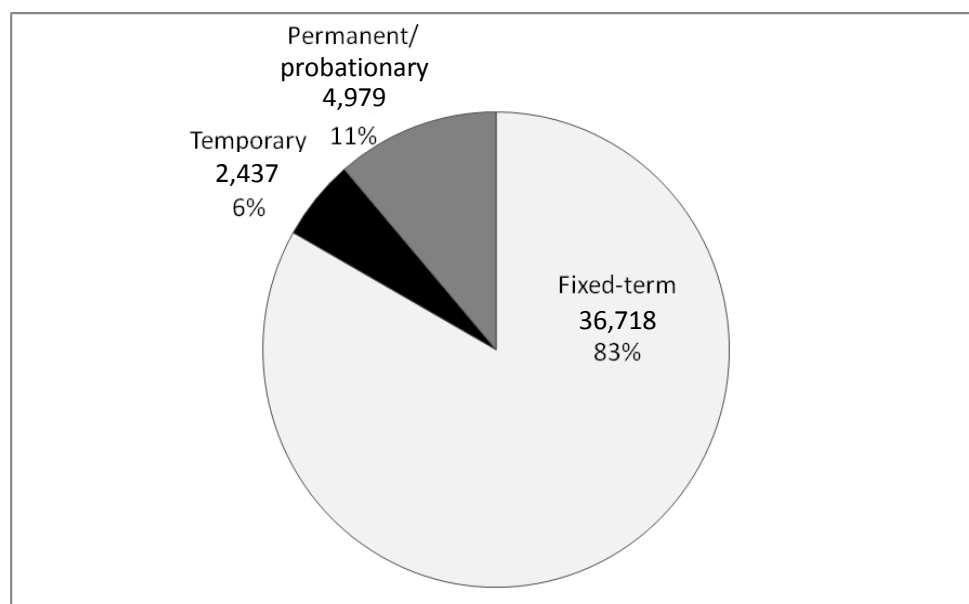

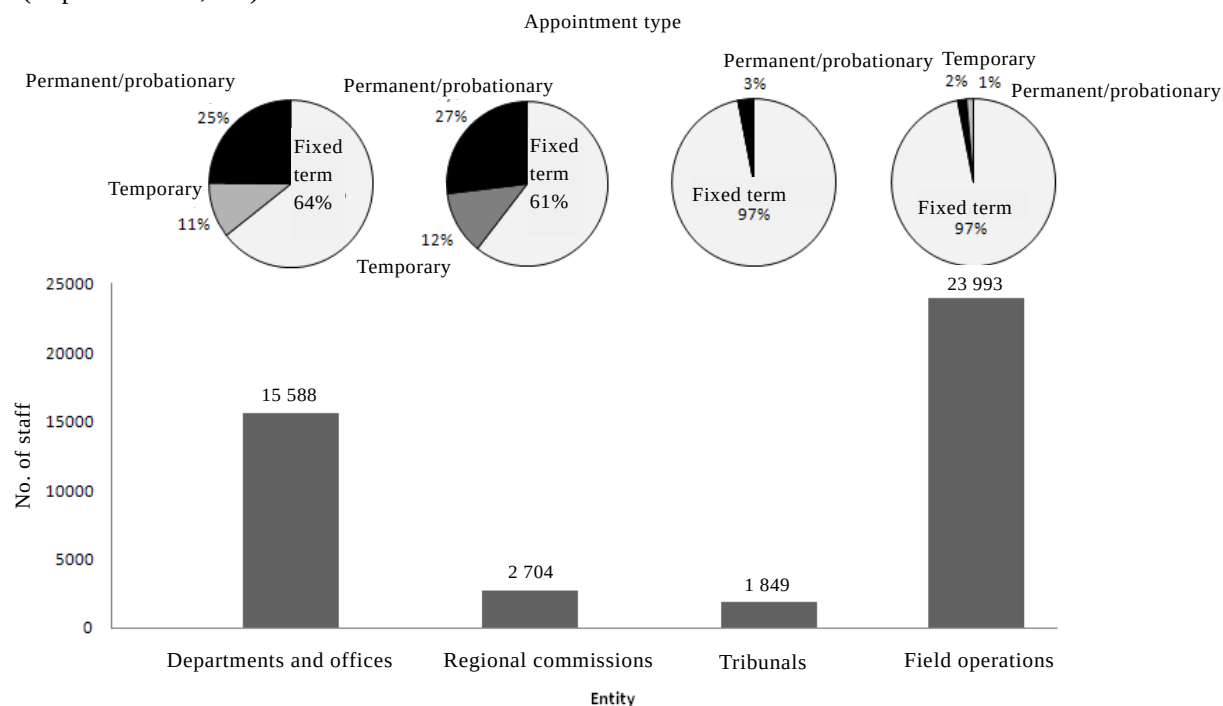

(Population: 20,141 of 44,134)

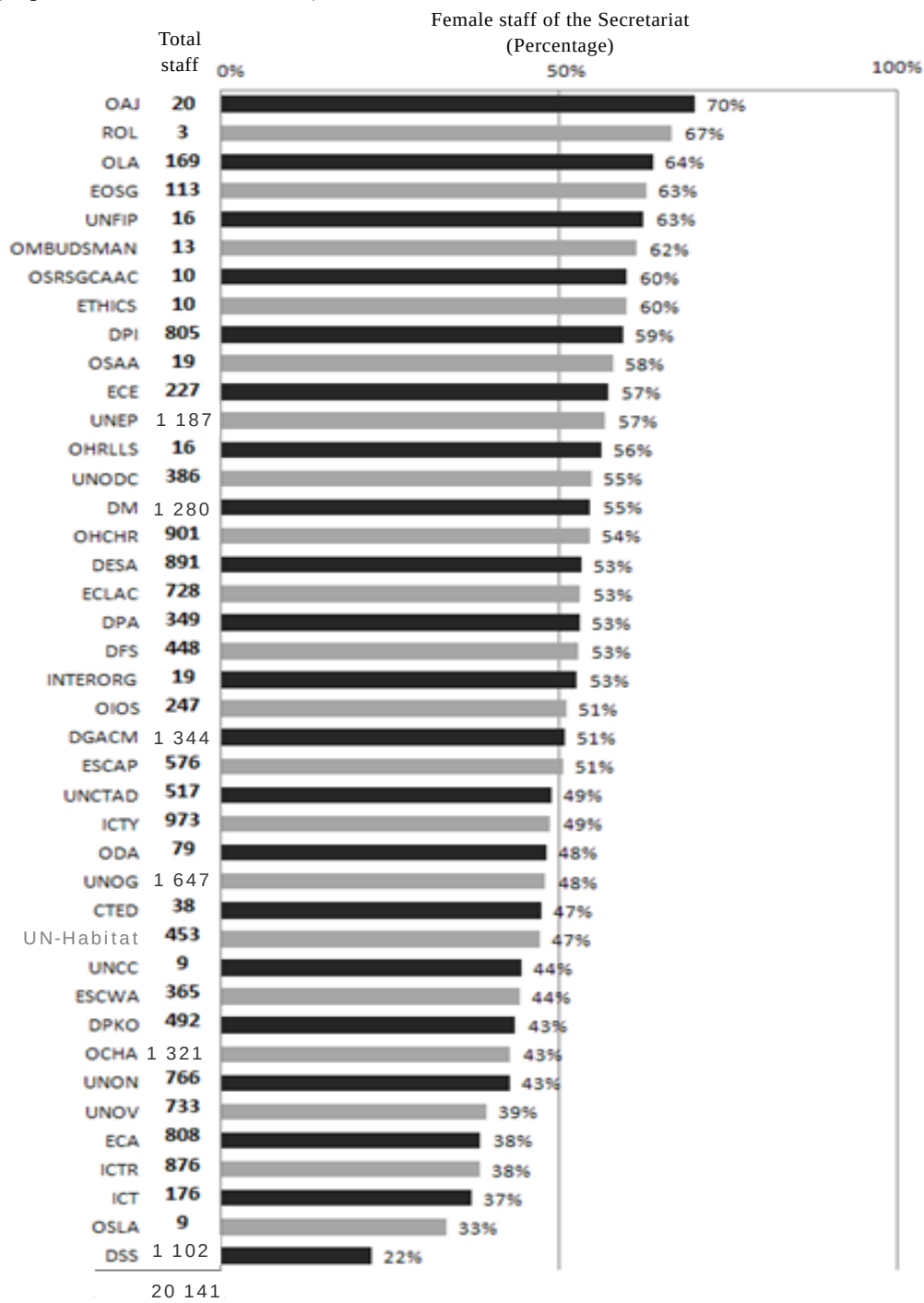
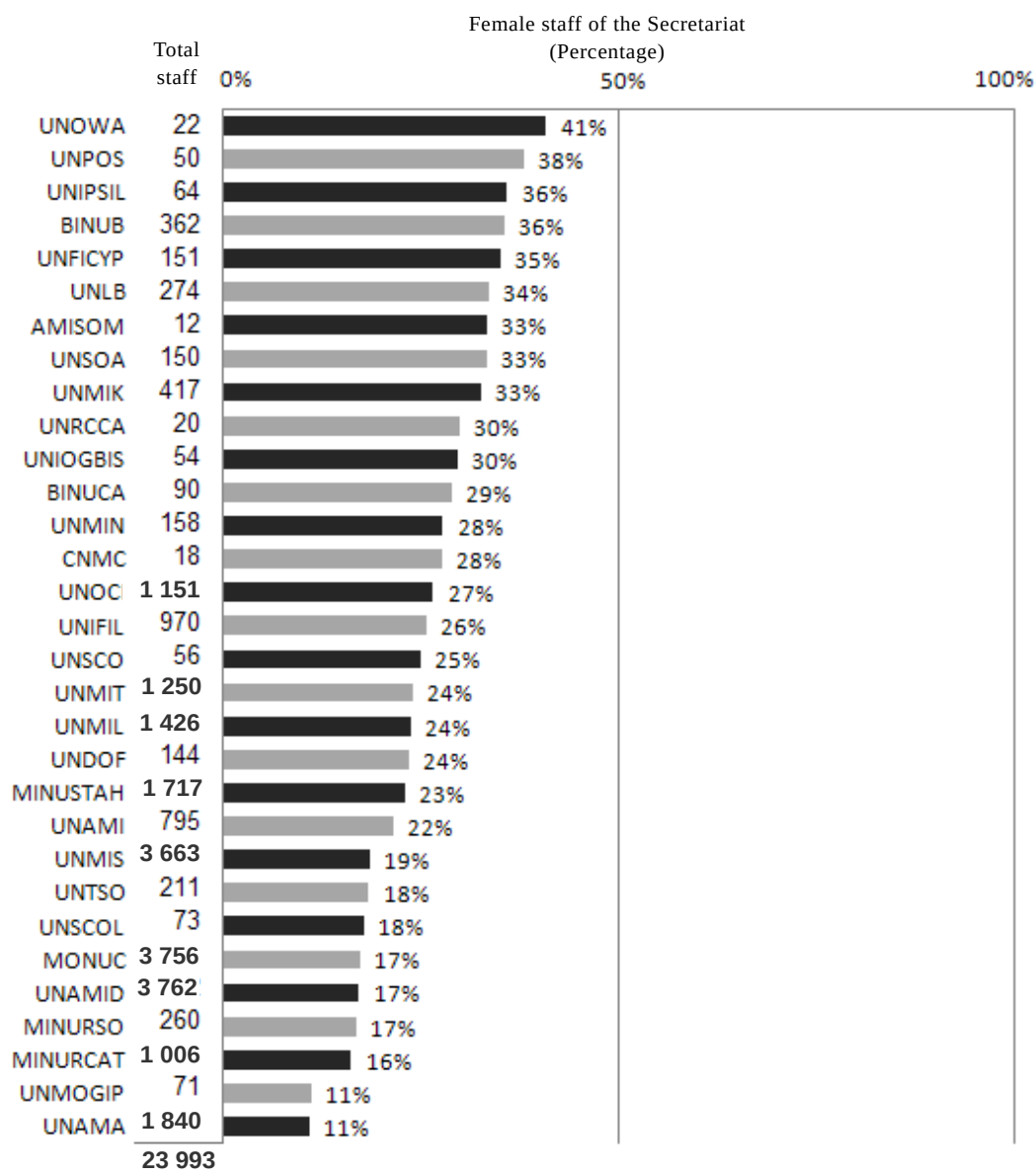

(Population: 44,134 as at 30 June 2010)

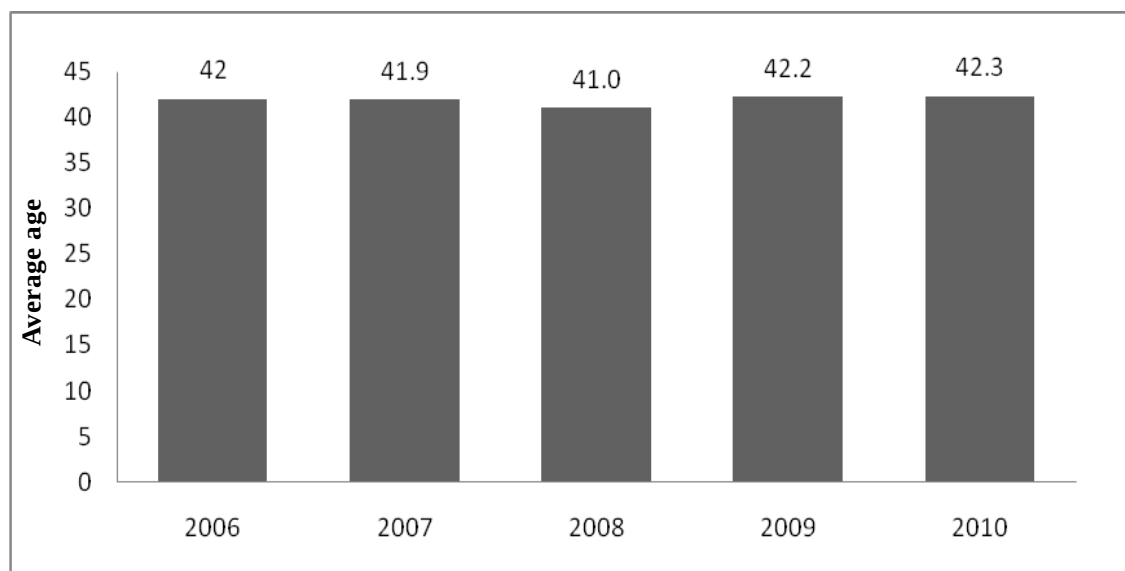
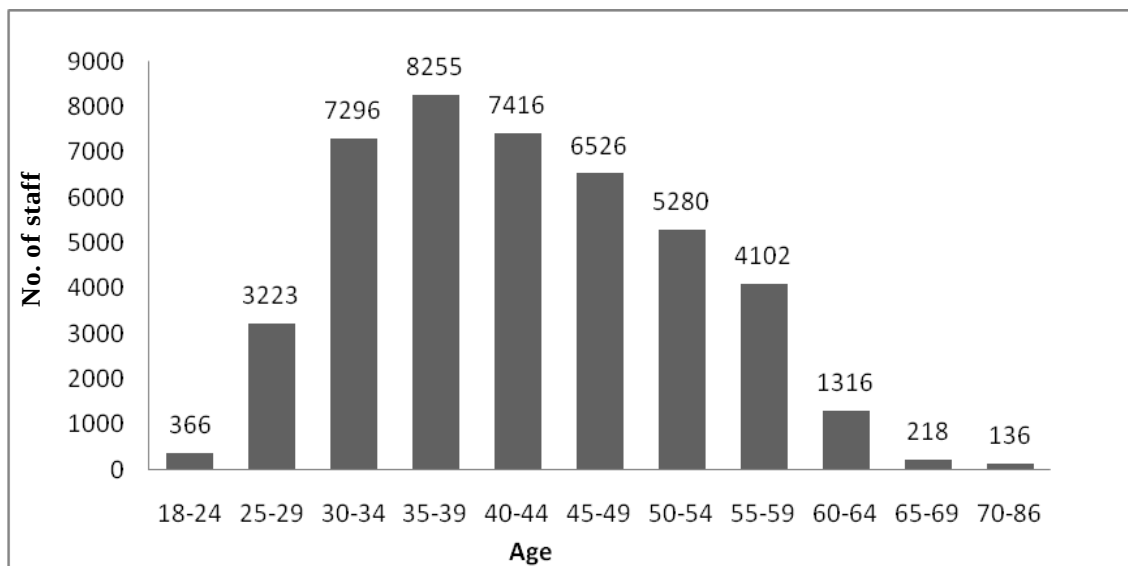

 (Population: 20,141 of 44,134)

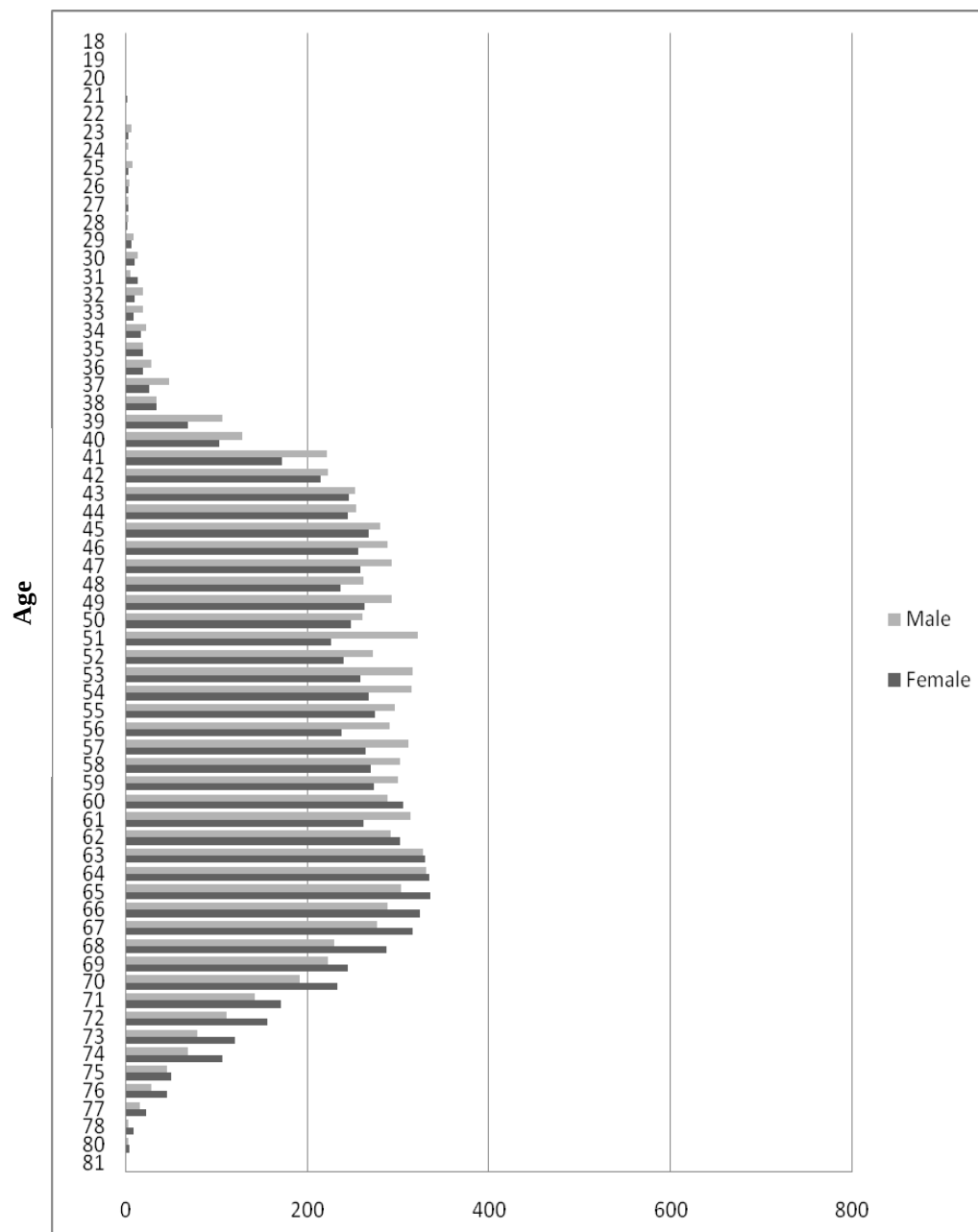
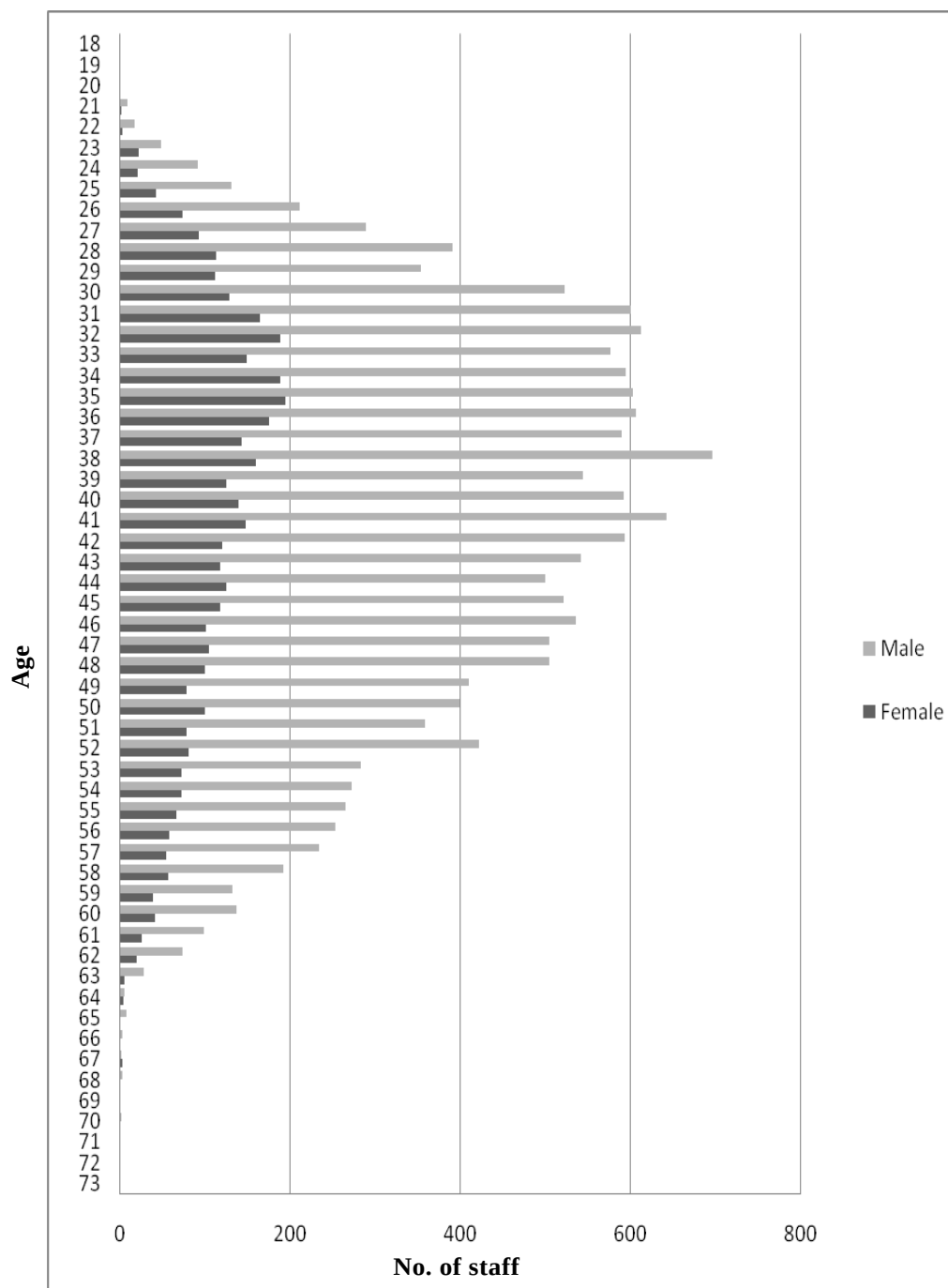

III. Staff movements

A. Population

22. Chapter III provides an analysis of the movements of the staff of the Secretariat, including: external movements — appointments and separations; and internal movements — promotions and transfers. The population used to report on staff movements, which was 28,045 as at 30 June 2010, includes only those staff members who are administered by IMIS. This population is smaller than that reported in chapter II on the all staff population (44,134) because 16,089⁹ staff of the Secretariat are not recorded in IMIS. This is mainly a result of the fact that most field operations do not have access to IMIS. The population reported on in the present report is more than double that reported on in 2009, in which only movements on 100 series appointments of one year or longer were reported.¹⁰ Table 12 below provides a summary of the staff movements.

27. In section VIII of its resolution 57/305, the General Assembly approved the proposal of the Secretary-General on the placement of staff members serving in the Executive Office of the Secretary-General (see A/56/816) and requested him to report on the implementation of the procedure. During the period from 1 July 2009 to 30 June 2010, nine staff members were transferred from the Executive Office of the Secretary-General to posts at the same level in other departments and offices.

D. Gender

28. Table 17 provides a summary of staff movements by gender. The gender balance of this population of staff as at 30 June 2010 did not change from 30 June 2009 as a result of the external movements; the percentage of women remained at 41 per cent.

E. Age

1. Separations

29. The average age of staff of the Secretariat at resignation was 40.6 years old. At resignation, the average length of service in the Secretariat was 3.7 years, and 7 years in the United Nations common system.

30. Table 18 shows that forecast retirements are not increasing but rather very slightly decreasing as a percentage of staff.

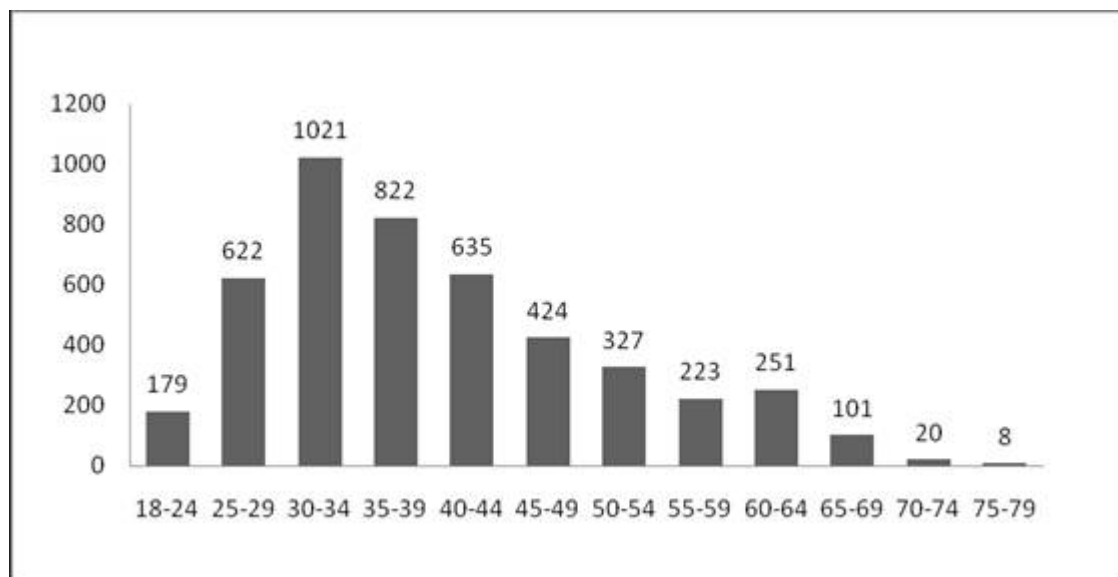

IV. Staff subject to the system of desirable ranges

A. Population

32. As at 30 June 2010 there were 2,886 Secretariat staff with geographical status from Member States as described in the report of the Secretary-General on desirable ranges (A/65/305/Add.2).

33. The representation of Member States falls into four groups: unrepresented, underrepresented, within range and overrepresented. A Member State is considered “unrepresented” when not a single one of its nationals, having gone through the established selection process, is serving in a post subject to geographical distribution. It is “underrepresented” when the number of its nationals appointed to such posts is below the lower limit of the desirable range; it is “within range” when the number of its nationals appointed to such posts is between the upper and lower limits of the desirable range; and it is “overrepresented” when the number of its nationals appointed to such posts exceeds the upper limit of the desirable range.

34. The representation of Member States under the system of desirable ranges over the last five years is shown in table 19. Table 20 shows the individual representation status by Member State as at 30 June 2010. The representation status of the Member States at 30 June 2009 is indicated if it is different from that as of 30 June 2010. Table 2.A (see annex) provides a detailed breakdown of Secretariat staff with geographical status by nationality, grade and gender, including information on appointments, separations and balances as at 30 June 2009 and 30 June 2010. Table 2.D provides a breakdown of staff in posts with special language requirements by nationality, grade and gender.

B. Entity

35. with geographical status were in departments/offices (2,253 Secretariat staff), 20 per cent in regional commissions (592 Secretariat staff) and 2 per cent in field operations (44 Secretariat staff).

C. Category

2. Representation of Member States at the senior and policymaking levels (D-1 level and above)

37. In section X, paragraph 2, of its resolution 55/258, the General Assembly requested the Secretary-General to take all necessary measures to ensure, at the senior and policymaking levels of the Secretariat, the equitable representation of Member States, especially those with inadequate representation at those levels and unrepresented and underrepresented Member States, in particular developing countries, in accordance with the relevant resolutions of the Assembly, and to continue to include relevant information from thereon in all future reports on the composition of the Secretariat. That request was reiterated by the General Assembly in a series of resolutions, most recently resolution 63/250 (sect. IX, para. 7).

38. Secretariat staff at the senior and policymaking levels are defined as those at the D-1 level and above. Table 22 shows Secretariat staff with geographical status at the D-1 level and above, grouped by economic country groupings (developed countries, developing countries and countries with economies in transition) from 2006 to 2010. In table 22, the sum of the group midpoints is calculated by adding the midpoints from the desirable ranges of each Member State in the economic grouping. The percentages of the combined midpoints of each economic group to

the global combined midpoints are compared to the percentages of staff representing Member States in those groupings to the total population of the Secretariat staff with geographical status representing Member States at the respective grades.

D. Appointments

40. From 1 July 2009 to 30 June 2010, 252 Secretariat staff, having gone through the selection process, were appointed to posts subject to geographical distribution. Of the 252 Secretariat staff newly appointed to geographical posts, 112 were appointed through national competitive examinations and 14 Secretariat staff (12 women and 2 men) were appointed through the competitive examination for recruitment to the Professional and higher categories of staff from other categories (“G to P examination”).

43. In 2009, 36 Member States participated in national competitive examinations (Afghanistan, Angola, Antigua and Barbuda, Belgium, Brunei Darussalam, Comoros, the Democratic People's Republic of Korea, the Dominican Republic, Equatorial Guinea, Finland, Grenada, Iran (Islamic Republic of), Japan, Latvia, Liberia, Libyan Arab Jamahiriya, Liechtenstein, Monaco, Montenegro, Mozambique, Namibia, Nepal, Norway, Solomon Islands, Spain, Tonga, Turkey, the Republic of Korea, Saint Lucia, Samoa, Saudi Arabia, Slovenia, the United Arab Emirates, the United Kingdom of Great Britain and Northern Ireland, the United States of America and Yemen). These are unrepresented and underrepresented Member States and those who may become so. Examinations were given in eight occupational groups.¹¹ Of the total number of 167 candidates who were successful in the 2009 examinations, one has been removed from the roster.

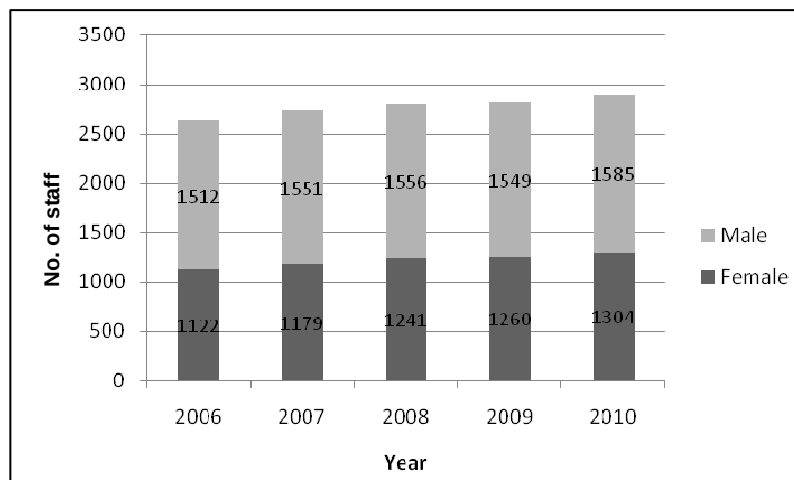
45. Since the forty-fifth session of the General Assembly, and in compliance with Assembly resolutions 45/239 C, 55/258 (sect. XIV, para. 2) and 57/305 (sect. II, paras. 39-41), the Secretary-General has continued to report on efforts made to increase the number of women with geographical status in the Secretariat, in particular in senior and policymaking posts.

46. The proportion of male and female staff of the Secretariat with geographical status for the five-year period from 2006 to 2010 is shown in figure XVI. The percentage of female staff of the Secretariat with geographical status has increased annually since 30 June 2006 (42.6 per cent female) to 30 June 2010 (45.1 per cent female).

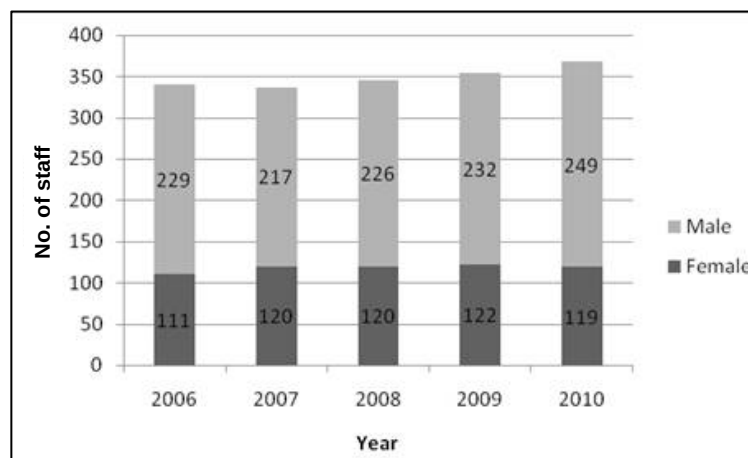

F. Age: forecast of retirements of staff under the system of desirable ranges

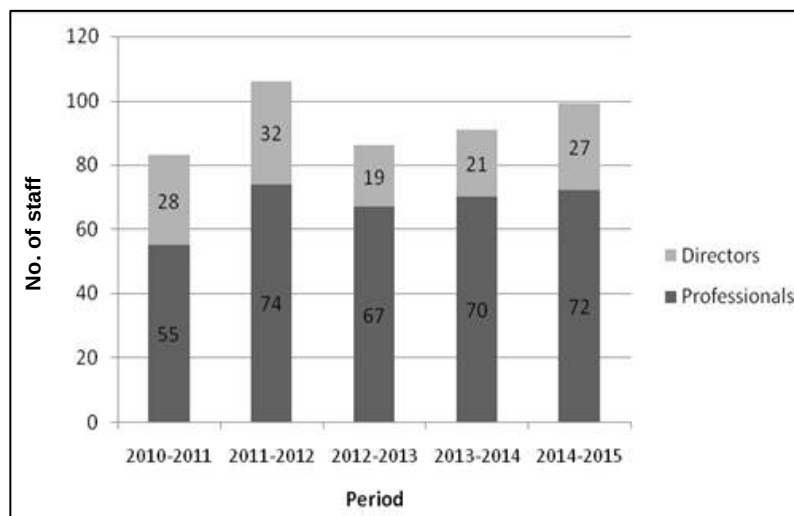
49. From 1 July 2009 to 30 June 2010, 102 Secretariat staff with geographical status retired (30 Directors and 72 staff in the Professional and higher categories).

50. Figure XVIII shows a five-year forecast of retirements of Secretariat staff members with geographical status at the level of Director and in the Professional and higher categories. This represents a forecast of 93 Secretariat staff with geographical status retiring, on average, each year during the next five years. The figures show that retirements of Secretariat staff with geographical status are not increasing but rather slightly decreasing. The average number of retiring Secretariat staff with geographical status was 114 per year over that past five years, from 1 July 2006 to 30 June 2010.
