### **Follow-up to the high-level meeting held on 24 September 2010: revitalizing the work of the Conference on Disarmament and taking forward multilateral disarmament negotiations**

#### **Letter dated 9 May 2011 from the Permanent Representative of Austria to the United Nations addressed to the Secretary-General**

I have the honour to transmit herewith a letter dated 18 April 2011 sent to the President of the General Assembly and to you (see annex) to request the convening of a plenary debate of the General Assembly under agenda item 162 at the earliest possible date. The request for convening such a General Assembly plenary debate as contained in the annexed letter has received the support of the following 49 Member States: Albania, Austria, Bangladesh, Belgium, Bulgaria, Chile, Costa Rica, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, Germany, Greece, Hungary, Ireland, Italy, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Mexico, Montenegro, Netherlands, New Zealand, Nigeria, Norway, Peru, Philippines, Poland, Portugal, Republic of Korea, Republic of Moldova, Romania, Serbia, Slovakia, Slovenia, South Africa, Spain, Sweden, Switzerland, Thailand, Turkey, Ukraine and Uruguay.

I should be grateful if you would have the present letter and its annex circulated as a document of the General Assembly, under agenda item 162.

## **Annex to the letter dated 9 May 2011 from the Permanent Representative of Austria to the United Nations addressed to the Secretary-General**

We, the undersigned Permanent Representatives/Chargés d'affaires a.i. of the Permanent Missions of Albania, Austria, Belgium, Bulgaria, Chile, Costa Rica, Croatia, Cyprus, the Czech Republic, Finland, Germany, Greece, Hungary, Ireland, Italy, Japan, Latvia, Liechtenstein, Luxembourg, Malaysia, Malta, Mexico, Montenegro, the Netherlands, New Zealand, Nigeria, Norway, Peru, the Philippines, Poland, Portugal, the Republic of Korea, the Republic of Moldova, Romania, Serbia, Spain, Sweden, Switzerland, Thailand, Turkey and Uruguay to the United Nations in New York, also on behalf of an additional number of members of the General Assembly (see attachment), request you kindly to convene a plenary debate of the General Assembly under agenda item 162, entitled "Follow-up to the high-level meeting held on 24 September 2010: revitalizing the work of the Conference on Disarmament and taking forward multilateral disarmament negotiations" at the earliest possible date. Such a plenary debate seems to us a logical step in the light of your participation in last year's high-level meeting and your statement of 28 February 2011 before the Conference on Disarmament in which you noted that the Conference must be strengthened and overcome its logjam.

We are convinced that given the lack of progress during the first part of the Conference on Disarmament in 2011 such a General Assembly plenary debate would provide an important opportunity to maintain the necessary political momentum created by the high-level meeting on the work of the Conference on Disarmament of 24 September 2010. Such a plenary debate of the General Assembly would send an important political signal to the Conference on Disarmament that more intensified efforts and more flexibility are needed to allow for the immediate start of substantive work.

Functioning multilateral security institutions are a vital component of our security. The long-term deadlock of core disarmament forums such as the Conference on Disarmament poses a serious security problem. We cannot afford to wait any longer. A plenary debate of the General Assembly would provide a suitable platform to discuss in an inclusive manner, inter alia, possible future options and alternatives for solving the impasse of the Conference on Disarmament.

We, the undersigned Permanent Representatives/Chargés d'affaires a.i. stand ready for a meeting with you — if you so wish — in order to explain in more depth our request for convening a plenary debate of the General Assembly at the earliest possible date.
