Summary

The present report is submitted pursuant to General Assembly resolutions concerning human resources management, the most recent of which are resolutions 57/305, 59/266, 60/238, 61/244, 63/250 and 65/247.

The report presents a demographic analysis of the composition of the staff of the Secretariat (43,747) from 1 July 2010 to 30 June 2011.

The Secretary-General invites the General Assembly to take note of the present report.

I. Introduction

1. The present annual report of the Secretary-General on the composition of the Secretariat is submitted pursuant to General Assembly resolutions concerning human resources management, the most recent of which are resolutions 57/305, 59/266, 60/238, 61/244, 63/250 and 65/247.
2. This report presents a demographic analysis¹ of the global staff of the Secretariat, which totalled 43,747 as at 30 June 2011.
3. Table 1 provides an overview of the report showing sections, populations and demographic variables. Table 2 provides an overview of trends by demographic variable from 2007 to 2011. In table 3, a summary of the major changes in information presented in the present report compared to the 2010 report (A/65/350) is shown. Table 4 shows the number of staff in the Secretariat and related entities in the United Nations system.

HR Insight

4. In August 2011, the Office of Human Resources Management launched the first release of an online reporting tool called HR Insight that is available to all permanent missions. It is based on the human resources data warehouse and retrieves information from other human resources systems, including IMIS and Nucleus.

5. The first release of the tool is providing permanent missions with reports on desirable ranges and staff demographic information. These online reports can be downloaded, allowing permanent missions convenient instant access to often requested reports from the Office of Human Resources Management and reducing the need to print thousands of report pages (for example, the list of staff of the United Nations Secretariat is now only available online on HR Insight).

6. With the launch of HR Insight, Member States now have access to reports that provide information similar to that contained in the report on the composition of the Secretariat, such as the statistical tables showing desirable ranges.

II. All staff of the Secretariat


A. Population

7. The total population of the staff of the Secretariat² as at 30 June 2011 was 43,747,³ comprised of all categories of staff holding permanent/probationary, fixed term and temporary contracts recruited internationally and locally.

8. The all staff population includes staff members from 186 Member States (see annex, table 1.A).

9. Figure I below shows the five-year trend for all staff in total and by non-field operations (departments/offices, regional commissions, tribunals) versus field operations. Table 5 details changes in the number of staff from 30 June 2010 to 30 June 2011.





(Population: 12,214 of 43,747)



(Population: 4,541 of 43,747)



(Population: 26,992 of 43,747)







(Population: 43,747)





(Population: 20,256 of 43,747)




(Population: 43,747 as at 30 June 2011)




(Population: 20,256 of 43,747)




III. Staff movements

A. Population

26. Chapter III provides an analysis of the movements of the staff of the Secretariat, including external movements (appointments and separations) and internal movements (promotions and transfers). The population used to report on staff movements, which was 27,491 as at 30 June 2011, includes only those staff members who are administered by IMIS. This population is smaller than that reported in section II on the all staff population (43,747) because 16,256⁸ staff of the Secretariat are not recorded in IMIS. This is mainly a result of the fact that most field operations do not have access to IMIS. Table 13 below provides a summary of the staff movements.



IV. Staff subject to the system of desirable ranges⁹

A. Population

36. As at 30 June 2011, there were 2,049 Secretariat staff with geographical status from Member States, pursuant to paragraph 66 of General Assembly resolution 65/247, in which the Assembly decided that staff members shall retain geographical status only when serving against a geographical post, except those recruited under the young professionals programme.

37. That provision in resolution 65/247 represents a change in the criteria for geographical status. Previously, once geographic status had been given, it was retained throughout the period of uninterrupted service of the staff member, regardless of the nature of the position or functions to which the staff member might subsequently be assigned (see A/65/305/Add.2, para. 20).

38. The representation of Member States falls into four groups: unrepresented, underrepresented, within range and overrepresented. A Member State is considered “unrepresented” when not a single one of its nationals, having gone through the established selection process, is serving in a post subject to geographical distribution. It is “underrepresented” when the number of its nationals appointed to such posts is below the lower limit of the desirable range; it is “within range” when the number of its nationals appointed to such posts is between the upper and lower limits of the desirable range; and it is “overrepresented” when the number of its nationals appointed to such posts exceeds the upper limit of the desirable range.

39. The representation of Member States under the system of desirable ranges over the last five years is shown in table 20. Table 21 shows the individual representation status by Member State as at 30 June 2011. The representation status of the Member States at 30 June 2010 is indicated if it is different from that as at 30 June 2011. Table 2.A (see annex) provides a detailed breakdown of Secretariat staff with geographical status by nationality, grade and gender, including information on appointments, separations and balances as at 30 June 2010 and 30 June 2011. Table 2.C provides a breakdown of staff in posts with special language requirements by nationality, grade and gender.

47. In 2010, 35 Member States participated in national competitive recruitment examinations (Afghanistan, Angola, Antigua and Barbuda, Belgium, Brunei Darussalam, Comoros, the Dominican Republic, Equatorial Guinea, Finland, Grenada, Iran (Islamic Republic of), Japan, Latvia, Liberia, Libyan Arab Jamahiriya, Liechtenstein, Monaco, Montenegro, Mozambique, Namibia, Nepal, Norway, the Republic of Korea, Saint Lucia, Samoa, Saudi Arabia, Slovenia, Solomon Islands, Spain, Tonga, Turkey, the United Arab Emirates, the United Kingdom of Great Britain and Northern Ireland, the United States of America and Yemen). 


