- 4.1 General and complete disarmament under strict and effective international control remains the ultimate goal of all efforts in the field of disarmament. The main responsibilities for disarmament lie with Member States. The United Nations, in accordance with its Charter, has a central role and primary responsibility in supporting Member States in this area.
- 4.2 The mandate for the programme derives from the priorities established in relevant General Assembly resolutions and decisions in the field of disarmament, including the Final Document of the Tenth Special Session of the General Assembly, the first special session devoted to disarmament (resolution S-10/2). The programme is also guided by the United Nations Millennium Declaration (see resolution 55/2) and takes into account other relevant resolutions of the United Nations. Weapons of mass destruction, in particular nuclear weapons, continue to be of primary concern to the Organization, due to their destructive power and threat to humanity. Conventional disarmament, especially with regard to major weapons systems, small arms and light weapons, landmines and cluster munitions, has received increased attention from the international community in view of the havoc that such weapons are inflicting on people's daily lives, in particular in conflict-ridden regions.
- 4.3 Within the Secretariat, substantive responsibility for the programme is vested in the Office for Disarmament Affairs. The Office's strategy in meeting the programme's objectives is designed around five subprogrammes and is based on its role in and responsibility for facilitating and encouraging, as appropriate, disarmament and non-proliferation measures at all levels. The Office will continue to assist Member States in promoting, strengthening and consolidating multilaterally negotiated principles and norms in all areas of disarmament and non-proliferation in all its aspects. It will support efforts of Member States in the areas of disarmament and non-proliferation in all its

aspects in order to help promote international peace and security and contribute to global efforts against terrorism. In order to do so effectively, the Office will enhance its capacity for more in-depth analysis, keeping track of developments in those areas, and to provide Member States with timely and practical advice, on request. It will continue to assist Member States in their efforts to prevent the destabilizing and excessive accumulation of illicit manufacture of and trafficking in small arms and light weapons in all their aspects. Moreover, the Office will facilitate and promote efforts for the further implementation of the Programme of Action adopted at the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects, as well as practical disarmament measures. It will promote transparency, based on the principle of undiminished security for all, and confidence-building measures in the field of disarmament. Through its regional centres for peace and disarmament, the Office will assist Member States in promoting regional approaches to disarmament, non-proliferation in all its aspects and regional and international peace and security. It will also continue to contribute to efforts to enhance disarmament expertise in Member States, particularly in developing countries.

- 4.4 The Office will seek to achieve the objectives of the programme by facilitating the process of multilateral deliberation and negotiation. This will include providing substantive organizational support to the First Committee, the Disarmament Commission and other subsidiary bodies of the General Assembly, the Conference on Disarmament and its subsidiary bodies, review conferences and other meetings of parties to multilateral disarmament agreements, as well as to expert groups mandated by the General Assembly. This will also include monitoring and assessing current and future trends in the field of disarmament, non-proliferation in all its aspects and international security.
- 4.5 The Office will continue to be a source of impartial and factual information on disarmament and security-related matters for Member States, organizations of the United Nations system, intergovernmental and regional organizations and non-governmental organizations and will expand its educational outreach programmes. Training and advisory services will continue to be provided, through the United Nations disarmament fellowship, training and advisory services programme and the United Nations Institute for Disarmament Research (UNIDIR), to Member States, in particular developing countries, to enable them to enhance their expertise in disarmament, so that they may participate more effectively in international deliberating and negotiating forums. The Office will also assist Member States in increasing understanding of the relationship between disarmament and development.
- 4.6 Gender mainstreaming will continue to be an integral part of the activities of the programme through the implementation of a plan of action aimed at raising awareness and increasing commitment to and capacity for gender mainstreaming in disarmament affairs.
- 4.7 The Office carries out its activities in cooperation with other departments and offices of the Secretariat, entities of the United Nations system and entities external to the United Nations, including treaty organizations, intergovernmental, interregional, regional and national organizations, non-governmental organizations and academic communities. Such cooperation includes the preparation of reports, participation in meetings, briefings, technical and substantive support and sharing of information and experience.
- 4.8 The issue of publications as a part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 4.3 and as described in the output information for each subprogramme. The increase in recurrent publications is attributable to the projected issuance of a bimonthly online newsletter for each of the regional centres during the biennium 2012-2013.

4.9 The overall level of resources for the Office for Disarmament Affairs for the biennium 2012-2013 amounts to \$22,711,800 before recosting, reflecting growth of \$577,000 (2.6 per cent). The growth shown in table 4.5 can be summarized as follows:

- (a) The increase of \$33,000 under executive direction and management relates to additional requirements for travel of staff;
- (b) The net increase of \$529,700 under the programme of work relates to:
 - (i) A net decrease of \$11,100 under subprogramme 1, resulting from a reduction in requirements for the replacement of office automation equipment;
 - (ii) A net increase of \$332,900 under subprogramme 2, resulting from the increased requirements for ad hoc expert meetings in 2012 and 2013 on outer space transparency and confidence-building measures as defined in General Assembly resolution 65/68;
 - (iii) A net decrease of \$50,700 under subprogramme 3 is attributable mainly to decreased requirements in terms of consultants, due to the finalization in 2010-2011 of a working group of governmental experts in information and telecommunications in the context of international security; and travel of staff;
 - (iv) A net decrease of \$30,800 under subprogramme 4, resulting from a reduction in requirements for consultants and other travel of staff;
 - (v) A net increase of \$289,400 under subprogramme 5, resulting from the delayed impact for two P-3 posts and two Local level posts approved in 2010-2011 and the inclusion of the core operational requirements of the United Nations Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean, and the United Nations Regional Centre for Peace and Disarmament in Asia and the Pacific, in line with General Assembly resolutions 63/74 and 63/77, respectively. In addition, there is an increase in non-post costs relating to the additional security requirements within the three regional centres to ensure that they are fully compliant with minimum operating security standards;
- (c) The increase of \$19,300 under programme support for non-post requirements relates to the contribution to support central data-processing services provided by the Office of Information and Communications Technology;
- (d) The projected decrease of \$5,000 under policymaking organs results from combining trips or reducing the number of trips whenever feasible.

4.10 During the biennium 2012-2013, projected extrabudgetary resources would amount to \$16,643,000, including \$4,031,300 for the Trust Fund for UNIDIR. The extrabudgetary resources will be utilized for activities related to organizing the twelfth and thirteenth annual meetings and the review conference of the States Parties to the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction; promoting greater mutual confidence among Member States in the field of conventional arms and addressing

the destabilizing and excessive accumulation of and illicit trafficking in and manufacture of small arms and light weapons, as well as promoting a reduction in armed violence; providing impartial and factual information on disarmament to Member States, organizations of the United Nations system and intergovernmental, regional and non-governmental organizations; and providing opportunities for regional cooperation, coordination and collaboration in matters related to disarmament, non-proliferation and regional peace and security. The decrease is due to funding provided in 2010-2011, under subprogramme 3, by a donor to a specific activity that is expected to commence in 2011 with no expectation of continued funding for 2012-2013.

- 4.11 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation activities for post and non-post requirements would amount to \$321,400, including the amount of \$271,400, which represents 16.0 work-months of staff at the Professional level and 4.0 work-months of staff at the General Service level.
- 4.12 The estimated percentage distribution of the resources of the programme in the biennium 2012-2013 is as shown in table 4.4 and the distribution of resources is summarized in tables 4.5 and 4.6.

A. Policymaking organ: Conference on Disarmament***Resource requirements (before recosting): \$37,400***

- 4.13 The Conference on Disarmament was set up in accordance with paragraph 120 of the Final Document of the Tenth Special Session of the General Assembly (resolution S-10/2) as the single multilateral disarmament negotiating forum of the international community. Following the expansions of its membership in 1996 and 1999, the Conference is open to the five nuclear-weapon States and 60 other States, including States of key military significance. In addition, every year some 40 non-member States are invited, upon their request, to participate in its work. The Conference on Disarmament conducts its work by consensus, adopts its own rules of procedure,

rotates its presidency among all its members every four weeks, adopts its own agenda taking into account the recommendations made to it by the General Assembly and the proposals presented by the members of the Conference, and submits a report to the General Assembly annually, or more frequently, as appropriate. The Conference divides its 24-week annual session into three parts and, if necessary, continues its negotiations on priority issues between sessions. Meetings thus may take place during six to nine months each year.

- 4.14 Pursuant to paragraph 120 (c) of the Final Document of the Tenth Special Session of the General Assembly, the Secretary-General, following consultations with the Conference on Disarmament, appoints the Secretary-General of the Conference, who also acts as his Personal Representative, to assist the Conference and its Presidents in organizing the Conference. As requested by the Assembly in its resolution 34/83 L, the Secretary-General provides staff, as well as the assistance and services needed by the Conference on Disarmament and any subsidiary bodies that it might establish, in accordance with the arrangements contained in its rules of procedure. The secretariat of the Conference consists of officers of the Conference on Disarmament Secretariat and Conference Support Branch (Geneva) of the Office for Disarmament Affairs.
- 4.15 The Conference on Disarmament successfully concluded the negotiation of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction (1992) and the Comprehensive Nuclear-Test-Ban Treaty (1996), with the participation of all five nuclear-weapon States and other militarily significant States. The Conference is currently conducting a comprehensive review of the priorities on the contemporary international disarmament agenda.

- 4.16 The non-post resources provide for travel of Geneva-based officials to attend meetings of the General Assembly and its subsidiary bodies as well as other consultations and meetings hosted at Headquarters.

B. Executive direction and management

Resource requirements (before recosting): \$2,899,900

- 4.17 Executive direction and management of the programme consists of the Office of the High Representative and the Office of the Director.
- 4.18 The Office of the High Representative is responsible for monitoring the implementation of the programme of work, as well as for the overall direction, supervision and management of the Office for Disarmament Affairs, including its financial and administrative activities. The High Representative provides the Secretary-General with advice and support on all disarmament and related security matters, and in that respect represents him as required, while also providing authoritative analysis and assessment of developments for policy guidance and decision-making

purposes and acting as focal point on these matters between the Secretariat and Member States. The High Representative undertakes advocacy work to advance the disarmament agenda, in partnership with the relevant parts of the United Nations and other international organizations, as well as with civil society, the media, academia and foundations.

- 4.19 In the exercise of his responsibilities, the High Representative is assisted by the Director, who is accountable to the High Representative and acts as deputy and assumes charge of the Office for Disarmament Affairs in the absence of the High Representative. The Director provides support to the High Representative on executive direction and management of the Office and ensures efficient coordination, synergy between branches and the delivery of the programmatic mandates of the Office. The Director advises the High Representative and makes recommendations on all substantive, organizational, administrative, personnel and budgetary matters. The Office of the Director is responsible for preparation of the programme of work, monitoring programme implementation and coordinating programme evaluation, as well as the overall coordination and revision of the outputs of the Office for Disarmament Affairs for the strategic framework and the programme budget.

External factors

- 4.20 The programme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the political environment is supportive of disarmament efforts; (b) political developments relating to international peace and security are conducive to the facilitation of negotiations on new arms limitation and disarmament agreements; (c) Member States are willing to implement the recommendations, resolutions and decisions of relevant meetings and conferences; (d) international organizations provide cooperation; (e) the required financial and human resources are made available; and (f) national institutions are supportive of gender balance and mainstreaming issues.

Outputs

- 4.21 During the biennium 2012-2013, the following final outputs will be delivered:
- (a) Substantive inputs and contributions, including political advice and analysis, to the Secretary-General on disarmament and non-proliferation-related matters in the form of briefing materials, statements and talking points;
 - (b) Advocacy on disarmament and non-proliferation issues with Member States and civil society through speaking engagements, conferences, information dissemination, raising public awareness and representation of the Secretary-General at international events and forums as appropriate;
 - (c) Regular monitoring of the Office's branches to ensure continued timely preparation and submission of parliamentary documentation and recurrent and non-recurrent publications;
 - (d) Support for multilateral efforts in the field of disarmament and non-proliferation, and cooperation with Member States, intergovernmental organizations and civil society, including at the regional level;

- (e) Preparation, organization and substantive servicing of meetings and/or activities related to relevant disarmament bodies, conferences and meetings, such as the Conference on Disarmament, the First Committee of the General Assembly, the Disarmament Commission, review conference of parties to multilateral disarmament agreements and groups of governmental experts established by the General Assembly.

- 4.22 The amount of \$2,899,900 would provide for the continuation of eight posts (1 Under-Secretary-General, 1 D-2, 3 P-5 and 3 General Service (Other level)), as well as related non-post operational requirements within the Office of the High Representative and the Office of the Director.
- 4.23 The extrabudgetary resources of \$370,300 would provide for the cost of one Professional post (P-5) and non-post resources in a new Vienna office of the Office for Disarmament Affairs. The proposed new post would head the office in Vienna, as part of a new initiative to respond to the growing need to cooperate and ensure effective interaction with intergovernmental organizations. The office would enhance the ability of the Office for Disarmament Affairs to keep the Secretary-General abreast of developments, in particular in the nuclear field, in a timely fashion.
- 4.24 The incumbent of the P-5 post would promote the objectives of the Office for Disarmament Affairs and facilitate closer cooperation with the United Nations Office at Vienna and with organizations and related agencies based in Vienna, such as the International Atomic Energy Agency, the Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization and the Organization for Security and Cooperation in Europe, including attending meetings and sessions of the above-mentioned bodies.
- 4.25 In addition, the incumbent of the post would follow developments that are of relevance to the work of the Office for Disarmament Affairs within the offices, funds and programmes of the United Nations system located at Vienna, as well as those of intergovernmental organizations and related agencies, and would provide advice and recommendations to the High Representative for Disarmament Affairs, as appropriate, in the light of those developments.
- 4.26 The functions of the P-5 post would also entail providing support for the organization of meetings and conferences in the field of disarmament, arms control and non-proliferation, as required and responding to public information queries relating to the Office for Disarmament Affairs and its activities.



- 4.30 The amount of \$4,604,400 illustrated in table 4.12, reflecting a decrease of \$11,100, would provide for the continuation of eight posts, (1 D-2, 1 P-5, 3 P-4 and 3 General Service (Other level)), as well as non-post operational requirements such as overtime, travel of staff, supplies and grants and contributions for the Department's fellowship programme and a subvention of \$577,800 to UNIDIR. The decrease in non-post requirements is mainly due to the non-recurrent requirements for the replacement of furniture and equipment in 2010-2011 in the Geneva office.
- 4.31 The amount of \$810,800 from extrabudgetary resources will be utilized to fund the twelfth and thirteenth annual meetings and/or review conferences of the States parties to the Convention of the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction, and to contribute to the Organization's objective of providing support to States parties to existing multilateral arms limitation and disarmament agreements, including through the purchase of specialized books and publications for the disarmament research and reference collection in order to provide up-to-date information for use by Member States in their negotiations on multilateral arms limitation and disarmament agreements, as well as by the substantive secretariat, research institutions and the general public.

- 4.35 The amount of \$2,701,800, reflecting an increase of \$332,900, would provide for the continuation of eight posts (1 D-1, 1 P-5, 1 P-4, 2 P-3, 1 P-2 and 2 General Service (Other level)), and non-post operational requirements for other staff costs, consultants and experts and travel of staff. The increase in non-post requirements (\$332,900) reflects a higher provision for ad hoc expert groups, owing to meetings to be held in 2012 and 2013 on outer space transparency and confidence-building measures, as defined in General Assembly resolution 65/68.
- 4.36 The amount of \$1,888,000 from extrabudgetary resources will be utilized to fund regional meetings on the implementation of Security Council resolution 1540 (2004), as well as transparency and confidence-building in the field of security, and to promote regional peace and security. The decrease is due to the reduction of the number of meetings planned for 2012-2013.

- 4.40 The amount of \$3,334,900, reflecting a decrease of \$50,700, would provide for the continuation of 10 posts (1 D-1, 2 P-5, 2 P-4, 1 P-3, 1 P-2 and 3 General Service (Other level)), as well as such related non-post resources as other staff cost, consultants, experts and travel of staff. The decrease in non-post requirements of \$50,700 relates to the reduction in the need for consultants, owing to the completion of the work, during the biennium 2010-2011, of the groups of governmental experts in information and telecommunications in the context of international security.
- 4.41 The amount of \$2,975,000 from extrabudgetary resources will be utilized to support activities in promoting international cooperation and assistance in the implementation of the Programme of Action and the International Tracing Instrument; promoting and supporting practical disarmament measures, including weapons collection programmes and the reduction of armed violence; promoting and supporting practical confidence-building measures in the field of conventional arms; promoting and supporting the United Nations Standardized Instrument for Reporting Military Expenditures; and promoting and supporting participation in the United Nations Register of Conventional Arms. The decrease is due to funding provided in 2010-2011 by a donor to a specific activity that is expected to commence in 2011, without expectation of further funding for 2012-2013.

- 4.45 The amount of \$2,853,800, would provide for the continuation of eight posts (1 P-5, 2 P-4, 1 P-3, 1 P-2, 2 General Service (Principal level) and 1 General Service (Other level)), and such non-post operational needs as other staff costs, consultancy, travel of staff and expert group requirements.
- 4.46 The amount of \$56,000 from extrabudgetary resources will be utilized to fund the services of consultants to complement work on the disarmament and non-proliferation component of the United Nations CyberSchoolBus website, and the *Disarmament Yearbook*.

- 4.50 The amount of \$4,987,300, would provide for 17 posts (1 D-1, 4 P-5, 1 P-4, 3 P-3, 1 P-2, 1 General Service (Principal level), 2 General Service (Other level)), 4 Local level and non-post resources for other staff costs, consultants and experts, travel and general operating expenses. The increase of \$289,400 relates to the delayed impact amounting to \$274,400 resulting from the establishment of four posts: two Political Affairs Officers at the P-3 level and two Administrative Assistants Local level, during the biennium 2010-2011, at the Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean and the Regional Centre for Peace and Disarmament in Asia and the Pacific. The increase in non-post requirements (\$15,000) relates to the additional provision for other staff costs and the inclusion of a provision for the core operational expenses of both regional centres.
- 4.51 The amount of \$6,003,600 from extrabudgetary resources will be utilized to fund the following: (a) conferences, seminars and meetings organized by the three regional centres for peace and disarmament; (b) various projects on capacity-building, peacebuilding, security reforms and technical support; (c) supporting the activities of the Standing Advisory Committee; (d) operating costs of the three regional centres; and (e) promoting existing disarmament and non-proliferation agreements. In its resolutions 63/77 and 63/74, the General Assembly called upon Member States, as well as international governmental and non-governmental organizations and foundations, to make voluntary contributions, which constitute the only resources of the regional centres, in order to strengthen the programme of activities of the centres and the implementation thereof. The General Assembly also called upon the Secretary-General to provide from the regular budget the necessary support to ensure the sustainability of the core activities and operations of the regional centres. The decrease under extrabudgetary resources reflects a combination of the reduction in provisions for consultants and their related travel costs, and the realignment of the operational requirements of the regional centres between extrabudgetary and regular budget resources, in line with the General Assembly resolutions cited above.

D. Programme support

Resource requirements (before recosting): \$1,292,300

- 4.52 The Executive Office provides services to the Office for Disarmament Affairs in connection with personnel, budgetary and financial administration, resource planning and use of common services, together with administrative support to policymaking organs and other meetings, as required.



- 4.53 The amount of \$1,292,300 would provide for the continuation of three posts (1 P-5, 1 General Service (Principal level) and 1 General Service (Other level)), as well as non-post operational requirements such as other staff costs, contractual services for data processing, infrastructure costs and general operating requirements.
- 4.54 The increase in non-post requirements of \$19,300 is due mainly to the contribution for the support of central data-processing services provided by the Office of Information and Communications Technology, partially offset by a marginal decrease in the requirements for supplies and material.
- 4.55 The amount of \$508,000 from extrabudgetary resources relates to general temporary assistance for support in the management of the various trust fund accounts in the Office.
