# **Report of the Internal Justice Council**

# I. Introduction

- 1. As part of the new framework for the system of administration of justice within the United Nations, the General Assembly, by its resolution 62/228, established the Internal Justice Council to help "ensure independence, professionalism and accountability" in the new system (see resolution 62/228, para. 35). A central feature of the new system of justice was the creation of two new tribunals, the United Nations Appeals Tribunal and the United Nations Dispute Tribunal. Pursuant to paragraph 37 (b) of that resolution 62/228, the Assembly requires that the Council, as one of its primary tasks, "provide its views and recommendations to the General Assembly on two or three candidates for each vacancy in the United Nations Dispute Tribunal and the United Nations Appeals Tribunal, with due regard to geographical distribution".
- 2. Currently the Appeals Tribunal has seven judges<sup>1</sup> and the Dispute Tribunal has five judges (three full-time and two half-time). There are also presently two ad litem judges of the Dispute Tribunal whose terms of office, which ended on 31 December 2011,<sup>2</sup> were extended by the General Assembly (see resolution 66/237, para. 42). When the first judges of both Tribunals were appointed, their terms of office were determined by the drawing of lots.<sup>3</sup> Accordingly, three-year terms of office were

determined for one full-time judge of the Dispute Tribunal (Memooda Ebrahim-Carstens (Botswana)), one half-time judge of the Dispute Tribunal (Goolam Hoosen Kader Meeran (United Kingdom of Great Britain and Northern Ireland)) and three judges of the Appeals Tribunal (Jean Courtial (France), Kamaljit Singh Garewal (India) and Mark P. Painter (United States of America)). As their terms of office commenced on 1 July 2009, their three-year terms of office are due to expire on 30 June 2012. Some of the judges were afforded shorter terms of office, through the mechanism of the drawing of lots, in order to protect institutional memory and provide continuity by ensuring that there would be staggered appointments to the Tribunals, so avoiding the problem attendant upon a new full set of judges being appointed for each Tribunal every seven years.

- 3. It is the understanding of the Internal Justice Council that, in the decision, contained in General Assembly resolution 66/237, to extend the mandate of the three ad litem Dispute Tribunal judges for one year, the Assembly intended for the incumbent ad litem judges to continue in office without the need for re-appointment. This understanding is based, in particular, on the language set out in paragraph 20 of the report of the Advisory Committee on Administrative and Budgetary Questions (A/66/7/Add.6), which is noted in paragraph 42 of the resolution 66/237. The Council notes that this approach achieves the twin objectives of ensuring continuity in the work of the Dispute Tribunal and providing capacity to that Tribunal to deal with the ongoing workload and pending cases.
- 4. Accordingly, the Council notes that the terms of office of two incumbent ad litem judges (Jean-François Cousin (France), who is based in Geneva and Nkemdilim Amelia Izuako (Nigeria), who is based in Nairobi) now run until 31 December 2012. However, there is no incumbent judge in New York and the present report provides recommendations on candidates for appointment to the ad litem post in New York. The Council also notes that Judge Cousin is a candidate for appointment as a permanent half-time judge of the Dispute Tribunal (see below). If Judge Cousin is appointed to the permanent position, a vacancy will arise in relation to the ad litem position in Geneva. If this happens, the Council will recommend candidates to the General Assembly to replace Judge Cousin as a matter of urgency.
- 5. The current members of the Council are Sinha Basnayake (Sri Lanka, distinguished external jurist nominated by management), Geoffrey Robertson QC (United Kingdom, distinguished external jurist nominated by staff), Frank Eppert (United States of America, management representative), Jenny Clift (Australia, staff representative) and Justice Kate O'Regan, former judge of the Constitutional Court of South Africa, who serves as chair.
- 6. During 2011, the Council noted that the three-year terms of office of five judges (as described in para. 2 above), would come to an end in June 2012, and accordingly transmits, in the present report, its recommendations for each vacancy. In its view, although the five judges concerned would be eligible to apply for re-appointment for a further non-renewable term of seven years, the expiry of their terms of office would result in vacancies on the Tribunals as contemplated by paragraph 37 (b) of General Assembly resolution 62/228 through the operation of Articles 4.4 and 3.4 of the Statutes of the UNDT and UNAT respectively.
- 7. As in the previous selection process (see A/63/489 and Add.1), the Council considered suitable candidates should be identified, who would ensure that the judicial process was independent and professional and delivered accountability. To

that end, the Council decided that a full public process, consistent with paragraph 45 of General Assembly resolution 65/251, should be instituted to identify suitable candidates. Advertisements for the vacancies were placed in mid-June 2011 both online and printed editions of The Economist (11 June), Le Monde (13 June), Jeune Afrique (12 June) and The Wall Street Journal (13 June in Europe and Asia, 20 June in the United States of America). A note verbale, dated 13 June 2011, was sent to all permanent missions. Vacancy notices were sent for local circulation to all United Nations information centres and United Nations resident coordinators and to all United Nations judicial institutions. In addition, the Chief Justices of all Member States were informed of the vacancies. Press releases were sent to a range of organizations, universities, legal journals, professional associations, other international courts and tribunals and to judges' associations. The closing date for applications was 15 July 2011. The Council expresses its gratitude to the Office of Human Resources Management for its assistance and support in this process.

- The Council is pleased to report that it received 411 applications from 78 different countries. There were a total of 112 candidates from North America, 34 from Latin America, 106 from Europe, 109 from Africa and 50 from Asia, including Australasia. Of those, 205 were male candidates and 206 female candidates. Very few candidates were unqualified, and given that to qualify under the applicable statutes, candidates for the Appeals Tribunal required 15 years' judicial experience and candidates for the Dispute Tribunal, 10 years, this was an impressive response from experienced sitting and retired judges in jurisdictions around the world. To reduce costs, the Council held several lengthy telephone conferences in early August to consider the applications and other material (including sample judgements), supplied by every applicant in support of their credentials, and to compile a shortlist for interview. To be shortlisted, candidates had to display on paper the qualifications to suggest they would be excellent judges for the Tribunals. Selections were also made bearing in mind the need for geographical distribution and gender balance. In weighing these considerations, the Council noted the current composition of the Tribunals, and the need for the judges to be of high moral character, as specified in the statutes of both Tribunals. Of the three judges of the Dispute Tribunal whose terms of office are not expiring, there are two male judges, one from Mauritius and one from Germany, and a female judge from New Zealand. There are four judges of the Appeals Tribunal whose terms are not expiring: a male judge from Uruguay and female judges from Argentina, Ghana and Ireland.
- 9. Shortlisted candidates were interviewed by the Council at the offices of the International Tribunal for the Former Yugoslavia in The Hague, the Netherlands, in early September 2011. Before the interviews were held, written references were obtained, from two referees, for each candidate. In The Hague, candidates were required to complete a written assessment to test their writing and reasoning abilities, which was followed by an interview lasting approximately 45 minutes. All shortlisted candidates attended. As it did for the previous round of judicial appointments, following the interviews and with permission (which no candidate refused to give), the Council, with the assistance of the International Bar Association, approached the relevant domestic bar associations for confirmation of the integrity of each candidate. No negative reports were received in relation to any of the candidates listed below.

- 10. As an independent body advising on judicial appointments, the Council believes that its members must not only act impartially, but be seen to do so. In consequence, the Council adopted a policy on recusal during this selection process. It agreed that the internationally accepted standard on recusal should apply. Accordingly, members should stand down from participating in the deliberations in respect of a particular candidate if there was a real risk that a sensible and well-informed observer might reasonably perceive that they were unable to act impartially in respect of a particular candidate. In application of this policy, and with the agreement of other members of the Council, the Chairperson recused herself from the consideration of a judicial colleague from South Africa, and Geoffrey Robertson recused himself from the consideration of a candidate with whom he had close social connections.
- 11. The Council provides below its views in respect of the candidates it recommends as suitable for appointment to the three vacancies on the Appeals Tribunal, as well as both the full-time vacancy and the half-time vacancy on the Dispute Tribunal. The Council also makes recommendations concerning the ad litem positions.
- 12. The Council has recommended six candidates for the three vacancies on the Appeals Tribunal, two candidates for each of the full-time and half-time vacancies on the Dispute Tribunal and three candidates for the ad litem position in New York. In the view of the Council, it would be equitable for the General Assembly to make the appointments to the permanent positions on the Dispute Tribunal before making the appointment to the ad litem position, as appointment to a permanent position is clearly more advantageous to the candidates concerned. All the candidates for the ad litem position are also candidates for permanent positions. If it becomes clear that it is necessary for the Council to furnish additional names to the General Assembly because all the candidates for the ad litem position are appointed to permanent positions, the Council will do so as expeditiously as possible.
- 13. In making its recommendations, the Council has chosen the most outstanding candidates after giving due consideration to gender balance and geographical distribution. It has also taken care not to recommend more than one candidate from any one Member State for the Dispute Tribunal and Appeals Tribunal respectively, as specified by the General Assembly in its resolution 63/253 (para. 57), nor to recommend candidates from States from which there is already a sitting member on the relevant Tribunal. In some cases, this has meant difficult choices have had to be made between outstanding candidates. It is the view of the Council that all the recommended candidates, were they to be appointed, would serve the management and the staff of the United Nations in a manner that will maintain the independence, professionalism and accountability of the new system. The Council has, as the result of its experience in operating this unique system for international recruitment and appointment of judges, a number of recommendations for its improvement and will bring them to the attention of the General Assembly in the next report.
- 14. The Council would like to thank the United Nations Secretariat for the outstanding support that it has provided to the Council. It would also like to thank all the staff of the International Tribunal for the Former Yugoslavia, who provided unstinting assistance to the Council during the examination and interview process held at their offices.

# II. Profiles of recommended candidates

15. Candidates are listed by Tribunal and vacancy, and then alphabetically by last name.

# **A.** United Nations Appeals Tribunal (three vacancies)

Rosalyn M. Chapman (United States), born in 1943

16. Judge Chapman has recently retired as a United States Magistrate Judge on the United States District Court for the Central District of California, a position which she held from 1995 to 2010. During this time, Judge Chapman adjudicated on a wide variety of matters including civil rights, appeals of decisions taken by administrative agencies and labour and employment issues. Prior to her tenure with the United States District Court, Judge Chapman served from 1977 until 1995 as an administrative law judge in the California Office of Administrative Hearings. This is a specialized administrative court that hears cases arising from decisions of approximately 60 state agencies. Judge Chapman also has experience in the area of labour arbitration gained during her services as a labour arbitrator and consultant from 1980 to 1995 and experience as a legal services attorney during the periods from 1967 to 1972 and from 1973 to 1977. Judge Chapman received her law degree from the Boalt Hall School of Law, University of California, Berkeley, in 1967. Her first language is English.

Moses Chinhengo (Zimbabwe), born in 1955

17. Judge Chinhengo has served as a Judge of the High Court of the Republic of Botswana since March 2004. Prior to his appointment to the bench in Botswana, Judge Chinhengo served as a judge of the High Court of Zimbabwe for 8 years, starting in March 1996. Both of these high courts have unlimited civil and criminal jurisdiction. Judge Chinhengo received a Bachelor of Law Degree (BL) from the University of Rhodesia in 1978, a diploma in legislative drafting from the University of Zimbabwe and a Bachelor of Laws degree (LLB) from the University of Zimbabwe in 1984. Judge Chinhengo is fluent in English.

Jean Courtial (France), born in 1951

18. Judge Courtial was appointed as a judge of the United Nations Appeals Tribunal in 2009. Judge Courtial also serves as a member of the Conseil d'Etat, the Supreme Court of the French administrative judicial system, a position he has held since 1996. He was appointed a Councillor of State in 2008. Prior to being appointed to the Council of State, Mr. Courtial served as a judge on various administrative tribunals. He holds a degree in public administration and administrative law from the National School of Administration (1982) and a diploma in philosophy from Toulouse University (1972). His first language is French and he has a working knowledge of English and Spanish.

Alessandra Greceanu (Romania), born in 1967

19. Judge Greceanu currently serves as a Judge at the Court of Appeal of Bucharest having been appointed in 2002. Judge Greceanu is currently on the Court's Civil Section (IV) and previously sat on the Court's Labour Section. She is

also currently serving as a trainer Judge at the National Institute of Magistracy in labour law and European Union law. Prior to appointment at the Court of Appeal, Judge Greceanu held appointments from 2000 until 2002 with the Tribunal of Bucharest (Civil and Administrative Suit) and from 1993 to 2000 as a first-instance Judge in Judecatoria sector 1, Bucharest. Judge Greceanu received her degree in law from the University of Bucharest in 1993 and received her Certificate from the National Institute for Training of Magistrates in 1994. Judge Greceanu is fluent in English, has a working knowledge of Russian and a basic knowledge of French.

#### Vagn Prusse Joensen (Denmark), born in 1950

20. Judge Joensen is currently serving as a Judge with the International Criminal Tribunal for Rwanda, having been appointed in 2007. Prior to taking up this appointment, Judge Joensen served from 2002 to 2007 as the Presiding Judge of the Danish High Court (Eastern Division), as an International Judge with the United Nations Interim Administration Mission in Kosovo from 2001-2002, as a Judge with the Danish High Court from 1994 to 2001, and as a Judge of the City Court of Copenhagen from 1982 to 1994. Judge Joensen received his degree in law from Aarhus University in 1973. He speaks fluent English and has a working knowledge of French.

#### Richard Lussick (Samoa), born in 1940

21. Judge Lussick is currently serving as a Judge with the Special Court for Sierra Leone, sitting as part of Trial Chamber II, which is hearing the case against Charles Taylor, former President of Liberia. During his service on the bench of the Special Court, Judge Lussick has acted as Staff Appeals Judge (2005-2006), hearing appeals by staff members against administrative decisions of the Registrar or against disciplinary actions taken against them. Prior to his current appointment with the Special Court, Judge Lussick served as Chief Justice of the Republic of Kiribati from 1995 to 2000 and as Judge and Chairman of the Public Service Board of Appeal, Samoa from 1987 through 1995. Judge Lussick received his Diploma in Law (Barristers Admission Board) from the University of Sydney (Law Extension Course) in 1973. Judge Lussick is fluent in English and has a good knowledge of French. Judge Lussick informed the Internal Justice Council that, although he has New Zealand citizenship conferred through the operation of law as a result of his father's New Zealand citizenship, he has never lived in New Zealand and considers himself to be Samoan. The Council has therefore listed him as Samoan.

#### 1. Full-time vacancy, New York:

Rosalyn M. Chapman (United States), born in 1943

Memooda Ebrahim-Carstens (Botswana), born in 1954

22. Judge Ebrahim-Carstens is currently a judge on the United Nations Dispute Tribunal in New York, to which she was appointed in 2009. Prior to her appointment to the Dispute Tribunal, Judge Ebrahim-Carstens was appointed to the High Court of Botswana in February 2009, a position that she vacated in June 2009 to join the Dispute Tribunal. She served as a judge of the Industrial Court of Botswana, a Superior Court of Law and Equity that specializes in labour law, from 1997 to 2009 (including as acting judge in 1997 and 1998 and thereafter as a permanent judge). Between her service on the bench of the Dispute Tribunal and the Industrial Court of Botswana, Judge Ebrahim-Carstens has considerable judicial experience in the field of labour law. From 1987 to 1998, she had her own legal practice in Botswana specializing in employment and labour law, human rights, commercial law and matrimonial law. She received her law degree from the City of London Polytechnic Business Law School in 1979. Her first language is English.

#### 2. Half-time vacancy, rotating between New York, Geneva and Nairobi as required:

Jean-François Cousin (France), born in 1944

23. Judge Cousin is currently an ad litem judge of the United Nations Dispute Tribunal in Geneva, to which he was appointed in 2009. Prior to his appointment to the Dispute Tribunal, Judge Cousin served as presiding judge in the Administrative Appeals Court of Marseille. He previously held office as a presiding judge in the Administrative Tribunal of Marseille (from 2004 to 2007 and from 1998 to 2002) as well as serving as a judge in various administrative tribunals. He also served as an adviser to the Supreme Administrative Court of Thailand (in 2002 and 2003); and as an administrative judge in Papeete, French Polynesia (in 1991 and 1992). He obtained a Master's degree in private law from the Faculty of Law of Paris in 1967. His first language is French and he has a good working knowledge of English.

Goolam Hoosen Kader Meeran (United Kingdom of Great Britain and Northern Ireland), born in 1943

24. Judge Meeran is currently a Judge of the United Nations Dispute Tribunal (half-time), to which he was appointed in 2009. Prior to his appointment to the Dispute Tribunal, Judge Meeran was Circuit Judge and President of the Employment Tribunals for England and Wales from 2002 until December 2008. Previously, he served as Regional Employment Judge of the Employment Tribunals for the London South Region, from 1997 to 2002 and was acting Regional Employment Judge from 1996 to 1997. He also served as a full-time Employment Judge for England and Wales from 1993 to 1996, and a part-time Employment Judge from 1992 to 1993. In all, he has more than 18 years of judicial experience in employment tribunals (including the Dispute Tribunal). He holds degrees from the University of

Manchester (1969) and the London School of Economics (1970) and a diploma in law (1981). His first language is English.
