

## Revitalization of the work of the General Assembly

#### Report of the Sixth Committee

#### I. Introduction

- 1. The item entitled "Revitalization of the work of the General Assembly" was included in the provisional agenda of the sixty-seventh session of the General Assembly pursuant to Assembly resolution 58/316 of 1 July 2004.
- 2. At its 2nd plenary meeting, on 21 September 2012, the General Assembly, on the recommendation of the General Committee, decided to allocate the item to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work for the sixty-eighth session of the General Assembly.
- 3. The Sixth Committee considered the item at its 25th meeting, on 16 November 2012 (see A/C.6/67/SR.25).

#### II. Consideration of draft decision A/C.6/67/L.18

- 4. At the 25th meeting, on 16 November, the Chair introduced a draft decision containing the provisional programme of work of the Committee for the sixty-eighth session of the General Assembly, as proposed by the Bureau (A/C.6/67/L.18).
- 5. Statements were made by the representatives of Chile (on behalf of the Community of Latin American and Caribbean States) and Cuba (see A/C.6/67/SR.25).
- 6. At the same meeting, the Committee adopted draft decision A/C.6/67/L.18 (see para. 7).
