### The Arms Trade Treaty

#### Report of the Secretary-General

1. Pursuant to paragraph 3 of General Assembly resolution [67/234 B](#), entitled “The Arms Trade Treaty”, the Secretary-General opened the Arms Trade Treaty for signature on 3 June 2013.
2. In paragraph 5 of the same resolution, the General Assembly requested the Secretary-General to report to the Assembly at its sixty-eighth session on the status of signature and ratification of the Treaty. The present report is issued pursuant to that request.
3. As at 5 August 2013, 81 States had signed the Treaty, with 2 of those having also deposited their instruments of ratification. In addition, in accordance with article 23 of the Treaty, two of the States declared that they would provisionally apply articles 6 and 7 of the Treaty, pending its entry into force. The list of 81 signatories and ratifying States is set out below.
