## **Expenses incurred and reimbursements received by the United Nations in connection with assistance provided to the International Criminal Court**

### **Report of the Secretary-General**

#### *Summary*

The present report is submitted pursuant to paragraph 11 of General Assembly resolution [67/295](#), in which the Assembly emphasized the need for the Secretary-General to inform it, at its sixty-eighth session, of the expenses incurred and reimbursements received by the United Nations in connection with assistance provided to the International Criminal Court.

1. During the period from 1 July 2012 to 30 June 2013, the United Nations provided facilities and services to the International Criminal Court in the amount of \$671,568. This amount covered, inter alia, costs incurred for staff who worked exclusively on matters pertaining to the Court, International Telecommunications Satellite Organization satellite communications and costs incurred in connection with recruitment, personnel training, conference and related services, field security and library services.
2. Additional expenses in the amount of \$442,665 were incurred by the Economic Commission for Latin America and the Caribbean, the United Nations Offices at Geneva and Nairobi, the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo and the International Tribunal for the Former Yugoslavia for services provided for the period from 1 July 2012 to 30 June 2013.
3. The Court has regularly reimbursed the United Nations in full upon receipt of invoices.
4. A narrative of itemized details of facilities and services provided to the Court for the period from 1 July 2012 to 30 June 2013 by the United Nations is provided in annex I and by the various offices away from Headquarters in annex II.
