## Overall orientation

- 4.1 General and complete disarmament under strict and effective international control remains the ultimate goal of all efforts exerted in the field of disarmament. The main responsibilities for disarmament lie with Member States. The United Nations, in accordance with its Charter, has a central role and primary responsibility in supporting Member States in this area.
- 4.2 The mandate for the programme derives from the priorities established in relevant General Assembly resolutions and decisions in the field of disarmament, including the Final Document of the Tenth Special Session of the General Assembly, the first special session devoted to disarmament (resolution S-10/2). The programme is also guided by the United Nations Millennium Declaration (resolution 55/2) and takes into account other relevant resolutions of the United Nations. Weapons of mass destruction, in particular nuclear weapons, continue to be of primary

concern to the Organization owing to their destructive power and the threat that they pose to humanity. Conventional weapons, especially with regard to major weapons systems, small arms and light weapons, landmines and cluster munitions, have received increased attention from the international community in view of the havoc that such weapons are inflicting on peoples' daily lives, in particular in conflict-ridden regions.

- 4.3 Within the Secretariat, substantive responsibility for the programme is vested in the Office for Disarmament Affairs. The Office's strategy in meeting the programme's objectives is designed around five subprogrammes and is based on its role in and responsibility for facilitating and encouraging, as appropriate, measures aimed at disarmament and non-proliferation in all its aspects and at all levels. The Office will continue to assist Member States in promoting, strengthening and consolidating multilaterally negotiated principles and norms in all areas of disarmament and non-proliferation in all its aspects. It will support efforts of Member States in the areas of disarmament and non-proliferation in all its aspects in order to help promote international peace and security and contribute to global efforts against terrorism. In order to do so effectively, the Office will enhance its capacity for more in-depth analysis, keeping track of developments in those areas, and will provide Member States with timely and practical advice, as requested. It will continue to assist Member States in their efforts towards international regulation of the arms trade and prevention of the illicit manufacture of and trafficking in small arms and light weapons in all its aspects. Moreover, the Office will facilitate and promote efforts for further implementation of the Programme of Action adopted at the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects, as well as practical disarmament measures.
- 4.4 The Office will assist Member States in increasing understanding of the relationship between disarmament and development. The Office will promote transparency, based on the principle of undiminished and increased security for all, and confidence-building measures in the field of disarmament. Through its regional centres for peace and disarmament, the Office will assist Member States in promoting regional approaches to disarmament, non-proliferation in all its aspects and regional and international peace and security. It will also continue to contribute to efforts to enhance disarmament expertise in Member States, as relevant, in particular in developing countries.
- 4.5 The Office will seek to achieve the objectives of the programme by facilitating the process of multilateral deliberation and negotiation. This will include providing substantive organizational support to the First Committee, the Disarmament Commission and other subsidiary bodies of the General Assembly, the Conference on Disarmament and its subsidiary bodies, review conferences and other meetings of parties to multilateral disarmament agreements, as well as to expert groups mandated by the General Assembly. This will also include monitoring and assessing current and future trends in the field of disarmament, non-proliferation in all its aspects and international security.
- 4.6 The Office will continue to be a source of impartial and factual information on disarmament and security-related matters for Member States, organizations of the United Nations system, intergovernmental and regional organizations and non-governmental organizations (NGOs), and it will expand its educational outreach programmes. Training and advisory services will continue to be provided, through the United Nations disarmament fellowship, training and advisory services programme and the United Nations Institute for Disarmament Research (UNIDIR), to Member States, in particular developing countries, to enable them to enhance their expertise in disarmament, so that they may participate more effectively in international deliberating and negotiating forums.
- 4.7 Gender mainstreaming will continue to be an integral part of the activities of the programme through the continued implementation of a plan of action aimed at raising awareness and increasing commitment to and capacity for gender mainstreaming in disarmament affairs.

- 4.8 The Office carries out its activities in cooperation with other departments and offices of the Secretariat, entities of the United Nations system and entities external to the United Nations, including treaty organizations, intergovernmental, interregional, regional and national organizations, non-governmental organizations and academic communities. Such cooperation includes the preparation of reports, participation in meetings, briefings, technical and substantive support and sharing of information and experience.
- 4.9 The establishment of a Strategic Planning Unit in the Office of the High Representative is proposed within existing post resources. The Strategic Planning Unit would advise on the overall strategic issues, policy planning, fund-raising strategies, as well as normative and analytical research activities in support of the Secretary-General's priority agenda related to disarmament issues. The Unit is also responsible for the preparation of political analyses and substantive background notes on a broad range of initiatives and topics with a particular emphasis on priority, as well as emerging issues, particularly those salient cross-cutting issues. The Unit would serve as a coordination and liaison node on programmatic issues with other Secretariat offices (such as the Policy Committee). In addition, the Unit would coordinate the preparation of substantive assessments and input to reports to intergovernmental and oversight bodies.
- 4.10 The proposed Strategic Planning Unit would be comprised of four posts (1 P-5, 1 P-4, 1 P-3 and 1 P-2/1), where three of the posts (1 P-4, 1 P-3 and 1 P-2/1) are to be redeployed from the other subprogrammes and whose core duties and responsibilities are similar to the functions expected to be performed in the proposed Unit. Hence, this would not negatively impact on the effective and timely delivery of the subprogrammes' outputs from which they would be redeployed.
- 4.11 Against this background, it is proposed that the Director and Deputy to the High Representative directly oversee the activities undertaken by subprogramme 5 (Regional disarmament). Based on this proposal, the mandates carried out under subprogramme 5 shall be maintained. Under the direct guidance of the Director and Deputy to the High Representative, the subprogramme would benefit from closer consultative coordination with donors, while ensuring that regional activities clearly feed into the achievement of the programme's expected accomplishments and ensure effective action on the resolutions and decisions of the General Assembly. Additionally, efficient project formulation, taking into account the proper integration and streamlining of relevant cross-cutting issues, development and implementation of a comprehensive fundraising strategy and resource mobilization efforts to broaden the funding base, and effective programme delivery at the regional level, would be achieved.
- 4.12 In the light of the ongoing efforts of the General Assembly and its Main Committees, including the First Committee, to improve their methods of work, and in order to better respond to the need to identify best practices and working methods to implement the mandates entrusted to the Office for Disarmament Affairs, it is proposed that the objective of subprogramme 2 (Weapons of mass destruction) be pursued through an enhanced division of labour within the Weapons of Mass Destruction Branch. This could be achieved by improved focus in two areas: (a) nuclear weapons; and (b) global security and other weapons of mass destruction. This arrangement would bring increased efficiency in addressing each category of weapons of mass destruction, while preserving the priority attached to nuclear weapons-related issues. In addition, such an enhanced division of labour within the Weapons of Mass Destruction Branch will better reflect the organization of the work of the First Committee, which facilitates the order of items allocated to its agenda in seven clusters or broad topic areas, as follows: (a) Nuclear weapons; (b) Other weapons of mass destruction; (c) Outer space (disarmament aspects); (d) Conventional weapons; (e) Regional disarmament and security; (f) Other disarmament measures and international security; and (g) Disarmament machinery.

- 4.13 As part of the restructuring of the Office to enhance efficiency, maximize the utilization of available resources, and ensure a balanced workload among the subprogrammes of the Office for Disarmament Affairs, it was deemed appropriate to move activities associated with expected accomplishment (c) and the related indicators of achievement (c) (i), (ii) and (iii) from subprogramme 1 (Multilateral negotiations on arms limitation and disarmament) to subprogramme 5 (Regional disarmament). This approach builds on the efficient utilization of existing capacity and the added comparative advantage offered by the two locations to the effective implementation of these activities. This includes, first, the transfer of the United Nations Disarmament Fellowship Programme to New York under subprogramme 5 (Regional disarmament). It should be noted that originally, the Programme, upon its inception in 1978, was coordinated from New York and the fellows would spend the longest segment of the programme in New York. Secondly, the Secretary-General's Advisory Board on Disarmament Matters would be supported by subprogramme 1 (Multilateral negotiations on arms limitation and disarmament) to allow for closer interaction between its members and the disarmament community based in Geneva. This also affords the Board closer oversight of the activities of UNIDIR, for which the Advisory Board acts as its board of trustees. The biennial programme plan relating to subprogrammes 1 and 5 has been revised to reflect these changes.
- 4.14 It is proposed that the title of the branch which has substantive responsibility for the implementation of subprogramme 1 (Multilateral negotiations on arms limitation and disarmament) be changed from the "Conference on Disarmament Secretariat and Conference Support Branch" to the "Geneva Branch", for simplification and brevity purposes, as it is actually a formalization of its commonly known name.

### **Overview of resources**

- 4.15 The overall resources proposed for the biennium 2014-2015 for this section amount to \$23,603,000 before recosting, reflecting a net decrease of \$442,000 (1.8 per cent) compared with the 2012-2013 budget at revised rates. Resource changes result from four factors, namely (a) technical adjustments relating to the removal of non-recurrent requirements; (b) new or expanded mandates and inter-component changes; (c) resource changes in line with General Assembly resolution 67/248; and (d) resource changes reflected in the report of the Secretary-General on the budget outline for 2014-2015 (A/67/529 and Corr.1).
- 4.16 The distribution of resources is reflected in tables 4.3 to 4.5 below.

**Technical adjustments**

- 4.17 Resource changes reflect the removal of non-recurrent requirements totalling \$134,200 relating to the travel of a consultant to provide technical and substantive support to the Office for Disarmament Affairs in connection with the preparations and substantive servicing of the Final United Nations Conference on the Arms Trade Treaty, as well as the travel of the President-designate of the Conference in order to undertake consultations and attend relevant meetings as part of the preparations for the Conference, in accordance with General Assembly resolution 67/234.

**New mandates and inter-component changes**

- 4.18 Pursuant to General Assembly resolution 67/53, a net increase of \$421,400 would be required for the travel of experts and a consultant to a meeting in Geneva in support of the treaty banning the production of fissile material for nuclear weapons or other nuclear explosive devices, in 2014 and 2015.

**Changes in line with General Assembly resolution 67/248**

- 4.19 Resource changes of \$663,900 are proposed in line with General Assembly resolution 67/248. The primary areas of resource changes in the amount of \$599,700 and the related impact are outlined in table 4.6 below.

4.20 Resource changes in line with the Secretary-General’s budget outline amount to \$65,300. The primary areas of resource changes in the amount of \$62,500 are outlined in table 4.7 below.

Communications	Regarding communication costs, the number of staff having access to mobile phones has been reduced from 11 to 7. Every effort is being made to obtain the most cost-effective plan for roaming costs, which account for the bulk of the communication costs in this regard. Other measures that have been put in place in order to reduce communication costs include the increased use of Skype for communicating with the regional centres of the Office for Disarmament Affairs as opposed to the more costly use of the telephone, and the working out of arrangements with larger funded departments that manage field offices and which operate on a global level, that allows the Office the use of their videoconferencing facilities at a minimal or no cost.

**Other assessed and extrabudgetary resources**

4.21 Under extrabudgetary resources, a revised amount of \$26,565,900 is estimated for 2012-2013, including \$6,622,600 for UNIDIR, owing to increased contributions under the trust funds for the United Nations Regional Centre for Peace and Disarmament in Africa, the United Nations Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean, the Disarmament Information Programme and UNIDIR.

4.22 A total amount of \$23,184,500 is projected for the biennium 2014-2015, including \$4,290,400 for UNIDIR. The projected reduction is attributable to the uncertainty of contributions from some

donors who made contributions in the biennium 2012-2013 and who have not indicated their commitment to additional contributions in the biennium 2014-2015.

### Other information

- 4.23 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$74,100, representing a total of 5.1 work-months of Professional staff and 1.0 work-month of General Service (Other level) staff for the biennium 2014-2015, funded from regular budget resources.
- 4.24 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 4.8 below and as distributed in the output information for each subprogramme.

## A. Policymaking organs

### *Resource requirements (before recosting) \$38,900*

- 4.25 The Conference on Disarmament was set up in accordance with paragraph 120 of the Final Document of the Tenth Special Session of the General Assembly (S-10/2) as the single multilateral disarmament negotiating forum of the international community. Following the expansions of its membership in 1996 and 1999, the Conference is open to the five nuclear-weapon States and 60 other States, including key militarily significant States. In addition, every year, some 40 non-member States are invited, upon their request, to participate in its work. The Conference on Disarmament conducts its work by consensus, adopts its own rules of procedure, rotates its presidency among all its members every four weeks, adopts its own agenda taking into account the recommendations made to it by the General Assembly and the proposals presented by the members of the Conference, and submits a report to the General Assembly annually, or more frequently, as appropriate. The Conference divides its 24-week annual session into three parts and, if necessary, continues its negotiations on priority issues between sessions. Meetings thus may take place during six to nine months each year.
- 4.26 Pursuant to paragraph 120 (c) of the Final Document of the Tenth Special Session of the General Assembly, the Secretary-General, following consultations with the Conference on Disarmament, appoints the Secretary-General of the Conference, who also acts as his Personal Representative, to assist the Conference and its Presidents in organizing the Conference. As requested by the Assembly in its resolution 34/83L, the Secretary-General provides staff, as well as the assistance and services needed by the Conference and any subsidiary bodies that it might establish, in accordance with the arrangements contained in its rules of procedure. The secretariat of the

Conference consists of officers of the Conference on Disarmament secretariat and Conference Support Branch (Geneva) of the Office for Disarmament Affairs.

- 4.27 The Conference on Disarmament successfully concluded the negotiation of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction (1992) and the Comprehensive Nuclear-Test-Ban Treaty (1996), with the participation of all five nuclear-weapon States and other militarily significant States.
- 4.28 The distribution of resources for policymaking organs is reflected in table 4.9 below.

- 4.29 The amount of \$38,900 relates to the travel and subsistence allowance of the Secretary-General of the Conference on Disarmament and Personal Representative of the Secretary-General of the United Nations and Deputy Secretary-General of the Conference on Disarmament to attend the sixty-ninth and seventieth sessions of the General Assembly, as well as consultative meetings in New York and other conferences and meetings relating to international security and disarmament.

## B. Executive direction and management

### *Resource requirements (before recosting): \$4,125,700*

- 4.30 The Office of the High Representative for Disarmament Affairs comprises the immediate Office of the High Representative, the Office of the Director and Deputy to the High Representative and the Strategic Planning Unit. The High Representative for Disarmament Affairs, in the performance of her activities, is assisted by a Director, who serves as Deputy to the High Representative and who is accountable to the High Representative.
- 4.31 The High Representative undertakes appropriate advocacy work to advance the disarmament agenda and is responsible for all the overall direction, supervision and management of the activities of the Office for Disarmament Affairs. The High Representative provides the Secretary-General with advice and support on all arms control, disarmament, non-proliferation and related security matters and, in that respect, represents the Secretary-General as required. The High Representative is also responsible for providing authoritative analysis and assessment of developments for policy guidance and decision-making purposes and acts as focal point on these matters between the Secretariat and Member States.
- 4.32 The Office of the Director is responsible for providing support to the High Representative on the executive direction and management of the Office; preparing and monitoring the implementation of the programme of work of the Office for Disarmament Affairs and ensuring efficient coordination, synergy between the branches and the effective delivery of the programmatic mandates of the Office; preparing reports and notes on political and managerial issues; providing advice to the High Representative on all substantive, organizational, administrative, personnel and budgetary matters, including the overall coordination in the preparation and revision of the

Office’s inputs to the biennial programme plan and the programme budget. The Office of the Director also ensures the implementation of regional disarmament activities through the three regional centres and oversees the activities of the Executive Office.

- 4.33 The Strategic Planning Unit would advise on overall strategic issues, policy planning, fundraising strategies as well as normative and analytical research activities in support of the Secretary-General’s priority agenda related to disarmament issues. The Unit is also responsible for the preparation of political analyses and substantive background notes on a broad range of initiatives and topics, with a particular emphasis on priority as well as emerging issues, particularly those salient cross-cutting issues. The Unit serves as a coordination and liaison node on programmatic issues with other Secretariat offices (such as the Policy Committee). The Unit shall coordinate the preparation of substantive assessments and input to reports to intergovernmental and oversight bodies.

### External factors

- 4.34 The programme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the political environment is supportive of disarmament efforts; (b) political developments relating to international peace and security are conducive to the facilitation of negotiations on new arms limitation and disarmament agreements; (c) Member States are willing to implement the recommendations, resolutions and decisions of relevant meetings and conferences; (d) international organizations provide cooperation; (e) the required financial and human resources are made available; and (f) national institutions are supportive of gender balance and mainstreaming issues.

  - (b) Parliamentary documentation: report of the Secretary-General on women, disarmament, non-proliferation and arms control (1).

- 4.37 The amount of \$4,125,700, reflecting an increase of \$1,118,800, would provide for 12 posts (1 Under-Secretary-General, 1 D-2, 3 P-5, 1 P-4, 1 P-3, 1 P-2 and 4 General Service (Other level)), as well as related non-post operational requirements within the Office of the High Representative and the Office of the Director. The increase in post and non-post resources is attributable mainly to the inward redeployment of four posts: 1 P-4, 1 P-2 and 1 GS (Other level) from subprogramme 3 (Conventional arms) and 1 P-3 post from subprogramme 2 (Weapons of mass destruction).

**Extrabudgetary resources**

- 4.38 The extrabudgetary resources of \$1,213,000 would provide for two posts (1 (P-5) and 1 GS (Other level)) and non-post resources in the Vienna office of the Office for Disarmament Affairs. The Chief of the Vienna office (P-5) promotes the objectives of the Office for Disarmament Affairs and facilitates closer cooperation with the United Nations at Vienna and with organizations and related agencies based in Vienna. The General Service (Other level) post provides administrative support to the Office for Disarmament Affairs in Vienna.

4.44 The amount of \$4,066,800, reflecting a reduction of \$900,600, would provide for the continuation of seven posts (1 D-2, 1 P-5, 2 P-4 and 3 General Service (Other level), as well as non-post operational requirements, such as overtime, travel of staff, supplies and a subvention of \$577,800 to UNIDIR. The reduction in post resources of \$399,400 is attributable mainly to the proposed abolishment of one P-4 post in line with General Assembly resolution 67/248, as reflected in table 4.6 above. The reduction in non-post resources of \$501,200 reflects the outward redeployment of resources amounting to \$1,348,500 to subprogramme 5 for the fellowship programme, which is offset by the

increase under experts (\$804,900) for the convening of the Group of Governmental Experts to make recommendations on possible aspects that could contribute to a treaty banning the production of fissile material for nuclear weapons or other nuclear explosive devices pursuant to General Assembly resolution 67/53 and the convening of the Secretary-General's Advisory Board on Disarmament Matters, in accordance with General Assembly resolution 37/99 K and decision 54/418, as well as increased requirements under general temporary assistance (\$22,400) and travel of staff (\$20,000).

### Extrabudgetary resources

- 4.45 The estimated amount of \$7,588,900 from extrabudgetary resources will be utilized to support the Biological Weapons Convention Meeting of Experts in 2014 and facilitate their national implementation of obligations under the Convention, as well as decisions and recommendations adopted by the Seventh Review Conference of the States Parties to the Biological Weapons Convention in December 2012, including the 2012-2015 intersessional work programme. In addition, the extrabudgetary resources will enable participation by developing countries in the 2014 Meeting of Experts and provide assistance to support activities for the States parties to the Convention and States not parties to ratify/accede and to implement the treaty. Moreover, resources will be used for the purchase of specialized books and publications for the Disarmament Research and Reference Collection in order to provide up-to-date information for use by Member States in their negotiations on multilateral arms limitation and disarmament agreements, as well as by the substantive secretariat, research institutions and the general public.

### Subprogramme 2 Weapons of mass destruction

*Resource requirements (before recosting): \$3,088,300*

- 4.46 Substantive responsibility for this subprogramme is vested within the Weapons of Mass Destruction Branch. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 2 of programme 3 of the biennial programme plan for the period 2014-2015.

- 4.50 The amount of \$3,088,300, reflecting an increase of \$265,200, would provide for the continuation of the nine posts (2 D-1, 1 P-5, 1 P-4, 1 P-3 and 2 P-2/1) and two General Service (Other level) posts and non-post resources for operational requirements under other staff costs, experts and travel of staff. The net increase in post resources is mainly due to the inward redeployment of two posts (1 D-1 and 1 P-2) from subprogramme 5 (Regional disarmament).

**Extrabudgetary resources**

4.56 The amount of \$2,673,600, reflecting a reduction of \$943,000, would provide for seven posts (1 D-1, 2 P-5, 1 P-4, 1 P-3 and 2 General Service (Other level)), as well as non-post operational resources for overtime, travel of staff and experts. 4.62 The amount of \$3,125,200, reflecting an increase of \$160,800, would provide for the continuation of nine posts (1 P-5, 2 P-4, 1 P-3, 1 P-2, 2 General Service (Principal level), 2 General Service (Other level)) and non-post resources for operational requirements under other staff costs, consultants, experts and travel of staff. The increase in post resources is due mainly to the inward redeployment of one General Service (Other level) post from subprogramme 5 (Regional

disarmament). The net increase in non-post resources reflect: (a) an increase in consultancy requirements to prepare materials requiring extensive research and technical knowledge in preparation of the *Disarmament Yearbook*, offset by (b) a decrease under experts. **External factors**

4.65 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the political environment is supportive of disarmament efforts; (b) there are no major shortfalls in resources; (c) Member States are willing to implement United Nations recommendations; and (d) regional organizations provide cooperation.

**Outputs**

4.66 During the biennium 2014-2015, the following outputs will be delivered:

(a) Servicing of intergovernmental and expert bodies (regular budget):

- (i) General Assembly — First Committee (Disarmament and International Security):
  - a. Substantive servicing of meetings: First Committee (2); Implementation of the Declaration of the Indian Ocean as a Zone of Peace: Ad Hoc Committee on the Indian Ocean (2);
  - b. Parliamentary documentation: reports of the Secretary-General on: the United Nations Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean (2); the United Nations Regional Centre for Peace and Disarmament in Africa (2); the United Nations Regional Centre for Peace, Disarmament and Development in Asia and the Pacific (2); strengthening of security and cooperation in the Mediterranean region (2); confidence-building measures in the regional and subregional context (2); and United Nations disarmament fellowship, training and advisory services (1);
- (ii) Standing Advisory Committee on Security Questions in Central Africa: substantive servicing of the disarmament, arms control and non-proliferation component of the Committee (4);
- (b) Other substantive activities (regular budget and extrabudgetary):
  - (i) Recurrent publications: web-based e-newsletters of the regional centres (24);
  - (ii) Non-recurrent publications: ad hoc conference reports published by the regional centres (12); manual, syllabus and training materials, as well as information publications and brochures published by the regional centres (8);
  - (iii) Technical material: maintenance of the library and/or website and databases of the regional centres (3);
  - (iv) Promotion of international and regional instruments: consultations and/or meetings with regional and subregional organizations in Latin America and the Caribbean (4); annual conferences on disarmament and non-proliferation in the Asia and the Pacific region (4); regional meetings to prepare for the United Nations Conference to review progress made in the implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects, 2012 (1); provision of assistance to Member States and regional arrangements on legislation related to small arms and light weapons (4); consultations and/or meetings with regional and subregional organizations in Africa (4); training for armed and security forces on security sector reform (4);
  - (v) Seminars organized by the Secretariat for outside users under specific mandate: subregional follow-up activities to regional outreach seminars on the implementation of Security Council resolution 1540 (2004) (1); seminars on disarmament and non-proliferation education (2); workshops, seminars and training on disarmament issues for judges and prosecutors (2); workshop or seminar on the role of women in disarmament, peace and security in support of the implementation of Security Council resolution 1325 (2000) on women and peace and security, and General Assembly resolutions 65/69 and 67/48 (1);
- (c) Technical cooperation (regular and extrabudgetary budget):
  - (i) Group training (seminars, workshops, symposiums): inter-institutional training courses on combating illicit firearms trafficking in the Latin America and Caribbean region (4); inter-institutional training courses on combating illicit firearms trafficking in the Asia and the Pacific region (4); inter-institutional training courses on combating illicit firearms trafficking in Africa (2);

- (ii) Field projects: stockpile management and weapons destruction projects (3); weapons destruction project (1);
- (iii) Fellowships and grants: implementation of the United Nations disarmament fellowship, training and advisory services programme: maintenance and updating of training material; training sessions for up to 25 fellows per year (Conference on Disarmament in Geneva and First Committee in New York) and study visits (to the International Atomic Energy Agency, the Organization for the Prohibition of Chemical Weapons, the Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization and Member States, at their invitation) (2);
- (iv) Advisory services at the request of Governments: review of national legislations and national plans (2); provision of assistance to Member States and regional arrangements on legislation related to small arms and light weapons (4).

- 4.68 The amount of \$5,013,300, reflecting a decrease of \$273,000, would provide for the continuation of 12 posts (4 P-5, 1 P-4, 3 P-3, 1 General Service (Other level) and 3 Local level), as well as non-post resources for operational requirements under other staff costs, core operation costs of the Regional Activities Unit in New York, the Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean, the Regional Centre for Peace and Disarmament in Asia and the Pacific and the Regional Centre for Peace and Disarmament in Africa and contributions for the United Nations Disarmament Fellowship Programme. The reduction in posts reflects the abolishment of one Local level post of Information Technology Assistant, in line with General Assembly resolution 67/248, as reflected in table 4.6 above, as well as the outward redeployment of 1 D-1 post and 1 P-2 post to subprogramme 2 (Weapons of mass destruction) and 1 General Service (Principal level) post to programme support.

#### Extrabudgetary resources

- 4.69 The estimated amount of \$8,356,600 from extrabudgetary resources will continue to fund the operation and activities of the three regional centres for peace and disarmament, including (a) the organization of seminars, training courses, weapons and ammunition destruction events, stockpile management activities, technical and legal advisory missions and studies; and (b) promoting existing disarmament and non-proliferation agreements.
- 4.70 These extrabudgetary resources directly impact the programme mandate to promote and enhance international efforts towards global disarmament and international peace and security through the

support and promotion of regional disarmament efforts and initiatives using approaches freely arrived at among the States of the regions and taking into account the legitimate requirements of States for self-defence and the specific characteristics of each region.

- 4.71 In 2012, no expenditures were incurred from the resources of the Trust Fund for Public Awareness on Disarmament Issues. In 2013, these resources are expected to be used to pilot a project on peace and disarmament education for schoolchildren in Nepal. The objective of the project is to increase awareness on peace and disarmament issues among schoolchildren and develop their peacemaking skills, such as resolving conflict without violence, and raise understanding of international peace and disarmament issues. It is anticipated that these extrabudgetary resources will continue to be used for peace and disarmament activities for the biennium 2014-2015. These resources contribute to the programme of work by making possible activities that provide opportunities for regional cooperation, coordination and collaboration in matters related to disarmament, non-proliferation and regional peace and security in the regions.

## D. Programme support

**Resource requirements (before recosting): \$1,471,200**

- 4.72 The Executive Office provides support services to the Office for Disarmament Affairs in connection with personnel, budgetary and financial administration, resource planning and use of common services, together with administrative support to policymaking organs and other meetings, as required.
- 4.73 The distribution of resources for programme support is reflected in table 4.23 below.


- 4.74 The amount of \$1,471,000 would provide for the continuation of four posts (1 P-5, 2 General Service (Principal level) and 1 General Service (Other level)) redeployed from the Regional Disarmament Branch (subprogramme 5), as well as non-post operational requirements, such as other staff costs, contractual services for data processing, infrastructure costs and general operating requirements. The increase in post resources is due to the inward redeployment of one General Service (Principal level) from subprogramme 5 (Regional disarmament). The decrease in non-post resources reflects the reductions under general operating expenses, as reflected in table 4.7 above.

### Extrabudgetary resources

- 4.75 The estimated amount of \$560,000 from extrabudgetary resources relates to general temporary assistance for support in the management of the various trust funds in the Office.
