### The Arms Trade Treaty

#### Report of the Secretary-General

1. In paragraph 5 of its resolution 68/31, entitled “The Arms Trade Treaty”, the General Assembly requested the Secretary-General to report to the Assembly at its sixty-ninth session on the status of signature and ratification of the Treaty. The present report is issued pursuant to that request.

2. As at 22 July 2014, 118 States had signed the Treaty, with 41 of those having also deposited their instruments of ratification. Also, in accordance with article 23 of the Treaty, 19 of the signatory States declared that they would provisionally apply articles 6 and 7 of the Treaty, pending its entry into force. The list of the 118 signatories and ratifying States is set out below.
