Expenses incurred and reimbursements received by the United Nations in connection with assistance provided to the International Criminal Court

Report of the Secretary-General

Summary

The present report is submitted pursuant to paragraph 19 of General Assembly resolution 68/305, by which the Assembly emphasized the need for the Secretary-General to continue to inform it, at its sixty-ninth session, of the expenses incurred and reimbursements received by the United Nations in connection with assistance provided to the International Criminal Court.

1. During the period from 1 July 2013 to 30 June 2014, the United Nations provided facilities and services to the International Criminal Court in the amount of \$818,581. This amount covered, inter alia, costs incurred for staff who worked exclusively on matters pertaining to the Court and the International Telecommunications Satellite Organization satellite communications and costs incurred in connection with recruitment, personnel training, conference and related services, field security and library services.
2. Additional expenses in the amount of \$459,457 were incurred by the International Tribunal for the Former Yugoslavia, the United Nations Stabilization Mission in the Democratic Republic of the Congo, the United Nations Office at Nairobi and the United Nations Office at Geneva for services provided for the period from 1 July 2013 to 30 June 2014.
3. The Court has regularly reimbursed the United Nations upon receipt of invoices.
4. Itemized lists of facilities and services provided to the Court for the period from 1 July 2013 to 30 June 2014 by the United Nations and by offices away from Headquarters are provided in annexes I and II, respectively.
