Expenses incurred and reimbursement received by the United Nations in connection with assistance provided to the International Criminal Court

Report of the Secretary-General

Summary

The present report is submitted pursuant to paragraph 19 of General Assembly resolution 69/279, in which the Assembly emphasized the need for the Secretary-General to inform the General Assembly at its seventieth session on the expenses incurred and reimbursements received by the United Nations in connection with assistance provided to the International Criminal Court.

1. During the period from 1 July 2014 to 30 June 2015, the United Nations provided facilities and services to the International Criminal Court in the amount of \$742,606. Facilities and services included costs for staff who worked exclusively on matters pertaining to the Court, International Telecommunications Satellite Organization satellite communications, costs incurred in connection with personnel training, conference and related services, field security, library services and others.
2. Additional expenses in the amount of \$201,508 were incurred by the International Tribunal for the Former Yugoslavia, the United Nations Assistance Mission in Afghanistan, the United Nations Office at Nairobi and the United Nations Office at Geneva for services provided for the period from 1 July 2014 to 30 June 2015.
3. The Court has regularly reimbursed the United Nations upon receipt of invoices.
4. A narrative of itemized details of facilities and services provided to the Court by the United Nations for the period from 1 July 2014 to 30 June 2015 is provided in annex I, and by the various offices away from Headquarters for the same period in annex II.
