Sustainable development

Report of the Second Committee**

I. Introduction

1. The Second Committee held a substantive debate on agenda item 20 (see [A/70/472](#), para. 2). Action on the item was taken at the 29th, 31st, 32nd, 34th, 35th and 36th meetings, on 5, 12 and 19 November and 4, 10 and 14 December 2015. An account of the Committee's consideration of the item is contained in the relevant summary records.¹

II. Consideration of draft resolution [A/C.2/70/L.3/Rev.1](#)

2. At the 34th meeting, on 4 December, the representative of Fiji, on behalf of Sweden and Australia, Bangladesh, Belarus, Belgium, Cabo Verde, Cameroon, the Comoros, Cuba, Dominica, Estonia, Fiji, Georgia, Grenada, Indonesia, Israel, Italy, Japan, Kazakhstan, Kiribati, Maldives, Malta, the Marshall Islands, Micronesia (Federated States of), Monaco, Morocco, Nauru, the Netherlands, New Zealand, Palau, Panama, Papua New Guinea, Peru, the Philippines, Poland, Portugal, Samoa, Senegal, Seychelles, Solomon Islands, Spain, Sweden, Thailand, Timor-Leste, Tonga, Tuvalu and Vanuatu, introduced a draft resolution entitled "United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and Sustainably Use the Oceans, Seas and Marine Resources for Sustainable Development" ([A/C.2/70/L.3/Rev.1](#)) and announced that Albania, Angola, Austria, the Bahamas, Bosnia and Herzegovina, Chile, Croatia, Cyprus, the

Czech Republic, Denmark, Finland, France, Germany, Greece, Guinea-Bissau, Hungary, Iceland, Ireland, Latvia, Lebanon, Liberia, Lithuania, Luxembourg, Mali, Mauritania, Mauritius, Montenegro, Mozambique, Qatar, Romania, Saint Kitts and Nevis, San Marino, Serbia, Singapore, Slovenia, Suriname, Tajikistan, Tunisia, Ukraine and the United Kingdom of Great Britain and Northern Ireland had joined in sponsoring the draft resolution. Subsequently, Algeria, Chad, Equatorial Guinea, Guinea, Kenya, the Niger, Senegal, Switzerland, the former Yugoslav Republic of Macedonia, Togo and the United Republic of Tanzania also joined in sponsoring the draft resolution.

3. At the same meeting, the Committee was informed that draft resolution [A/C.2/70/L.3/Rev.1](#) had no programme budget implications.

4. Also at the same meeting, the Committee adopted draft resolution [A/C.2/70/L.3/Rev.1](#) (see para. 6).

5. Also at the 34th meeting, a statement was made by the representative of the Bolivarian Republic of Venezuela.

III. Recommendation of the Second Committee

6. The Second Committee recommends to the General Assembly the adoption of the following draft resolution:

United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and Sustainably Use the Oceans, Seas and Marine Resources for Sustainable Development

The General Assembly,

Recalling the outcome document of the United Nations Conference on Sustainable Development, held in Rio de Janeiro, Brazil, from 20 to 22 June 2012, entitled “The future we want”,¹

Reaffirming its resolution 70/1 of 25 September 2015, entitled “Transforming our world: the 2030 Agenda for Sustainable Development”, in which it adopted a comprehensive, far-reaching and people-centred set of universal and transformative Sustainable Development Goals and targets, its commitment to working tirelessly for the full implementation of this Agenda by 2030, its recognition that eradicating poverty in all its forms and dimensions, including extreme poverty, is the greatest global challenge and an indispensable requirement for sustainable development, its commitment to achieving sustainable development in its three dimensions — economic, social and environmental — in a balanced and integrated manner, and to building upon the achievements of the Millennium Development Goals and seeking to address their unfinished business,

Reaffirming also its resolution 69/313 of 27 July 2015 on the Addis Ababa Action Agenda of the Third International Conference on Financing for Development, which is an integral part of the 2030 Agenda for Sustainable Development, supports and complements it, helps to contextualize its means of implementation targets with concrete policies and actions, and reaffirms the strong political commitment to address the challenge of financing and creating an enabling environment at all levels for sustainable development in the spirit of global partnership and solidarity,

Reaffirming that the implementation of the Sustainable Development Goals will depend upon a revitalized and enhanced Global Partnership for Sustainable Development, bringing together Governments, civil society, the private sector, the United Nations system and other actors, and noting in this regard the interest expressed in holding future conferences or events at a high level that would complement but not duplicate existing efforts and activities to support implementation and to maintain political momentum to achieve Sustainable Development Goal 14,

Recognizing the central role of the General Assembly, the Economic and Social Council and the high-level political forum on sustainable development held under their auspices, as well as the role of the United Nations Open-ended Informal Consultative Process on Oceans and the Law of the Sea and the important

contribution of all relevant specialized agencies and funds and programmes of the United Nations in the implementation of Sustainable Development Goal 14,

1. *Decides* to convene the High-level United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and Sustainably Use the Oceans, Seas and Marine Resources for Sustainable Development, to be held in Fiji from 5 to 9 June 2017, coinciding with World Oceans Day, to support the implementation of Sustainable Development Goal 14;

2. *Also decides* that all costs relating to the Conference and its preparation shall be financed through extrabudgetary resources;

3. *Welcomes* the generous offer by the Governments of Fiji and Sweden to co-host and assume the costs of the Conference;

4. *Decides* to consider, before the end of the seventieth session of the General Assembly, the modalities of the Conference in the most efficient and effective manner possible;

5. *Expresses its intention* to consider further opportunities to actively involve Governments, civil society, the private sector, the United Nations system and other actors in driving progress and supporting the implementation of Sustainable Development Goal 14.
