Revitalization of the work of the General Assembly

Report of the Third Committee

1. At its 2nd plenary meeting, on 18 September 2015, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventieth session the item entitled “Revitalization of the work of the General Assembly” and to allocate it to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work.
2. The Third Committee considered the item at its 56th meeting, on 25 November 2015.¹
3. At its 56th meeting, the Committee had before it a tentative programme of work of the Third Committee for the seventy-first session of the General Assembly ([A/C.3/70/L.110](#)).
4. At the same meeting, the Committee approved its tentative programme of work for the seventy-first session, as contained in document [A/C.3/70/L.110](#), and decided to transmit it to the General Assembly (see para. 5).

5. The Third Committee recommends to the General Assembly the adoption of the following draft decision:

 - (b) Follow-up to the outcome document of the high-level plenary meeting of the General Assembly known as the World Conference on Indigenous Peoples.
 - Item 7. Promotion and protection of human rights:
 - (a) Implementation of human rights instruments;
 - (b) Human rights questions, including alternative approaches for improving the effective enjoyment of human rights and fundamental freedoms;
 - (c) Human rights situations and reports of special rapporteurs and representatives;
 - (d) Comprehensive implementation of and follow-up to the Vienna Declaration and Programme of Action.
 - Item 8. Elimination of racism, racial discrimination, xenophobia and related intolerance:
 - (a) Elimination of racism, racial discrimination, xenophobia and related intolerance;
 - (b) Comprehensive implementation of and follow-up to the Durban Declaration and Programme of Action.

 - Item 10. Report of the Human Rights Council.
 - Item 11. Report of the United Nations High Commissioner for Refugees, questions relating to refugees, returnees and displaced persons and humanitarian questions.
