

I. Introduction

- 1. The item entitled "Revitalization of the work of the General Assembly" was included in the provisional agenda of the seventieth session of the General Assembly pursuant to Assembly resolution 58/316 of 1 July 2004.
- 2. At its 2nd plenary meeting, on 18 September 2015, the General Assembly, on the recommendation of the General Committee, decided to allocate the item to all the Main Committees for the purpose of discussing their working methods and considering and taking action on their respective tentative programmes of work for the seventy-first session of the General Assembly.
- 3. The Sixth Committee considered the item at its 28th and 29th meetings, on 16 and 20 November 2015. The views of the representatives who spoke during the Committee's consideration of the item are reflected in the relevant summary records (see A/C.6/70/SR.28 and 29).

II. Consideration of draft decision A/C.6/70/L.18

- 4. At the 29th meeting, on 20 November, the Chair introduced a draft decision containing the provisional programme of work of the Committee for the seventy-first session of the General Assembly, as proposed by the Bureau (A/C.6/70/L.18).
