

Seventy-first session Agenda item 115 (e) Appointments to fill vacancies in subsidiary organs and other appointments

Appointment of members of the Independent Audit Advisory Committee

Note by the Secretary-General

- 1. The Secretary-General refers to decision 71/409 of the General Assembly, on the recommendation of the Fifth Committee (see A/71/593), at its 45th plenary meeting, on 10 November 2016, to appoint two members to the Independent Audit Advisory Committee for a three-year term of office beginning on 1 January 2017 and to postpone to a later date the appointment of one member to fill the remaining vacancy.
- 2. The Government of the Philippines has nominated Maria Gracia Pulido-Tan to fill the vacancy in the Independent Audit Advisory Committee for a three-year term of office beginning on 1 January 2017.
- 3. In a communication dated 3 November 2016, the Secretariat was informed by the Chair of the Group of Asia-Pacific States that the candidature of Ms. Pulido-Tan had been endorsed by the Group.
