Summary

The present report is submitted pursuant to the request of the General Assembly in its resolution 67/255, and in compliance with previous resolutions of the Assembly, including resolutions 51/243, 57/281 B, 57/305, 59/266, 61/244, 63/250 and 65/247, concerning the engagement of consultants, individual contractors, gratis personnel and retired staff.

The report presents a demographic analysis of the engagement of gratis personnel (5,091), retired staff (3,628) and consultants and individual contractors (65,551) during the biennium 2014-2015.

I. Introduction

1. The present report is submitted pursuant to the request of the General Assembly in its resolution 67/255, and in compliance with previous resolutions of the Assembly, including resolutions 51/243, 57/281 B, 57/305, 59/266, 61/244, 63/250 and 65/247. The report provides demographic analysis on the engagement¹ of gratis personnel and the employment of retired staff, consultants and individual contractors from 1 January 2014 to 31 December 2015.

2. Table 1 provides an overview of the structure of the report, by section, including demographic variables. The organizational structure in this report has been aligned with the budgets. In previous reports the organizational structure was presented following the respective entity providing the administrative support. The day-to-day operational and management arrangements will remain the same.

II. Gratis personnel

A. Population

3. The present section includes an analysis of gratis personnel engaged by the United Nations Secretariat during the biennium 2014-2015.² Gratis personnel are personnel seconded to the United Nations by Governments or other entities at no cost to the Organization. Type I gratis personnel consists of interns, associate experts³ and technical cooperation experts on non-reimbursable loans.⁴ Type II gratis personnel are provided to the Organization by Governments or other entities responsible for the remuneration of their services. They may be accepted for two purposes and on an exceptional basis only: (a) to provide expertise not available within the Organization for very specialized functions; or (b) to provide temporary and urgent assistance in the case of new and/or expanded mandates of the Organization.⁵

4. The information for type I and type II gratis personnel, as shown in table 2, includes all engagements during the reporting period.

5. Nationals from a total of 149 Member States served as gratis personnel during the biennium 2014-2015. For a more detailed breakdown of gratis personnel by nationality, see annex I, table 1.A (for type I), and annex I, table 2.A (for type II).

6. Table 3 shows the trend for gratis personnel during the past three bienniums. It indicates that the number of type I gratis personnel engagements in 2014-2015 has increased 11 per cent compared to the previous biennium. As shown in annex I, table 1.B, of the current report and the previous biennial report ([A/69/292/Add.1](#)),



C. Gender

8. During the biennium 2014-2015, 66 per cent of all gratis personnel engaged (both type I and type II) were female. Female personnel made up 67 per cent of type I engagements, while 33 per cent of those engaged under type II arrangements were female. Figure I illustrates the gender breakdown by each group of gratis personnel. For a more detailed breakdown of the gender of gratis personnel, see annex I, tables 1.A, 1.B and 2.A.

(Population: 5,091 engagements)




D. Length of service

9. Figure II illustrates the average length of service by number of days employed during the biennium 2014-2015 for each group of gratis personnel. The average length of service for type I gratis personnel was 172 days and for type II was 162 days.

III. Retired staff

A. Population

10. There were three different populations of retired staff members⁶ employed by the United Nations Secretariat during the biennium 2014-2015: retirees, non-retired former staff members and staff retained beyond the mandatory age of separation. Additional details on retirees can be found in annex II, tables 1.A, 1.B, 1.C, 1.D and 2.A. Further information on non-retired former staff members is provided in annex II, table 3.A. Further information on staff members retained beyond the mandatory age of separation is provided in annex II, table 3.B.

11. A retiree, as defined in the report of the Secretary-General of 20 October 1998 ([A/53/526](#)), refers to “a former staff member 55 years of age or older who, consequent upon service exceeding five years, is in receipt of a pension benefit from the United Nations Joint Staff Pension Fund”. As shown in table 5, on the basis of that description, there were 3,103 engagements of retirees during the biennium 2014-2015, including a total of 1,193 persons who met the definition of retirees who were working in the Secretariat during that period.

12. The population of non-retired former staff members comprises former staff members who are of the normal retirement age or older, who previously opted for a withdrawal settlement and were re-employed for six months or more during the reporting period. In accordance with article 31 of the regulations of the United Nations Joint Staff Pension Fund, a withdrawal settlement is payable to participants in the Pension Fund whose age on separation is less than the normal retirement age, or in the event that the participants are of the normal retirement age or older on separation but are not entitled to a retirement benefit. During the biennium 2014-2015, there were 117 staff members meeting that description working on a total of 376 engagements.

13. The third population includes staff retained in service beyond the mandatory age of separation. Administrative instruction [ST/AI/2003/8](#), Amend.1 and Amend.2 sets out the criteria governing the retention of staff beyond the mandatory age of separation, including when: (a) it has not been possible to identify a qualified candidate to discharge the functions of the post in a timely manner; and (b) retention of the staff member is in the interest of the Organization owing to the exigencies of the service concerned. Accordingly, 96 staff members retained beyond the mandatory age of separation worked during the 2014-2015 biennium on a total of 149 engagements.

IV. Consultants and individual contractors

A. Population

21. The present section contains an analysis of the use of consultants and individual contractors⁸ during the biennium 2014-2015.⁹ The data contained in annex III, tables 1.A, 1.B, 2.A, 2.B and 2.C, provide further information on the engagement of consultants and individual contractors in non-field operations on contract during the reporting period. Annex III, tables 3.A and 3.B, provides further information on UNDAC engagements. Annex III, tables 4.A and 4.B, includes additional details on the number of engagements of consultants and individual contractors at field operations. Annex III, table 5, in the previous report, showed data on institutional contractors, which are now not separately recorded in Umoja and have been replaced by contracts for services.

22. The total number of engagements of consultants and individual contractors is 65,551. There were 20,732 engagements of consultants and individual contractors recruited by non-field operations entities, 12,764 for consultants and 7,968 for individual contractors (see table 17). With regard to field operations, 44,819 engagements were recorded during the biennium 2014-2015, 1,634 for consultants and 43,185 for individual contractors. In terms of the number of persons, a total of 10,537 individuals were engaged as consultants or individual contractors at non-field operations during the reporting period, and a total of 18,334 persons were recruited as consultants or individual contractors at field operations (see table 18).

23. Consultants and individual contractors employed at non-field operations during the biennium 2014-2015 were from 180 Member States; consultants came from 177 Member States; and individual contractors came from 139 Member States. Consultants and individual contractors employed at field operations during the biennium 2014-2015 were from 107 Member States; consultants came from 85 Member States; and individual contractors came from 90 Member States.

24. Table 19 shows the trend for consultants and individual contractors at non-field operations during the past three bienniums. It shows that the number of days worked during the biennium 2014-2015 increased 5.9 per cent compared to the previous biennium. 

E. Length of engagement

28. The average length of engagement for consultants and individual contractors employed at non-field operations was 86 days during the 2014-2015 biennium. Figure III provides a breakdown of engagements of consultants and individual contractors at non-field operations by length of engagement.

29. Annex III, table 2.C, provides a list of non-field operations that employed consultants for a period longer than a year during the biennium 2014-2015. As requested by the General Assembly in its resolution 67/255, paragraph 69, information is provided on the job network, the number of days worked and the incurred expenditure.

30. During the reporting period, 88 persons from the group of UNDAC¹⁰ consultants with OCHA were deployed as part of UNDAC teams (26 females and 62 males), for a total of 106 deployments, with an average duration of 20 days per deployment. Details on UNDAC deployments by nationality of person deployed and emergency situation are provided in annex III, tables 3.A and 3.B.

V. Conclusion

31. The Secretary-General invites the General Assembly to take note of the present report.

¹⁰ By its resolution 46/182, on the strengthening of the coordination of humanitarian emergency assistance of the United Nations, the General Assembly requested the establishment of a central roster of specialized personnel available from within the United Nations system and from Governments to be called upon at short notice. It also called for the establishment of standby arrangements with interested Governments and intergovernmental organizations for access to those relief capacities and resources, including personnel and funding support for UNDAC.
