## I. Overview

1. In its resolutions 69/17 and 70/8, the General Assembly adopted the biennial programme plan and priorities for the period 2016-2017 ([A/69/6/Rev.1](#); see also the report of the Committee for Programme and Coordination ([A/70/16](#)) and previous consolidated changes to the biennial programme plan ([A/70/80](#))). It is recalled that the Assembly, in its resolution 58/269, requested the Committee for Programme and Coordination, in performing its programmatic role in the planning and budgeting process, to review the programmatic aspects of new and/or revised mandates subsequent to the adoption of the biennial programme plan, as well as any differences that arose between the biennial programme plan and the programmatic aspects of the proposed programme budget. The present report has been prepared in response to that request.

## II. Proposed programme budget for the biennium 2016-2017

2. In line with rule 104.8 of the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation ([ST/SGB/2016/6](#)), and on the basis of new and/or revised mandates, revisions to the biennial programme plan for the period 2016-2017 are proposed under programme 3, Disarmament; programme 6, Legal affairs; programme 7, Economic and social affairs; programme 8, Least developed countries, landlocked developing countries and small island developing States; programme 9, United Nations support for the New Partnership for Africa's Development; programme 10, Trade and development; programme 11, Environment; programme 12, Human settlements; programme 13, International drug control, crime and terrorism prevention and criminal justice; programme 14, Gender equality and empowerment of women; programme 15, Economic and social development in Africa; programme 16, Economic and social development in Asia and the Pacific; programme 17, Economic development in Europe; programme 18, Economic and social development in Latin America and the Caribbean; programme 19, Economic and social development in Western Asia; programme 20, Human rights; and programme 22, Palestine refugees.

3. The changes in the biennial programme plan for the period 2016-2017 for the aforementioned programmes relate to the Addis Ababa Action Agenda of the Third International Conference on Financing for Development, endorsed by the General Assembly in its resolution 69/313, Economic and Social Council resolution 2015/30 on restructuring the conference structure of the Economic and Social Commission for Asia and the Pacific to be fit for the evolving post-2015 development agenda, Council resolution 2015/33 on the international arrangement on forests beyond 2015, the outcome document of the United Nations summit for the adoption of the post-2015 development agenda, entitled "Transforming our world: the 2030 Agenda for Sustainable Development, adopted by the Assembly in its resolution 70/1, and Assembly resolution 70/199 on the United Nations forest instrument.

4. The information in the present consolidated document has been prepared for review by the Committee for Programme and Coordination and the General Assembly. For each affected programme, introductory information is provided, including references to the new and/or revised mandates that give rise to the programmatic adjustments. The proposed revised text is presented under

subheadings indicating the numbers of the affected paragraphs of document [A/69/6/Rev.1](#).

### **Programme 3 Disarmament**

5. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolution 70/1. Specifically, revisions are proposed under programme 3, Disarmament, to paragraph 3.2 of the overall orientation; and subparagraph 3.10 (a) of the strategy for subprogramme 3, Conventional arms (including practical disarmament measures).

### **Overall orientation**

*Paragraph 3.2 of [A/69/6/Rev.1](#)*

6. The mandate for the programme is derived from the priorities established in relevant General Assembly resolutions and decisions in the field of disarmament, including the Final Document of the Tenth Special Session of the General Assembly, the first special session devoted to disarmament (resolution S-10/2). The programme is also guided by the 2030 Agenda for Sustainable Development. Weapons of mass destruction, in particular nuclear weapons, continue to be of primary concern to the Organization owing to their destructive power and the threat that they pose to humanity. Conventional weapons, small arms, light weapons, landmines and cluster munitions have received increased attention from the international community.

### **Subprogramme 3 Conventional arms (including practical disarmament measures)**

#### **Strategy**

*Subparagraph 3.10 (a) of [A/69/6/Rev.1](#)*

7. The subprogramme is implemented by the Conventional Arms Branch. The objective of the subprogramme will be pursued by:

(a) Promoting and supporting Member States' efforts to prevent illicit trade in small arms and light weapons through the effective implementation of the United Nations Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects and the International Instrument to Enable States to Identify and Trace, in a Timely and Reliable Manner, Illicit Small Arms and Light Weapons, including the relevant target of the 2030 Agenda for Sustainable Development;

## Programme 6

### Legal affairs

8. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolutions 70/1 and 70/235. Specifically, revisions under programme 6, Legal affairs, are proposed to indicator of achievement (b) (ii) and paragraph 6.19 of the strategy for subprogramme 4, Law of the sea and ocean affairs.

9. The Division will continue to assist the Commission on the Limits of the Continental Shelf in its consideration of submissions, and to advise States, in particular developing States, on the preparation of those submissions and of the proceedings before the Commission. It will also continue to provide enhanced support to the Regular Process for Global Reporting and Assessment of the State of the Marine Environment, including Socioeconomic Aspects, as its secretariat. In addition, the Division will continue to engage in activities aimed at enhancing the peaceful use and sustainable development of oceans and seas, including the conservation and sustainable use of marine living resources and marine biodiversity in areas beyond national jurisdiction; and the implementation of the oceans-related goals in the 2030 Agenda for Sustainable Development.

**Programme 7****Economic and social affairs**

10. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolutions 70/1 and 70/199 and Economic and Social Council resolution 2015/33.

11. In line with General Assembly resolution 70/1, revisions are proposed under programme 7, Economic and social affairs, to the overall orientation (paras. 7.2, 7.3 and 7.5); the objective and subparagraph 7.7 (a) and (c) of the strategy for subprogramme 1, Economic and Social Council support and coordination; subparagraph 7.8 (a) of the strategy for subprogramme 2, Social policy and development; the objective, expected accomplishments and subparagraphs 7.9 (a), (b), (e) and (f) of the strategy for subprogramme 3, Sustainable development; the objective, expected accomplishments (a) and (c) and the related indicators of achievement and subparagraph 7.10 (a) of the strategy for subprogramme 4, Statistics; expected accomplishment (c) and the related indicator of achievement of subprogramme 6, Development policy and analysis; and the objective, expected accomplishments (a), (c) and (d) and the related indicators of achievement and subparagraphs 7.15 (a)-(d) of the strategy for subprogramme 9, Financing for development.

12. In line with Economic and Social Council resolution 2015/33 and General Assembly resolution 70/199, revisions are proposed to the objective, expected accomplishments (a), (b) and (e) and the related indicators of achievement and subparagraphs 7.14 (a), (b), (f) and (i) of the strategy for subprogramme 8, Sustainable forest management.

**Overall orientation***Paragraphs 7.2 and 7.3 of [A/69/6/Rev.1](#)*

13. The programme, which is under the responsibility of the Department of Economic and Social Affairs, is ensuring complementarity and synergy among its nine subprogrammes. Its key programmatic thrusts are: (a) to provide substantive support to the bodies established under the Charter of the United Nations dealing with development issues, namely, the General Assembly, the Economic and Social Council and its related functional commissions, and expert bodies; (b) to monitor and analyse development trends, prospects and policy issues globally; and (c) to provide support for capacity development in policy formulation and implementation, in particular in relation to the implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals, through, inter alia, the implementation of the regular programme of technical cooperation and Development Account projects.

14. The programme has placed development issues at the centre of global deliberations and helped Member States to forge a shared vision of development, as identified in the outcomes of major United Nations conferences and summits. The programme will continue to support the implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals, and its follow-up process, as well as the follow-up to and implementation of the outcomes of the Addis Ababa Action Agenda on financing for development.

15. Fulfilling those functions requires strengthened analytical and monitoring capacity to identify and address emerging issues and cross-cutting policy challenges and to support both national development strategies and accountability and monitoring mechanisms at the intergovernmental level. Strategic integration is also essential to promoting a coherent and coordinated implementation process in advancing the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals. This includes enhancing horizontal linkages across the subprogrammes to facilitate more effective and flexible support for Member States in pursuing the 2030 Agenda, including the Sustainable Development Goals, in cooperation with entities of the Executive Committee on Economic and Social Affairs, to which the programme provides strategic support and ensures its stronger linkages with the United Nations Development Group, other executive committees and various other partners.

## **Subprogramme 1**

### **Economic and Social Council support and coordination**

**Objective of the Organization:** To advance the role of the General Assembly and the Economic and Social Council and promote coordination and coherence in the activities of the United Nations system in the implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals

#### **Strategy**

16. The Office for Economic and Social Council Support and Coordination is responsible for the subprogramme. The strategy will include:

(a) Strengthening the role of the Economic and Social Council in coordinating progress towards the 2030 Agenda for Sustainable Development and enhancing the integration of the three dimensions of sustainable development, by reinforcing policy development, coherence and coordination through its national reviews of country experiences, with adequate consideration given to promoting gender equality;

(c) Enhancing the role of the Economic and Social Council in the balanced integration of the economic, social and environmental dimensions of sustainable development through its integration segment and high-level segment.

**Subprogramme 2**  
**Social policy and development**

**Strategy**

*Subparagraph 7.8 (a) of [A/69/6/Rev.1](#)*

17. The Division for Social Policy and Development is responsible for the subprogramme. The strategy will include:

(a) Promoting greater awareness of and support for the integrated follow-up to and the implementation of: (i) the 2030 Agenda for Sustainable Development; (ii) commitments from United Nations conferences and summits, especially the World Summit for Social Development, the twenty-fourth special session of the General Assembly and the United Nations Conference on Sustainable Development; (iii) commitments contained in documents such as the Convention on the Rights of Persons with Disabilities, the outcome document of the high-level meeting of the General Assembly on the realization of the Millennium Development Goals and other internationally agreed development goals for persons with disabilities, the United Nations Declaration on the Rights of Indigenous Peoples and the follow-up to the International Year of Cooperatives, 2012; (iv) mandates and recommendations of the United Nations Permanent Forum on Indigenous Issues and major international action plans; (v) mandates contained in General Assembly and Economic and Social Council resolutions; (vi) the United Nations system-wide plan of action on the Second United Nations Decade for the Eradication of Poverty, and the social dimensions of the New Partnership for Africa's Development; and (vii) follow-up to the outcomes of the high-level plenary meeting of the General Assembly in 2014, to be known as the World Conference on Indigenous Peoples.

18. The Division for Sustainable Development is responsible for the subprogramme. The strategy will include:

- (a) Promoting and supporting effective, coherent and coordinated implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals, the outcomes of major United Nations agreements on sustainable development in general and the sustainable development of the least developed countries, landlocked developing countries and small island developing States, at the national, regional and global levels, with an emphasis on greater integration of social, economic and environmental dimensions of sustainable development through national sustainable development strategies;
- (b) Providing substantive and effective support, including policy development and analysis, to the high-level political forum and the follow-up to the 2030 Agenda, including the United Nations Conference on Sustainable Development, including through the preparation of periodic sustainable development reports;
- (e) Engaging major groups and other stakeholders in the work of the United Nations on sustainable development, including on the 2030 Agenda;
- (f) Analysing sustainable development trends and policies, including on means of implementation, culminating in the *Global Sustainable Development Reports* for consideration by the high-level political forum.

19. The subprogramme is under the responsibility of the Statistics Division. The strategy will include:

(a) Expanding the normative role of the subprogramme in the development and enhancement of statistical standards, the collection and dissemination of statistical data by Member States and the coordination of international statistical activities, especially those related to the Sustainable Development Goals and other new and emerging policy issues.

## Strategy

20. The secretariat of the United Nations Forum on Forests is responsible for the subprogramme. The strategy will include:

(a) Supporting efforts to advance the sustainable management of all types of forests and trees outside forests, including the United Nations forest instrument global objectives on forests and forest sustainable development goals and targets, and, to this end, enhancing cooperation through country- and region-led initiatives, as well as supporting the interaction between the United Nations Forum on Forests and relevant regional and subregional organizations and processes, with the participation of major groups and other relevant stakeholders;

(b) Promoting greater awareness, at all levels, of the role of forests in achieving the sustainable development goals within the 2030 Agenda for Sustainable Development, as well as the United Nations Forum on Forests, and the objectives of the international arrangement on forests beyond 2015;

(f) Providing substantive support through the Global Forest Financing Facilitation network, addressing the special needs of Africa, the least developed countries, low-forest-cover countries, high-forest-cover low-deforestation countries and small island developing States, in accessing financing for forests;

(i) Assisting Member States, at their request, in advancing the sustainable management of all types of forests, including implementing the United Nations forest instrument, particularly for achieving its global objectives.

21. The Financing for Development Office is responsible for the subprogramme. The strategy will include:

(a) Serving as a focal point in the United Nations Secretariat for overall follow-up to the implementation at the national, regional and global levels of the outcomes of the 2002, 2008 and 2015 International Conferences on Financing for

Development, and, in this context, intensifying collaboration and interaction with all relevant stakeholders;

(b) Promoting policy coherence within the United Nations on issues related to financing for development, for the integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits in the economic and social fields, including the outcome of the United Nations Conference on Sustainable Development, and the 2030 Agenda for Sustainable Development;

29. NEPAD remains critical to the three dimensions of sustainable development in Africa (economic, social and environmental), as highlighted in the outcome document of the United Nations Conference on Sustainable Development (General Assembly resolution 66/288, annex). As NEPAD has been the overarching framework for the implementation of the Millennium Development Goals in Africa, it will continue to be a critical guiding framework for the continent's implementation of the 2030 Agenda for Sustainable Development and its Sustainable Development Goals.

30. The United Nations is working to further support Africa in overcoming barriers to peace through the implementation of General Assembly resolution 67/302, in which the Assembly acknowledged the efforts to enhance coordination and cooperation between the African Union Peace and Security Council and the United Nations Security Council in the areas of peace and security, including the joint annual consultative meetings between members of the two Councils. The Assembly requested the Secretary-General to strengthen the role of the Interdepartmental/Inter-agency Task Force on Africa of the Office of the Special Adviser on Africa to bring greater coherence and coordination in the United Nations support to Africa for the Ten-Year Capacity-building Programme for the African Union and its successor programme, the implementation of the 2030 Agenda for Sustainable Development and the Sustainable Development Goals, and other processes.

## **Subprogramme 1 Coordination of global advocacy of and support for the New Partnership for Africa's Development**

### **Strategy**

Because sustainable and inclusive outcomes in an interdependent world involve collective responses at the multilateral level, UNCTAD is one of the appropriate bodies of the United Nations system for building consensus around more development-centred globalization, which would lead to faster and more stable growth, economic diversification, sustainable debt management, job creation, poverty reduction and sustainable and inclusive development.

34. 38. The International Trade Centre bears substantive responsibility for the implementation of the subprogramme. Its strategic thrust is in line with the mandate entrusted to it by the Economic and Social Council in its resolution 1819 (LV), by which the Council recognized the Centre as the focal point for technical assistance and cooperation activities in the trade promotion and export development field within the United Nations system of assistance to developing countries. The subprogramme will focus on the implementation of international goals, including the 2030 Agenda for Sustainable Development. It will contribute to the implementation of the Programme of Action for the Least Developed Countries for the Decade 2011-2020 and the outcome of the United Nations Conference on Sustainable Development, entitled “The future we want” (General Assembly resolution 66/288, annex). The subprogramme will play an important role in furthering the implementation of the Doha, Hong Kong and Geneva ministerial declarations adopted by WTO, in particular by improving and enhancing trade support institutions and policies for the benefit of exporting efforts and by strengthening the export capacity of enterprises to respond to market opportunities.

## Programme 12 Human settlements

40. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolution 70/1. Specifically, revisions are proposed under programme 12, Human settlements, to paragraphs 12.2, 12.3 and 12.7 of the overall orientation, and subparagraph 12.27 (a) of the strategy for subprogramme 4, Urban basic services.

### Overall orientation

#### *Paragraphs 12.2 and 12.3 of A/69/6/Rev.1*

41. The mandate of UN-Habitat is further derived from other internationally agreed development goals, including the 2030 Agenda for Sustainable Development and Sustainable Development Goal 11, which calls on the global community to make cities and human settlements inclusive, safe, resilient and sustainable.

42. Through its resolution 24/15 of 19 April 2013, the Governing Council of UN-Habitat approved a six-year strategic plan for the period 2014-2019, which will be implemented through three successive biennial strategic frameworks and programme budgets, for 2014-2015, 2016-2017 and 2018-2019. The strategic direction of the framework would be derived from the 2030 Agenda for Sustainable Development, and from the outcome of the Third United Nations Conference on Housing and Sustainable Urban Development (Habitat III), scheduled to take place in 2016.

*Paragraph 12.7 of [A/69/6/Rev.1](#)*

43. Owing to the global economic crisis that started in 2008, urbanization is taking place within the context of a relatively weakened global economy, with reduced investment prospects in some parts of the world. The slump in economic growth could adversely affect slum upgrading and prevention programmes, urban renewal and poverty-reduction initiatives, which traditionally rank low in priority, and seriously threaten the possibility of achieving the targets of the 2030 Agenda for Sustainable Development. However, some countries, including many in Africa, have experienced positive economic growth in recent years, thus opening up opportunities for planned urbanization to contribute significantly to sustainable development.

## **Subprogramme 4**

### **Urban basic services**

#### **Strategy**

*Subparagraph 12.27 (a) of [A/69/6/Rev.1](#)*

44. A key focus of subprogramme 4 is on supporting local, regional and national authorities responsible for urban and human settlements issues in developing and implementing policies for increasing equitable access to urban basic services and improving the standard of living of the urban poor. The strategy for achieving the expected accomplishments is as follows:

(a) Regarding access to sustainable urban basic services, the subprogramme will support local, regional and national authorities in strengthening their legislative and institutional frameworks for the expansion of equitable access to urban basic services. Efforts will focus on advocacy and networking on basic services to contribute to the 2030 Agenda for Sustainable Development, through collaboration with the United Nations inter-agency coordination mechanisms on water resources and energy (UN-Water and UN-Energy), the technical working group of the Secretary-General on transport, regional economic commissions and intergovernmental bodies. Support will also be given to national and subnational policy and sector reform processes to develop and implement pro poor policies. To achieve this, the subprogramme will strengthen its involvement in the development of country support strategies through active engagement with other United Nations partners. The subprogramme will also support the implementation of the international guidelines on decentralization and the guidelines on access to basic services for all, and the development and dissemination of toolkits, standards and guidelines as valuable tools for expanding access to urban basic services.

## **Programme 13**

### **International drug control, crime and terrorism prevention and criminal justice**

45. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolution 70/1. Specifically, revisions are proposed under programme 13, International drug control, crime and terrorism prevention and criminal justice, in the overall orientation to include a new paragraph below existing paragraph 13.4 and to revise existing paragraph 13.5 (which will become paragraph 13.6); the strategy for subprogramme 7, Policy support; and paragraph 13.19 of the strategy for subprogramme 8, Technical cooperation and field support.

## **Overall orientation**

*New paragraph 13.5 and revision of former paragraph 13.5 (now paragraph 13.6) of [A/69/6/Rev.1](#)*

46. For the first time, the new global development agenda explicitly affirms that development requires peaceful and inclusive societies, justice for all and effective, accountable and inclusive institutions at all levels. There exists a strongly related and mutually reinforcing relationship between the rule of law and development and, as such, neither can be realized in the absence of the other.

47. Besides the foundational mandates, the policy directions of UNODC are grounded in: (a) the 2030 Agenda for Sustainable Development (General Assembly resolution 70/1); (b) the Millennium Declaration (see General Assembly resolution 55/2); (c) the twentieth special session of the General Assembly on countering the world drug problem; (d) the recommendations resulting from the 2005 World Summit Outcome (General Assembly resolution 60/1); (e) Economic and Social Council resolutions 2007/12 and 2007/19; and (f) the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem, as adopted by the Commission on Narcotic Drugs at the high-level segment of its fifty-second session (United Nations publication, Sales No. E.10.XI.8).

## **Subprogramme 7**

### **Policy support**

#### **Strategy**

*Paragraph 13.18 of [A/69/6/Rev.1](#)*

48. Substantive responsibility for implementation of the subprogramme lies with the Division for Policy Analysis and Public Affairs. The objective will be achieved by:

- (a) Developing normative results-based management frameworks for planning, monitoring and reporting purposes;
- (b) Providing assistance on policy coherence and institutional reforms to increase the effective implementation of the UNODC mandate areas, including drug control, crime prevention and criminal justice, at the national, regional and international levels;
- (c) Facilitating and providing interdivisional headquarters and field based assistance, including through United Nations country teams, to increase national and regional capacity: (i) to implement mandated areas of the international normative framework which address cross-cutting, systemic issues (such as illicit financial flows, corruption and economic crime); (ii) to achieve relevant Sustainable Development Goals targets; and (iii) other commitments (such as the Addis Ababa Action Agenda);
- (d) Conducting dialogues with donor Governments, Member States, international organizations and private sector entities to mobilize resources;
- (e) Reaching out to non-governmental organizations and international media;
- (f) Carrying out targeted advocacy and communication activities, with emphasis on key stakeholders in the substantive areas such as drugs, corruption, human trafficking and smuggling of migrants;
- (g) Coordinating with other United Nations agencies on issues related to drugs, crime and terrorism in all its forms and manifestations;
- (h) Undertaking policy analysis and providing coherent advice, upon request;
- (i) Promoting collaboration between the three pillars of the United Nations system — peace and security, human rights and sustainable development — as called for in the 2030 Agenda for Sustainable Development.

## **Subprogramme 8**

### **Technical cooperation and field support**

#### **Strategy**

*Paragraph 13.19 of [A/69/6/Rev.1](#)*

49. Substantive responsibility for the implementation of the subprogramme lies with the Division of Operations. With the adoption of the Sustainable Development Goals, the UNODC field offices will ensure the inclusion of governance, security and human rights-based crime control interventions into a larger number of joint United Nations programmes that address the development and health components of the Goals. The Division will provide policy advice, strategic guidance and coordination for the development of integrated programmes and ensure their full implementation, notably through synergies with global programmes. In addition, the Division will provide overall management, quality assurance and oversight to ensure successful programme implementation. Key tasks include:

51. The programme contributes to the achievement of internationally agreed development goals in the area of gender equality and the empowerment of women, recognizing that gender equality is pivotal to the achievement of sustainable development in all its dimensions. To this end, the programme contributes to the implementation of Sustainable Development Goal 5, to achieve gender equality and empower all women and girls; gender-specific targets in other goals; and the systematic mainstreaming of a gender perspective in the implementation of the 2030 Agenda for Sustainable Development. The programme will also contribute to the implementation and monitoring of the gender equality commitments and actions in the Addis Ababa Action Agenda.

52. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolution 70/1. Specifically, revisions are proposed under programme 15, Economic and social development in Africa, to paragraph 15.3 of the overall orientation; and under subprogramme 7, Subregional activities for

development, to the strategies of all components: paragraph 15.38 of component 1, Subregional activities in North Africa; paragraph 15.44 of component 2, Subregional activities in West Africa; paragraph 15.51 of component 3, Subregional activities in Central Africa; paragraph 15.53 of component 4, Subregional activities in East Africa; and paragraph 15.56 of component 5, Subregional activities in Southern Africa.

### **Overall orientation**

*Paragraph 15.3 of [A/69/6/Rev.1](#)*

53. Many African economies have been growing steadily over the past decade, making remarkable progress in advancing economic and social development, including progress towards meeting some of the 2030 Agenda for Sustainable Development targets. The growth momentum continued in 2013, with the growth in gross domestic product averaging 5 per cent, which is well above the world average, making the continent one of the fastest-growing regions of the world.

## **Subprogramme 7 Subregional activities for development**

### **Component 1 Subregional activities in North Africa**

#### **Strategy**

*Paragraph 15.38 of [A/69/6/Rev.1](#)*

54. Component 1 of subprogramme 7 will be implemented by the subregional office for North Africa, which covers the following seven member States: Algeria, Egypt, Libya, Mauritania, Morocco, Sudan and Tunisia. The strategy applied under the subprogramme will focus on internationally and regionally agreed development goals, including the 2030 Agenda for Sustainable Development, as well as the outcome of the United Nations Conference on Sustainable Development. In addition, the subprogramme will focus on boosting intra-African cooperation and trade.

### **Component 2 Subregional activities in West Africa**

#### **Strategy**

*Paragraph 15.44 of [A/69/6/Rev.1](#)*

55. Component 2 of subprogramme 7 will be implemented by the subregional office for West Africa, which covers the following 15 countries: Benin, Burkina Faso, Cabo Verde, Côte d'Ivoire, Gambia, Ghana, Guinea, Guinea-Bissau, Liberia, Mali, Niger, Nigeria, Senegal, Sierra Leone and Togo. The strategy will focus on the provision of support to member States and regional economic communities in meeting internationally agreed development goals, such as the 2030 Agenda for Sustainable Development, as well as the outcome of the United Nations Conference on Sustainable Development. In addition, the subprogramme will organize consultations with countries in the subregion on the African Union's Agenda 2063.

### **Component 3**

#### **Subregional activities in Central Africa**

##### **Strategy**

*Paragraph 15.51 of [A/69/6/Rev.1](#)*

56. The special initiatives will reflect the priorities defined by the regional economic communities in their efforts to advance post-conflict recovery, regional integration and economic, social and environmental development. The component will assist regional economic communities and member States in formulating and implementing programmes and activities in line with NEPAD priorities, the 2030 Agenda for Sustainable Development and structural transformation. The implementation strategy will include building and maintaining knowledge and information networks for harnessing and disseminating best practices to member States and their organizations as well as maintaining the subregional repository of statistical information to feed into the common databank and to support all of the analytical and research needs of the Commission. This will require close consultation with regional economic communities and the strengthening of partnerships with United Nations agencies and other stakeholders, including the private sector and civil society, and with regional intergovernmental organizations, including the African Development Bank, the African Union Commission, the NEPAD secretariat, the Central African States Development Bank and the Bank of Central African States, for better synergy in order to increase the effectiveness and impact of ECA activities. The subregional coordination mechanism convened by the office will be used as a formal consultation platform.

### **Component 4**

#### **Subregional activities in East Africa**

##### **Strategy**

*Paragraph 15.53 of [A/69/6/Rev.1](#)*

57. As part of the capacity-building strategy of ECA, targeted and multidisciplinary advisory and capacity-development support will be provided to a select number of priority member States (post-conflict countries, small island States), regional economic communities and intergovernmental organizations to accelerate the implementation of high-impact subregional initiatives in line with the 2030 Agenda for Sustainable Development and the African Union's Agenda 2063. ECA will foster innovative partnerships with regional and national think tanks, non-governmental organizations and private sector organizations to generate better results and economies of scale.

### **Component 5**

#### **Subregional activities in Southern Africa**

##### **Strategy**

*Paragraph 15.56 of [A/69/6/Rev.1](#)*

58. The component will also concentrate on producing country profiles aimed at providing policy advice in support of the development agenda of member States. Furthermore, the component will convene meetings and provide technical support and advisory services focusing on special initiatives for the subregion to member

States, the Common Market for Eastern and Southern Africa, the Southern African Development Community and other subregional organizations with a view to improving their capacity for regional integration in relation to emerging issues and areas of priority to Southern Africa. This will include supporting programmes and activities carried out under the special initiatives, focusing on the formulation of policy papers geared towards supporting the implementation of the social and economic development priorities of regional economic communities in the context of the subregional coordination mechanism, NEPAD and achievement of internationally agreed development goals, including the 2030 Agenda for Sustainable Development.

## **Programme 16**

### **Economic and social development in Asia and the Pacific**

59. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolutions 70/1 and 69/313, as well as Economic and Social Commission for Asia and the Pacific resolution 71/1 on restructuring the conference structure of the Economic and Social Commission for Asia and the Pacific to be fit for the evolving post-2015 development agenda, which was endorsed by the Economic and Social Council in its resolution 2015/30.

60. In line with Economic and Social Council resolution 2015/30, the name of subprogramme 1, “Macroeconomic policy and inclusive development” is being revised to “Macroeconomic policy, poverty reduction and financing for development”, and a new subprogramme 9, Energy, is being proposed.

61. In line with General Assembly resolution 69/313, revisions are proposed to paragraph 16.14 of the strategy for subprogramme 1, and to paragraph 16.18 of the strategy for subprogramme 2, Trade and investment.

62. In line with General Assembly resolution 70/1, revisions are proposed to paragraph 16.2 of the overall orientation; the objective, expected accomplishment (c) and paragraphs 16.14 and 16.15 of the strategy for subprogramme 1; paragraphs 16.18-16.20 of the strategy for subprogramme 2; paragraph 16.22 of the strategy for subprogramme 3, Transport; the objective, expected accomplishments, indicators of achievement and paragraphs 16.25 and 16.26 of the strategy for subprogramme 4, Environment and development; paragraphs 16.30 and 16.33 of the strategy for subprogramme 5, Information and communications technology and disaster risk reduction and management; paragraph 16.35 of the strategy for subprogramme 6, Social development; paragraph 16.39 of the strategy for subprogramme 7, Statistics;

and paragraphs 16.41, 16.42 and 16.45-16.48 of the strategy for subprogramme 8, Subregional activities for development.

## Overall orientation

*Paragraph 16.2 of A/69/6/Rev.1*

63. This strategic framework covers the first biennium of the 2030 Agenda for Sustainable Development. Its strategic direction is derived from internationally agreed development mandates, including the outcome of the United Nations Conference on Sustainable Development, which emphasized the role of the regional commissions in promoting the balanced integration of the economic, social and environmental dimensions of sustainable development; General Assembly resolution 67/226 on the quadrennial comprehensive policy review, which called for the adoption of collaborative approaches to support country-level development initiatives; and Commission resolution 71/1 on restructuring the conference structure of the Commission to be fit for the evolving post-2015 development agenda.

## Subprogramme 1

### Macroeconomic policy, poverty reduction and financing for development

**Objective of the Organization:** To enhance regional economic cooperation and foster forward-looking macroeconomic policymaking for inclusive and sustainable development, especially in support of poverty reduction and attainment of internationally agreed development goals, including the 2030 Agenda for Sustainable Development

## Strategy

*Paragraphs 16.14 and 16.15 of A/69/6/Rev.1*

64. The substantive responsibility for the subprogramme is vested in the Macroeconomic Policy and Development Division, with support from the Centre for Alleviation of Poverty through Sustainable Agriculture. The strategic direction of this subprogramme is provided by the internationally agreed development goals, including those enunciated in: (a) the 2030 Agenda for Sustainable Development (General Assembly resolution 70/1); (b) the outcome document of the United Nations Conference on Sustainable Development (General Assembly resolution 66/288, annex; (c) the follow-up to the outcome document of the Conference on the

World Financial and Economic Crisis and Its Impact on Development (General Assembly resolution 63/303, annex); (d) the Addis Ababa Action Agenda of the Third International Conference on Financing for Development (General Assembly resolution 69/313); (e) the programmes of action for the least developed countries, landlocked developing countries and small island developing States; and (f) other resolutions contained in the list of legislative mandates.

65. Forward-looking macroeconomic policies are essential both to ensure economic stability and to support inclusive, equitable and sustainable development. With its emphasis on strengthening capacities to formulate and implement these policies for a resilient Asian and Pacific region, the subprogramme will monitor macroeconomic trends and prospects towards reducing poverty and narrowing development gaps; promote capacity development for the implementation of the 2030 Agenda for Sustainable Development; identify key issues in financing for development; assist in the implementation of the programmes of action for the least developed countries, landlocked developing countries and small island developing States; promote development in fragile States by strengthening regional support measures; and strengthen regional and South-South cooperation in the form of policy dialogues and advocacy to address medium- to long-term challenges and to close development gaps. Special emphasis will be placed on efforts to strengthen regional economic cooperation and integration and on sharing good experiences and best practices. Due attention will be given to redressing gender inequalities; supporting the efforts of least developed countries to enhance their productive capacities to sustain their growth momentum and close their development gaps by 2020; and fostering a regional coordinated voice on development issues and challenges.

## **Subprogramme 2**

### **Trade and investment**

#### **Strategy**

*Paragraphs 16.18-16.20 of [A/69/6/Rev.1](#)*

66. The substantive responsibility for the subprogramme is vested in the Trade and Investment Division, with support from the Asian and Pacific Centre for Transfer of Technology and the Centre for Sustainable Agricultural Mechanization. The strategic direction of the subprogramme is derived mainly from the internationally agreed development goals, including those enunciated in the outcome document of the United Nations Conference on Sustainable Development, the Addis Ababa Action Agenda of the Third International Conference on Financing for Development (General Assembly resolution 69/313) and the Vienna Programme of Action for Landlocked Developing Countries for the Decade 2014-2024, as well as in Commission resolutions 70/5 and 68/3.

67. To meet its objective, the subprogramme will be implemented through a combination of analytical and capacity-building work on trade, investment, enterprise development, sustainable agricultural mechanization, innovation and technology transfer, with a particular view to enhancing the contribution of trade and investment in meeting the development goals envisaged in the 2030 Agenda for Sustainable Development. The focus of the analytical work will be to provide inputs

for evidence-based policymaking and the sharing of experiences on related policy reforms.

68. The following issues will be addressed, with a key focus on inclusive, equitable, sustainable and resilient development and linkages with the 2030 Agenda for Sustainable Development: (a) strengthening the capacity of member States to effectively negotiate, conclude and implement trade and investment agreements at the international and regional levels, including the World Trade Organization Bali package and further agreements on the outstanding issues of the Doha Development Agenda; (b) designing and implementing trade facilitation policies and measures, including paperless trade systems; (c) formulating and implementing effective policy measures to strengthen responsible business practices and the integration of small and medium-sized enterprises, including agro-based enterprises, into regional and global value chains, with attention given to the different needs, challenges and interests of women and men entrepreneurs; (d) promoting foreign direct investment; (e) promoting technological innovation and transfer; and (f) establishing and strengthening common frameworks and mechanisms for regional cooperation in trade, investment, technology transfer and the development of small and medium-sized enterprises, including agricultural enterprises.

### **Subprogramme 3**

#### **Transport**

##### **Strategy**

*Paragraph 16.22 of [A/69/6/Rev.1](#)*

69. The substantive responsibility for this subprogramme is vested in the Transport Division. The strategic direction of the subprogramme is derived from phase II (2012-2016) of the Regional Action Programme for Transport Development in Asia and the Pacific, from the relevant resolutions contained in the list of legislative mandates and from the outcome of meetings of ministers of transport convened by ESCAP. It will also be guided by the 2030 Agenda for Sustainable Development. During the biennium, the subprogramme will support member States in working towards the vision of an international, integrated, intermodal transport and logistics system connecting the Asian and Pacific region. It will do this by supporting member States in their efforts to integrate the regional transport networks, including by continuing to act as the secretariat for the intergovernmental agreements governing the Asian Highway network, the Trans-Asian Railway network and dry ports. In particular, the subprogramme will support the least developed countries, landlocked developing countries and small island developing States in their efforts to develop and upgrade their transport networks, including through public-private partnerships and private-sector involvement in infrastructure projects. In line with the Regional Action Programme, the secretariat will also continue to focus on improving inter-island shipping in archipelagic and island countries. Special consideration will be given to mainstreaming gender considerations into the subprogramme.

## Subprogramme 4 Environment and development

### Strategy

*Paragraphs 16.25 and 16.26 of [A/69/6/Rev.1](#)*

70. The substantive responsibility for the subprogramme is vested in the Environment and Development Division. The strategic direction of the subprogramme is mainly derived from the internationally agreed development goals, the outcomes of the United Nations Conference on Sustainable Development and relevant regional agreements within the context of ESCAP, and will also be guided by the 2030 Agenda for Sustainable Development.

71. The subprogramme will build on the previous achievements of the ESCAP secretariat in supporting countries of the region in their efforts to integrate the three dimensions of sustainable development. It will facilitate regional cooperation as an overarching strategy to address rapid urbanization, shortcomings in access to basic services, integrated water resources management as well as climate change, sustainable management of resources and other environmental pressures and constraints. The subprogramme will focus on supporting a long-term perspective in policymaking to sustain the quantity and improve the quality of growth based on

enhanced economic dynamism, social inclusiveness, environmental sustainability and resilience, critical factors for achieving sustainable development.

## **Subprogramme 5**

### **Information and communications technology and disaster risk reduction and management**

#### **Strategy**

*Paragraph 16.30 of A/69/6/Rev.1*

72. The substantive responsibility for the subprogramme is vested in the Information and Communications Technology and Disaster Risk Reduction Division, with support from the Asian and Pacific Training Centre for Information and Communication Technology for Development. The subprogramme deals with pressing contemporary development challenges of building resilience to natural disasters and deepening connectivity in Asia and the Pacific, with the strategic direction provided by the resolutions contained in the list of legislative mandates and the 2030 Agenda for Sustainable Development. The subprogramme will be implemented through a combination of normative, analytical and capacity-building work and will be anchored in regional cooperation mechanisms.

*Paragraph 16.33 of A/69/6/Rev.1*

73. The emphasis of the disaster risk reduction and management work will be on enhancing regional knowledge and knowledge-sharing, development of disaster information and strengthening of capacities to manage risks and vulnerabilities in order to reduce socioeconomic impacts of disasters and build resilience. The subprogramme will provide member States with analysis, strategies and evidence-based policy options in mainstreaming disaster risk reduction, including climate change adaptation, into long-term development plans and strategies through knowledge-sharing mechanisms, and develop information management solutions for financing disaster risk reduction. The efforts will be further augmented by the regional advisory services on disaster risk reduction, the progress towards an integrated regional early warning system provided through the ESCAP Multi-Donor Trust Fund for Tsunami, Disaster and Climate Preparedness in Indian Ocean and Southeast Asian Countries, and capacity-building activities delivered through ESCAP-supported regional mechanisms, including South-South cooperation.

## **Subprogramme 6**

### **Social development**

#### **Strategy**

*Paragraph 16.35 of A/69/6/Rev.1*

74. The substantive responsibility for the subprogramme is vested in the Social Development Division. The strategic direction of the subprogramme is derived mainly from the commitments agreed upon through relevant United Nations intergovernmental processes, including: (a) the 2030 Agenda for Sustainable Development; (b) the World Summit for Social Development; (c) the Programme of

Action of the International Conference on Population and Development; (d) the Beijing Declaration and Platform for Action; (e) the Convention on the Elimination of All Forms of Discrimination against Women; (f) the Convention on the Rights of Persons with Disabilities; (g) the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families; (h) the Madrid International Plan of Action on Ageing, 2002; (i) the World Programme of Action on Youth; and (j) the Political Declaration on HIV and AIDS: Intensifying our Efforts to Eliminate HIV and AIDS (General Assembly resolution 65/277, annex). Regional mandates that guide the subprogramme include the Incheon Strategy, the Bangkok Statement on the Asia-Pacific Review of the Implementation of the Madrid International Plan of Action on Ageing, the Bangkok Declaration on Beijing+15, the outcome document of the Asia-Pacific High-level Intergovernmental Meeting on the Assessment of Progress against Commitments in the Political Declaration on HIV/AIDS and the Millennium Development Goals and the Asian and Pacific Ministerial Declaration on Population and Development of the Sixth Asian and Pacific Population Conference, which was adopted by a vote.

## **Subprogramme 7**

### **Statistics**

#### **Strategy**

*Paragraph 16.39 of [A/69/6/Rev.1](#)*

75. Within the overall programme of work, the subprogramme will also link its work closely with that of other subprogrammes to support evidence-based policy analyses and advocacy. Capitalizing on the diversity in the region, the subprogramme will emphasize sharing of knowledge, experiences and solutions in developing and implementing regional initiatives to strengthen national statistical capacity by enhancing collaborative research and capacity development with regional think tanks, centres of excellence and leading national statistical offices. The subprogramme will make full use of the opportunities arising from the increased capacities of member States as centres of expertise and providers of development assistance, including through South-South cooperation modalities. The subprogramme will make conscious efforts to adapt its approaches to specific country circumstances and needs of member States. For least developed member States with more acute and widespread needs, this often means targeted support.

## **Subprogramme 8**

### **Subregional activities for development**

#### **Strategy**

*Paragraphs 16.41 and 16.42 of [A/69/6/Rev.1](#)*

76. The overall responsibility for coordinating the work of the subprogramme is vested in the Office of the Executive Secretary. The subprogramme will be implemented by the subregional offices in the Pacific, East and North-East Asia, North and Central Asia and South and South-West Asia, and by ESCAP headquarters in the South-East Asian subregion. Internationally agreed development goals, including the 2030 Agenda for Sustainable Development, the outcome of the

United Nations Conference on Sustainable Development and the programmes of action for the least developed countries, landlocked developing countries and small island developing States provide the mandates and strategic direction for the subprogramme.

77. Given the vast coverage and diversity of the Asian and Pacific region, the subprogramme, within the broad contours of its overall orientation, would strengthen the Commission's presence and strategic position at the subregional level, through strengthened coordination among substantive divisions, subregional offices and regional institutions, enabling better targeting and delivery of programmes that address specific key priorities of member States in the five subregions. Priority will be accorded to strengthening sustainable, equitable and inclusive development and supporting the integration of the least developed countries, landlocked developing countries and small island developing States for a resilient Asian and Pacific region. The subprogramme will also provide subregional perspectives in order to inform the Commission's normative and analytical work.

*Paragraphs 16.45-16.48 of A/69/6/Rev.1*

78. The subregional office for the Pacific, within the overall strategy and mandates and in coordination with the relevant subprogrammes, will work closely with the Council of Regional Organizations of the Pacific, and in particular the Pacific Islands Forum Secretariat, the Secretariat of the Pacific Community and the Secretariat of the Pacific Regional Environment Programme through the Sustainable Development Working Group, to assist member States in the following priority areas:

- (a) National sustainable development planning to address sustainable development in the Pacific;
- (b) Balanced integration of the economic, social and environmental dimensions of sustainable development;
- (c) Climate change, environmental degradation and management of the ocean;
- (d) Gender inequality.

79. The subregional office for East and North-East Asia, within the overall strategy and mandates and in coordination with the relevant subprogrammes, will work closely with major development partners in the subregion, including the Greater Tumen Initiative, to assist member States in the following priority areas:

- (a) Promoting subregional cooperation on green economy (in the context of sustainable development and poverty eradication) and subregional environmental challenges such as nature and marine conservation and transboundary air pollution, including through the North-East Asian Subregional Programme for Environmental Cooperation;
- (b) Facilitating subregional cooperation towards inclusive development while ensuring gender equality, in particular by leveraging the skills and knowledge of older persons, women, youth and persons with disabilities;
- (c) Enhancing transport and trade facilitation to promote economic growth and cooperation in East and North-East Asia;

(d) Strengthening disaster resiliency in East and North-East Asia through enhanced cooperation on technology and knowledge-sharing.

80. The subregional office for North and Central Asia, within the overall strategy and mandates and in coordination with the relevant subprogrammes, will work closely with the Economic Commission for Europe, as well as the Economic Cooperation Organization, the Eurasian Economic Commission, the Eurasian Development Bank, the International Fund for Saving the Aral Sea and the Shanghai Cooperation Organization to assist member States in the following priority areas:

(a) Subregional cooperation in transport, water and energy, trade, statistics, knowledge-based development and gender and economy through the United Nations Special Programme for the Economies of Central Asia;

(b) Transport and trade facilitation through improved transport links, transit transport and trade facilitation measures, and reduction of trade barriers;

(c) Energy and water resource management, environmental protection, disaster risk reduction and climate change adaptation.

81. The subregional office for South and South-West Asia, within the overall strategy and mandates and in coordination with the relevant subprogrammes, will work closely with the South Asian Association for Regional Cooperation, the Economic Cooperation Organization, the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation, international organizations, government agencies and civil society think tanks, among other stakeholders, to assist member States in the following priority areas:

(a) Accelerating inclusive and sustainable growth, poverty eradication, gender equality and universal access to quality education and health, in line with the 2030 Agenda for Sustainable Development;

(b) Subregional connectivity through transport, trade and transport facilitation and infrastructure investment for economic integration;

(c) Attainment of sustainable development goals on energy and food security through subregional cooperation;

(d) Subregional cooperation for increased capacity for disaster risk reduction strategies and policies;

(e) Assisting the least developed and landlocked countries of the subregion in accelerating inclusive development through increased productive capacity and achieving graduation from least developed country status.

## Subprogramme 9

### Energy

**Objective of the Organization:** To enhance energy security and the sustainable use of energy through improved regional cooperation in the attainment of internationally agreed development goals, including the 2030 Agenda for Sustainable Development

### Strategy

82. The substantive responsibility for the subprogramme is vested in the Energy Division. The strategic direction of the subprogramme is derived from internationally agreed development goals, including those contained in the outcome document of the United Nations Conference on Sustainable Development and General Assembly resolution 67/215 on the promotion of new and renewable sources of energy, in which the Assembly declared 2014-2024 the United Nations Decade of Sustainable Energy for All, as well as the Ministerial Declaration on Regional Cooperation for Enhanced Energy Security and the Sustainable Use of Energy in Asia and the Pacific: Shaping the Future of Sustainable Energy in Asia and the Pacific and its Plan of Action, as endorsed by the Commission in its resolution 70/9, and the implementation of the outcomes of the first Asian and Pacific Energy Forum. It would also be guided by General Assembly resolution 70/1 on the 2030 Agenda for Sustainable Development.

83. The subprogramme will focus on enhancing energy security and promoting the sustainable use of energy in Asia and the Pacific. Energy connectivity and use in the context of regional economic integration will also be considered. The subprogramme will promote policy dialogues and networking among member States so as to strengthen a regional cooperation framework for enhanced energy security. The subprogramme will support the implementation of the Asian and Pacific Energy Forum and other regional agreements and mandates, including the 2030 Agenda for Sustainable Development, and identify policy options and strategies for improved access to affordable, reliable and sustainable energy for all. It will also identify policies and strategies to promote investment in energy infrastructure and clean energy technologies. The ESCAP Committee on Energy will furthermore be

integrated into the preparatory process for the second Asian and Pacific Energy Forum (2018) and complement the implementation of the Sustainable Energy for All initiative at the regional level.

84. Evidence-based policy and trends analysis of issues highlighted in the outcome document of the Asian and Pacific Energy Forum, including sustainable energy for all, will allow identification of emerging issues and means to address new challenges. Ad hoc expert group meetings and policy dialogues will enable the review of such analysis, as well as direct consultation and guidance from technical experts and partners, in order to allow exploration of innovative approaches. Capacity-building will focus on specific issues identified through such analysis.

85. The subprogramme will be delivered in collaboration with international, regional, subregional and national institutions dealing with energy security and its sustainable use, with focus given to both research and regional cooperation.

Specifically, revisions are proposed under programme 17, Economic development in Europe, to paragraph 17.9 of the overall orientation; paragraph 17.17 of the strategy for subprogramme 1, Environment; subparagraph 17.19 (c) of the strategy for subprogramme 2, Transport; paragraph 17.23 of the strategy for subprogramme 3, Statistics; paragraph 17.26 of the strategy for subprogramme 4, Economic cooperation and integration; paragraph 17.33 of the strategy for subprogramme 5, Sustainable energy; paragraph 17.36 of the strategy for subprogramme 6, Trade; paragraph 17.41 of the strategy for subprogramme 7, Forestry and timber; and paragraph 17.51 of the strategy for subprogramme 8, Housing, land management and population.

## Overall orientation

*Paragraph 17.9 of [A/69/6/Rev.1](#)*

87. The programme will actively contribute to integrated and coordinated follow-up to and implementation of the outcomes of the major United Nations conferences and summits in the economic, social and environmental fields, including the United Nations Conference on Sustainable Development, the United Nations summit for the adoption of the post-2015 development agenda, which adopted the 2030 Agenda for Sustainable Development, the Third International Conference on Financing for Development, the Third United Nations Conference on Human Settlements, the 20-year review of the Beijing Programme for Action and the comprehensive 10-year review of the Almaty Programme of Action.

## Subprogramme 1 Environment

### Strategy

*Paragraph 17.17 of [A/69/6/Rev.1](#)*

88. Other activities will include the promotion of sustainable development in the region, as well as the implementation of the outcomes of the regional and global summits and conferences on environment and sustainable development, in particular the United Nations Conference on Sustainable Development and the 2030 Agenda for Sustainable Development.

## Subprogramme 2 Transport

### Strategy

*Subparagraph 17.19 (c) of [A/69/6/Rev.1](#)*

89. To achieve goals in the above four functional areas, the subprogramme will:

(c) Effectively follow up on the transport-related outcome of the United Nations Conference on Sustainable Development and contribute to the 2030 Agenda for Sustainable Development.

## Subprogramme 3 Statistics

### Strategy

*Paragraph 17.23 of [A/69/6/Rev.1](#)*

90. The subprogramme will work on priorities identified by the ECE member States, with a focus on the 2030 Agenda for Sustainable Development, in particular on measuring sustainable development; globalization; population, poverty and inequality; promoting modernization of statistical production, including the use of geospatial information; and capacity-building, taking into account recent

methodological and technological development in official statistics. Work will be undertaken in close cooperation with experts from ECE member States and international organizations through expert groups performing specific tasks within a set time frame and resulting in the development of methodological and practical guidelines, including training materials.

## **Subprogramme 4**

### **Economic cooperation and integration**

#### **Strategy**

*Paragraph 17.26 of [A/69/6/Rev.1](#)*

91. The Economic Cooperation, Trade and Land Management Division is responsible for implementing the subprogramme. The subprogramme will contribute to the follow-up to the United Nations Conference on Sustainable Development and to the 2030 Agenda for Sustainable Development by assisting ECE member States, particularly those with economies in transition, to create an enabling environment for innovation and competitiveness at the national and regional levels.

## **Subprogramme 5**

### **Sustainable energy**

#### **Strategy**

*Paragraph 17.33 of [A/69/6/Rev.1](#)*

92. The Sustainable Energy Division is responsible for implementing the subprogramme. The subprogramme will promote international policy dialogue and cooperation among Governments, energy industries and other stakeholders. This work will contribute to fostering sustainable energy development in States Members of the United Nations, improving their access to affordable and clean energy for all within the Sustainable Energy for All initiative of the Secretary-General and reducing greenhouse gas emissions and the carbon footprint of the energy sector. The subprogramme will focus on issues related to energy security, energy efficiency, cleaner electricity production from fossil fuels, renewable energy, coal mine methane, the United Nations Framework Classification related to energy and mineral reserves and resources and natural gas. The subprogramme will continue its energy security dialogue and contribute to the 2030 Agenda for Sustainable Development.

## **Subprogramme 6**

### **Trade**

#### **Strategy**

*Paragraph 17.36 of [A/69/6/Rev.1](#)*

93. The Economic Cooperation, Trade and Land Management Division is responsible for implementing the subprogramme. The subprogramme contributes to the establishment of an open, rule-based, predictable and non-discriminatory trading

system, especially in the ECE less economically developed and landlocked developing countries. It takes into account the international recognition of trade as a key vehicle for achieving sustained economic growth, the elimination of poverty and greater regional integration by United Nations summits and conferences on sustainable development and the 2030 Agenda for Sustainable Development.

## **Subprogramme 7 Forestry and timber**

### **Strategy**

*Paragraph 17.41 of [A/69/6/Rev.1](#)*

94. The subprogramme promotes the sustainable management of forests through the sound and legal use of forest products (including raw material, energy and forest ecosystem services), based on appropriate policies and institutions. Priorities for 2016-2017 will be guided primarily by the outcomes of the joint session of the ECE Committee on Forests and the Forest Industry and the FAO European Forestry Commission (Metsä 2013). The subprogramme supports the development of cross-sectoral and cross-institutional policies promoting sustainable forest management, and enhanced forest governance in line with the outcome of the United Nations Conference on Sustainable Development. Furthermore, the subprogramme contributes to the 2030 Agenda for Sustainable Development by supporting sustainable management of forests, soils and grasslands and by monitoring the status of forests and their effect on climate change mitigation.

## **Subprogramme 8 Housing, land management and population**

### **Strategy**

*Paragraph 17.51 of [A/69/6/Rev.1](#)*

95. The subprogramme will contribute to the 2030 Agenda for Sustainable Development in energy, environmental protection and other topics related to housing, urban planning, land management and population dynamics.

## **Programme 18**

### **Economic and social development in Latin America and the Caribbean**

96. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolution 70/1. Specifically, revisions are proposed under programme 18, Economic and social development in Latin America and the Caribbean, to paragraphs 18.3, 18.6, 18.16 and 18.17 of the overall orientation; paragraph 18.36 of the strategy for subprogramme 5, Social development and equality; subparagraph 18.45 (c) of the strategy for subprogramme 7, Population and development; paragraphs 18.49 and 18.51 of the strategy for subprogramme 8, Sustainable development and human settlements; paragraph 18.56 of the strategy for subprogramme 9, Natural resources and infrastructure; subparagraph 18.62 (c) of the strategy for subprogramme 10, Planning of public administration; paragraphs 18.68 and 18.70 of the strategy for subprogramme 11, Statistics; the objective and paragraph 18.73 of the strategy for subprogramme 12, Subregional activities in Central America, Cuba, the Dominican Republic, Haiti and Mexico; and paragraph 18.77 of the strategy for subprogramme 13, Subregional activities in the Caribbean.

### **Overall orientation**

#### *Paragraph 18.3 of [A/69/6/Rev.1](#)*

97. The Commission will continue to pursue key objectives shared by all the regional commissions, to support the development pillar of the United Nations, to foster economic integration at the subregional and regional levels, to promote the implementation of the 2030 Agenda for Sustainable Development and the resulting internationally agreed Sustainable Development Goals and to facilitate sustainable development by helping to bridge economic, social and environmental gaps between and among countries in the region and the industrialized economies.

#### *Paragraph 18.6 of [A/69/6/Rev.1](#)*

98. The main guidelines and overarching orientation for the formulation of the strategic framework for the biennium 2016-2017 were drawn from the internationally agreed development goals stemming from the major United Nations conferences and summits in the economic and social fields, the outcome document of the United Nations Conference on Sustainable Development (General Assembly resolution 66/288, annex), as well as the new set of Sustainable Development Goals deriving from the 2030 Agenda for Sustainable Development.

#### *Paragraphs 18.16 and 18.17 of [A/69/6/Rev.1](#)*

99. To that end, the Commission will emphasize analytical, normative, advocacy and capacity-building work to strengthen the design of sustainable development strategies and public policies and to facilitate the continuous monitoring of their practical implementation as part of the 2030 Agenda for Sustainable Development. Operational services in the areas of specialized information, technical cooperation and training will foster cooperation, networking and sharing of good practices at the subregional, regional and interregional levels, including South-South cooperation.

100. ECLAC will continue to work on the integrated and comprehensive follow-up to the world summits from a regional perspective, in particular the outcome of the United Nations Conference on Sustainable Development and in articulating the region's approach to the 2030 Agenda for Sustainable Development. For that purpose, ECLAC will reinforce its leading role as the convener of the regional coordination mechanism to coordinate the work programme of the specialized agencies, funds and programmes of the United Nations system in the region, which reports to the Economic and Social Council and to the General Assembly. The Commission will continue its active participation to foster substantive coordination among all participating entities in the Executive Committee on Economic and Social Affairs.

## **Subprogramme 5**

### **Social development and equality**

#### **Strategy**

*Paragraph 18.36 of [A/69/6/Rev.1](#)*

101. The Social Development Division will be responsible for the implementation of the subprogramme. It will work in close collaboration with other ECLAC divisions, in particular the Division for Gender Affairs and the Latin American and Caribbean Demographic Centre (CELADE), as well as with ECLAC subregional headquarters and national offices and with other agencies of the United Nations system. The strategy will take into account the internationally agreed development goals stemming from the major United Nations conferences in the economic and social fields, especially those deriving from the Rio+20 agenda and the 2030 Agenda for Sustainable Development.

## **Subprogramme 7**

### **Population and development**

#### **Strategy**

*Subparagraph 18.45 (c) of [A/69/6/Rev.1](#)*

102. Its strategy will be:

(c) To provide support to the countries of the region in the follow-up to the Programme of Action of the International Conference on Population and Development, in the fulfilment of the Strategy for the Implementation in Latin America and the Caribbean of the Madrid International Plan of Action on Ageing and in monitoring the goals and objectives stemming from the 2030 Agenda for Sustainable Development.

## **Subprogramme 8**

### **Sustainable development and human settlements**

#### **Strategy**

*Paragraph 18.49 of [A/69/6/Rev.1](#)*

103. The Sustainable Development and Human Settlements Division will be responsible for the implementation of the subprogramme and will work in close coordination with other ECLAC divisions and offices in order to mainstream the comprehensive approach to sustainable development in the work programme of the Commission, in particular with respect to climate change and the Sustainable Development Goals in the context of the 2030 Agenda for Sustainable Development.

*Paragraph 18.51 of [A/69/6/Rev.1](#)*

104. The second covers the sustainability of the human settlements, encompassing issues such as urban development, sustainable cities, land use and metropolitan areas. The United Nations Conference on Housing and Sustainable Urban Development (Habitat III), which will be one of the first global conferences after the approval of the 2030 Agenda, will be held in 2016. The subprogramme will participate in the process by making proposals to face the upcoming challenges. In addition, the support to the Regional Meeting of Ministers and High-level Authorities of the Housing and Urban Development Sector in Latin America and the Caribbean will be crucial for the appropriation of Habitat III outcomes in the region.

## **Subprogramme 9**

### **Natural resources and infrastructure**

#### **Strategy**

*Paragraph 18.56 of [A/69/6/Rev.1](#)*

105. The Natural Resources and Infrastructure Division will be responsible for implementing the subprogramme, in close coordination with other ECLAC divisions and offices, in particular the Division of International Trade and Integration, the Financing for Development Division, the Sustainable Development and Human Settlements Division, the Division of Production, Productivity and Management and the subregional headquarters in Mexico. The strategy will include providing stakeholders of the region with analytical studies and systematized information and data in terms of regulation and management of natural resources and the provision of public utility and infrastructure services in the context of the Sustainable Development Goals and the 2030 Agenda for Sustainable Development.

## **Subprogramme 10**

### **Planning of public administration**

#### **Strategy**

*Subparagraph 18.62 (c) of [A/69/6/Rev.1](#)*

106. ILPES will concentrate its research activities and technical cooperation and training efforts in fostering a new thinking on regional integration and cooperation, in particular regarding:

(c) Coordination among levels of government, from the global development agenda to regional, national and local action, including the territorial expression of the 2030 Agenda for Sustainable Development; the decentralization and strengthening of local development capabilities; structural change and regional convergence; gender mainstreaming in budget planning; land-use planning; and valuing of environmental public goods.

## **Subprogramme 11**

### **Statistics**

#### **Strategy**

*Paragraph 18.68 of [A/69/6/Rev.1](#)*

107. Two important features of the subprogramme strategy should be stressed. On the one hand, the activities will be carried out in close coordination with the Statistical Conference of the Americas of ECLAC. The activities of the subprogramme reflect the thematic priorities identified by the Conference, as it considers national accounts, environmental accounts, economic and environmental statistics, the 2030 Agenda for Sustainable Development, broader measures of welfare and social indicators. The subprogramme will act as coordinator of regional and global activities, including joint actions with the Statistics Division of the Department of Economic and Social Affairs, the regional commissions and other United Nations entities working in the area of statistics. Collaboration with other international agencies (such as IADB, ILO, IMF, the World Bank and WTO) and international expert groups, such as the Intersecretariat Working Group on National Accounts, will be also envisaged. The subprogramme will convey the experience and interests of the subregion in global events, such as the United Nations Statistical Commission and the Committee for the Coordination of Statistics Activities.

*Paragraph 18.70 of [A/69/6/Rev.1](#)*

108. Regarding the joint work with other ECLAC divisions, special attention will be paid to the implementation of gender-sensitive indicators in collaboration with the Division of Gender Affairs; support in the use of economic indicators and demographic data in collaboration with the Economic Development and Population divisions, respectively, the provision of data from household surveys and other social indicators to the Social Development Division, the development of environmental indicators in collaboration with the Sustainable Development and Human Settlements and the Natural Resources and Infrastructure divisions, and the

provision of relevant information to monitor the progress of the region to attain the 2030 Agenda for Sustainable Development.

## **Subprogramme 12**

### **Subregional activities in Central America, Cuba, the Dominican Republic, Haiti and Mexico**

---

**Objective of the Organization:** To achieve dynamic growth and sustainable, inclusive and equitable development within a robust and democratic institutional framework and to fulfil the internationally agreed development goals, including those set forth as a result of the 2030 Agenda for Sustainable Development

---

#### **Strategy**

*Paragraph 18.73 of [A/69/6/Rev.1](#)*

109. This subprogramme, which focuses on the countries of the Central American isthmus, Cuba, the Dominican Republic, Haiti and Mexico, will be executed by the ECLAC subregional headquarters in Mexico in close coordination with other ECLAC divisions and offices. The strategy to be followed will take special account of the relevant provisions of internationally agreed development goals, including those resulting from the 2030 Agenda for Sustainable Development, in particular regarding the eradication of extreme poverty and hunger, the promotion of gender equality and women's empowerment, ensuring environmental sustainability and building a global partnership for development.

## **Subprogramme 13**

### **Subregional activities in the Caribbean**

#### **Strategy**

*Paragraph 18.77 of [A/69/6/Rev.1](#)*

110. The strategy is built on four pillars. First, implementation of the activities will occur within the context of coordination and collaboration with other divisions of ECLAC and the wider United Nations system. Secondly, as the secretariat for the Caribbean Development and Cooperation Committee, the subregional headquarters for the Caribbean will, through alignment with the guidance provided by the Committee and the identification of priority areas and development challenges, ensure continued relevance to the needs of the subregion. Thirdly, within the context of the internationally agreed development goals, the activities will facilitate the active engagement of Caribbean countries in the follow-up to global conferences, including those deriving from the 2030 Agenda for Sustainable Development. Fourthly, a multidisciplinary approach will be pursued in responding to the development needs of the countries served by the subprogramme, through the following: (a) financing for development, fiscal management and market diversification, within the context of assimilating Caribbean economies into the global economy; (b) broadening the monitoring mechanism for measuring progress in the implementation of the Mauritius Strategy; (c) facilitating wider application of information and communications technology for development and knowledge

management; (d) enhancing the role of social development within the context of the broader sustainable development process; and (e) strengthening the statistical capacity of Caribbean countries to support more effective evidence-based policymaking.

112. In line with General Assembly resolution 69/313, revisions are proposed to the objective, indicator of achievement (d) (i) and paragraph 19.41 of the strategy for subprogramme 3, Economic development and integration; and to expected accomplishment (b) of subprogramme 4, Technology for development and regional integration.

113. In line with General Assembly resolution 70/1, revisions are proposed under the overall orientation, specifically to paragraphs 19.5, 19.7, 19.8, and 19.25; paragraphs 19.32 and 19.34 of the strategy for subprogramme 1, Integrated management of natural resources for sustainable development; the addition of a new expected accomplishment (d) with two related indicators of achievement, and revisions to paragraph 19.37 of the strategy for subprogramme 2, Social development; paragraph 19.42 of the strategy for subprogramme 3; expected accomplishment (a) and related indicator of achievement (i) of subprogramme 4, Technology for development and regional integration; and expected accomplishment (c) of subprogramme 5, Statistics for evidence-based policymaking.

### **Overall orientation**

#### *Paragraph 19.5 of [A/69/6/Rev.1](#)*

114. As the regional arm of the United Nations, ESCWA will continue to foster economic integration at the subregional and regional levels, to promote the regional implementation of internationally agreed development goals, including the 2030 Agenda for Sustainable Development, and to support regional sustainable development by addressing economic, social and environmental policy gaps in its member States.

*Paragraph 19.7 of A/69/6/Rev.1*

115. The mandates resulting from the 2030 Agenda for Sustainable Development will have a considerable impact on the work of ESCWA in the biennium 2016-2017.

*Paragraph 19.8 of A/69/6/Rev.1*

116. To address regional and global priorities established under the 2030 Agenda for Sustainable Development, ESCWA engaged in an extensive process of internal consultations for this proposed strategic framework to ensure that it will contribute to its four-year vision (2015-2019).

*Paragraph 19.25 of A/69/6/Rev.1*

117. The outcome document of the United Nations Conference on Sustainable Development (Rio+20) asserted the need for comparable, reliable statistics on sustainable development. Member States and the relevant bodies of the United Nations system, within their respective mandates, have supported the regional commissions in collecting and compiling official statistics. Member States have also committed to mobilizing financial resources and building the capacity of developing countries to produce statistical data related to the 2030 Agenda for Sustainable Development and the Sustainable Development Goals.

## **Subprogramme 1**

### **Integrated management of natural resources for sustainable development**

#### **Strategy**

*Paragraph 19.32 of A/69/6/Rev.1*

118. The Sustainable Development Policies Division will implement the subprogramme. The interrelated and complex challenges and current social and political tensions provide a sense of urgency for concerted efforts to strengthen the interlinkages between the economic, social and environmental pillars of sustainable development. Regional challenges include rise in demand for food, water and energy, leading to unsustainable use of resources and food insecurity; unsustainable production and consumption patterns; and inefficient energy use in key productive and consuming sectors, as well as climate change and its impact on natural resources.

*Paragraph 19.34 of A/69/6/Rev.1 (new subparagraph (f))*

119. ESCWA will:

(f) Support member States in the alignment of national plans in the fields of water, energy and food security to the 2030 Agenda for Sustainable Development and the Sustainable Development Goals;

(g) Foster regional approaches on climate change adaptation and mitigation by supporting the development of mechanisms to deal with climate change impacts, including those on the implementation of the Sustainable Development Goals, as well as examine impact and vulnerability assessments and associated socioeconomic and environmental issues to inform the policymaking processes, and to support member States in their negotiations and policy design.

### Social development

**Objective of the Organization:** To enhance the capacity of member States to adopt and implement rights-based social policies that promote social justice and lead to equitable, inclusive and participatory socioeconomic development

120. This subprogramme is implemented by the Social Development Division. During the biennium 2016-2017, ESCWA will build on the experience gained during the previous bienniums to advocate the principles of social justice as a guiding framework for public policymaking. Specific attention will be paid to: promoting and implementing policies that foster social inclusion and social protection and address the social dimensions of poverty; mainstreaming key population and human development issues into policymaking, focusing on youth development and international migration; and upholding participatory development and civic engagement. The subprogramme will also address the capacity needs of member States to implement, follow-up and review the 2030 Agenda for Sustainable Development, with a particular focus on Sustainable Development Goals pertaining to the social dimension of sustainable development.

121. The Economic Development and Globalization Division is responsible for the subprogramme. The legislative mandates for this subprogramme are: the 2013 report of the Secretary-General on global economic governance and development (A/67/769), the Second United Nations Decade for the Eradication of Poverty (2008-2017), the outcome documents of the International Conferences on Financing for Development, comprising the Monterrey Consensus, the Doha Declaration on Financing for Development and the Addis Ababa Action Agenda, the 2030 Agenda on Sustainable Development, the Integrated Transport System in the Arab Mashreq and the relevant resolutions of the General Assembly, the Economic and Social Council and ESCWA.

122. ESCWA will promote equitable growth and sustainability, regional integration and economic governance by supporting member States in reforming economic institutions and developing and implementing policies based on good governance; designing and implementing pro-poor rights and evidence-based economic plans and policies; working towards creating and improving access to decent and competitive jobs for men and women; fostering policies and implementation mechanisms aimed at economic policy convergence; and enhancing regional integration, which can accelerate progress towards implementing the 2030 Agenda on Sustainable Development.

## Overall orientation

*Paragraphs 20.1 and 20.2 of A/69/6/Rev.1*

124. The overarching objective of the United Nations human rights programme is to promote and protect the effective enjoyment by all of all human rights. Its mandate derives from Articles 1, 13, 55 and 62 of the Charter of the United Nations; the Vienna Declaration and Programme of Action, including its principles and recommendations, adopted by the World Conference on Human Rights and subsequently endorsed by the General Assembly in its resolution 48/121; Assembly resolution 48/141 establishing the post of the United Nations High Commissioner for Human Rights; international human rights instruments adopted by the United Nations; the outcomes of relevant United Nations conferences and summits; and the resolutions and decisions of policymaking bodies, including, in particular, Assembly resolutions 57/300, on strengthening of the United Nations: an agenda for further change, 60/1 on the 2005 World Summit Outcome and 60/251 and 65/281 on the Human Rights Council and its review, and 70/1, entitled “Transforming our world: the 2030 Agenda for Sustainable Development”. The Office of the United Nations High Commissioner for Human Rights (OHCHR) will also be guided by international humanitarian law, as applicable.

125. The programme is guided by the principles of universality, objectivity, impartiality, indivisibility and non-selectivity in removing obstacles to the full realization of all human rights and in preventing the continuation of human rights violations, including with relevant parties. It undertakes to give practical effect to the will and resolve of the world community, as expressed through the United Nations, including in the 2005 World Summit Outcome and the 2030 Agenda for Sustainable Development, which sets forth 17 Sustainable Development Goals and 169 targets that seek to realize the human rights of all and to achieve gender equality and the empowerment of all women and girls, to ensure that all human beings can fulfil their potential in dignity and equality and in a healthy environment and to leave no one behind. They build upon the achievements of the Millennium Development Goals, set out in General Assembly resolutions 55/2 and 65/1. The United Nations human rights programme has a role in making development equitable, sustainable and responsive to the needs of people and in relation to conflict prevention and resolution.

## Subprogramme 1

### Human rights mainstreaming, right to development, and research and analysis

#### B. Right to development

##### Strategy

*Subparagraphs 20.10 (d) and (e) of A/69/6/Rev.1*

126. This part of the subprogramme will pursue a multidimensional strategy to support the implementation of the right to development in accordance with the Declaration on the Right to Development, the Vienna Declaration and Programme of Action and other relevant mandates. The strategy will focus on:

(d) Encouraging the promotion and protection of the right to development in global development partnerships, as reflected in the Sustainable Development Goals, through advocacy, networking, technical advice and the establishment of partnerships and other kinds of cooperation;

(e) Promoting the implementation of the right to development in technical assistance to requesting States and, taking into account a human rights-based approach, in national development strategies, such as poverty reduction strategy papers, where they exist, national Sustainable Development Goals strategies and United Nations development frameworks, through close cooperation with Member States and United Nations agencies, funds and programmes.

##### Strategy

*Subparagraph 20.11 (a) of A/69/6/Rev.1*

127. This part of the subprogramme will be responsible for enhancing the research and analysis of human rights issues, problems and challenges, and the development and application of expertise on human rights themes and methodologies. It will be responsible for the consolidation, further development and strengthening of substantive human rights expertise to support effective engagement with countries and global and national-level partnerships, and to lead efforts within the United Nations system to meet current human rights challenges. Strengthened expertise will be used to support States' efforts in overcoming human rights implementation gaps and will provide the basis for OHCHR to work on technical cooperation, advocacy, training, policy development, analysis, protection and advice to partners at all levels. The strategy will focus on:

(a) Advocacy for the indivisibility, interdependence and interrelatedness of all human rights by enhancing substantive and methodological expertise; the

promotion and protection of all human rights; the development and consolidation of partnerships for strengthening national capacity in the areas of the rule of law, democracy and good governance at all levels; human rights-based approaches to development, counter-terrorism and anti-trafficking measures as well as to the implementation of the Sustainable Development Goals and poverty reduction strategies and programmes; the protection of human rights in the context of the fight against terrorism; the protection of human rights in the context of business activities; contributing to the elimination of all forms of discrimination, racism, including its contemporary forms, racial discrimination, xenophobia and related intolerance; and strengthening respect for the enjoyment of all human rights and fundamental freedoms by everyone, inter alia, by combating discrimination.

128. Modifications to the biennial programme plan for the period 2016-2017 take into account General Assembly resolution 70/1. Specifically, revisions are proposed under programme 22, Palestine refugees, to paragraph 22.6 of the overall orientation.

129. UNRWA strategy is aligned with the Sustainable Development Goals. Poverty and human rights, which are major components of the Goals, are also at the core of the UNRWA medium-term strategy. With respect to the former, both the Goals and the medium-term strategy recognize that poverty is multidimensional and that its mitigation and eradication can be achieved only through a coordinated, multisectoral response. The Goals focus on achieving food security, attaining gender equality, achieving peaceful and inclusive societies, responding to changing health needs, attaining equitable and inclusive quality education, water and sanitation, and reducing inequalities, among other things.
