

General and complete disarmament: taking forward multilateral nuclear disarmament negotiations

Report of the United Nations conference to negotiate a legally binding instrument to prohibit nuclear weapons, leading towards their total elimination

I. Introduction

1. In its resolution 71/258 of 23 December 2016, the General Assembly decided to convene in New York, under the rules of procedure of the General Assembly unless otherwise agreed by the conference, a United Nations conference to negotiate a legally binding instrument to prohibit nuclear weapons, leading towards their total elimination, from 27 to 31 March and from 15 June to 7 July 2017, with the participation and contribution of international organizations and civil society representatives. In addition, the General Assembly decided that the conference would hold a one-day organizational session in New York, to be held as soon as possible after the adoption of the resolution. The organizational session was held on 16 February 2017.

II. Organizational matters and proceedings of the conference

A. Opening and duration of the conference

- 2. The United Nations conference to negotiate a legally binding instrument to prohibit nuclear weapons, leading towards their total elimination, was convened at United Nations Headquarters on 16 February 2017, 27 to 31 March 2017, and 15 June to 7 July 2017. The list of participants is contained in document A/CONF.229/2017/INF.4.
- 3. The conference was opened on 16 February 2017 by the Secretary-General of the conference and Director and Deputy to the High-Representative for Disarmament Affairs, Thomas Markram. At the same session, Elayne Whyte Gómez (Costa Rica) was elected President of the conference. The Acting President of the General Assembly, Masud Bin Momen (Bangladesh) and the High Representative for Disarmament Affairs, Kim Won-soo, made statements at the opening of the conference.







4. The conference held its organizational session on 16 February, during which two plenary meetings and one informal meeting were convened. At its first plenary meeting, the conference took decisions related to the agenda of its organizational session and of the March and June sessions of the conference (see paras. 6 and 7). The conference also took note of the draft indicative timetable for the meetings of its March session (A/CONF.229/2017/3). At the second meeting of its organizational session, the conference adopted a decision regarding the modalities and arrangements for participation by non-governmental organizations (A/CONF.229/2017/4).

B. Rules of procedure

5. At the 2nd meeting of the March session, on 27 March, the conference adopted its rules of procedure (A/CONF.229/2017/L.1), as orally revised, which was subsequently issued as document A/CONF.229/2017/5.

C. Agenda and organization of work

- 6. At the 1st meeting of its organizational session, on 16 February, the conference adopted the agenda of its organizational session (A/CONF.229/2017/1), as orally revised, as follows:
 - 1. Opening of the session.
 - 2. Election of officers.
 - 3. Adoption of the agenda.
 - 4. Organizational matters:
 - (a) Draft provisional agenda of the conference;
 - (b) Draft proposed organization of work of the conference;
 - (c) Draft provisional rules of procedure of the conference;
 - (d) Credentials of representatives to the conference;
 - (e) Arrangements for the accreditation and participation of international organizations, United Nations agencies, funds and programmes and civil society representatives.

 - 7. Closure of the session.
- 7. At the same meeting, the conference adopted the provisional agenda of the conference (A/CONF.229/2017/2) as follows, on the understanding that an additional sub-item might be added under item 11.
 - 1. Opening of the conference.
 - 2. Election of the President.
 - 3. Adoption of the agenda.
 - 4. Adoption of the rules of procedure.
 - 5. Organization of work.
 - 6. Election of other officers.

- 7. Credentials of representatives to the conference:
 - (a) Appointment of members of the Credentials Committee;
 - (b) Report of the Credentials Committee.
- 8. General exchange of views:
 - (a) High-level segment;
 - (b) General exchange of views on all matters.
- 9. Negotiations, pursuant to paragraph 8 of General Assembly resolution 71/258 of 23 December 2016, on a legally binding instrument to prohibit nuclear weapons, leading towards their total elimination.
- 10. Other matters.
- 11. Adoption of the report of the conference.
- 12. Closure of the conference.
- 8. At its 10th, 11th, 20th and 23rd plenary meetings, on 31 March, 15 June, 23 June and 30 June, the conference considered the indicative timetable for meetings of the conference at its second substantive session, as proposed by the President (A/CONF.229/2017/3/Add.1 and Add.1/Rev.1, A/CONF.229/2017/3/Add.2 and A/CONF.229/2017/3/Add.3).

III. Credentials

- 11. Pursuant to rule 4 of the rules of procedure of the conference (A/CONF.229/2017/5), according to which the Credentials Committee shall be composed of five members, the conference appointed Azerbaijan, Malawi, Paraguay, Sri Lanka and Sweden as members of its Credentials Committee.
- 12. At the 28th meeting of the conference, on 7 July, the Chair of the Credentials Committee introduced the report of the Committee (A/CONF.229/2017/7), in which the Committee reported that it had examined the credentials of the representatives of States participating in the conference and found them to be in order. The Chair also

informed the conference that, since the formal meeting of the Committee, credentials in the form required by rule 3 of the rules of procedure of the conference had been received from Haiti and that other information concerning the appointment of representatives of States to the conference had been received from Chad, Equatorial Guinea, Eritrea, Grenada, Sierra Leone and Timor-Leste. The conference adopted the draft resolution recommended by the Credentials Committee in paragraph 14 of its report, and accepted the additional credentials mentioned by the Chair of the Credentials Committee.

IV. Consideration and adoption of the final documents of the conference and the report of the conference to the General Assembly

- 13. The conference held 29 plenary meetings from 27 to 31 March and 15 June to 7 July 2017, at which it considered and negotiated the text of the legally binding instrument to prohibit nuclear weapons, leading towards their total elimination under agenda item 9.
- 14. At its 28th meeting, on 7 July, the conference adopted the text of the Treaty on the Prohibition of Nuclear Weapons by 122 votes to 1, with 1 abstention (A/CONF.229/2017/8). The Treaty will be open for signature to all States at United Nations Headquarters in New York as from 20 September 2017. After the vote, statements in explanation of vote were made by the representatives of El Salvador (on behalf of the Community of Latin American and Caribbean States), Lebanon (on behalf of the Arab Group), South Africa, Trinidad and Tobago (on behalf of the Caribbean Community), Cuba, Chile, Colombia, Costa Rica, the Bolivarian Republic of Venezuela, the Islamic Republic of Iran, the State of Palestine, Brazil, Ecuador, Paraguay, Malaysia, Peru, Argentina, Indonesia, Kazakhstan, the Holy See, Liechtenstein, Egypt, Switzerland, Sweden, the Netherlands, Nigeria, Austria, Singapore, Guatemala, the Marshall Islands, the Philippines (also on behalf of the Association of Southeast Asian Nations), Thailand, Algeria, Panama, Trinidad and Tobago, Uruguay, Ireland and the Plurinational State of Bolivia.
- 15. At its 29th meeting, on 7 July, the conference adopted its report to the General Assembly by consensus.
