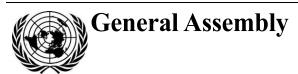

Proposed programme budget for the biennium 2018-2019

Revised estimates relating to the Office of the Victims' Rights Advocate under section 1, Overall policymaking, direction and coordination, section 29D, Office of Central Support Services, and section 36, Staff assessment

Report of the Secretary-General

Summary

The present report is submitted pursuant to the adoption by the General Assembly of resolution 71/297, whereby the Assembly welcomed the steps taken to introduce victims' assistance support functions at Headquarters and in the field, and looked forward to future proposals from the Secretary-General in this regard. The present report contains the revised estimates proposed under section 1, Overall policymaking, direction and coordination, section 29D, Office of Central Support Services, and section 36, Staff assessment, of the proposed programme budget for the biennium 2018-2019, in the additional amount of \$1,326,500 net (\$1,431,500 gross).







I. Introduction

- 1. In his report entitled "Special measures for protection from sexual exploitation and abuse: a new approach" (A/71/818), the Secretary-General pledged to lead the collective effort, across the United Nations system, to stand up against sexual exploitation and abuse in all its forms, placing the victims at the heart of all United Nations efforts to prevent and respond to this scourge. The centrepiece of the Secretary-General's strategy is elevating the voice of victims and putting their rights and dignity at the forefront of United Nations efforts to combat sexual exploitation and abuse.
- 2. In paragraph 11 and 12 of its resolution 71/297, the General Assembly welcomed the steps taken to introduce victims' assistance support functions at Headquarters and in the field and emphasized the importance of providing expeditious support to victims of sexual exploitation and abuse, as well as the need to identify gaps, lessons learned and to develop recommendations for an integrated system-wide approach in accordance with its resolution 62/214.
- 3. The key priority of the Organization is strengthening support for victims and promoting reliable recourse to justice. To accomplish this, the Secretary-General proposed the creation of a position of Victims' Rights Advocate at the Assistant Secretary-General level, to be supported by a small staff.
- 4. The Victims' Rights Advocate will work across the United Nations system to develop an integrated strategic response to ensure that reliable gender- and child-sensitive mechanisms exist to enable a victim or a witness to file complaints, that assistance is rapidly delivered and that information on the progress of the case is conveyed to the victim in a timely manner.
- 5. The Victims' Rights Advocate will also work closely with government institutions, civil society and national legal and human rights organizations in both host countries and the countries of alleged perpetrators to build networks of support and to help ensure that the full effects of local laws, including remedies for victims, are brought to bear. Such networks will also help to maintain updated information on judicial and administrative proceedings to help ensure that victims have access to those proceedings and that their rights are protected. The Victims' Rights Advocate will invite external experts, advocates and leading aid organizations to inform the development of policies and tools to strengthen support for victims.
- 6. In the addendum to his report (A/71/818/Add.1), the Secretary-General informed the General Assembly of a requirement for additional resources, under the programme budget for the biennium 2016-2017, for four temporary positions (1 Victims' Rights Advocate (Assistant Secretary-General)), 1 Human Rights Officer (P-4), 1 Political Affairs Officer (P-3) and 1 Administrative Assistant (General Service (Other level)) for the second half of 2017, as well as other related non-post costs. In its resolution 71/297, the General Assembly endorsed the conclusions and recommendations contained in the related report of the Advisory Committee on Administrative and Budgetary Questions (A/71/867).

In his report, the Secretary-General proposed a four-part strategy: (a) putting the rights and dignity of victims first; (b) ending impunity for those guilty of sexual exploitation and abuse; (c) building a multi-stakeholder network to support the United Nations effort to prevent and respond to sexual exploitation and abuse by engaging more directly and continuously with civil society, as well as with external experts and organizations; and (d) reorienting the United Nations approach to strategic communications to raise awareness worldwide regarding the problem of sexual exploitation and abuse, to address the stigma and discrimination that victims face.

- 7. Furthermore, the Secretary-General proposed the establishment of four temporary positions of Victims' Rights Advocate (P-5), one each at the following four peacekeeping missions: the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic, the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo, the United Nations Stabilization Mission in Haiti and the United Nations Mission in South Sudan. The estimated requirements in respect of the four positions and related non-post costs amount to \$1,180,000 for the financial period from 1 July 2017 to 31 June 2018, which, the Secretary-General indicated, will be absorbed within the budgets of the respective peacekeeping missions for the financial period 2017/18. Any resources with respect to victims' assistance functions at field missions for the period from 1 July 2018 to 30 June 2019 will be presented in the relevant proposed budgets for consideration by the General Assembly at the second part of its resumed seventy-second session.
- 8. The Office of the Victims' Rights Advocate will be placed under section 1, Overall policymaking, direction and coordination, as part of the Office of the Special Coordinator on Improving the United Nations Response to Sexual Exploitation and Abuse, given the broad scope of its mandate. The Victims' Rights Advocate will report to the Secretary-General through the Special Coordinator, who in turn reports to the Secretary-General through the Chef de Cabinet. Currently, there are no existing resources devoted to victims' rights across the Secretariat or in other relevant entities and no resources are available in the programme budget for addressing sexual exploitation and abuse are available from peacekeeping and extrabudgetary sources.
- 9. The present report contains additional resource requirements for the biennium 2018-2019 under section 1, Overall policymaking, direction and coordination, section 29D, Office of Central Support Services, and section 36, Staff assessment, arising from resolution 71/297, reflecting biennial resources (\$1,326,500 net of staff assessment (\$1,431,500, gross)).

II. Relationship of the current proposals to the proposed programme budget for the biennium 2018-2019

10. The current proposals relate to section 1, Overall policymaking, direction and coordination, section 29D, Office of Central Support Services, and section 36, Staff assessment, of the proposed programme budget for the biennium 2018-2019.

III. Budgetary implications of the establishment of the Office of the Victims' Rights Advocate

11. Additional resource requirements for the proposals contained in the present report for the biennium 2018-2019 amount to \$1,326,500 (net of staff assessment), as summarized in tables 1-8.

IV. Office of the Victims' Rights Advocate

12. The Office of the Victims' Rights Advocate will support, monitor and align an integrated strategic response to victim assistance and support in coordination with United Nations system actors in the field and at Headquarters in accordance with General Assembly resolution 62/214 and the report of the Secretary-General entitled "Special measures for protection from sexual exploitation and abuse: a new approach" (A/71/818). Responsibility for the implementation of the mandate rests with component J, Office of the Victims' Rights Advocate, under section 1, Overall policymaking, direction and coordination, of the proposed programme budget for the biennium 2018-2019.

13. The Office of the Victims' Rights Advocate is expected to achieve its objective and expected accomplishments on the assumption that: (a) governmental institutions, civil society and national legal and human rights organizations collaborate to build networks of support, help ensure that the full effects of local laws, including remedies for victims, are brought to bear and are willing to strengthen coordination in promoting protection measures for victims during investigations and disciplinary/administrative proceedings; and (b) United Nations

system actors coordinate and support an integrated, strategic response to victims' rights and assistance.

16. The amount of \$933,700 would provide for four posts (1 Assistant Secretary-General, 1 P-4, 1 P-3 and 1 General Service (Other level)) and non-post requirements to support the implementation of the mandate of the Office. The non-post resources comprise travel of staff (\$103,400) and operational costs such as contractual services, covering the standard cost of service-level agreements for maintenance support services and other services provided by the Office of Information and

Communications Technology (\$16,800), general operating expenses, including the rental of office equipment and communications services (\$5,100), supplies and materials, for stationery and office supplies (\$4,000), and furniture and equipment, for the acquisition of office automation equipment (\$7,500).

- 17. During the biennium 2018-2019, it is proposed that the following four posts be established:
- (a) Victims' Rights Advocate (Assistant Secretary-General): the incumbent of the post would support an integrated, strategic response to victim assistance in coordination with United Nations system actors with responsibility for assisting victims in accordance with General Assembly Resolution 62/214;
- (b) Human Rights Officer (P-4): the incumbent of the post would work with relevant entities across the United Nations system to develop mechanisms and policies system-wide that promote reliable and gender- and child-sensitive processes enabling a victim or witness to file complaints, facilitate the rapid and sensitive delivery of assistance and help ensure access to appropriate and timely judicial processes;
- (c) Political Affairs Officer/Special Assistant (P-3): the incumbent of the post would serve as Special Assistant to the Victims' Rights Advocate and support the implementation of the Office's mandate;
- (d) Administrative Assistant (General Service (Other level)): The incumbent of the post would support the Office of the Victims' Rights Advocate in the overall administration of the Office, including by providing substantive support.

18. The revised resource requirements for the Office of Central Support Services are reflected in table 8.

19. The proposed additional resources under non-post items, amounting to \$392,800, would provide for the rental of premises and non-recurrent requirements for furniture and equipment related to the four proposed posts.

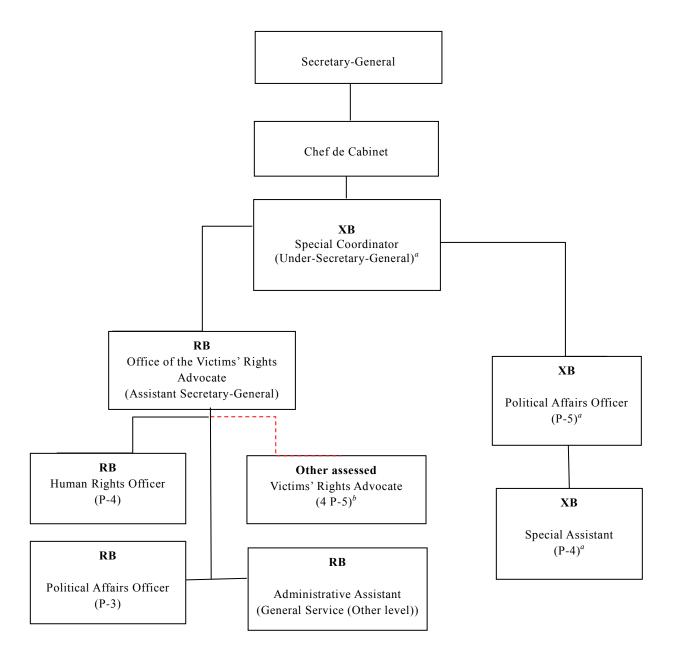
V. Conclusions and recommendations

- 20. The General Assembly is requested:
- (a) To approve the additional resources proposed in the amount of \$1,326,500 (net of staff assessment);
- (b) To approve the establishment of the four posts, comprising one Assistant Secretary-General, one P-4, one P-3 and one General Service (Other level), under section 1, Overall policymaking, direction and coordination;
- (c) To appropriate an additional amount of \$1,326,500 (net of staff assessment) under section 1, Overall policymaking, direction and coordination (\$933,700), and section 29D, Office of Central Support Services (\$392,800), of the programme budget for the biennium 2018-2019, which would represent a charge against the contingency fund;
- (d) To appropriate an additional amount of \$105,000 under section 36, Staff assessment, to be offset by an equivalent amount under income section 1, Income from staff assessment, of the proposed programme budget for the biennium 2018-2019.
