Overall orientation

- 9.1 The overall objective of the programme is to promote and support international cooperation in the pursuit of sustainable development for all. While focused on tackling interlinked challenges in the social, economic and environmental fields, the programme also seeks to contribute to a mutually reinforcing relationship among the three pillars of the United Nations work: peace and security, development and human rights.
- 9.2 The programme, which is under the responsibility of the Department of Economic and Social Affairs, ensures complementarity and synergy among its nine subprogrammes. Its key programmatic thrusts are: (a) to provide substantive support to the bodies established under the Charter of the United Nations dealing with development issues, namely, the General Assembly, the Economic and Social Council and its related functional commissions, and expert bodies; (b) to monitor and analyse development trends, prospects and policy issues globally; and (c) to provide support for capacity development in policy formulation and implementation, in particular in relation to the implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals, through, inter alia, the implementation of the regular programme of technical cooperation and Development Account projects.

Note: The following abbreviations are used in tables and charts: ASG, Assistant Secretary-General; GS, General Service; OL, Other level; PL, Principal level; RB, regular budget; USG, Under-Secretary-General; XB, extrabudgetary.

- 9.3 In the biennium 2018-2019, the programme will continue to mobilize and provide practical support to help to translate the development commitments into action. To further enhance its key programmatic thrusts, it will focus on the delivery of the following functions: (a) monitoring, research and analysis of development issues and emerging challenges, including through support for the global statistical system; (b) normative and policy support for United Nations intergovernmental processes; (c) assistance in capacity development to support the implementation of global conference outcomes at the country level; and (d) fostering collaboration and partnerships within the United Nations system and with civil society and the private sector, while ensuring proper accountability and oversight by Member States. Increased attention will be given to capacity development needs of the least developed countries, small island developing States and countries emerging from conflict.
- 9.4 The programme has placed development issues at the centre of global deliberations and helped Member States to forge a shared vision of development, as identified in the outcomes of major United Nations conferences and summits. The programme will continue to support the implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals, and its follow-up process, as well as the follow-up to and implementation of the outcomes of the Addis Ababa Action Agenda on financing for development.
- 9.5 Fulfilling those functions requires strengthened analytical and monitoring capacity to identify and address emerging issues and cross-cutting policy challenges and to support both national development strategies and accountability and monitoring mechanisms at the intergovernmental level. Strategic integration is also essential to promoting a coherent and coordinated implementation process in advancing the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals. This includes enhancing horizontal linkages across the subprogrammes to facilitate more effective and flexible support for Member States in pursuing the 2030 Agenda, including the Sustainable Development Goals, in cooperation with entities of the Executive Committee on Economic and Social Affairs, to which the programme provides strategic support and ensures its stronger linkages with the United Nations Development Group, other executive committees and various other partners.
- 9.6 The programme will continue to emphasize the mainstreaming of gender perspectives in its subprogrammes.

Overview of resources

- 9.7 The overall resources proposed for the biennium 2018-2019 for this section amount to \$171,266,474 before recosting, reflecting a net increase of \$9,118,874, or 5.6 per cent, compared with the appropriation for 2016-2017. Resource changes result from three factors, namely: (a) technical adjustments relating to the removal of non-recurrent requirements and the biennial provision of new posts established in 2016-2017; (b) new and expanded mandates; and (c) other resource changes. The proposed resource level provides for the full, efficient and effective implementation of mandates.
- 9.8 The distribution of resources is reflected in tables 9.3 to 9.5 below.

Technical adjustments

- 9.9 Resource changes reflect the net effect of:
- (a) Removal of non-recurrent requirements totalling \$4,479,700 relating to the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development approved pursuant to General Assembly resolution [71/272](#);
 - (b) Removal of non-recurrent requirements totalling \$79,000 relating to 2017 activities for the modalities for the intergovernmental negotiations of the global compact for safe, orderly and regular migration approved pursuant to General Assembly resolution [71/280](#);
 - (c) Biennial provision of \$1,427,900 relating to four new temporary posts (1 P-4, 2 P-3 and 1 GS (OL)) under subprogramme 8 that were established in the biennium 2016-2017, effective 1 January 2016 pursuant to General Assembly [70/248](#), in the context of revised estimates resulting from resolutions and decisions adopted by the Economic and Social Council; and five new temporary posts under subprogrammes 4 (2 P-5) and 9 (1 P-5, 1 P-4 and 1 P-3) that were established in the biennium 2016-2017, effective 1 January 2017, pursuant to General Assembly resolution [71/272](#) in support of the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development ([A/71/534](#)).

New and expanded mandates

- 9.10 Resource changes reflecting an increase of \$13,974,774 would provide for:
- (a) The contribution of the United Nations Secretariat to the resident coordinator system in the amount of \$13,321,574 in line with the request by the General Assembly to the Secretary-General contained in its resolution [71/272](#) B of 6 April 2017 to present to the Assembly at its seventy-second session a refined proposal on the cost-sharing arrangement and management of the financing thereof and to submit associated costs in the proposed programme budget for 2018-2019;
 - (b) Non-post resources in the amount of \$653,200 for new mandates pursuant to General Assembly resolution [71/272](#) in support of the implementation of resolutions and decisions adopted by the Economic and Social Council during 2016 ([A/71/401](#) and Add.1), including those arising from the ministerial declaration contained in document [E/HLS/2016/1](#) ([A/71/401](#)) (under subprogramme 3); and Economic and Social Council resolution 2017/2 and decision 2017/205 ([A/71/401/Add.1](#)) (under policymaking organs).

Other changes

- 9.11 Resource changes reflect a reduction of \$1,725,100, made possible from efficiencies that the Department of Economic and Social Affairs plans to bring about in the biennium 2018-2019. The proposed reduction is a result of the efforts of the Department to apply the anticipated Umoja efficiencies presented in the eighth progress report of the Secretary-General on the enterprise resource planning project ([A/71/390](#)) to individual day-to-day operations. The Umoja efficiencies set out in the eighth progress report were based on the Organization's experience with the system, anticipated future changes, including future roll-outs, a global review of end-to-end processes, the retirement of legacy systems and improvements to business process and planning capabilities. Efficiencies were expressed, inter alia, as the dollar value of a full-time equivalent, where applicable. Further information on the approach is provided in the foreword and introduction of the proposed programme budget for the biennium 2018-2019.

- 9.12 For the Department of Economic and Social Affairs, this translates to post and non-post net reductions of \$1,725,100, which fall under executive direction and management (\$162,400), programme of work (\$1,592,000), specifically under subprogrammes 1, 2, 5, 6 and 7, and programme support (\$29,300).

Extrabudgetary resources

- 9.13 The Department receives both cash and in-kind contributions, which continue to be vital in the delivery of its mandates. For the biennium 2018-2019, the total projected extrabudgetary cash contributions amounting to \$137,705,700 will supplement resources from the regular budget to provide for various substantive and technical cooperation activities, including consultancy, expert groups, travel, technical advisory services, training, workshops, seminars and field projects.
- 9.14 Anticipated in-kind contributions for the biennium 2018-2019 would provide mainly for rent-free premises of the Department’s field presence, at an estimated value of \$0.3 million.

Other information

- 9.15 The Department will conduct self-evaluations and self-assessments and will report on the implementation of evaluation activities. Training programmes on monitoring and evaluation will be organized to further strengthen departmental monitoring and evaluation capacity. The departmental evaluation policy serves as a basis for the monitoring and evaluation activities.
- 9.16 Pursuant to General Assembly resolution [58/269](#), resources identified for the conduct of monitoring and evaluation would amount to \$584,800, including \$522,800 for post resources and \$62,000 for non-post resources. Post resources represent 39.5 work-months comprising 29.5 work-months in the Professional and higher category and 10.0 work-months in the General Service category for the biennium 2018-2019 funded from the regular budget.
- 9.17 Following a review of the publications pertaining to each subprogramme, it is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 9.6 and as distributed in the output information for each subprogramme.
- 9.18 The Department’s publications and data subscriptions are also a revenue source for the Secretariat, generating \$3.1 million in sales and subscriptions in 2015 and 2016.

- 9.19 Provision is made under this subsection for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes, the servicing of which is the responsibility of the Department of Economic and Social Affairs and which are deemed to require specific provisions. The provisions for experts serving on committees in their individual capacity are in accordance with General Assembly resolution 2491 (XXIII), as amended by resolutions 41/176, 42/25, section VI, and 43/217, section IX, while the provisions for members of the functional commissions are in accordance with General Assembly resolutions 1798 (XVII), 2128 (XX) and 2245 (XXI).

Standing intergovernmental organs and expert bodies

Statistical Commission

Resource requirements (before recosting): \$107,800

- 9.20 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I). Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) and 1566 (L), are to assist the Council in: promoting the development of national statistics and the improvement of their comparability; coordinating the statistical work of the specialized agencies; developing the central statistical services of the Secretariat; advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information; and promoting the improvement of statistical methods in general. The Commission consists of 24 representatives of Member States elected by the Council for a period of four years.
- 9.21 Bearing in mind General Assembly resolution 50/227 and the need to provide for more continuity in the Commission's decision-making and oversight with respect to the global statistical process, and with the aim of enabling the Commission to follow up on the statistical implications of the major United Nations conferences and summits, the Council, in its resolution 1999/8, decided that the Commission would meet annually for a period of four working days in New York, beginning in 2000.
- 9.22 The forty-ninth and fiftieth sessions of the Statistical Commission are scheduled to be held in 2018 and 2019, respectively.

Committee of Experts on Global Geospatial Information Management***Resource requirements (before recosting):***

- 9.23 The Committee of Experts on Global Geospatial Information Management was established by the Economic and Social Council in its resolution 2011/24 at its 47th plenary meeting, on 27 July 2011. In accordance with its terms of reference contained in the annex to the resolution, the objectives of the Committee of Experts are to make joint decisions and set directions on the production and use of geospatial information within national and global policy frameworks; promote common principles, policies, methods, mechanisms and standards for the interoperability of geospatial data and services; and provide a platform for the development of effective strategies on how to build and strengthen national capacity concerning geospatial information, especially in developing countries. In its resolution 2011/24, the Council stipulated that the Committee of Experts be established and administered within existing resources and organized accordingly, and requested it to present to the Council in 2016 a comprehensive review of all aspects of its work and operations, in order to allow Member States to assess its effectiveness.
- 9.24 In early 2016, the Committee of Experts submitted a comprehensive five-year programme review of its work to the Council ([E/2016/47](#)) in response to the request as referenced in Council resolution 2011/24. On 26 July 2016, the Council adopted its resolution 2016/27 on strengthening institutional arrangements on geospatial information management. The resolution broadens and strengthens the mandate of the Committee of Experts as the relevant body to report on all matters relating to geography, geospatial information and related topics. The resolution also confirmed the inclusion of the annual three-day session of the Committee of Experts within the regular United Nations calendar of conferences and meetings under the Council, inclusive of the provision of dedicated United Nations conference management services and full support for the annual session of the Committee.
- 9.25 The eighth and ninth sessions of the Committee of Experts are scheduled to be held in 2018 and 2019, respectively.

Commission on Population and Development***Resource requirements (before recosting): \$123,600***

- 9.26 The Population Commission was established by the Economic and Social Council in its resolution 3 (III). Its terms of reference were initially set out in Council resolution 150 (VII). In its resolution [49/128](#), the General Assembly decided that the revitalized Population Commission would be renamed the Commission on Population and Development and that it would meet on an annual basis. The Commission is composed of 47 representatives of Member States elected by the Council for a period of four years (Council decision 1995/320). It normally meets annually for a period of five working days.
- 9.27 Under its terms of reference, the Commission is to assist the Council by: (a) arranging for studies and advising the Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance, as well as addressing population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; (b) monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and global levels, identifying reasons for success and failure and advising the Council thereon; and (c) reviewing the findings of research and analysis pertaining to the interrelationships between population and development at the national, regional and international levels and advising the Council thereon. By General Assembly resolution [65/234](#) of 22 December 2010, Member States extended the Programme of Action and the key actions for its further implementation beyond 2014.

- 9.28 During its forty-ninth session, the Commission reviewed its methods of work and recommended to the Economic and Social Council a draft resolution on the future organization and methods of work of the Commission on Population and Development. The resolution was adopted by the Council on 27 July 2016 (resolution 2016/25). In the resolution, Member States reaffirmed the Programme of Action of the International Conference on Population and Development and the key actions for its further implementation and reaffirmed the primary mandate of the Commission to monitor, review and assess the implementation of the Programme of Action at the national, regional and international levels. Member States also affirmed that the Commission would contribute to the follow-up and review of the 2030 Agenda for Sustainable Development within its existing mandate.
- 9.29 The fifty-first and fifty-second sessions of the Commission on Population and Development are scheduled to be held in 2018 and 2019, respectively.

Commission for Social Development

Resource requirements (before recosting): \$206,100

- 9.30 The Social Commission was established as a functional commission of the Economic and Social Council by the Council in its resolution 10 (II). As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI), renamed it the Commission for Social Development to clarify its role as a preparatory body of the Council for the entire range of social development policy. By its resolution 1996/7, the Council decided to expand the membership of the Commission from 32 to 46 representatives of Member States, elected by the Council for a period of four years, and that it should meet in annual sessions of eight working days. The Council also decided, by its resolution 2005/11, that the Commission would be organized in a series of two-year action-oriented implementation cycles that would include a review segment and a policy segment.
- 9.31 The fifty-sixth and fifty-seventh sessions of the Commission for Social Development are scheduled to be held in 2018 and 2019, respectively.

High-level political forum follow-up on the implementation of sustainable development

Resource requirements (before recosting): \$752,600

- 9.32 The General Assembly, in its resolution 66/288 (outcome document of the United Nations Conference on Sustainable Development entitled “The future we want”), decided to establish a universal, intergovernmental, high-level political forum on sustainable development. The forum replaced the Commission on Sustainable Development and builds on the strengths, experiences, resources and inclusive participation modalities of the Commission. The Assembly provided guidance with respect to the format and organizational aspects of the high-level political forum in its resolution 67/290. According to those mandates, the high-level political forum provides political leadership, guidance and recommendations for sustainable development, follows up and reviews progress in the implementation of sustainable development commitments, enhances the integration of the three dimensions of sustainable development and has a focused, dynamic and action-oriented agenda, ensuring the appropriate consideration of new and emerging sustainable development challenges.¹ The meetings of the high-level political forum will be convened under the auspices of the General Assembly and the Economic and Social Council). The meetings of the high-level political forum under the auspices of the Council shall be convened annually. The travel of representatives from the least developed countries to the meetings of the high-level political forum under the auspices of the Council will be facilitated. The meetings of the high-level political forum under the auspices of the General Assembly shall be convened every four years at the Heads of State level.

Committee for Development Policy***Resource requirements (before recosting): \$360,500***

- 9.33 The Economic and Social Council, in annex I to its resolution 1998/46, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) and 1079 (XXXIX) and decision 1995/215, the Committee for Development Policy and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts who possess expertise in the fields of economic development, social development and environmental protection and who reflect adequate geographical and gender balance. The experts are nominated by the Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years.
- 9.34 The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. Since the adoption in 1997 of additional guidelines for the identification of least developed countries, this has also involved undertaking impact assessments of countries found to be eligible for graduation. Furthermore, the Committee reports to the Council its findings with respect to the monitoring exercises on the development progress of countries graduating from the list of least developed countries. In its resolution [67/221](#), the General Assembly requested the Committee to monitor the development progress of graduated countries on an annual basis for the first three years after graduation became effective and triennially thereafter. Economic and Social Council resolution 2011/20 reflects the Council's intention to engage in more frequent interactions with the Committee on the themes of the high-level segment and on other pertinent issues that the Committee wishes to bring to the attention of the Council.
- 9.35 The twentieth and twenty-first sessions of the Committee for Development Policy are scheduled to be held in 2018 and 2019, respectively.

Committee of Experts on Public Administration***Resource requirements (before recosting): \$337,600***

- 9.36 The Committee of Experts on Public Administration has been holding annual sessions since 2003 in accordance with Economic and Social Council resolution 2003/60. The Committee comprises 24 experts, who serve in their personal capacity. The experts are nominated by the Secretary-General, in consultation with Member States, and approved by the Economic and Social Council. The membership is drawn from the interrelated fields of public economics, public administration and public finance and reflects geographical and gender balance. The term of office of members is four years.² The Committee's role is to support intergovernmental deliberations in providing policy options and making recommendations to improve governance and public administration structures and processes for development. It assists the Council by reviewing trends, issues and priorities in public administration, notably in relation to the 2030 Agenda for Sustainable Development and in support of the implementation and progress reviews of the Sustainable Development Goals.³
- 9.37 The seventeenth and eighteenth sessions of the Committee of Experts on Public Administration are scheduled to be held in 2018 and 2019, respectively.

Committee of Experts on International Cooperation in Tax Matters***Resource requirements (before recosting): \$827,800***

- 9.38 By its resolution 2004/69, the Economic and Social Council decided to rename the Ad Hoc Group of Experts on International Cooperation in Tax Matters the Committee of Experts on International Cooperation in Tax Matters. The Committee comprises 25 members who act in their expert capacity, nominated by Governments. The members are appointed by the Secretary-General, after the notification of the Council, for a term of four years and are drawn from the fields of tax policy and tax administration. Their appointment reflects adequate equitable geographical distribution, representing different tax systems. From 2005 to 2015, the Committee met on a yearly basis for a period of five days in Geneva.
- 9.39 By its resolution [69/313](#), the General Assembly decided to increase the frequency of the Committee's meetings to two sessions per year, with a duration of four working days each. It further decided to increase the engagement of the Committee with the Economic and Social Council through the special meeting on international cooperation in tax matters, with a view to enhancing intergovernmental consideration of tax issues. In the same resolution, the Assembly decided that the members shall be appointed by the Secretary-General, in consultation with Member States.
- 9.40 In its resolution 2017/2, the Economic and Social Council decided that starting in 2017, one session of the Committee would be held in New York in the spring and one in Geneva in the fall, with the session in New York held back to back with the special meeting of the Council on international cooperation in tax matters.
- 9.41 The Committee of Experts on International Cooperation in Tax Matters is mandated to: (a) keep under review and update as necessary the United Nations Model Double Taxation Convention between Developed and Developing Countries and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries; (b) provide a framework for dialogue with a view to enhancing and promoting international tax cooperation among national tax authorities; (c) consider how new and emerging issues could affect international cooperation in tax matters and develop assessments, commentaries and appropriate recommendations; (d) make recommendations on capacity-building and the provision of technical assistance to developing countries and countries with economies in transition; and (e) give special attention to developing countries and countries with economies in transition in dealing with all the aforementioned issues. The Committee submits its report on the work of its annual sessions to the Economic and Social Council at its substantive session.
- 9.42 In its resolution 2008/16, the Economic and Social Council recognized that the Committee had agreed to create, as necessary, ad hoc subcommittees composed of experts and observers who would work according to the Committee's rules of procedure to prepare and determine the supporting documentation for the agenda items, including requests for papers by independent experts, for consideration at its regular session.
- 9.43 At each annual session, the Committee reviews the list of subcommittees and working groups and decides to terminate those that have fulfilled their mandates and to establish new ones to be tasked with new mandates emerging from its programme of work.
- 9.44 In its resolution 2017/2, the Economic and Social Council noted the work of the Committee's nine subcommittees.
- 9.45 The sixteenth, seventeenth, eighteenth and nineteenth sessions of the Committee of Experts on International Cooperation in Tax Matters are scheduled to be held in 2018 and 2019, respectively.

United Nations Forum on Forests***Resource requirements (before recosting): \$102,400***

- 9.46 By its resolution 2000/35, the Economic and Social Council established the United Nations Forum on Forests as an intergovernmental subsidiary body of the Council, to serve as a permanent policy and political forum, with the main objective of promoting the management, conservation and sustainable development of all types of forests, and to strengthen long-term political commitment to that end. The Forum is composed of all States Members of the United Nations and members of the specialized agencies with full and equal participation, including voting rights.
- 9.47 In its resolution 2015/33, the Council decided to strengthen the international arrangement on forests and extend it to 2030. By the same resolution, the Council also decided to improve and strengthen the functioning of the Forum beyond 2015 and requested it to carry out its core functions on the basis of a strategic plan for the period 2017-2030. The Forum is mandated to hold annual sessions for a period of five days and to dedicate the odd-year sessions of the Forum to discussions on implementation and technical advice and to hold policy sessions with recommendations for consideration in even years. The thirteen and fourteenth sessions of the United Nations Forum on Forests will take place in 2018 and 2019, respectively.
- 9.48 In its resolution 2015/33, the Economic and Social Council decided that the core functions of the Forum are to: (a) provide a coherent, open, transparent and participatory global platform for policy development, dialogue, cooperation and coordination on issues related to all types of forests, including emerging issues, in an integrated and holistic manner, including through cross-sectoral approaches; (b) promote, monitor and assess the implementation of sustainable forest management, in particular the United Nations Forest Instrument and the achievement of its global objectives on forests, and mobilize, catalyse and facilitate access to financial, technical and scientific resources to that end; (c) promote governance frameworks and enabling conditions at all levels to achieve sustainable forest management; (d) promote coherent and collaborative international policy development on issues related to all types of forests; and (e) strengthen high-level political engagement, with the participation of major groups and other stakeholders, in support of sustainable forest management.

Permanent Forum on Indigenous Issues***Resource requirements (before recosting): \$356,700***

- 9.49 The Economic and Social Council, in its resolution 2000/22, established the Permanent Forum on Indigenous Issues, as a subsidiary organ of the Council, consisting of 16 members, 8 members to be nominated by Governments and elected by the Council, and 8 members to be appointed by the President of the Council, following formal consultation with the Bureau and the regional groups, through their coordinators. Nominations are decided on the basis of broad consultations with indigenous organizations, taking into account the diversity and geographical distribution of the indigenous people of the world as well as the principles of transparency, representativity and equal opportunity for all indigenous people, including internal processes, when appropriate, and local indigenous consultation processes. All members serve in their personal capacity as independent experts on indigenous issues for a period of three years, with the possibility of re-election or reappointment for one further period. States, United Nations bodies and organs, intergovernmental organizations and non-governmental organizations in consultative status with the Council may participate as observers. Organizations of indigenous people may also participate as observers, in accordance with the procedures that have been applied in the Working Group on Indigenous Populations of the Subcommission on the Promotion and Protection of Human Rights.
- 9.50 The Economic and Social Council decided that the Permanent Forum shall hold an annual session of 10 working days at the United Nations Office at Geneva, United Nations Headquarters or such other place as the Permanent Forum may decide in accordance with existing Financial Rules and Regulations of the United Nations.

- 9.51 The seventeenth and eighteenth sessions of the Permanent Forum on Indigenous Issues are scheduled to be held in 2018 and 2019, respectively.
- 9.52 The distribution of resources for policymaking organs is reflected in table 9.8 below.

- 9.54 The net decrease of \$44,700 reflects:
- Removal of non-recurrent requirements relating to the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development pursuant to General Assembly resolution [71/272](#);
 - Provision of additional non-post resources to cover new mandates related to the Committee of Experts on International Cooperation in Tax Matters, approved in General Assembly resolution [71/272](#), in support of the implementation of resolutions and decisions adopted by the Economic and Social Council during 2016 ([A/71/401/Add.1](#)), and pursuant to Economic and Social Council resolution 2017/2 and decision 2017/205.

B. Executive direction and management

Resource requirements (before recosting): \$9,649,600

- 9.55 The Under-Secretary-General for Economic and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and its approved programme of work. He serves as convener of the Executive Committee on Economic and Social Affairs as well as the Programme Manager of the Development Account and is responsible for the overall management of capacity development activities. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Assistant Secretary-General for Economic Development.
- 9.56 The Assistant Secretary-General for Economic Development serves as the principal economic adviser to the Under-Secretary-General, whom he assists by leading and coordinating the policy research and analysis work of the Department. The Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs supports the Under-Secretary-General by providing substantive support to the Economic and Social Council and other relevant intergovernmental bodies.
- 9.57 The Strategic Planning and Communications Service supports the Under-Secretary-General in promoting strategic integration and policy coherence, including collaborative work with other Secretariat entities and the formulation of policies and strategies in the areas of knowledge management, website communications, publishing and electronic administration. In addition, the Service represents the Department in relevant Secretariat policy and normative bodies, including the Publications Board, the Information and Communications Management Committee, the Data Governance Council and the Task Force on Knowledge Management.

9.59 The amount of \$9,649,600, reflecting a decrease of \$162,400 compared with the appropriation for 2016-2017, would provide for the financing of 25 posts (1 USG, 2 ASG, 2 D-1, 5 P-5, 3 P-4, 1 P-3, 3 P-2, 2 GS (PL) and 6 GS (OL)) (\$8,183,600) and for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials, furniture and equipment, and grants and contributions (\$1,466,000) to support the implementation of mandates under the programme.

9.60 The decrease of \$162,400 reflects the proposed abolishment of one General Service (Other level) post (Team Assistant) in the Office of the Under-Secretary-General for Economic and Social Affairs, resulting from efficiencies that the Department plans to bring about in 2018-2019.

External factors

9.63 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) policymakers, both national and international, will be involved in the consideration of economic, social and environmental issues in the General Assembly and the Economic and Social Council; (b) the international community will be responsive to the recommendations and decisions of the Assembly and the Council; (c) United Nations agencies will be committed to participating in the Assembly/Council process and to implementing recommendations and decisions of those bodies; and (d) non-governmental organizations will maintain interest in applying for consultative status with the Council and engaging with the Council and its subsidiary bodies.

Outputs

9.66 The amount of \$14,460,700, reflecting a net decrease of \$377,800 compared with the appropriation for 2016-2017, would provide for the financing of 45 posts (1 D-2, 4 D-1, 6 P-5, 10 P-4, 6 P-3, 3 P-2, 1 GS (PL) and 14 GS (OL)) (\$13,298,000) and for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials,

furniture and equipment, and grants and contributions (\$1,162,700) to support the implementation of mandates under the programme.

9.67 The net decrease of \$377,800 reflects:

- (a) Removal of non-recurrent requirements relating to the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development pursuant to General Assembly resolution 71/272;
- (b) the proposed abolishment of one General Service (Other level) post (Administrative Assistant) in the Office of the Director, resulting from efficiencies that the Department plans to bring about in 2018-2019;
- (c) offset in part by the proposed conversion of general temporary assistance resources to established posts (1 P-4 and 1 P-3) to implement the quadrennial comprehensive policy review of operational activities for development of the United Nations system (General Assembly resolution 67/226). In view of the long-term need to support the review of the operational activities of the United Nations system and pursuant to Assembly resolution 71/243, the continuing request to assist the development and implementation of actions (reports, assessments, analyses, monitoring frameworks) related to existing and new quadrennial comprehensive policy review mandates directed to the Secretary-General has been made.

9.68 During the biennium 2018-2019, projected extrabudgetary resources of \$908,000 would provide for multi-stakeholder participation in expert group meetings supporting the high-level segment preparatory process; the utilization of external expertise to improve the analytical work for the quadrennial comprehensive policy review of United Nations operational activities for development; support to the global preparations for the Development Cooperation Forum, including the financing of substantive studies, global/regional preparatory meetings and expert group meetings; and the implementation of the 2016 General Assembly resolution on the quadrennial comprehensive policy review of operational activities for development of the United Nations system (resolution 71/243).

9.73 The amount of \$17,048,300, reflecting a decrease of \$455,200 compared with the appropriation for 2016-2017, would provide for the financing of 57 posts (1 D-2, 3 D-1, 5 P-5, 14 P-4, 7 P-3, 8 P-2, 1 GS (PL) and 18 GS (OL)) (\$15,990,700) and for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials, furniture and equipment, and grants and contributions (\$1,057,600) to support the implementation of mandates under the programme.

9.74 The decrease of \$455,200 reflects the proposed abolishment of one General Service (Other level) post (Team/Staff Assistant) in the secretariat for the Convention on the Rights of Persons with Disabilities; and one P-3 post (Social Affairs Officer) in the secretariat of the Permanent Forum on Indigenous Issues, resulting from efficiencies that the Department plans to bring about in 2018-2019.

9.75 During the biennium 2018-2019, projected extrabudgetary resources amounting to \$1,650,900 would support the implementation of activities under the programme. The decrease in projected extrabudgetary resources reflects the completion of some projects in the biennium 2016-2017.

9.80 The amount of \$18,827,800, reflecting a net decrease of \$1,210,300 compared with the appropriation for 2016-2017, would provide for the financing of 58 posts (1 D-2, 5 D-1, 12 P-5, 10 P-4, 5 P-3, 4 P-2, 2 GS (PL) and 19 GS (OL)) (\$17,182,700) and for non-post requirements, including other staff costs, consultants, experts, travel of representatives, travel of staff, contractual services, general operating expenses, supplies and materials, and furniture and equipment (\$1,645,100) to support the implementation of mandates under the programme.

9.81 The net decrease of \$1,210,300 reflects:

- (a) Removal of non-recurrent requirements relating to the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International

Conference on Financing for Development pursuant to General Assembly resolution 71/272; offset in part by

- (b) Provision of additional non-post resources to cover new mandates pursuant to General Assembly resolution 71/272 in support of the implementation of resolutions and decisions adopted by the Economic and Social Council during 2016 (A/71/401 and Add.1), including those arising from the ministerial declaration contained in document E/HLS/2016/1 (A/71/401).

9.82 During the biennium 2018-2019, projected extrabudgetary resources of \$16,786,500 would support: the participation of representatives of developing countries and countries with economies in transition in a range of meetings related to sustainable development and in the intergovernmental meetings; the Special Adviser of the High-level Panel on Water; the strengthening of the means of implementation of Agenda 2030, in particular through the high-level political forum on sustainable development; and delegates of major groups of stakeholders in actively participating in the voluntary national review process of the achievement of the Sustainable Development Goals. Extrabudgetary resources under this subprogramme would also support technical cooperation projects.

- 9.108 The amount of \$12,789,400, reflecting a decrease of \$487,200 compared with the appropriation for 2016-2017, would provide for the financing of 44 posts (1 D-2, 3 D-1, 6 P-5, 9 P-4, 2 P-3, 3 P-2, 2 GS (PL) and 18 GS (OL)) (\$12,159,400) and for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, general operating expenses, supplies and materials and furniture and equipment (\$630,000) to support the implementation of mandates under the programme.

- 9.122 The amount of \$8,275,500, reflecting a net decrease of \$567,100 compared with the appropriation for 2016-2017, would provide for the financing of 25 posts (1 D-2, 2 D-1, 5 P-5, 5 P-4, 6 P-3 and 6 GS (OL)) (\$7,967,900) and for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials and furniture and equipment (\$307,600) to support the implementation of mandates under the programme.
- 9.123 The net decrease of \$567,100 reflects: (a) removal of non-recurrent requirements relating to the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development (pursuant to General Assembly resolution [71/272](#)); offset in part by (b) biennial provision of resources for three new temporary posts (1 P-5, 1 P-4 and 1 P-3), established in the biennium 2016-2017, effective 1 January 2017, pursuant to General Assembly resolution [71/272 A](#), in support of the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development.
- 9.124 During the biennium 2018-2019, projected extrabudgetary resources of \$552,200 would support technical cooperation projects.

1. Executive Office

Resource requirements (before recosting): \$7,150,500

- 9.125 The Executive Office assists the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of human resources management, finance and general administration.
- 9.126 During the biennium 2018-2019, the Office will provide support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretaries-General, on: (a) the use of post and non-post resources across subprogrammes; (b) the management of staff resources, including staff selection processes, performance management, staff management relations, conflict resolution, litigation, workforce planning, talent management and training and staff development; (c) the implications of new mandates and timely preparation and issuance of reports and oral statements of programme budget implications; (d) the management of Secretariat administrative arrangements, including service-level agreements for centrally delivered services; (e) donor agreements, memorandums of understanding and arrangements for various activities organized in collaboration with other United Nations offices; (f) funding and travel arrangements for delegates to all Department of Economic and Social Affairs-serviced intergovernmental and expert meetings and negotiations on host country arrangements for global conferences; (g) management of contingency plans to ensure business continuity of the Department's programmes; and (h) compliance with all management authority delegated to the Department.
- 9.127 The amount of \$7,150,500, reflecting a net decrease of \$89,000 compared with the appropriation for 2016-2017, would provide for the financing of 14 posts (1 D-1, 2 P-5, 2 P-4, 1 P-3, 2 GS (PL) and 6 GS (OL)) (\$3,653,200) and for non-post requirements, including other staff costs, contractual services, general operating expenses, hospitality, supplies and materials, and furniture and equipment (\$3,497,300) to support the implementation of mandates under the programme.
- 9.128 The net decrease of \$89,000 reflects: (a) removal of non-recurrent requirements relating to the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda pursuant to General Assembly resolution [71/272 A](#); and (b) non-post reductions resulting from efficiencies that the Department plans to bring about in 2018-2019; offset in part by (c) additional non-post resources, mainly for general temporary assistance to cover some of the functions of the posts proposed for abolishment in the Department resulting from efficiencies that the Department plans to bring about in 2018-2019.

2. Capacity Development Office

Resource requirements (before recosting): \$1,984,800

- 9.129 The Capacity Development Office provides broad substantive guidance and management to the implementation of the Department's capacity development work, promoting effective translation of intergovernmental outcomes into the Department's operational programmes and capacity development work.
- 9.130 In the biennium 2018-2019, the Office will promote the Department's delivery of integrated policy advisory services, drawing on the expertise of the subprogrammes of the Department of Economic and Social Affairs, as a contribution to the formulation of national sustainable development strategies, including the identification of policy options to balance the achievement of social, economic and environmental goals, as enshrined in the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda.
- 9.131 The Office will also promote closer programme cooperation within the United Nations Secretariat and with other United Nations entities, in line with the need for a more coherent, coordinated and cross-sectoral approach in implementing the two agendas.
- 9.132 To maximize the effective delivery of the capacity development programme of the Department of Economic and Social Affairs, an integrated programming approach will be taken which ensures

full complementarity and synergies between the various strands of the portfolio of the Department, including the regular programme of technical cooperation, the Development Account and its extrabudgetary resources.

- 9.133 The Capacity Development Office also provides management oversight, including through monitoring, evaluation and reporting on the capacity development deliverables of the Department of Economic and Social Affairs. It provides efficient and effective administration and management of financial and human resources, including the delivery of extensive capacity development training workshops, seminars, fellowships and study tours. The Office supports the Under-Secretary-General in his or her role as Programme Manager of the Development Account, which involves the active management of approximately 150 Development Account projects across 10 implementing entities at various stages of implementation. The Office also supports the management of the Associate Expert Programme of the United Nations Secretariat, administering on average 200 experts per annum.
- 9.134 The amount of \$1,984,800 would provide for the financing of six posts (1 D-1, 1 P-5, 2 P-4, 1 P-2 and 1 GS (OL)) to assist the Under-Secretary-General with the management of the Development Account and the implementation of the Department's capacity development programmes, projects and strategy.
- 9.135 During the biennium 2018-2019, the projected extrabudgetary resources of \$97,829,900 for the programme support component (both Executive Office and Capacity Development Office) would support the operational programmes of the Department and the delivery of the Department's capacity development activities, funded under donor arrangements.

E. Support of United Nations Secretariat to the resident coordinator system

Resource requirements (before recosting): \$13,321,574

- 9.136 The proposal for United Nations Secretariat support for the United Nations Development Group (UNDG) resident coordinator system was first presented in the report of the Secretary-General on revised estimates resulting from resolutions and decisions adopted by the Economic and Social Council during its 2014 session ([A/69/535](#)), pursuant to Economic and Social Council resolution 2014/14, progress in the implementation of General Assembly resolution [67/226](#), on the quadrennial comprehensive policy review of operational activities for development of the United Nations system.
- 9.137 The Advisory Committee on Administrative and Budgetary Questions, in its related report ([A/69/609](#)), stressed that the General Assembly had not yet considered the cost-sharing arrangement for the resident coordinator system. The Assembly, in its resolution [69/262](#), stated that it looked forward to receiving all relevant information on the resource requirements for the arrangement in the proposed programme budget for the biennium 2016-2017.
- 9.138 The proposed programme budget for the biennium 2016-2017 for the Department of Economic and Social Affairs ([A/70/6](#) (Sect. 9)) included a proposal to cover the United Nations Secretariat contribution to the resident coordinator system. However, the General Assembly, in its resolution [70/247](#), requested the Secretary-General to provide further detailed information at the first part of its resumed seventieth session.
- 9.139 As requested by the General Assembly in its resolution [70/247](#), the Secretariat presented a report on the proposed United Nations Secretariat contribution to the cost-sharing arrangement for the resident coordinator system ([A/70/703](#)), in which the Assembly was requested to appropriate \$13,321,574 to cover the contribution of the Secretariat to that system. However, the Advisory Committee, in its report ([A/70/7/Add.48](#)), noted that it was not clear how the cost-sharing formula reflected the requirement for contributions to reflect the direct involvement of each participating entity based on the proportion of services used. The Committee also noted the absence of a unified

mechanism for intergovernmental consideration of all aspects of the cost-sharing arrangement, including the global budget of the resident coordinator system. In that context, the Committee requested the Secretary-General to submit a new report on the cost-sharing arrangement for consideration and approval by the Assembly.


- 9.140 The General Assembly endorsed the conclusions and recommendations of the Advisory Committee and requested the Secretary-General to present to the Assembly, at its seventy-second session, a refined proposal on the cost-sharing arrangement and management of the financing of the resident coordinator system, as well as to submit associated costs in the proposed programme budget of 2018-2019.
- 9.141 The amount of \$13,321,574 being presented for contribution by the United Nations Secretariat to the resident coordinator system in the proposed programme budget for the Department of Economic and Social Affairs for 2018-2019 is based on the amount communicated for the biennium 2016-2017, as per the report on the proposed Secretariat contribution to the cost-sharing arrangement for the resident coordinator system (A/70/703). This amount is provisional pending the report of the Secretary-General on the refined proposal on the resident coordinator system, including any adjustment to the proposed contribution of the United Nations Secretariat for 2018-2019.
- 9.142 The final proposed contribution by the United Nations Secretariat, to be presented in the context of the report on the refined proposal, would cover the participation in the resident coordinator system of the following 14 departments, offices and programmes of the United Nations Secretariat that are members of UNDG: the United Nations Environment Programme, the United Nations Human Settlements Programme, the United Nations Office on Drugs and Crime, the United Nations Conference on Trade and Development, the five regional commissions, the Office of the United Nations High Commissioner for Human Rights, the Office of the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States, the Office of the Special Adviser on Africa, the Office of the Special Representative of the Secretary-General for Children and Armed Conflict and the Department of Economic and Social Affairs.
