Report of the Second Committee*

1. At its 3rd plenary meeting, on 21 September 2018, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-third session the item entitled:

“Groups of countries in special situations:

“(a) Follow-up to the Fourth United Nations Conference on the Least Developed Countries;

“(b) Follow-up to the second United Nations Conference on Landlocked Developing Countries.”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 19th meeting, on 22 October 2018. An account of the Committee’s discussion of the item is contained in the relevant summary record.¹ Attention is also drawn to the general debate held by the Committee at its 2nd to 6th meetings, on 8, 9 and 10 October.² An account of the Committee’s further consideration of the item is provided in the addenda to the present report.
