Land violations committed in March 2019

3 March	1315	From inside occupied Palestinian territory opposite the town of Kafr Kila, the Israeli enemy violated the Blue Line by stretching nylon and cardboard over a surface area measuring approximately 45 m long and 1.8 m wide.
4 March	0800	From inside occupied Palestinian territory, Israeli enemy soldiers pointed the cannons of two Merkava tanks, one at the Rumaysh gate post and the other inside the Matat barracks, towards Lebanese territory.
	1145	From inside occupied Palestinian territory opposite the town of Kafr Kila, near point B83(1), one of the workers who was stretching nylon violated the Blue Line. The workers left in the direction of occupied territory at 1155 hours.
	1350	Opposite the town of Kafr Kila, from inside occupied Palestinian territory, the Israeli enemy violated the Blue Line by stretching nylon and cardboard over a surface area measuring approximately 45 m long and 1.8 m wide. The enemy personnel left in the direction of occupied territory at 1430 hours.
5 March	0800	From inside occupied Palestinian territory, at the Israeli enemy Khallat al-Budiyah post opposite the town of Rumaysh, the Israeli enemy pointed the cannon of a Merkava tank towards Lebanese territory.
	0900	Opposite the town of Udaysah, west of point B80, on the Lebanese-Palestinian border, the Israeli enemy continued to place steel netting atop the concrete T-wall units that it had recently installed in occupied Lebanese territory between points TP36(1) and TP37, which are on a part of the Blue Line to which a claim is maintained in that area. An Israeli enemy patrol comprising a crane and four workers placed steel netting atop 66 concrete T-wall units measuring 2.5 m tall. The work ended at 1600 hours, and the patrol left in the direction of occupied territory.
6 March	0700	From inside occupied Palestinian territory, at the Matat barracks opposite Rumaysh, the Israeli enemy pointed the cannon of a Merkava tank towards Lebanese territory.
	0700	From inside occupied Palestinian territory, near point B83 opposite Kafr Kila, an Israeli enemy patrol comprising 12 soldiers approached and inspected the technical fence. One of the soldiers pointed his weapon towards Lebanese territory. They left in the direction of occupied territory at 0815 hours.
	0700	Opposite the town of Udaysah, west of point B80, on the Lebanese-Palestinian border between points TP36(1) and TP37, which are on a part of the Blue Line to which a claim is maintained in that area, an Israeli enemy patrol comprising a crane and four workers stabilized and welded the steel

		netting atop the concrete units along a stretch measuring approximately 200 m. They left in the direction of occupied territory at 1500 hours.
	1330	Opposite the town of Kafr Kila, inside occupied Palestinian territory, an Israeli enemy patrol comprising four concrete mixers and a pump approached. Four Israeli enemy soldiers violated the Blue Line by pouring concrete onto an area approximately 45 m long and 1.8 m wide. The work ended at 1500 hours, and the patrol left in the direction of occupied territory.
	1400	From inside occupied Palestinian territory, opposite the town of Rumaysh, the Israeli enemy continued to clear and remove grass and timber and build a dirt road starting opposite point BP14 and ending opposite point B37 using a jackhammer. Two rocks rolled towards point BP14/2, violating the Blue Line by approximately 20 m.
7 March	0800	Opposite the town of Udaysah, west of point B80, on the Lebanese-Palestinian border, the Israeli enemy continued to place steel netting atop the concrete T-wall units that it had recently installed in occupied Lebanese territory between points TP36(1) and TP37, which are on a part of the Blue Line to which a claim is maintained in that area. An Israeli enemy patrol comprising two cranes and four workers approached and laid barbed wire on the steel netting that had recently been installed atop the T-wall units, along a stretch measuring approximately 100 m. The work ended at 1200 hours, and the patrol left in the direction of occupied territory.
	0800	Opposite the town of Kafr Kila at the Israeli enemy Jabal al-Tayyarah position, a Merkava tank pointed its cannon towards Lebanese territory. The tank left in the direction of occupied territory at 0825 hours.
	0820	From inside occupied Palestinian territory at the Rumaysh gate post, the Israeli enemy pointed the cannon of a Merkava tank towards Lebanese territory.
8 March	1010	From inside occupied Palestinian territory, opposite point BP10/1(1) (Ramiyah) an Israeli enemy patrol comprising two Humvees, one of which had a 12.7 mm machine gun mounted on it, approached. The patrol pointed the machine gun towards a Lebanese Army observation post for two minutes.
10 March	0800	Opposite the town of Udaysah, west of point B80, on the Lebanese-Palestinian border, the Israeli enemy continued to place steel netting atop the concrete T-wall units that it had recently installed in occupied Lebanese territory between points TP36(1) and TP37, which are on a part of the Blue Line to which a claim is maintained in that area. An Israeli enemy patrol comprising a crane and four workers laid barbed wire on the steel netting that had recently been installed atop the concrete T-wall units, along a stretch measuring approximately 200 m. The work ended at 1615 hours, and the patrol left in the direction of occupied territory.
	0855	From inside occupied Palestinian territory, near point B87 opposite the town of Kafr Kila, an Israeli enemy soldier pointed his weapon towards Lebanese territory.

11 March	0745	Opposite the town of Udaysah, west of point B80, on the Lebanese-Palestinian border, the Israeli enemy continued to place steel netting atop the concrete T-wall units that it had recently installed in occupied Lebanese territory between points TP36(1) and TP37, which are on a part of the Blue Line to which a claim is maintained in that area. An Israeli enemy patrol comprising a crane and four workers laid barbed wire on the steel netting that had recently been installed atop the concrete T-wall units, along a stretch measuring approximately 200 m. The work ended at 1655 hours, and the patrol left in the direction of occupied territory.
	1030	Opposite the town of Udaysah, west of point B80, on the Lebanese-Palestinian border, the Israeli enemy resumed construction work atop the concrete T-wall units that it had installed inside occupied Lebanese territory between points TP36(1) and TP37, which are on a part of the Blue Line to which a claim is maintained in that area. The Israeli enemy also installed a concrete T-wall unit at the opening previously left during the construction of the wall near point TP36(2). The work ended at 1115 hours, and the patrol left in the direction of occupied territory.
	1145	From inside occupied Palestinian territory opposite the town of Kafr Kila, near point B82, an Israeli enemy digger violated the Blue Line for five minutes when it removed the technical fence. The vehicle left in the direction of occupied territory at 1150 hours.
12 March	0800	Opposite the town of Udaysah, west of point B80, on the Lebanese-Palestinian border, the Israeli enemy continued to place steel netting atop the concrete T-wall units that it had recently installed in occupied Lebanese territory between points TP36(1) and TP36, which are on a part of the Blue Line to which a claim is maintained in that area. An Israeli enemy patrol comprising a crane and four workers laid barbed wire on the steel netting that had recently been installed atop the T-wall units, along a stretch measuring approximately 30 m. The work ended at 1630 hours, and the patrol left in the direction of occupied territory.
	0950	From inside occupied Palestinian territory opposite the town of Kafr Kila, near point B83(1), as an Israeli enemy trench digger was pulling five concrete units in the direction of occupied territory, the boom of the digger crossed the technical fence and violated the Blue Line.
	1020	From inside occupied Palestinian territory opposite the town of Kafr Kila, near point B83(1), one of the members of an Israeli enemy patrol present at the site pointed his weapon towards Lebanese territory for 10 minutes.
	1525	From inside occupied Palestinian territory opposite the town of Kafr Kila, near point B83(1), the members of an Israeli enemy patrol deployed near the technical fence trained their weapons on Lebanese territory.
13 March	0855	From inside occupied Palestinian territory, near point TP37, opposite the town of Udaysah, an Israeli enemy patrol comprising two Hummer vehicles and two Defender vehicles approached. Seven soldiers disembarked and carried out maintenance work on the technical fence. One of the soldiers

		pointed a machine gun that was mounted on a Hummer vehicle towards Lebanese territory.
	1130	From inside occupied Palestinian territory, at the Tallat Karantina post opposite the town of Yarun, the Israeli enemy pointed the cannon of a Merkava tank towards Lebanese territory. At 1315 hours he pointed the cannon back towards of occupied territory.
	1400	From inside occupied Palestinian territory, near point TP37, opposite the town of Udaysah, an engineering vehicle, a crane and two workers carried out maintenance work on the steel netting that had been installed on the concrete units. While performing that work, one of the workers directed vulgar comments at a Lebanese Army soldier at the observation post. The work ended at 1610 hours, and they left in the direction of occupied territory.
17 March	1300	Inside occupied Palestinian territory, opposite point BP10/1(1) (Ramiyah), an Israeli enemy patrol comprising two Humvee vehicles approached. One of the vehicles was equipped with a 12.7 mm machine gun. One of the soldiers directed the machine gun towards a Lebanese Army observation post for five minutes. The work ended at 1315 hours, and the patrol left in the direction of occupied territory.
18 March	0850	From inside occupied Palestinian territory, near point TP37, opposite the town of Udaysah, an Israeli enemy patrol comprising two Hummer vehicles approached. The patrol pointed the machine gun that was mounted on one of the vehicles towards Lebanese territory. The work ended at 1025 hours, and the patrol left in the direction of occupied territory.
19 March	0750	From inside occupied Palestinian territory, near point TP37, opposite the town of Udaysah, an Israeli enemy patrol comprising a Hummer vehicle approached. One of the soldiers pointed a machine gun mounted on the vehicle towards Lebanese territory. The work ended at 0850 hours, and the patrol left in the direction of occupied territory.
	0910	Opposite the town of Rumaysh, the Israeli enemy pointed the cannons of two Merkava tanks towards Lebanese territory from inside its southern Rumaysh and Khallat al-Budiyah posts. At 1020 hours and 1445 hours, the Israeli enemy turned the cannons at the aforementioned posts back towards occupied territory.
20 March	1030	From inside occupied Palestinian territory, at the Khallat al-Budiyah post opposite Rumaysh, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. At 1120 hours, the soldiers pointed the cannons back towards occupied Palestinian territory.
	1400– 1520	Tanks, armoured vehicles and circling warplanes and MK unmanned reconnaissance aircraft were heard from inside the occupied Shab'a Farms.
21 March	0840	From inside occupied Palestinian territory at the Rumaysh gate post, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory.

26 March	0935	From inside occupied Palestinian territory, at the Khallat al-Budiyah post opposite Rumaysh, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory for 25 minutes. At 1000 hours, the tank moved from inside the aforementioned post to the Mataat barracks post and pointed its cannon towards Lebanese territory for 25 minutes. It then left in the direction of occupied territory.

	1620	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for four minutes, and proceeded on its way for some 650 m. The launch then left in the direction of occupied Palestinian territorial waters.
	1812	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for eight minutes, and proceeded on its way for some 925 m. The launch then left in the direction of occupied Palestinian territorial waters.
