

Addendum

- 1. The Secretary-General has received notification of the resignation of Matsunaga Takeshi (Japan) from the Advisory Committee on Administrative and Budgetary Questions, effective 15 August 2020. Accordingly, the General Assembly will be required to appoint, at its current session, a person to fill the vacancy for the remaining period of the term of office of Mr. Matsunaga, which expires on 31 December 2022.
- 2. The Government of Japan has nominated Suzuki Yoriko to fill the vacancy arising from the resignation of Mr. Matsunaga.
- 3. In a communication dated 10 August 2020, the Secretariat was informed by the Chair of the group of Asia-Pacific States that the candidature of Ms. Suzuki had been endorsed by the group.

Suzuki Yoriko(Japan)

Ms. Suzuki has served in the Japanese Foreign Service for nearly thirty years, during which she has developed extensive knowledge and experience regarding, inter alia, public administration, development and human rights agenda, as well as political and economic situation in Latin America.

During her four years' assignment in the Minister's Secretariat of the Japanese Foreign Ministry, Ms. Suzuki dealt extensively with organizational management and administrative issues in a wide range of fields, from crisis management, policy evaluation, public records management to information security. In addition, as Deputy Coordinator for Building and Property Management at the headquarters, Ms. Suzuki engaged specifically in accounting, construction, maintenance and management of all the diplomatic mission facilities overseas. These experiences have led to the accumulation of expertise in the field of administration and finance.

Furthermore, in her past capacity as Principal Deputy Director of the Human Rights and Humanitarian Affairs Division and as Head of the Social Section of the Permanent Mission of Japan to the United Nations since 2018, Ms. Suzuki has been working closely with relevant United Nations entities especially in the field of human rights and humanitarian affairs. She has served as facilitator of several resolutions and had them adopted through consensus.
